(57) **CLAIM**

The ornamental design for a machine for earth-moving,
material handling, lifting, and/or construction, as shown and
described.

DESCRIPTION

FIG. 1 is a top, front, and right-side isometric view a
machine for earth-moving, material handling, lifting, and/or
construction showing the new design.

FIG. 2 is an enlarged top, back, and right-side isometric view
of the part of the machine that bears the claimed design.

FIG. 3 is a top plan view of the part of the machine that
machine seen in FIG. 2.

FIG. 4 is a right-side elevation view of the part seen in FIG.
2.

FIG. 5 is a back elevation view of the part seen in FIG. 2.

FIG. 6 is a left-side elevation view of the part seen in FIG.
2.

FIG. 7 is a front elevation view of the part seen in FIG. 2.

FIG. 8 is a bottom plan view of the part seen in FIG. 2.

FIG. 9 is a rear elevation view of the machine for earth-
moving, material handling, lifting, and/or construction seen
in FIG. 1, showing a second embodiment of the design,
which a mirror image of the first embodiment that is borne
on a different part of the same machine.

FIG. 10 is an enlarged top, back, and left-side isometric view
of the part of the machine that bears the second embodiment
of the design.

FIG. 11 is a top plan view of the part seen in FIG. 10.

FIG. 12 is a rear elevation view of the part seen in FIG. 10.

FIG. 13 is a left-side elevation view of the part seen in FIG.
10.

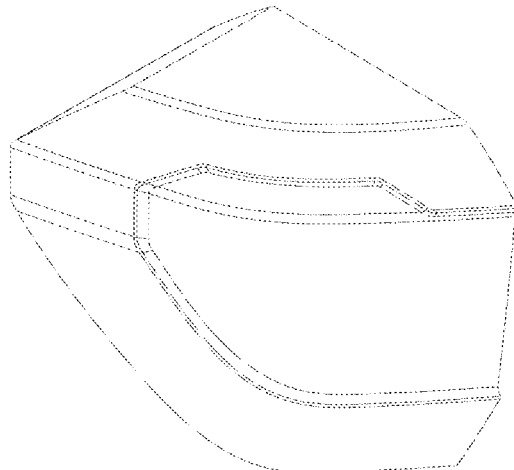
FIG. 14 is a front elevation view of the part seen in FIG. 10.

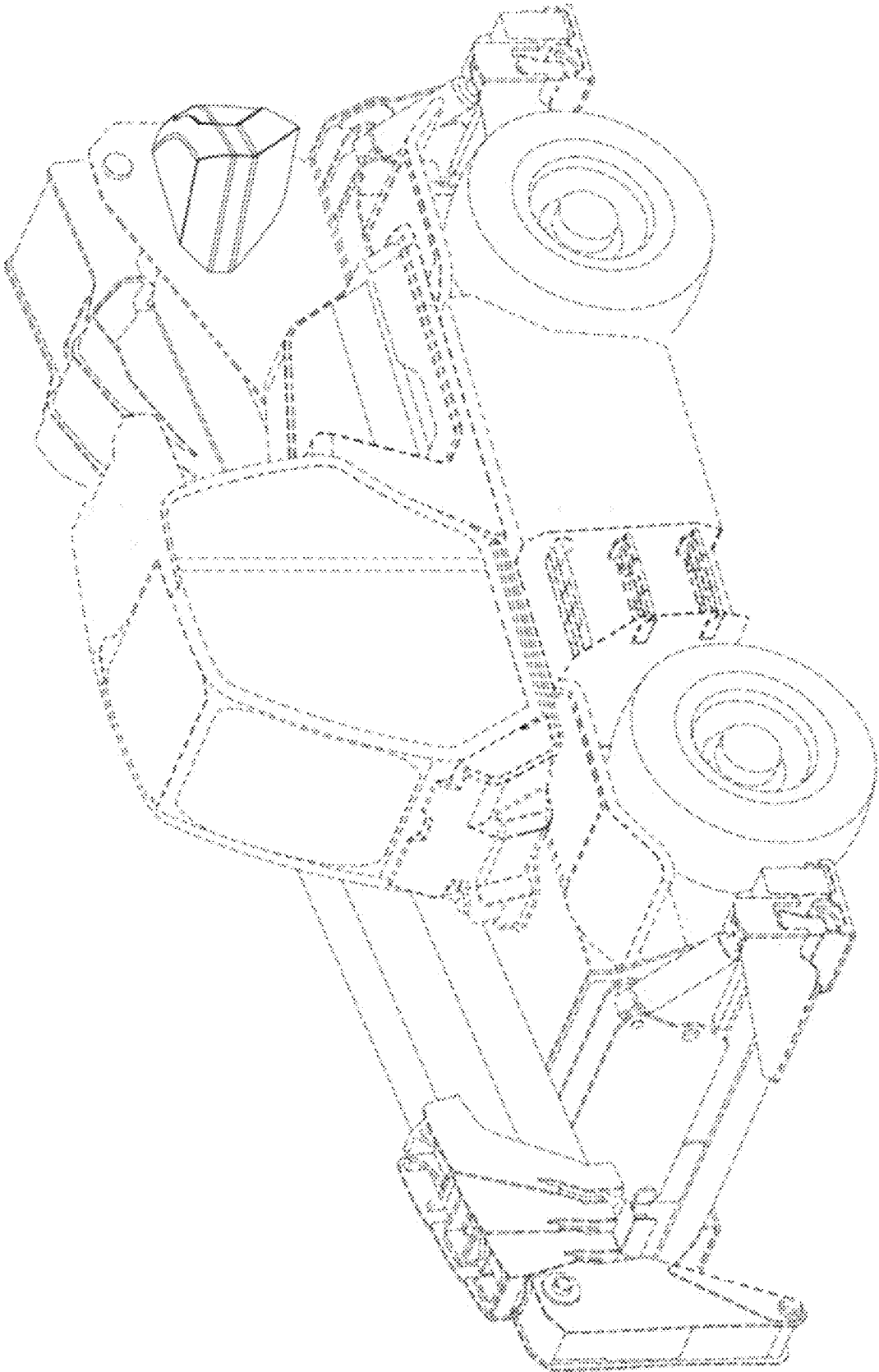

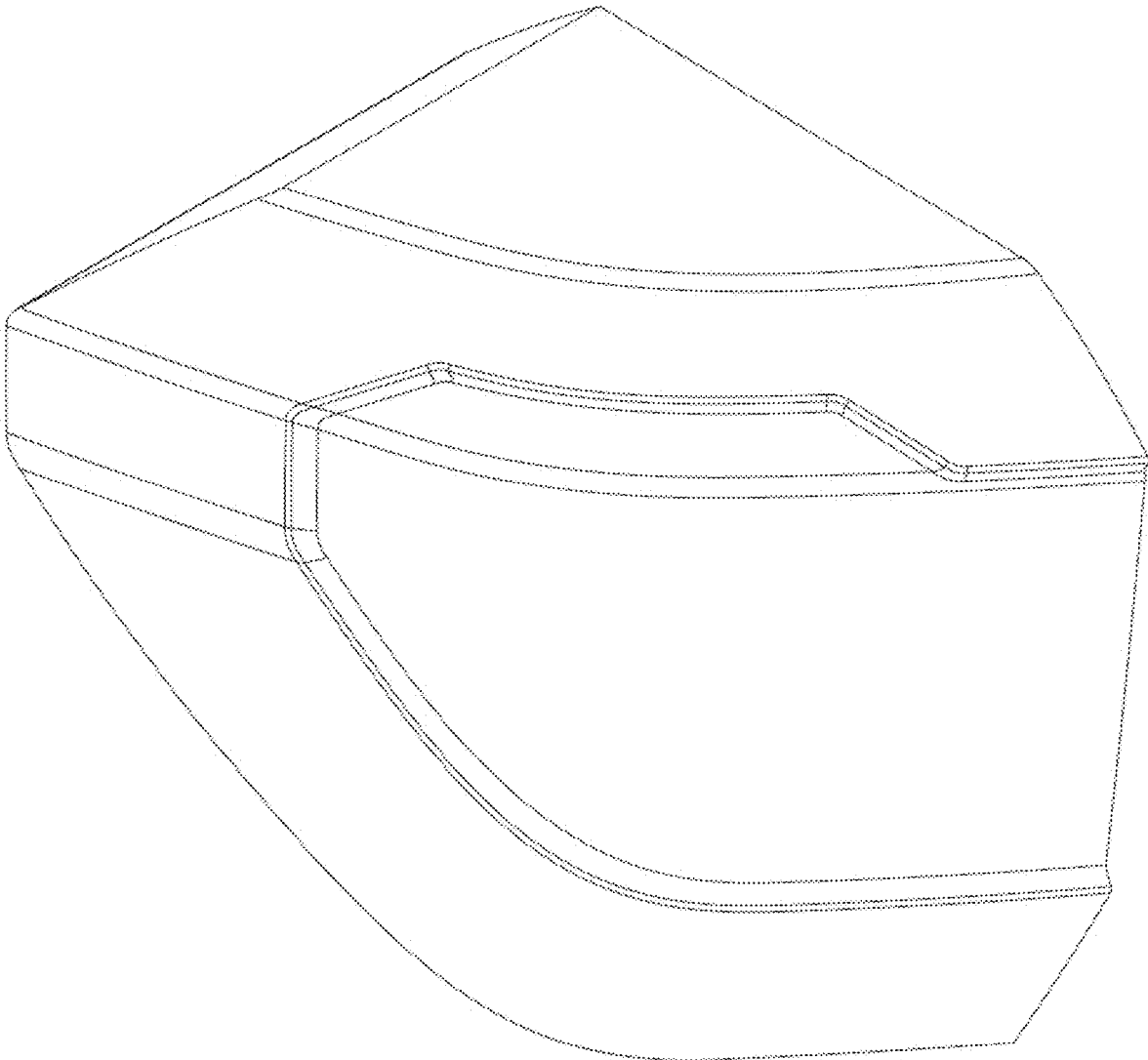

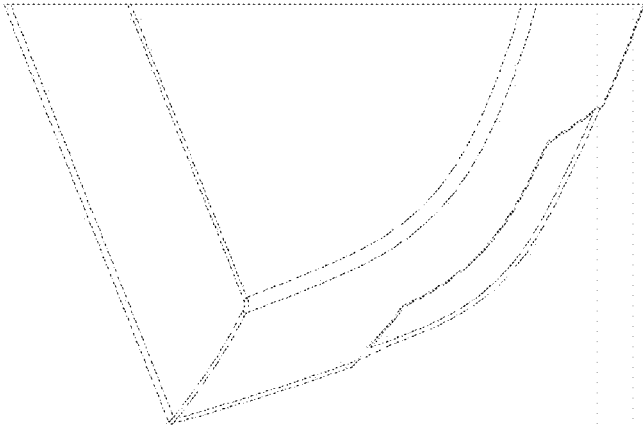

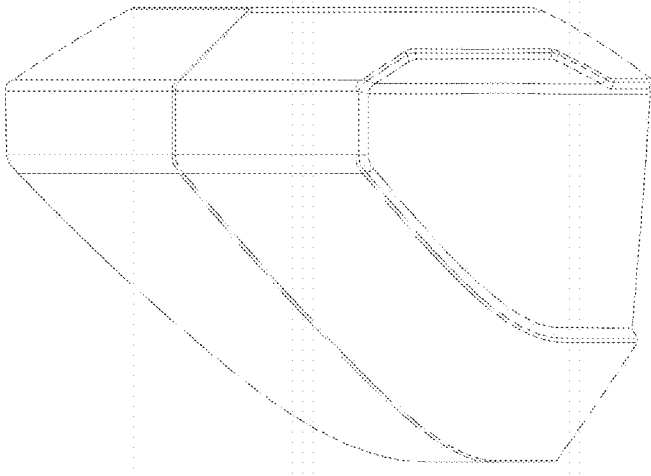

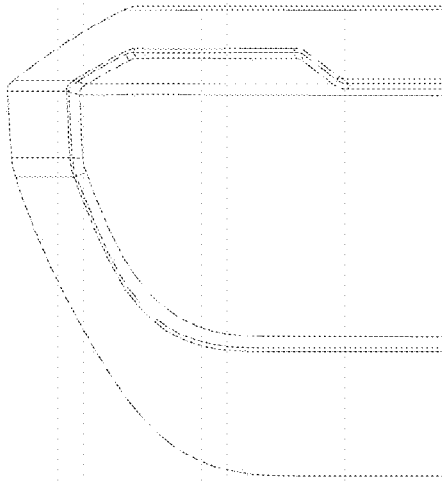

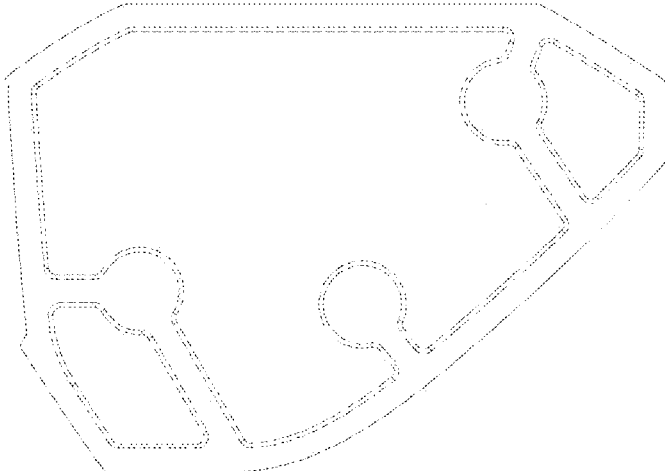

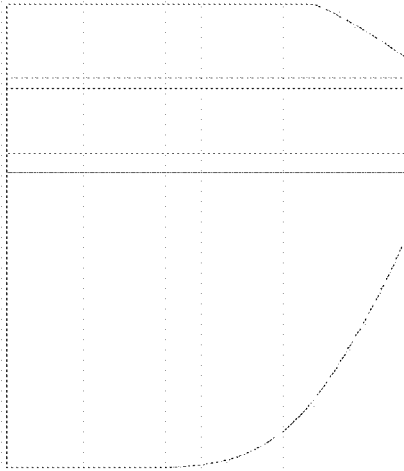

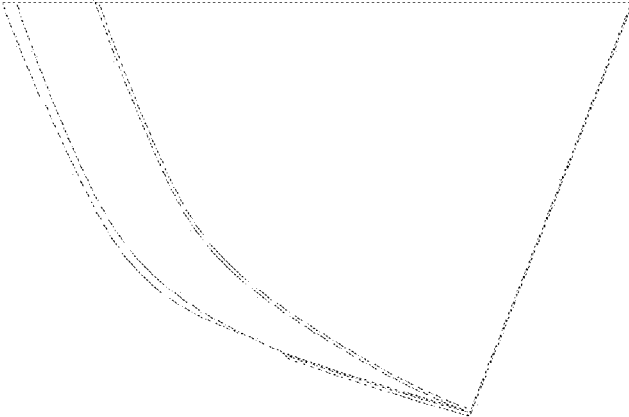

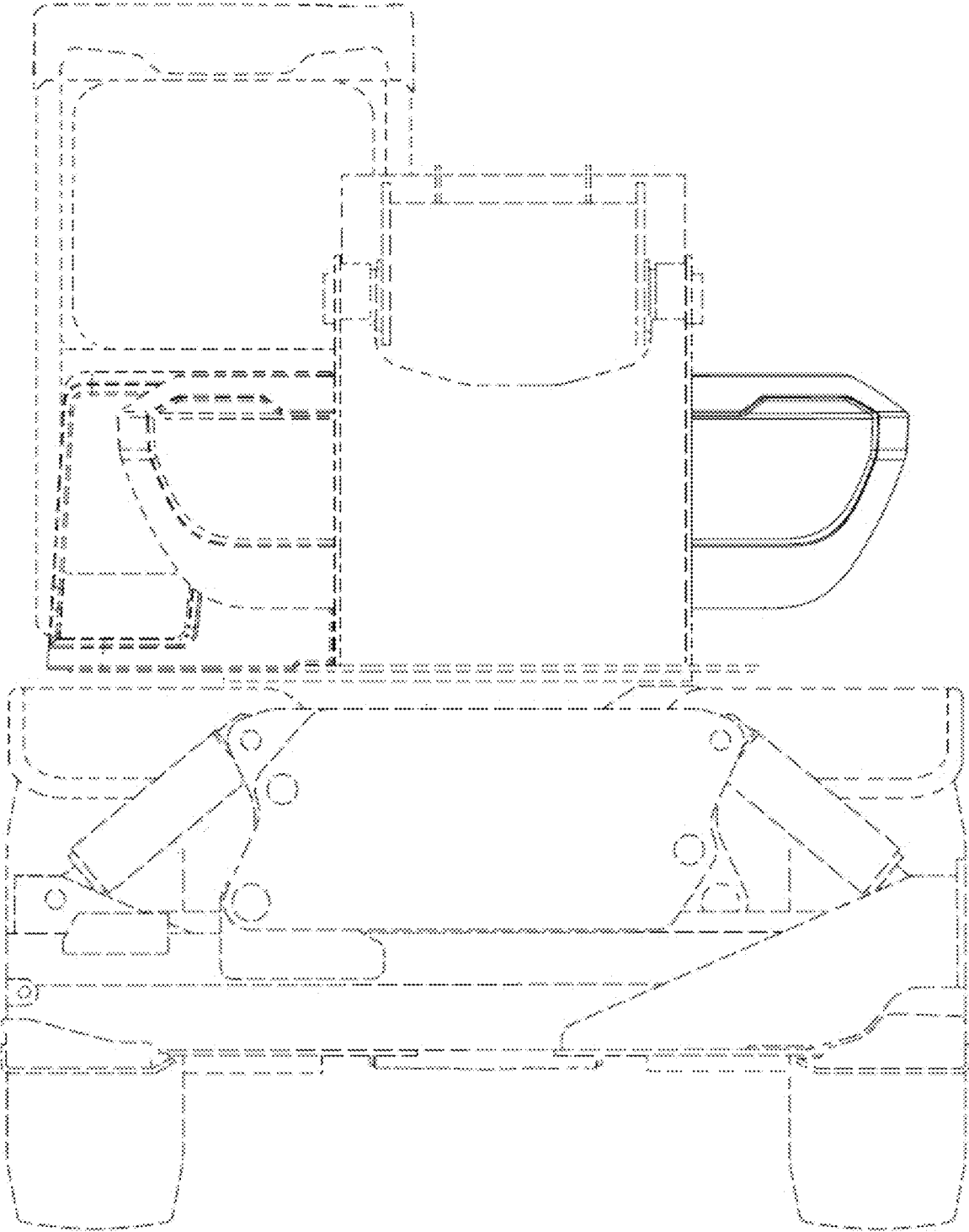

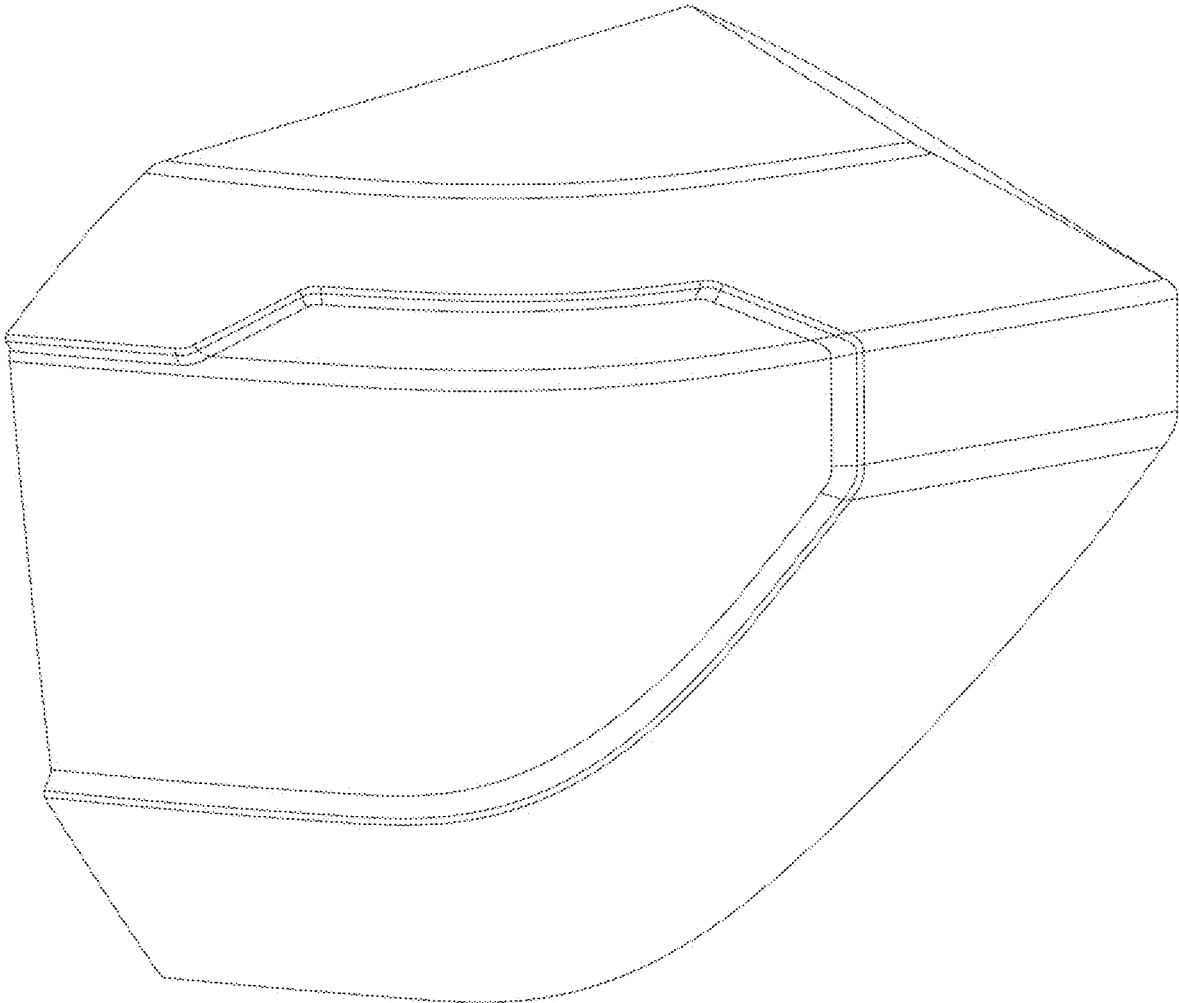

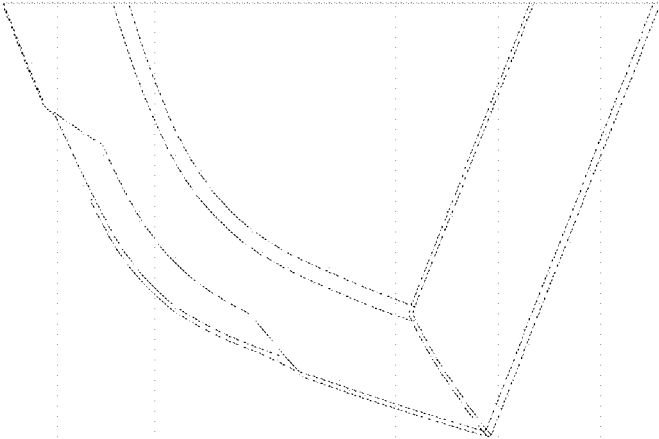

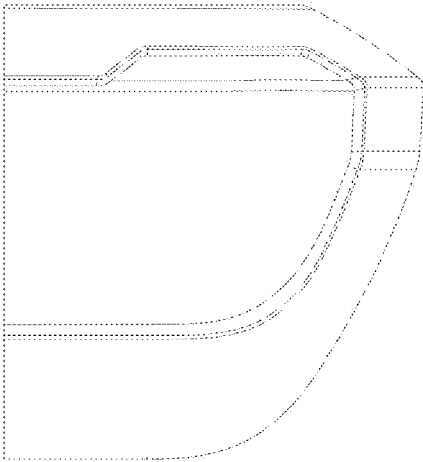

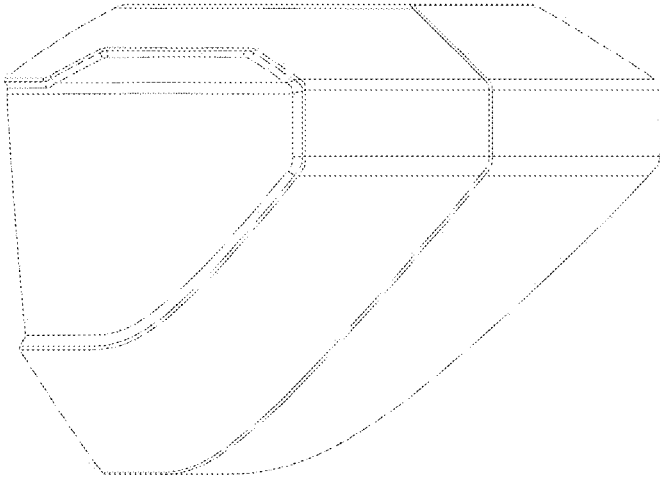

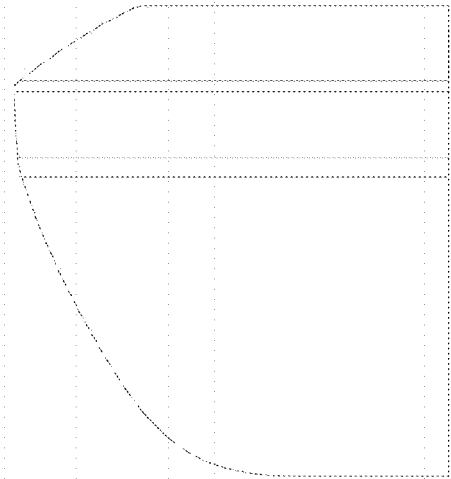

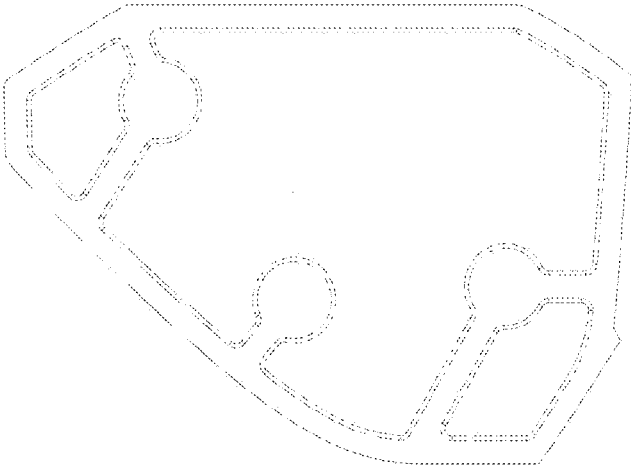

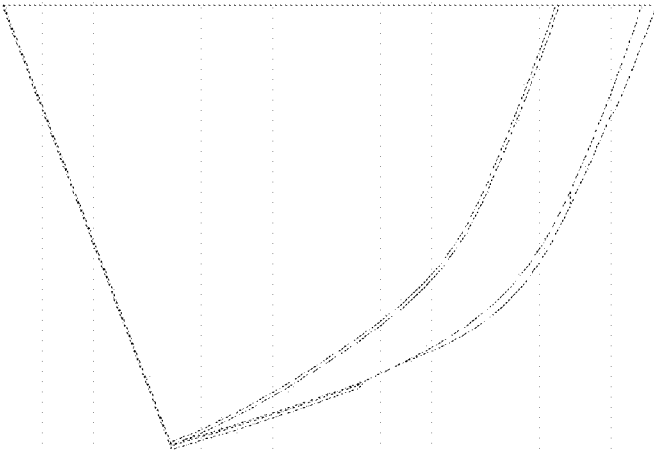
