(57) **CLAIM**

We claim the ornamental design for a bottle, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a top, right, front isometric view of a first embodiment of a bottle.

FIG. 2 is a front elevation view of the bottle of FIG. 1.

FIG. 3 is a rear elevation view of the bottle of FIG. 1.

FIG. 4 is a right side elevation view of the bottle of FIG. 1.

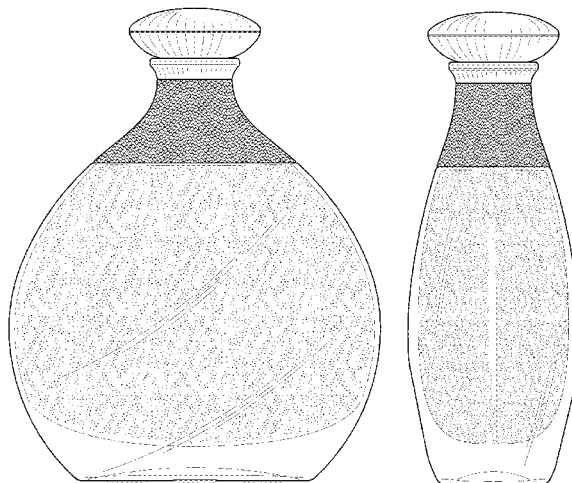
FIG. 5 is a left side elevation view of the bottle of FIG. 1.

FIG. 6 is a top plan view of the bottle of FIG. 1; and,

FIG. 7 is a bottom plan view of the bottle of FIG. 1.

The broken lines in the drawings illustrate the portions of the bottle that form no part of the claim. The stippling within the bottle is not included in the claimed design and is provided to more clearly show the shape of the inside cavity of the bottle.

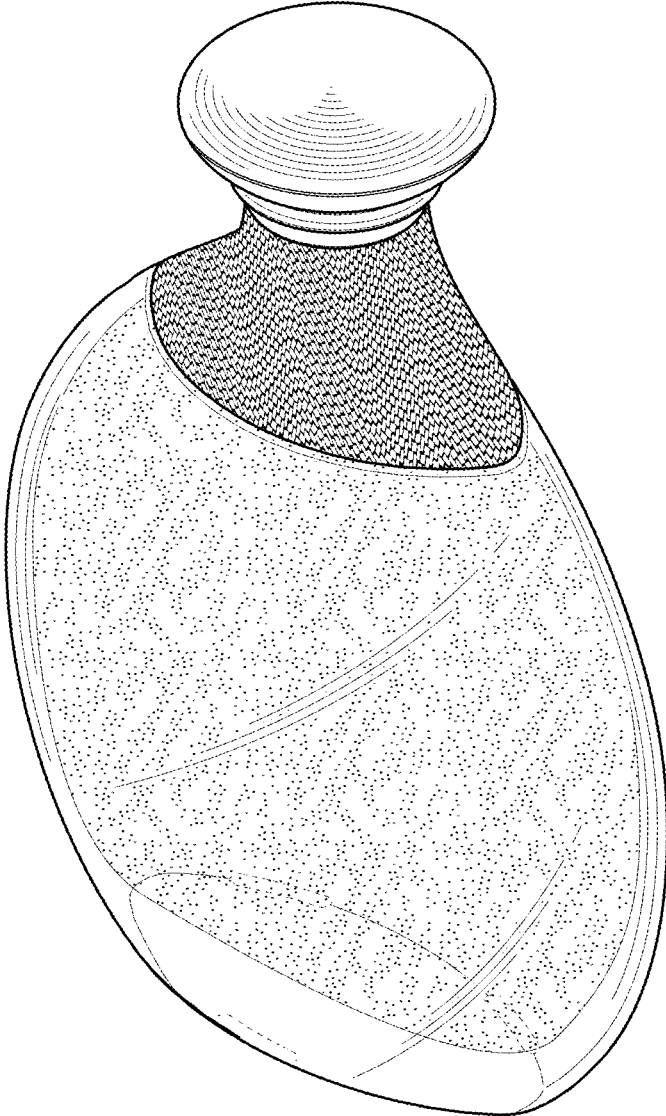

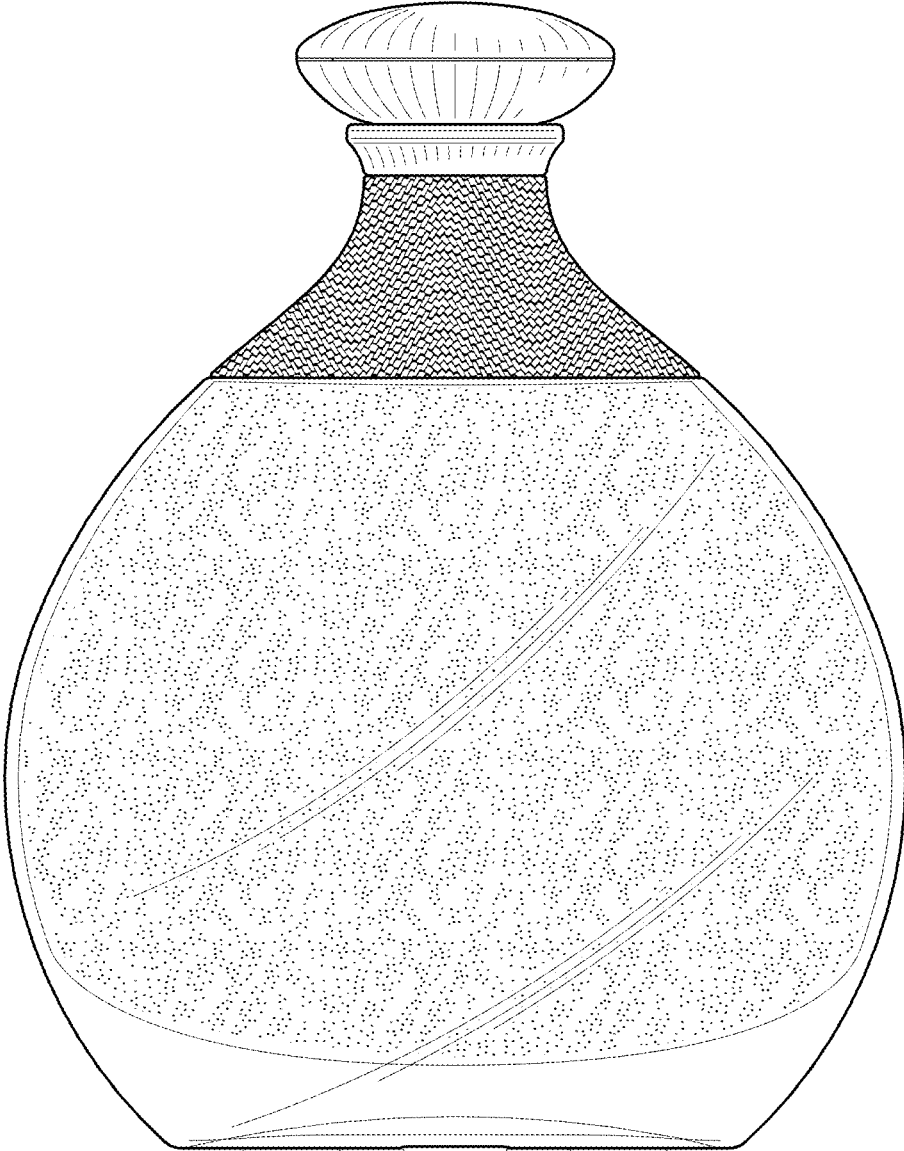

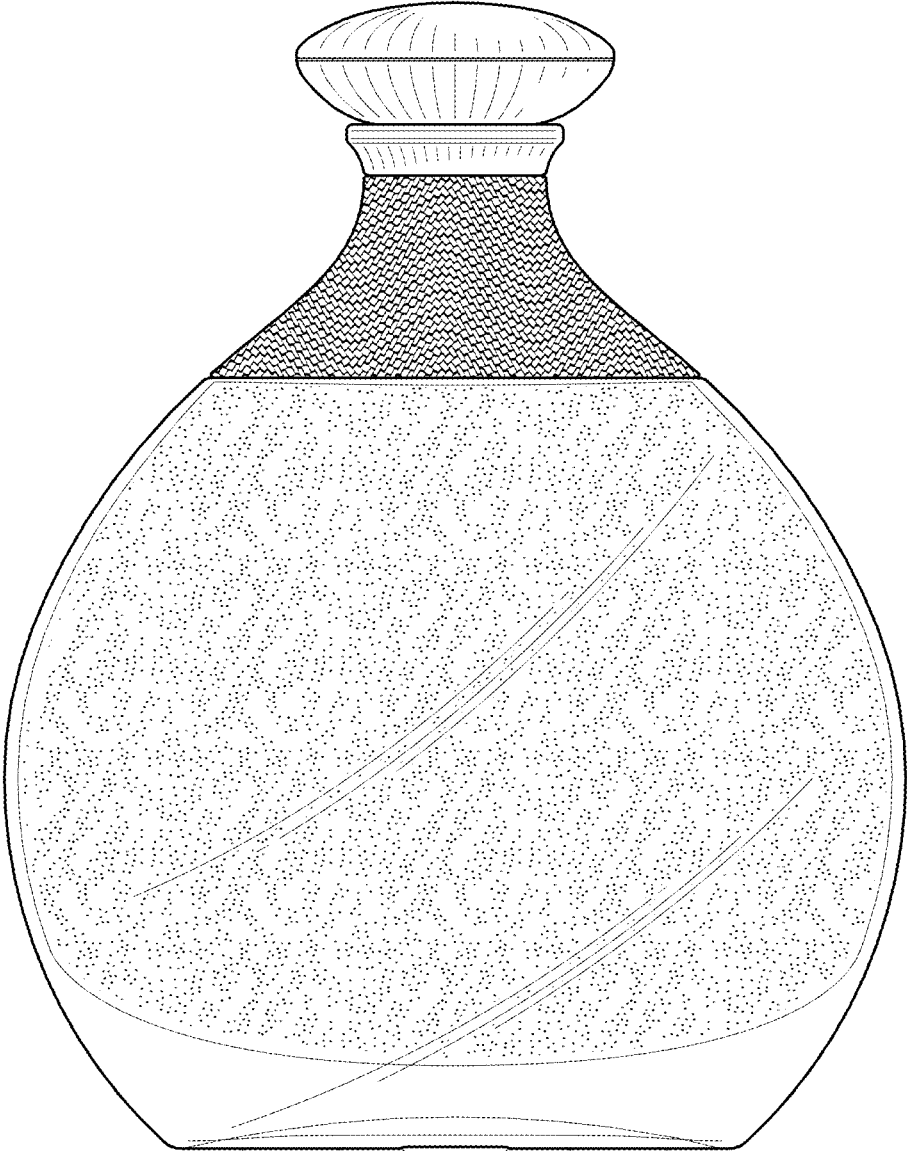

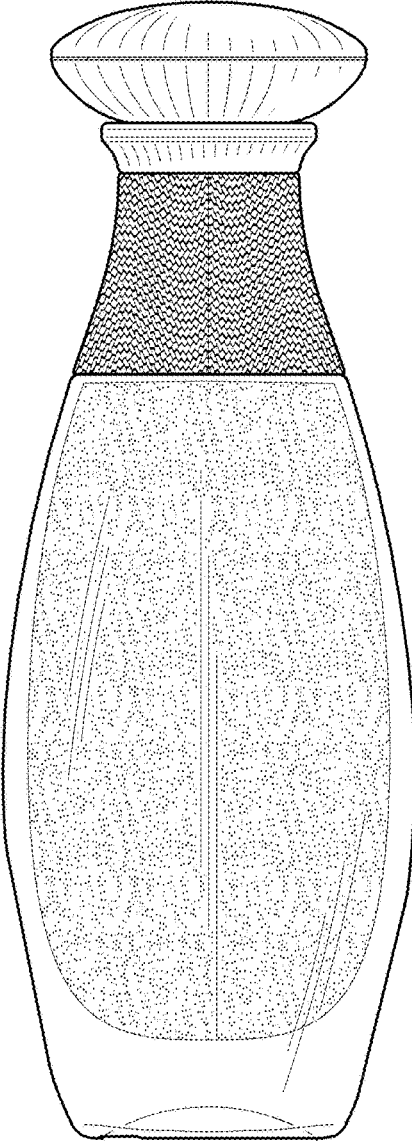

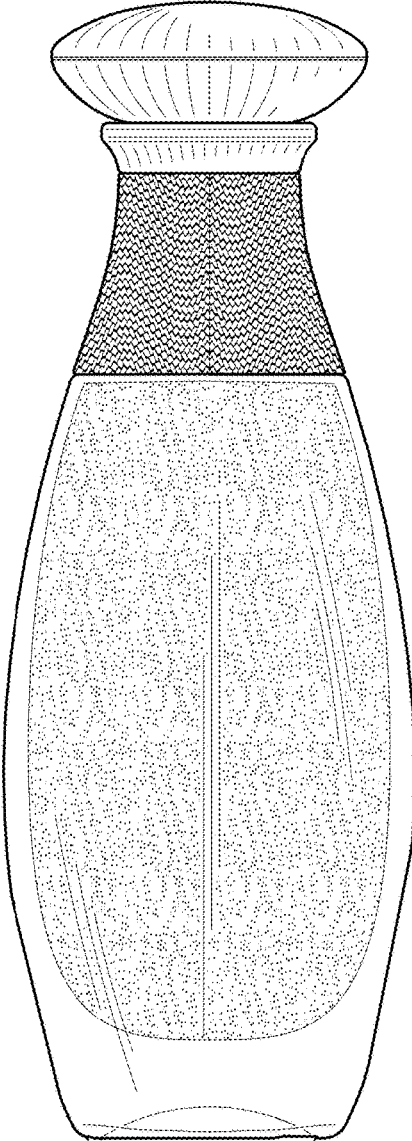

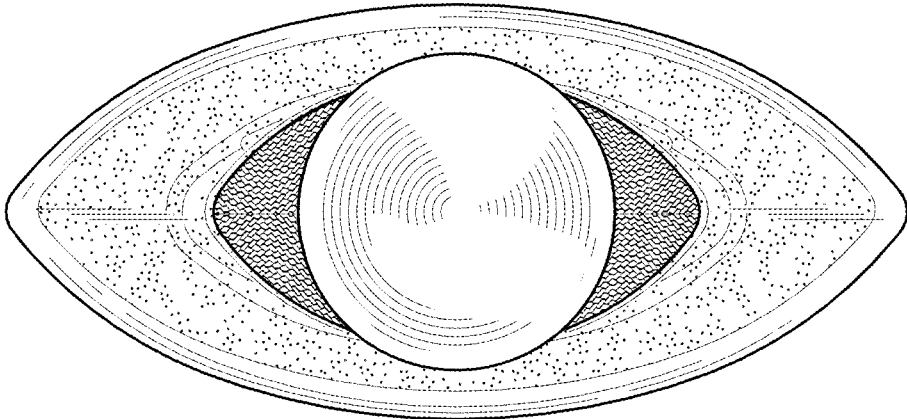

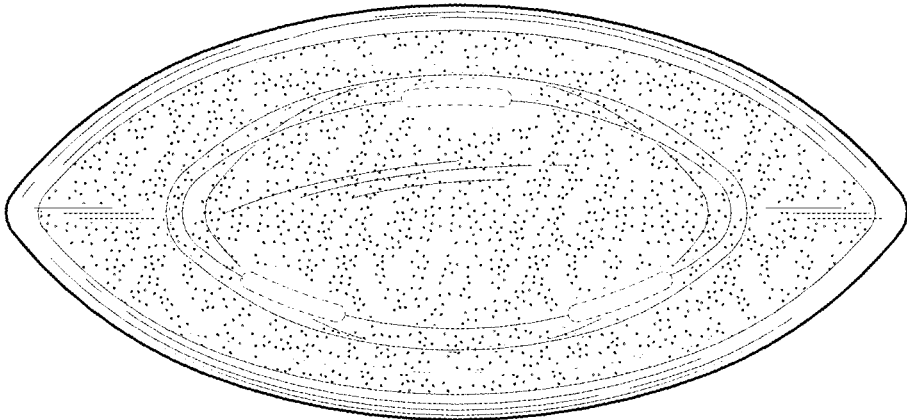
