

(57) Abstract: This invention relates to chemical uncouplers with a broader safety window making the use of them in treating obesity and, consequently, in the treatment of obesity related dis-eases and conditions such as atherosclerosis, hypertension, diabetes, especially type 2 dia-betes (NIDDM (non-insulin dependent diabetes mellitus)), impaired glucose tolerance, dyslip-idemia, coronary heart disease, gallbladder disease, osteoarthritis and various types of can-cer such as endometrial, breast, prostate and colon cancers and the risk for premature death as well as other conditions, such as diseases and disorders, which conditions are improved by an increase in mitochondrial respiration, more attractive.

Claims 1-11 relate to methods of treatment of the human or animal body by surgery or by therapy or diagnostic methods practised on the human or animal body (PCT Rule 39.1(iv)). Nevertheless, a search has been executed for those claims. The search has been based on the alleged effects of the compounds or medicaments.

Claims Nos.: 12-15

Carbonyl-cyanide p-trifluoromethoxy-phenylhydrazone (FCCP) is a lipid-soluble weak acid which is a very powerful mitochondrial uncoupling agent related to CCCP and DNP according to the closest prior art in documents WO 01/51923A2 and WO 00/06143A1. FCCP belongs to the group of uncouplers used in screen methods to detect agents (compounds) that bind to mitochondrial calcium uniporter and may also detect modulators of mitochondrial respiration.

Present claims 12-15 relate to a method of screening for compounds, wherein a mitochondrial uncoupling agent is used as a reference. The method is only defined by reference to the following equation:

P1: Xn = (Y2-Y0)/(Y1-Y0)

The use of these parameters in the present context is considered to lead to a lack of clarity within the meaning of Article 6 PCT. It is impossible to compare the parameters the applicant has chosen to employ with what is set out in the prior art. Methods of screening in similar manners are described in WO 01/51923A2, WO 00/06143A1, Drummond et al (Journal of Physiology(1999),516.1 pp139-147) and Altenburger et al (Environmental

Toxicology and Chemistry, Vol19 No9 pp2341-2347 (2000)).

The lack of clarity is such as to render a meaningful complete search impossible. Consequently, the search has been restricted to:

The parts relating to the compounds mentioned in the description on pages 110-112 (Table 1).

Claim 16

Present claim 16 relates to an extremely large number of possible variations. Support within the meaning of Article 6 PCT and/or disclosure within the meaning of Article 5 PCT is to be found, however, for only a very small proportion of the variations claimed. In the present case, the claims so lack support, and the application so lacks disclosure, that a meaningful search over the whole of the claimed scope is impossible.
