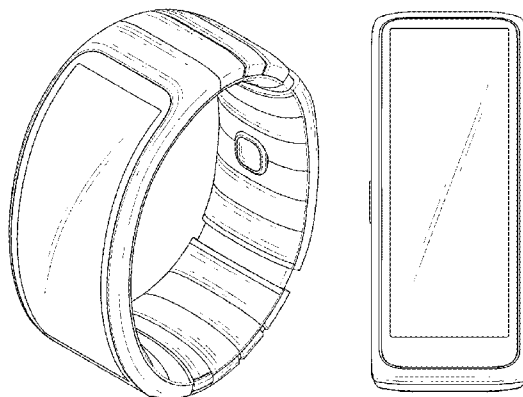
(57) **CLAIM**

The ornamental design for a wrist-worn smartphone, as shown and described.

DESCRIPTION

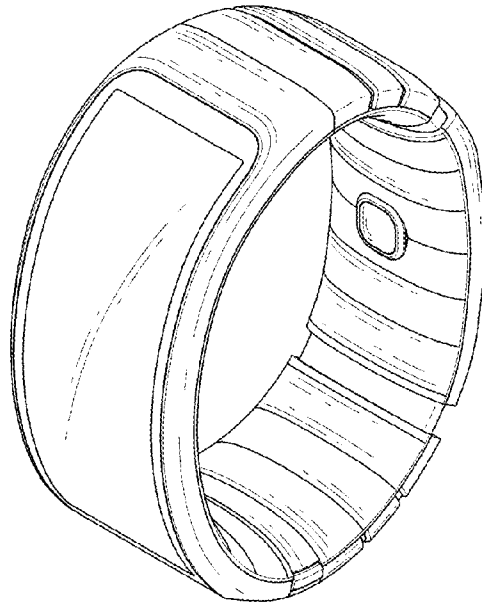

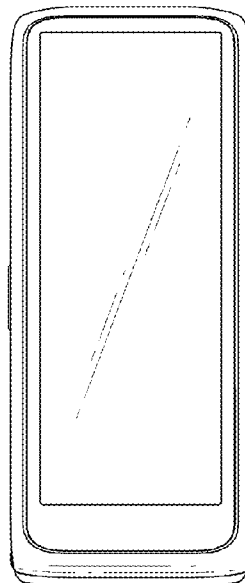

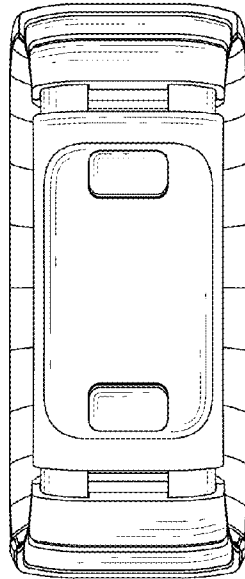

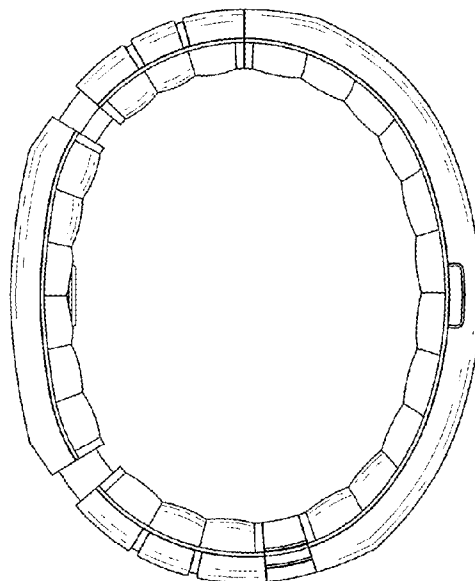

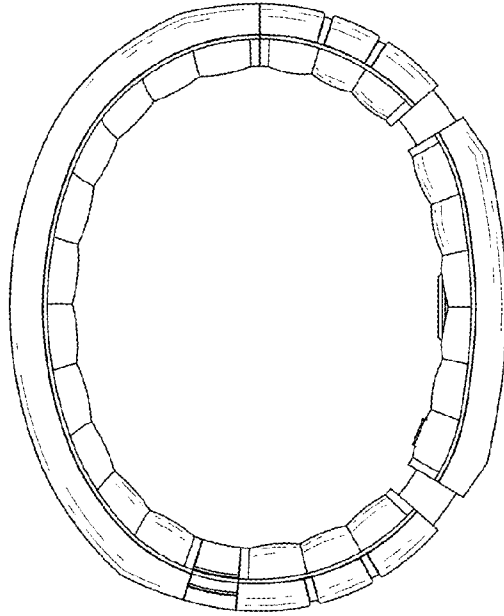

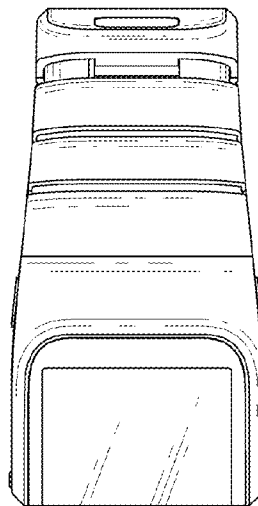
