(57) **CLAIM**

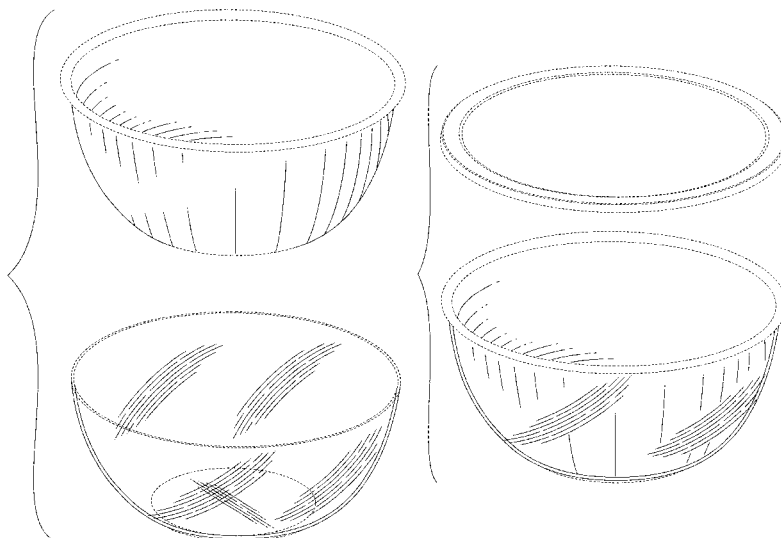
The ornamental design for a shiny bowl with transparent outer coating, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded perspective view of a shiny bowl with transparent outer coating showing our design;  
FIG. 2 is side view thereof;  
FIG. 3 is a bottom view of the shiny bowl with transparent outer coating removed;  
FIG. 4 is a bottom view of a transparent outer coating with the shiny bowl removed;  
FIG. 5 is a perspective view of the shiny bowl with transparent outer coating with an unclaimed lid;  
FIG. 6 is a side view of the shiny bowl with transparent outer coating;  
FIG. 7 is a top view thereof;  
FIG. 8 is a bottom view thereof; and,  
FIG. 9 is a cross-sectional view thereof taken from line 9-9 on FIG. 8.

The broken lines in the drawings illustrate portions of the bowl and a lid and form no part of the claimed design.

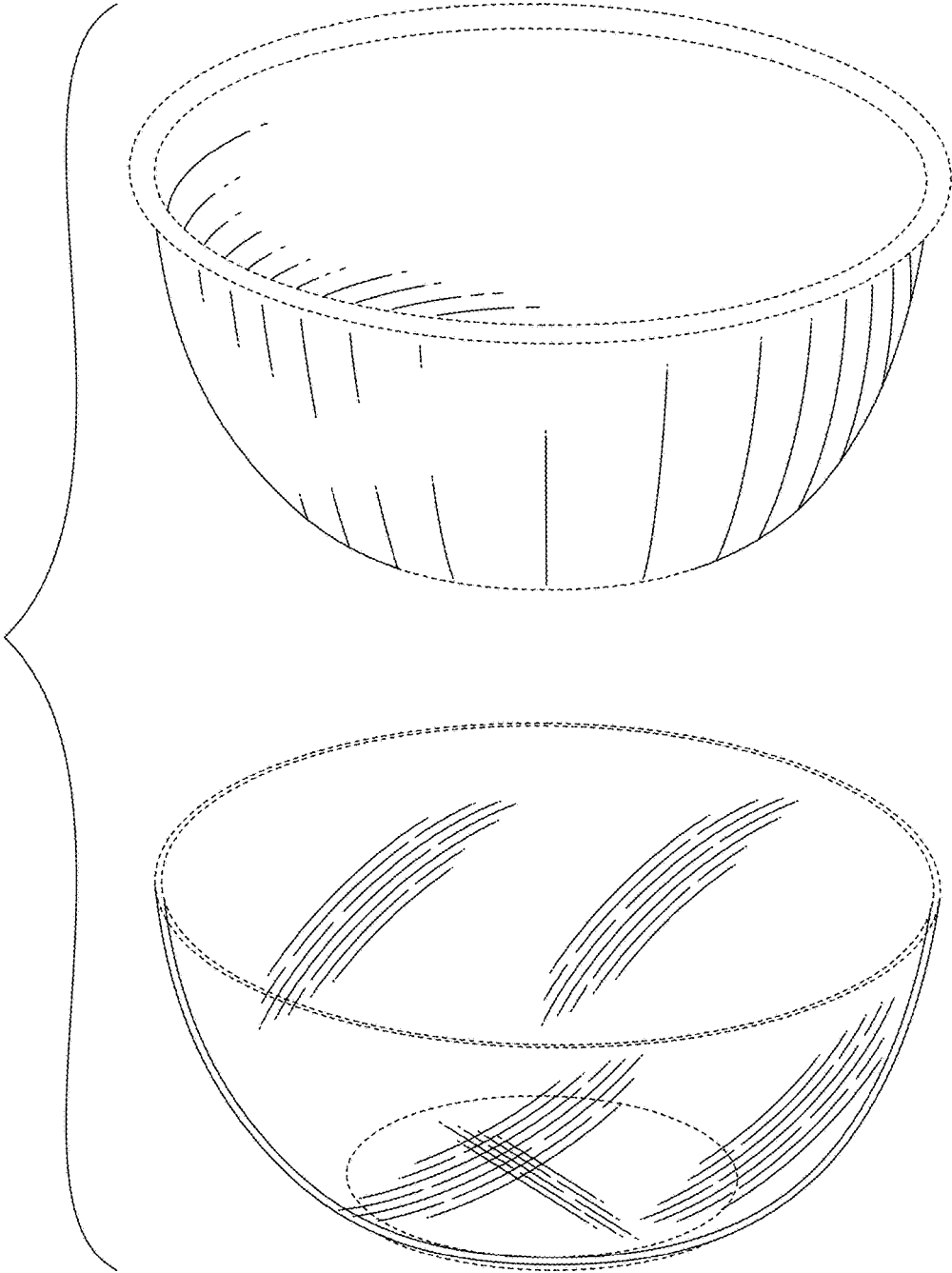

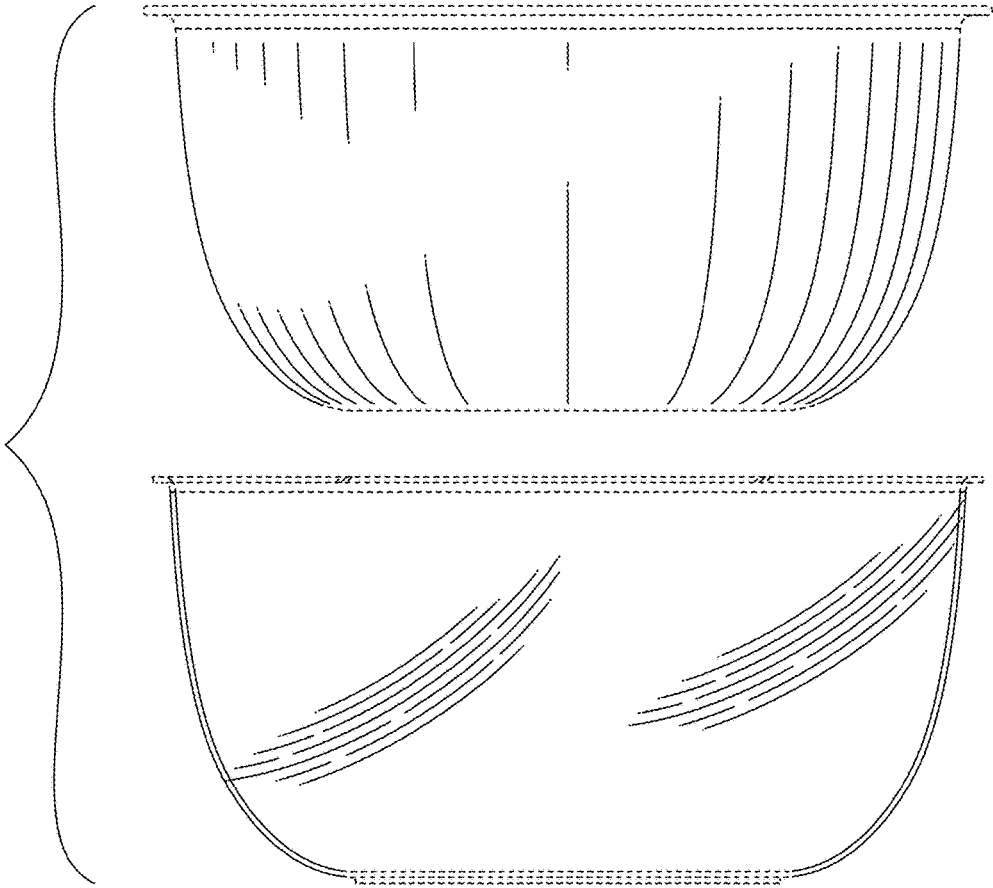

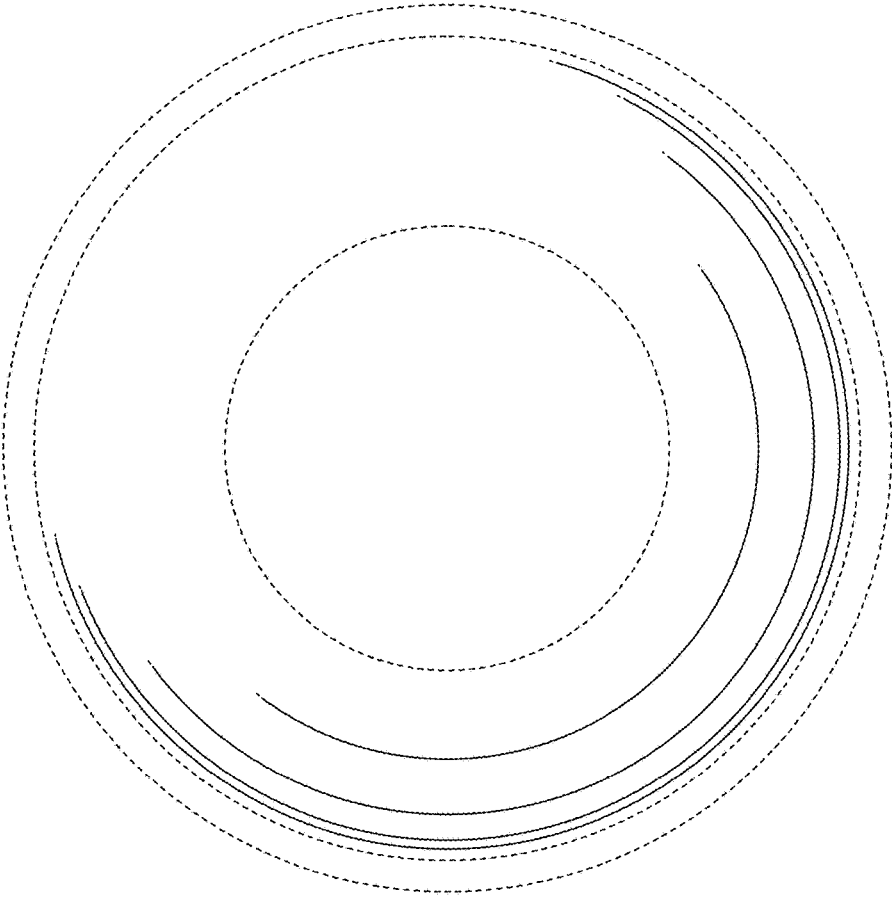

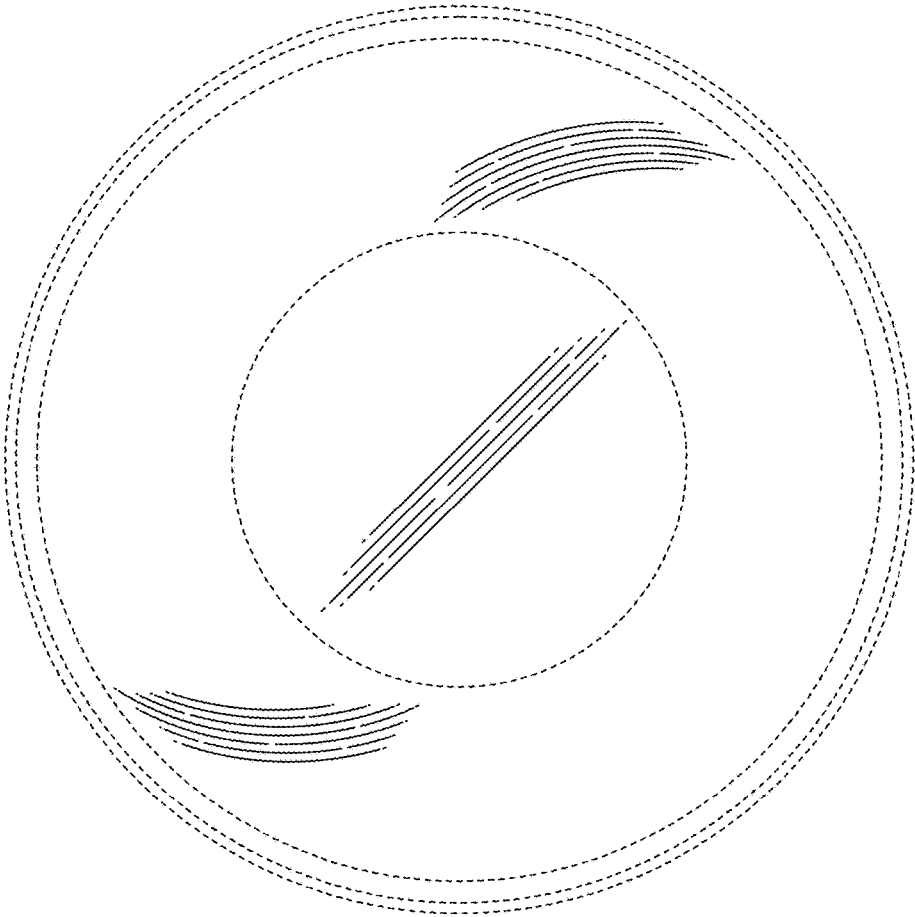

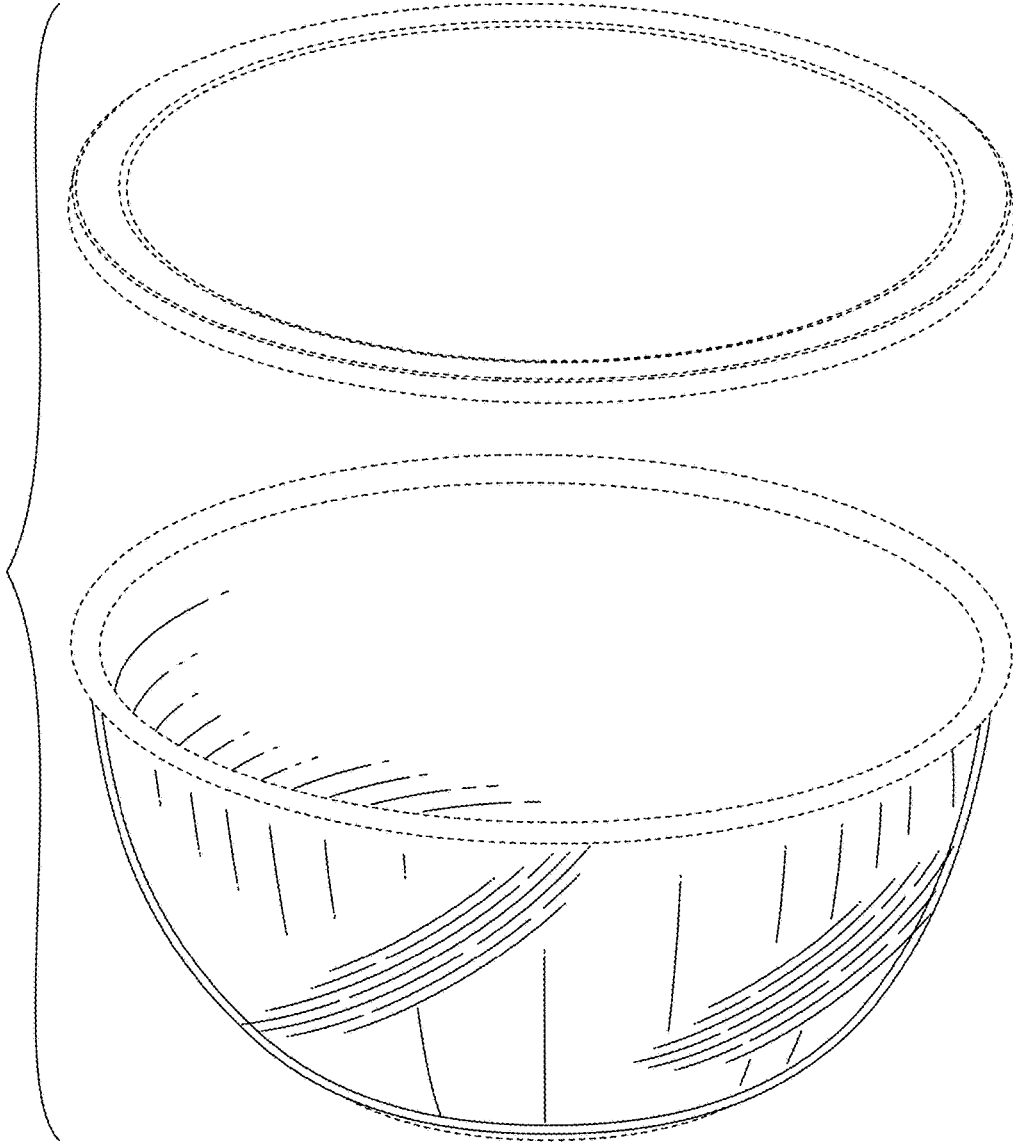

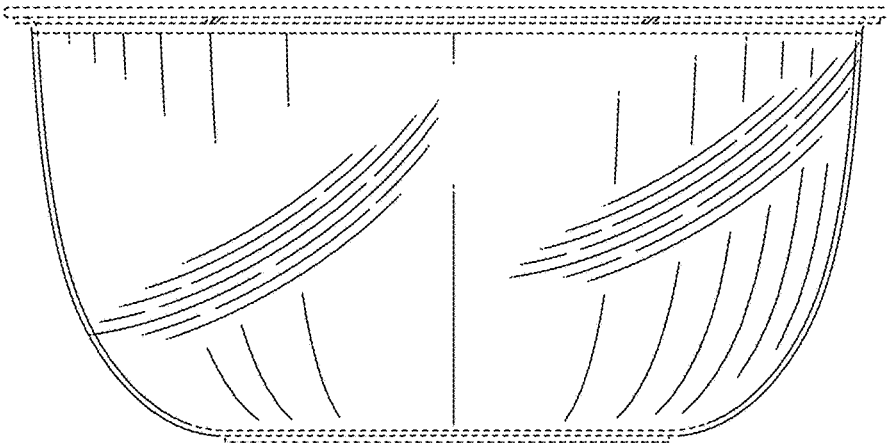

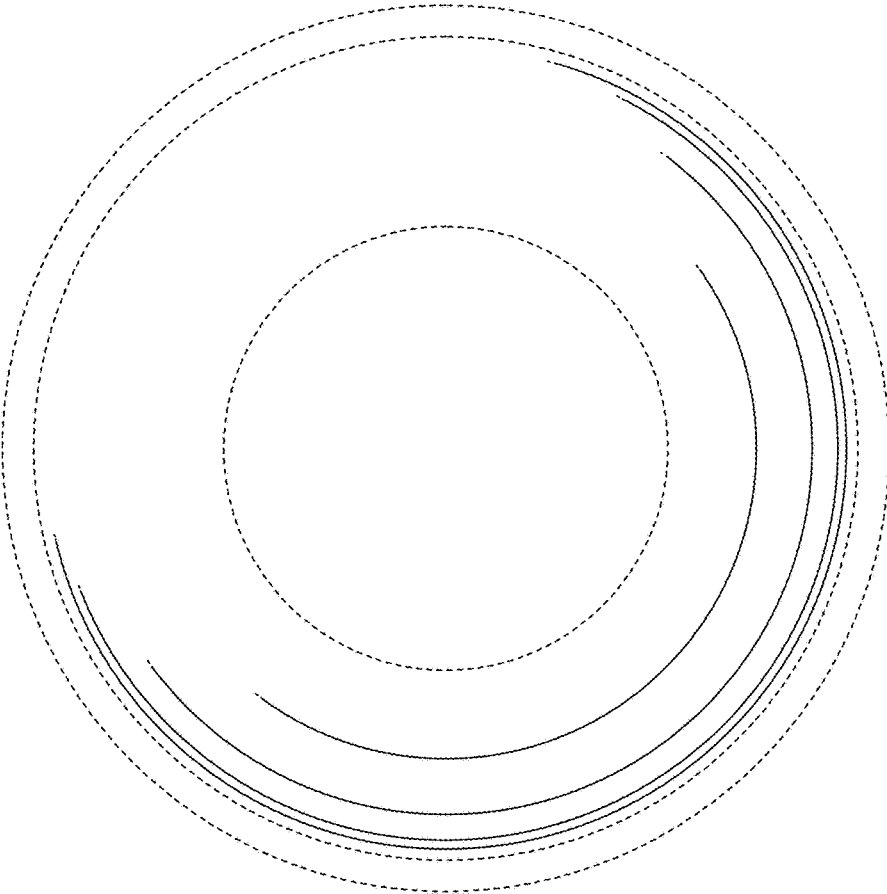

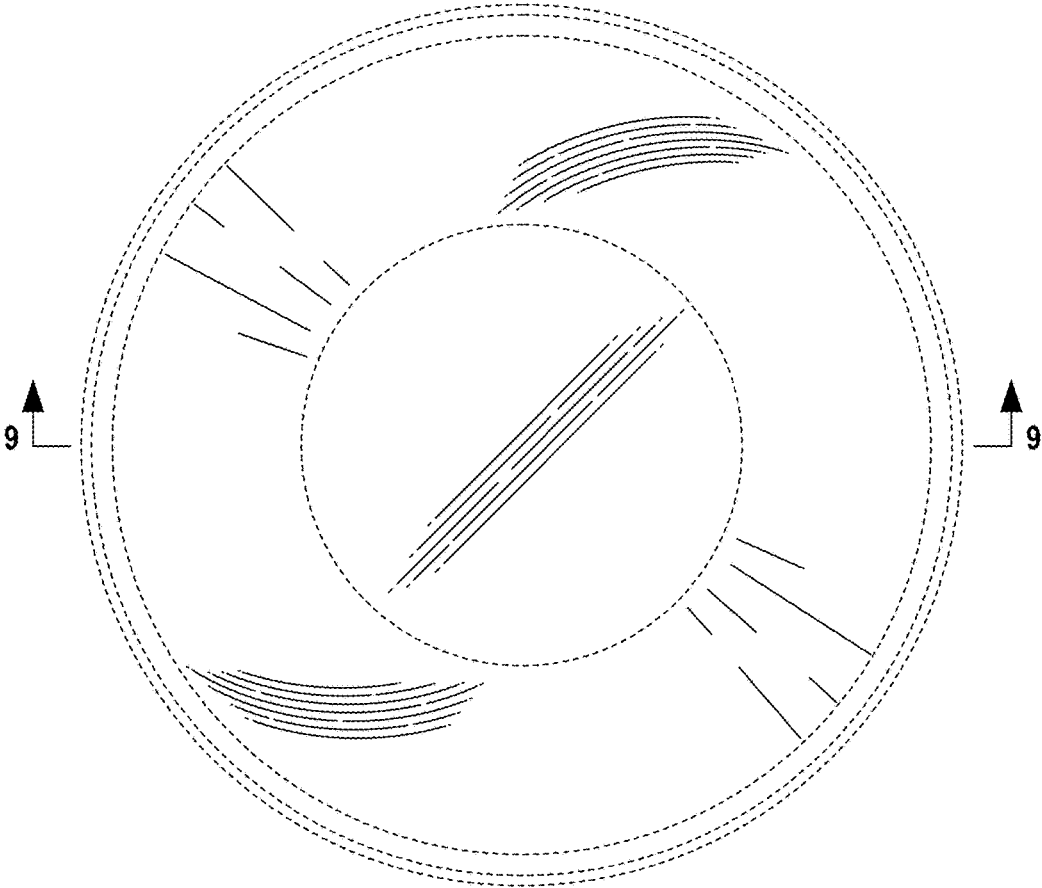

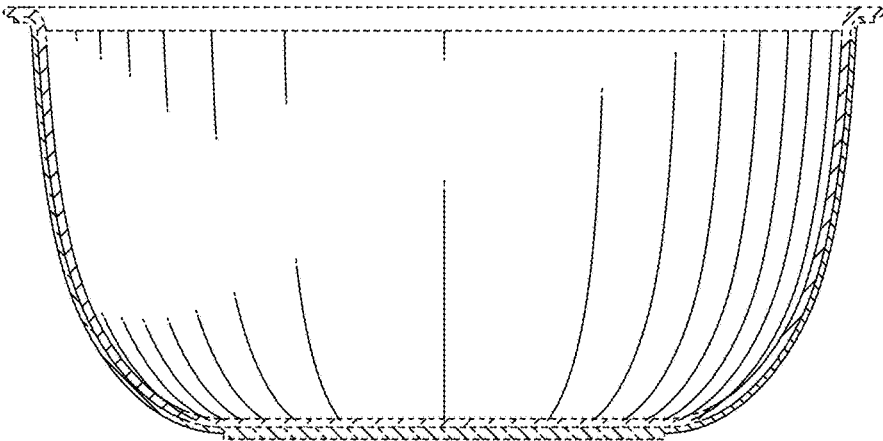
