**DESCRIPTION**

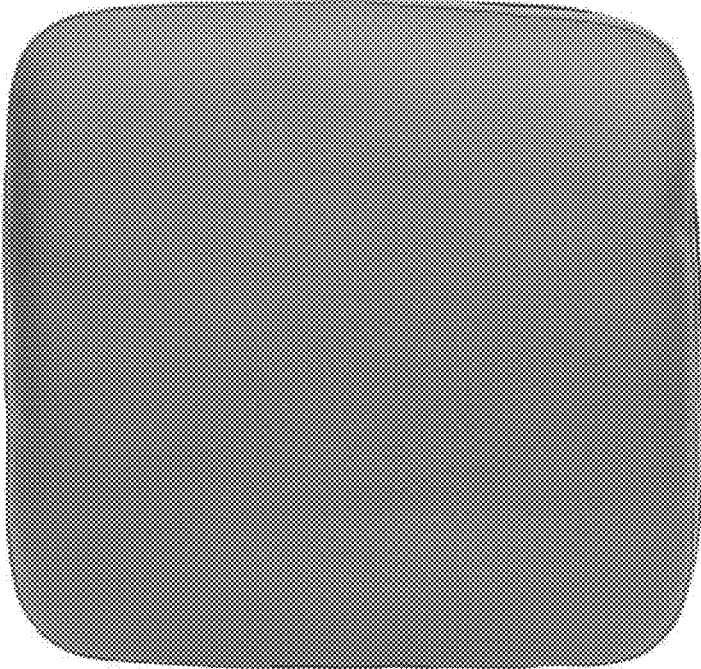
