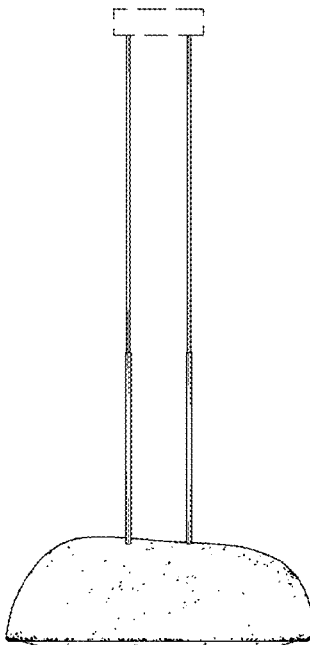
(57) **CLAIM**

The ornamental design for a chandelier, as shown and described.

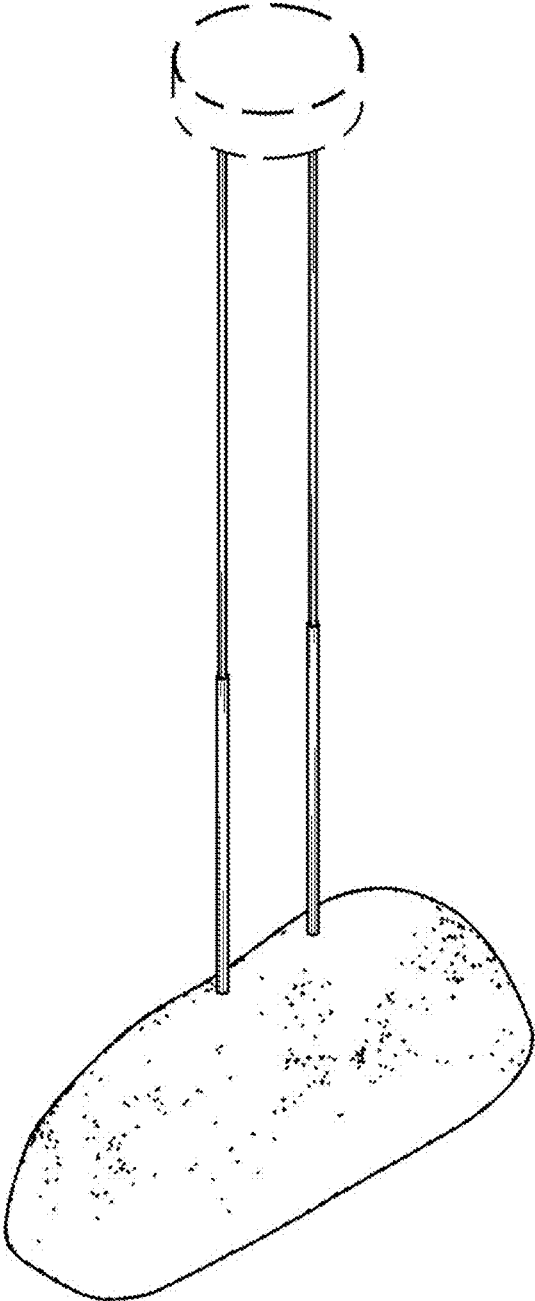
DESCRIPTION

The broken lines shown in the drawings illustrate environmental structure and form no part of the claimed design.

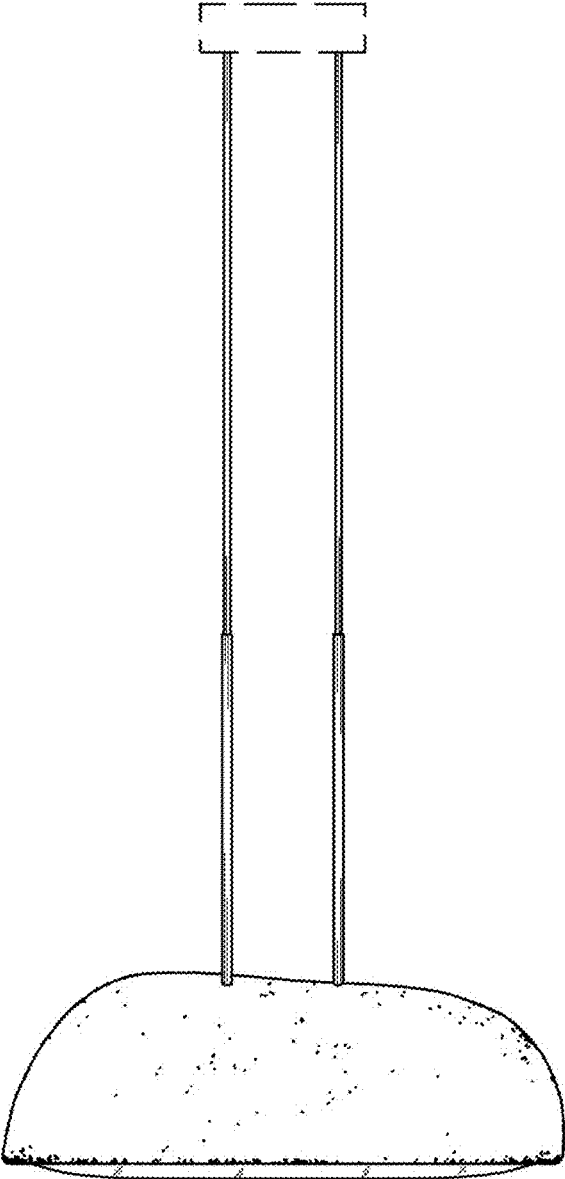

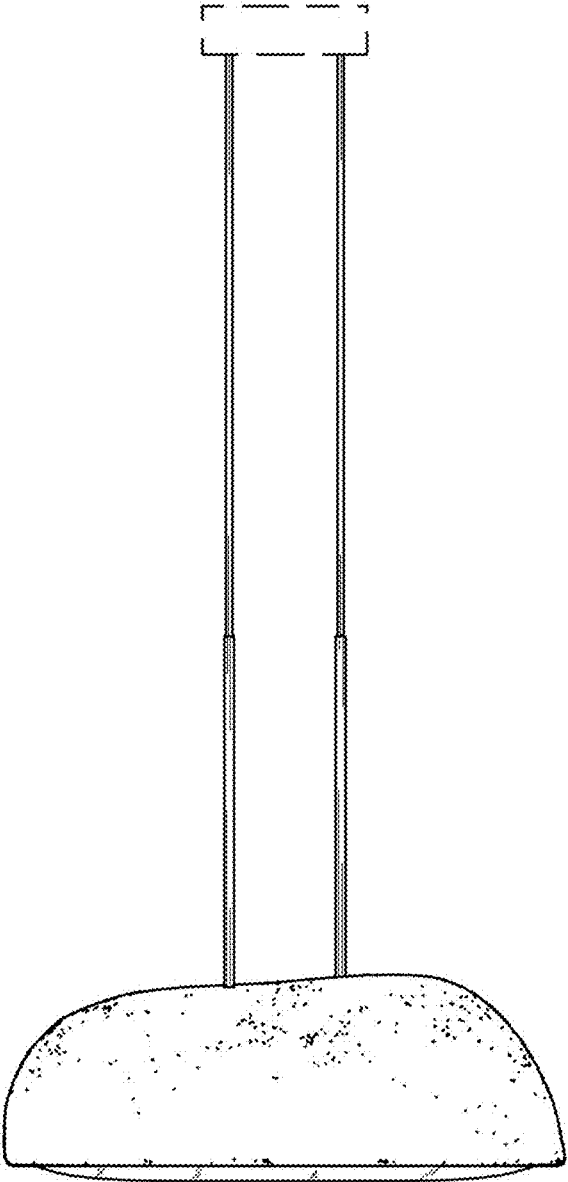

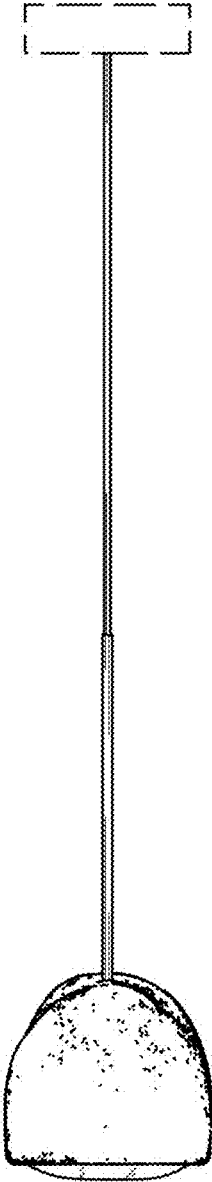

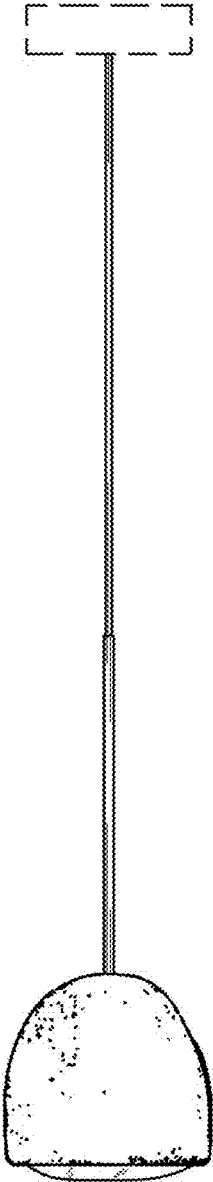

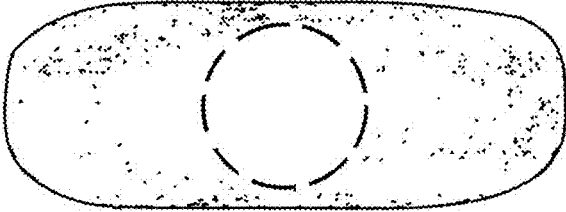
