**DESCRIPTION**

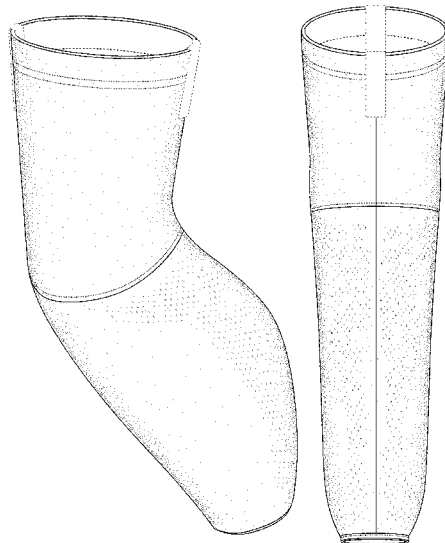
FIG. 1 is a perspective view of a leg sleeve, showing my new design;

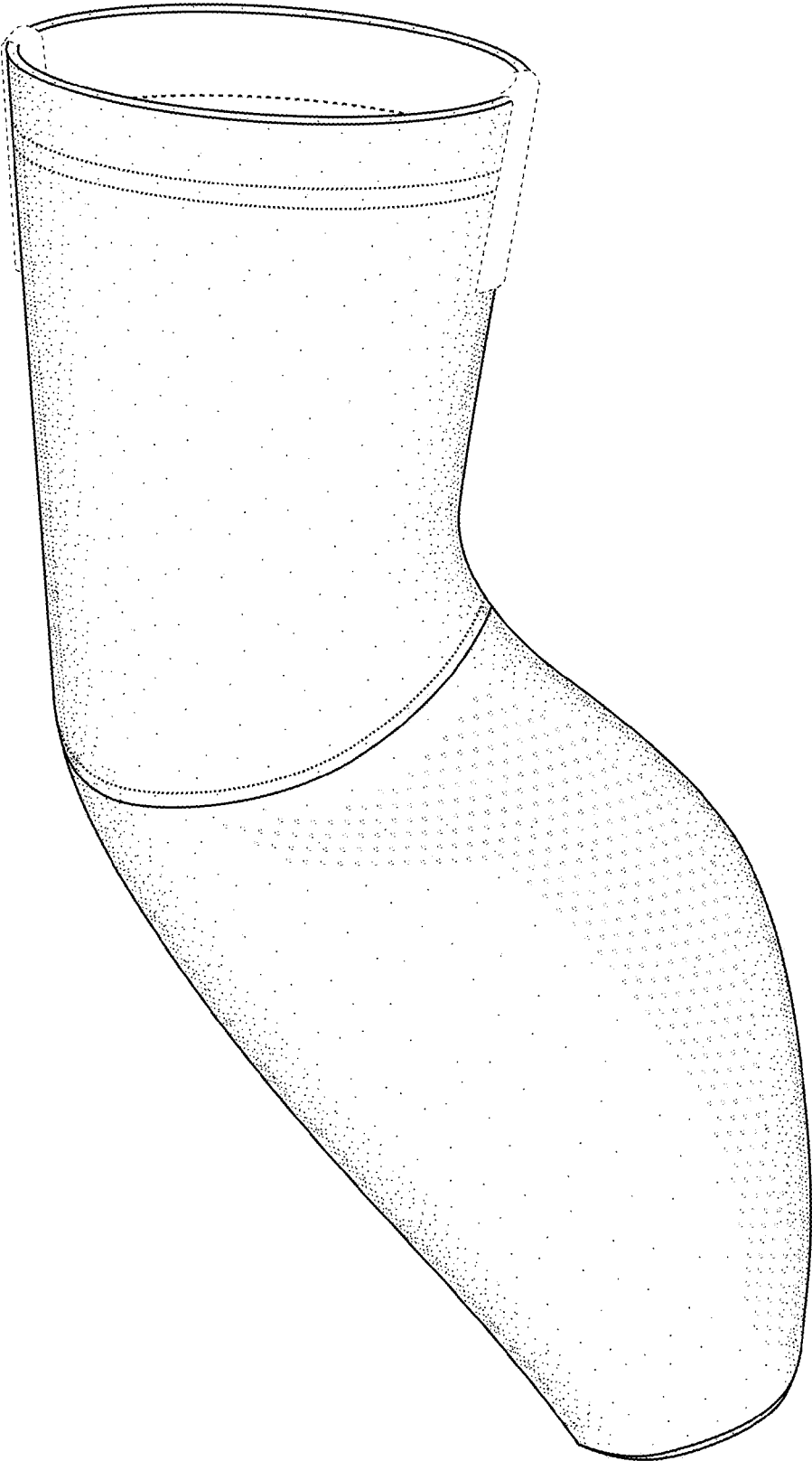

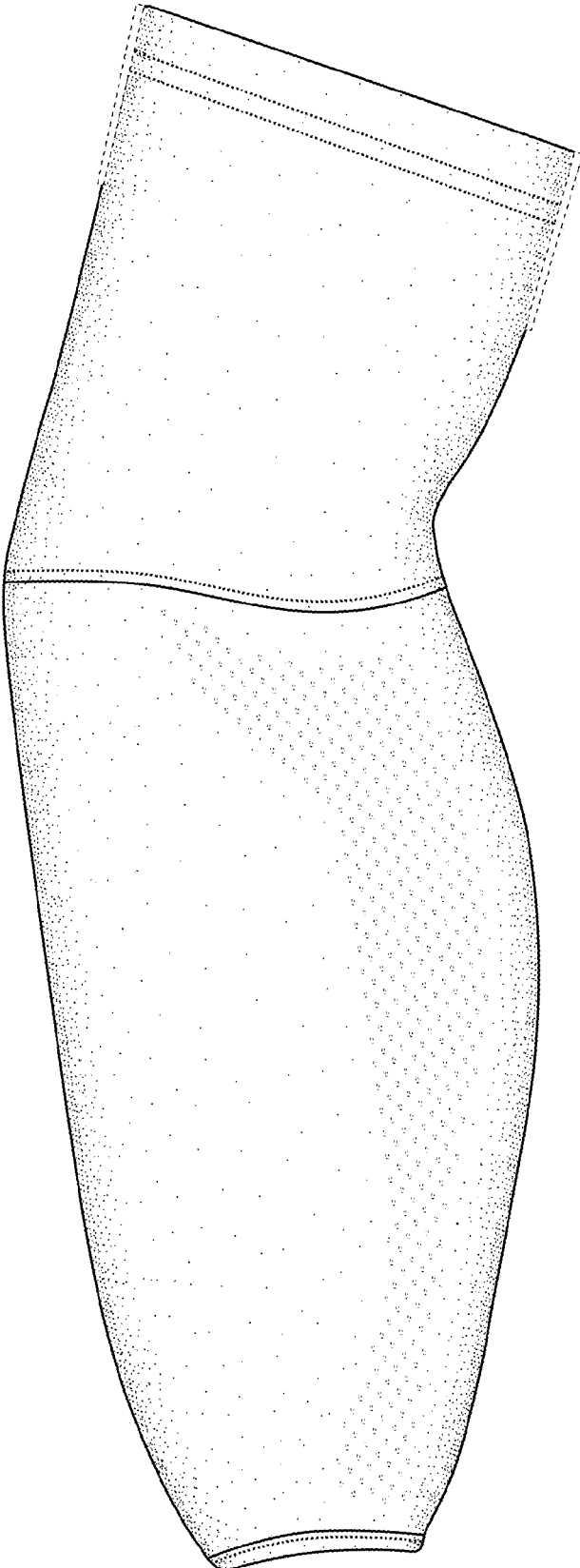
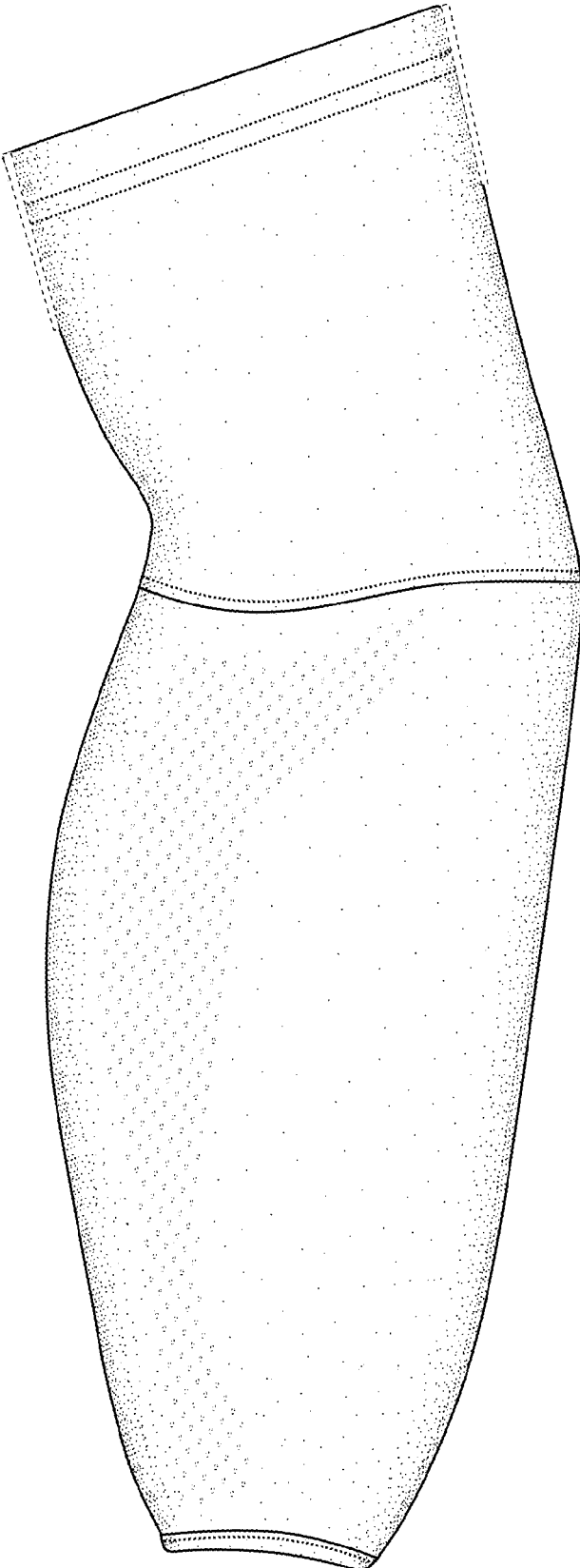
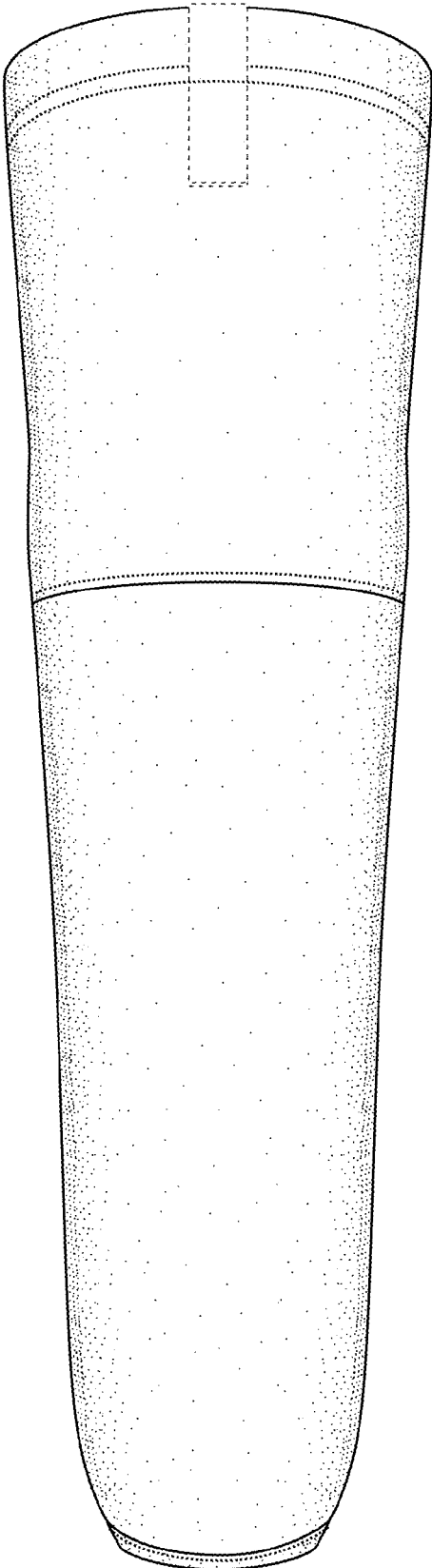


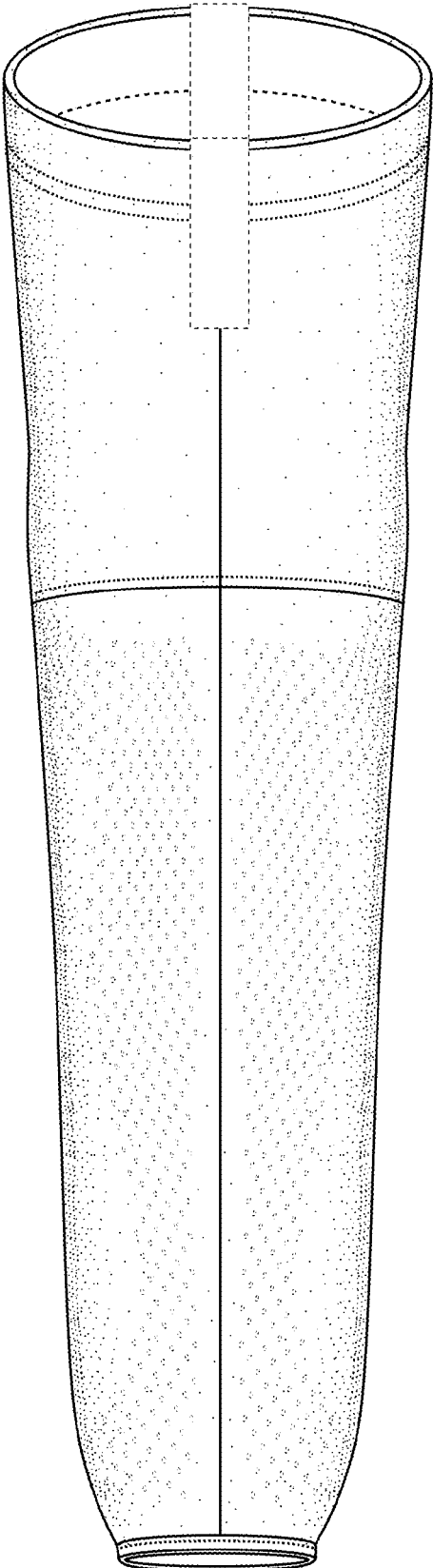

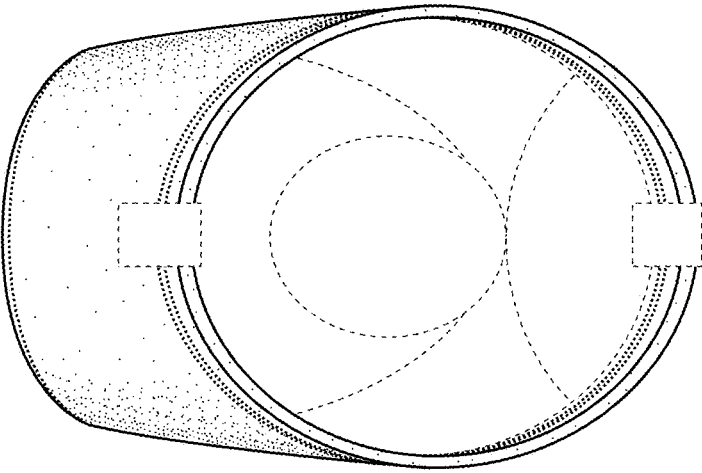
