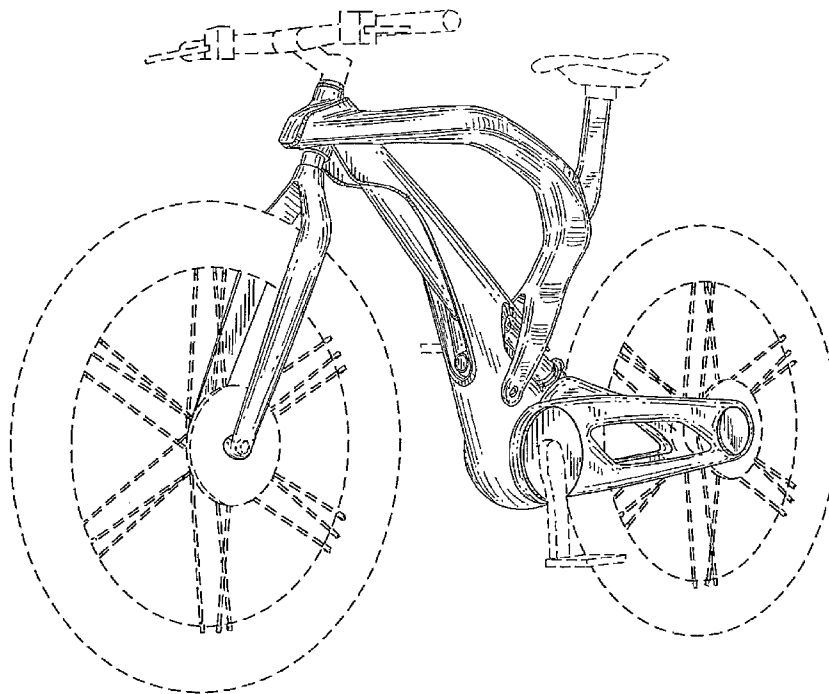
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right, front and side perspective view showing our new electric bicycle design;

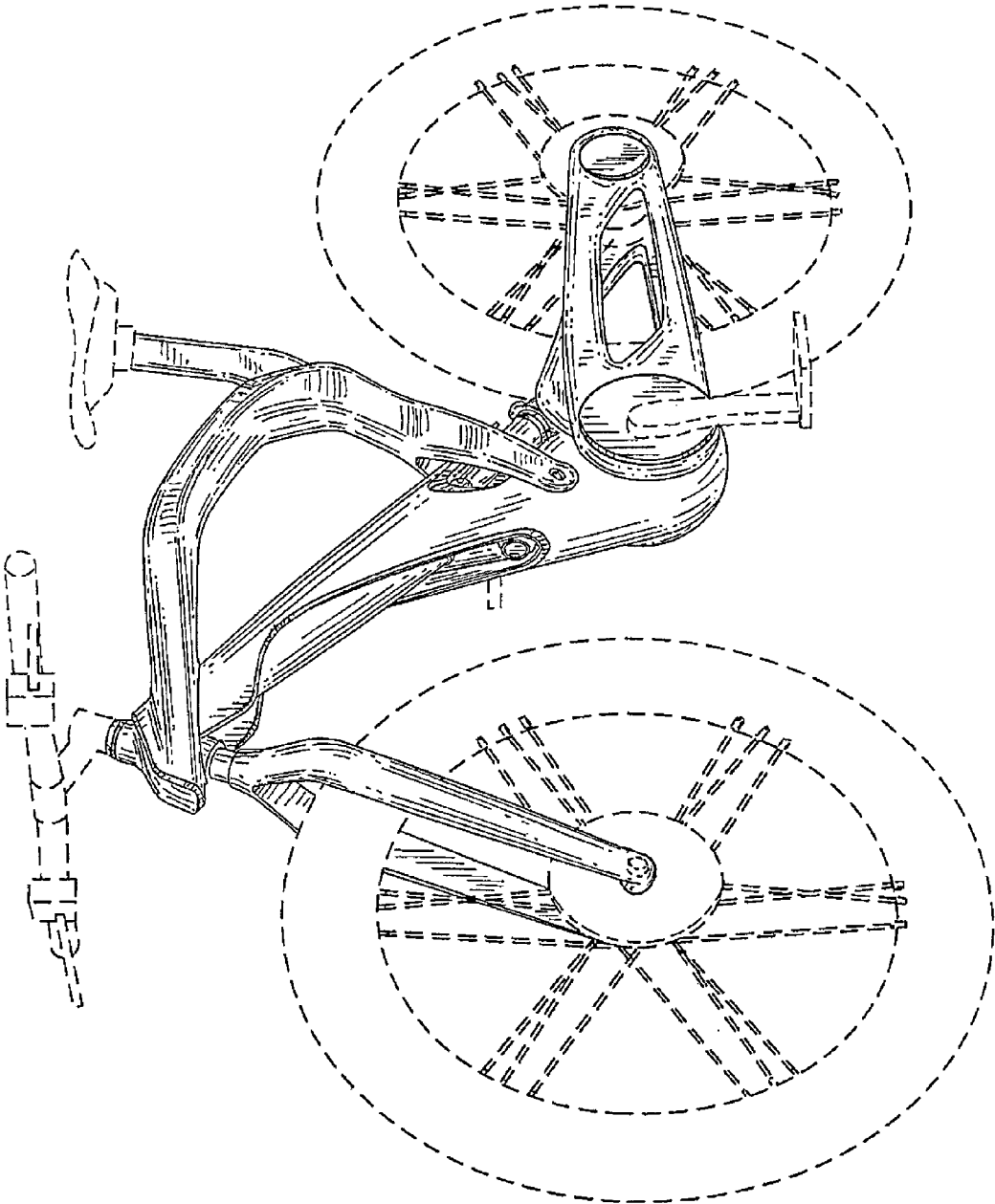

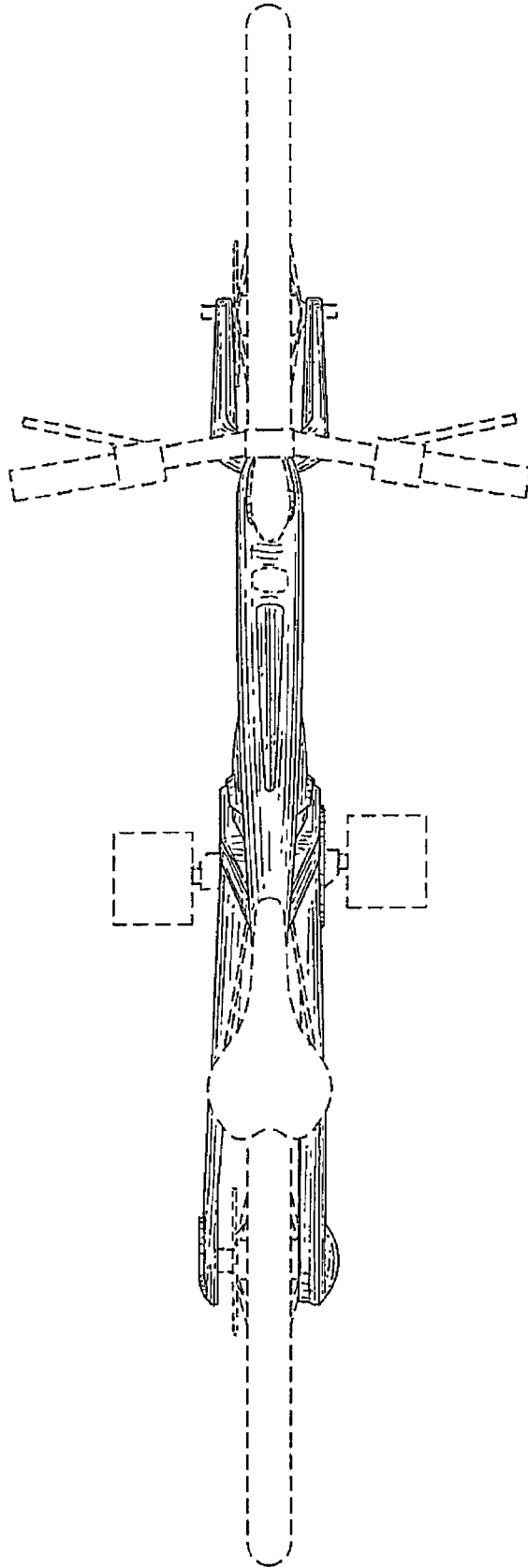
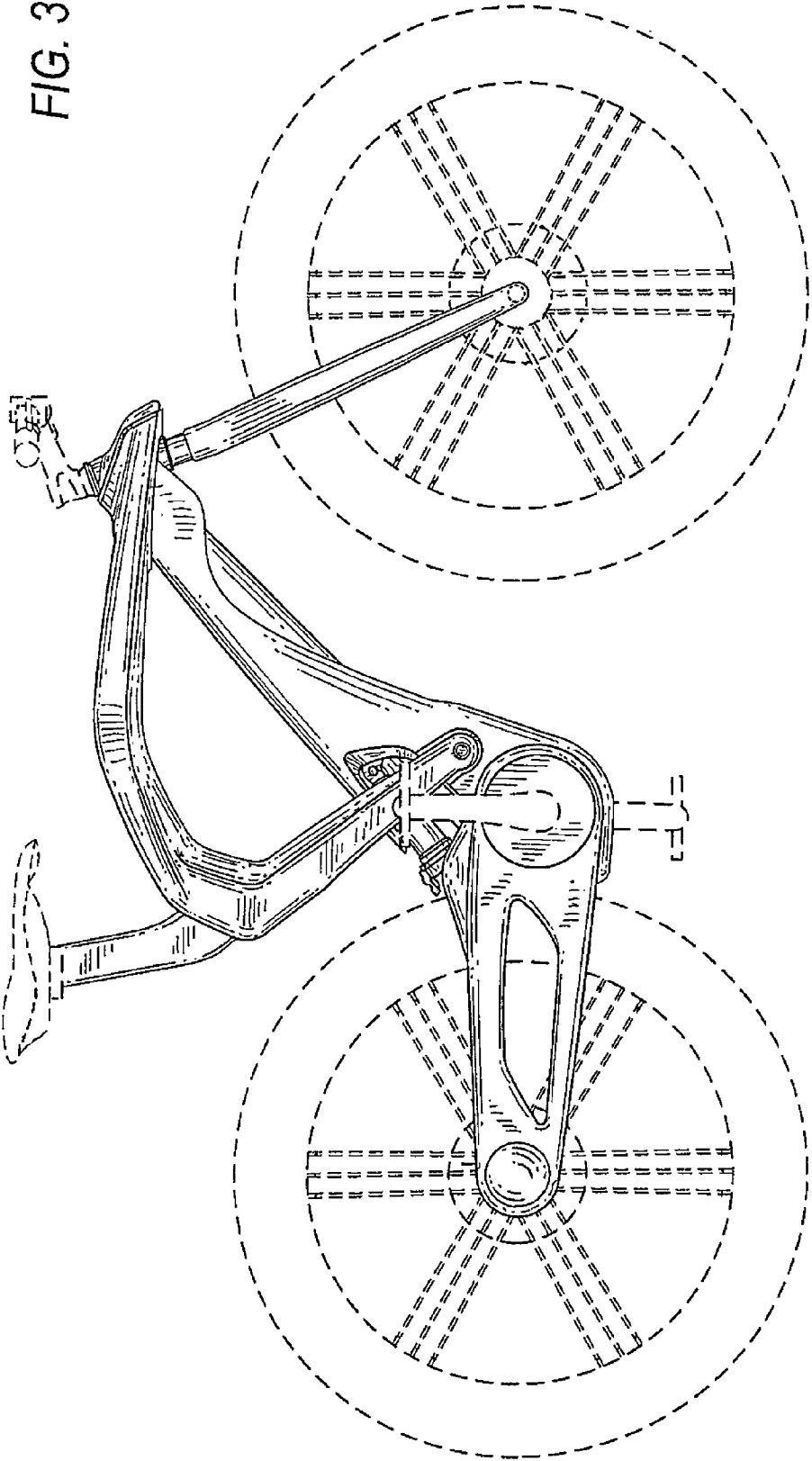

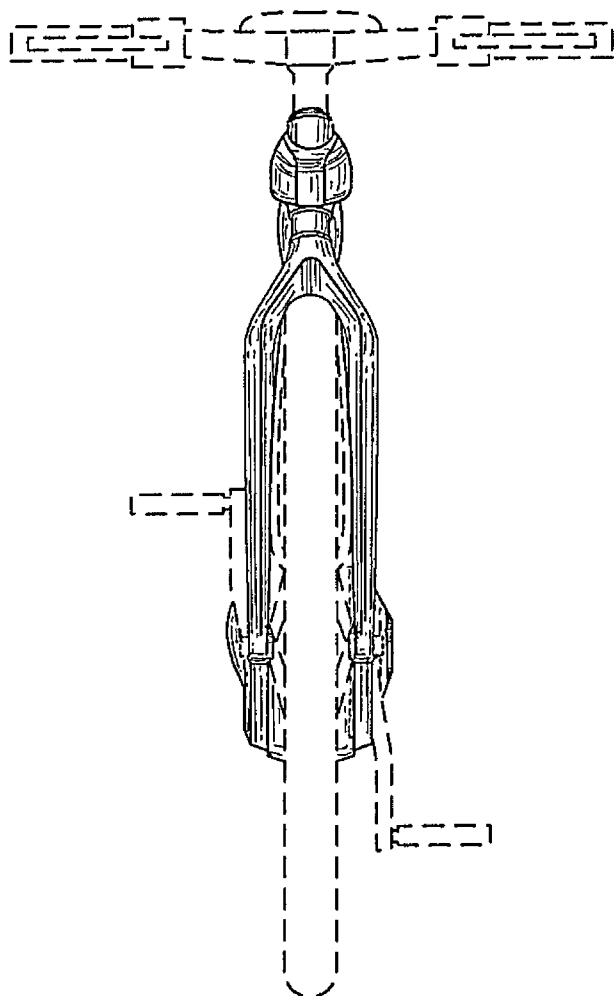

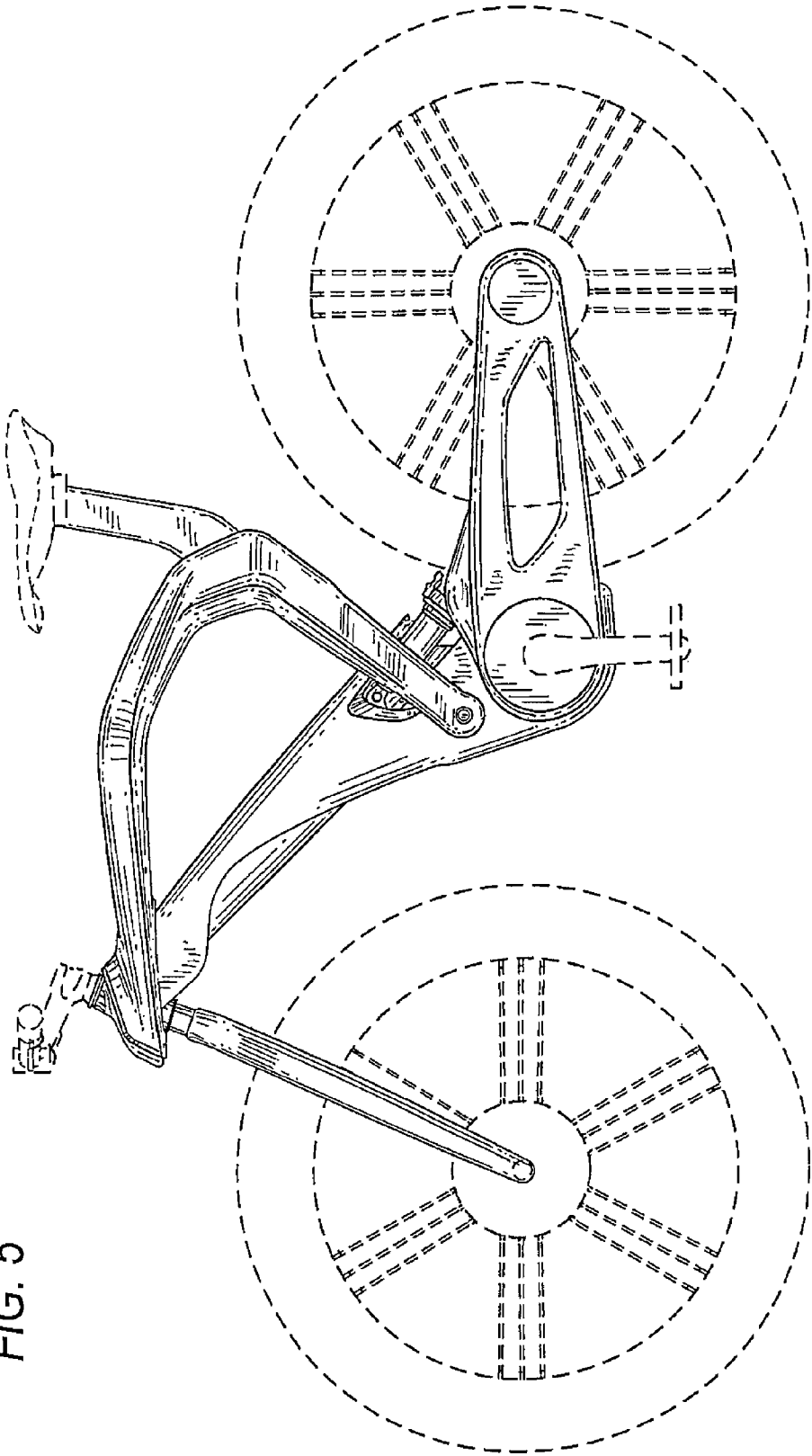

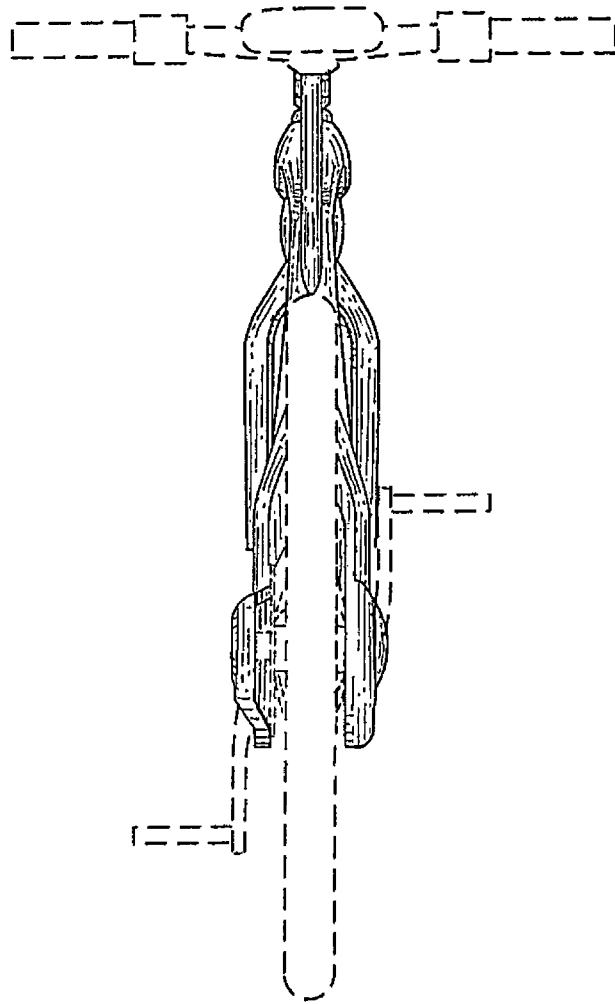

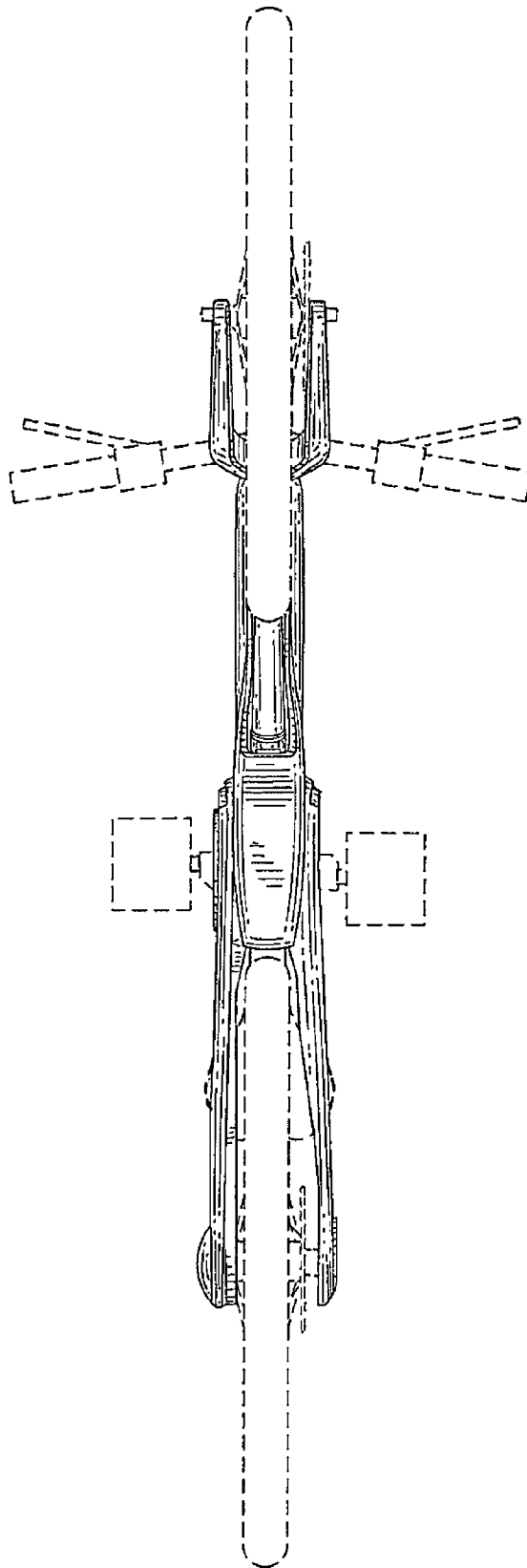
