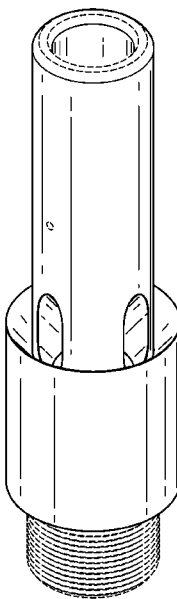

FIG. 1 is a side perspective view of a plunger adapter
FIG. 2 is a front side elevational view of the plunger adapter of FIG. 1;
FIG. 3 is a rear side elevational view of the plunger adapter of FIG. 1;
FIG. 4 is a top plan view of the plunger adapter of FIG. 1; and,
FIG. 5 is a bottom plan view of the plunger adapter of FIG. 1.

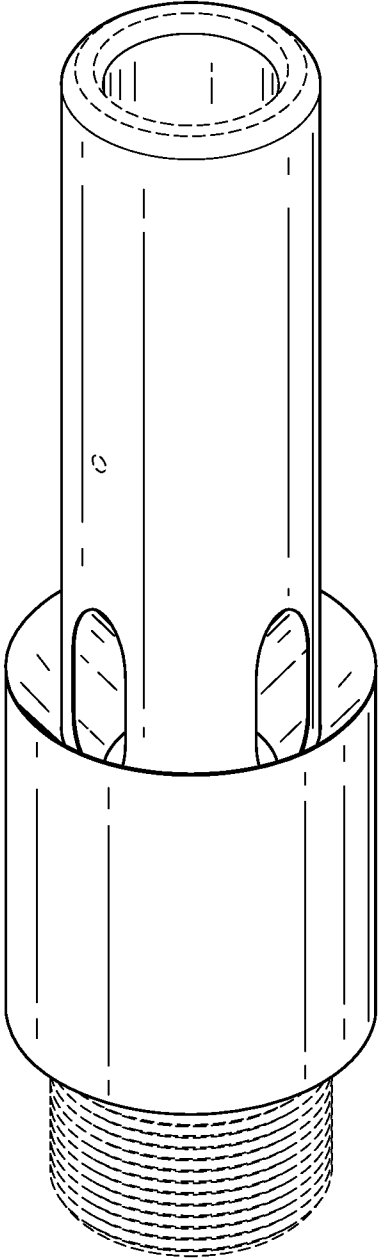

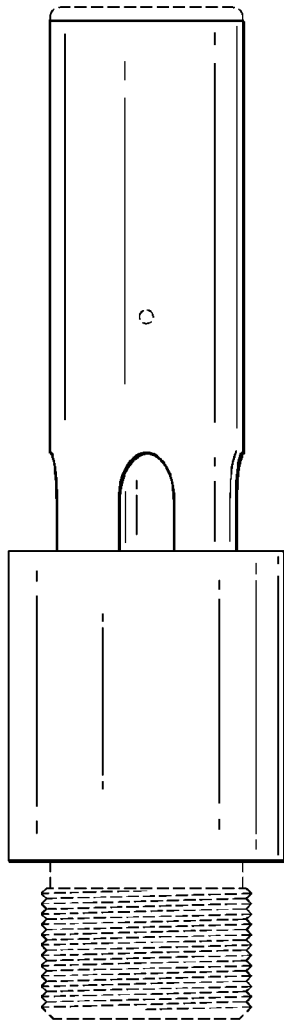

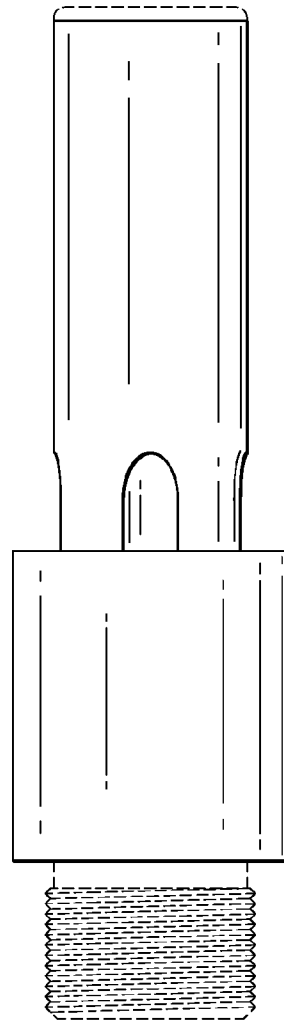

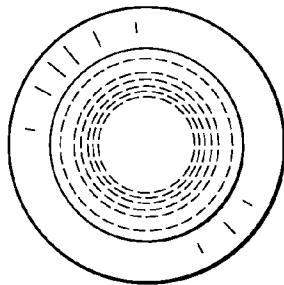

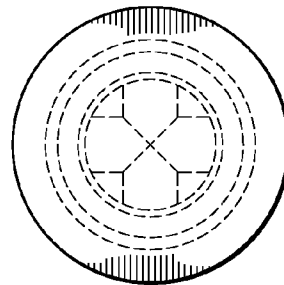
