**DESCRIPTION**

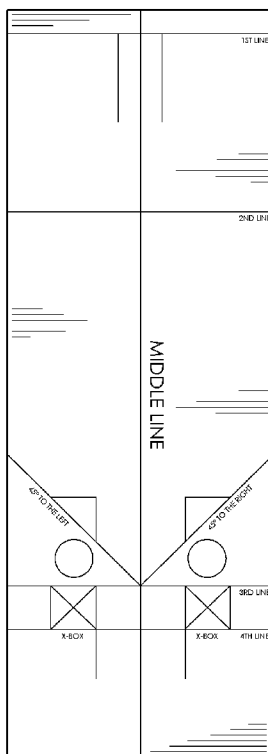
FIG. 1 is a top view of a yoga mat according to the present invention;

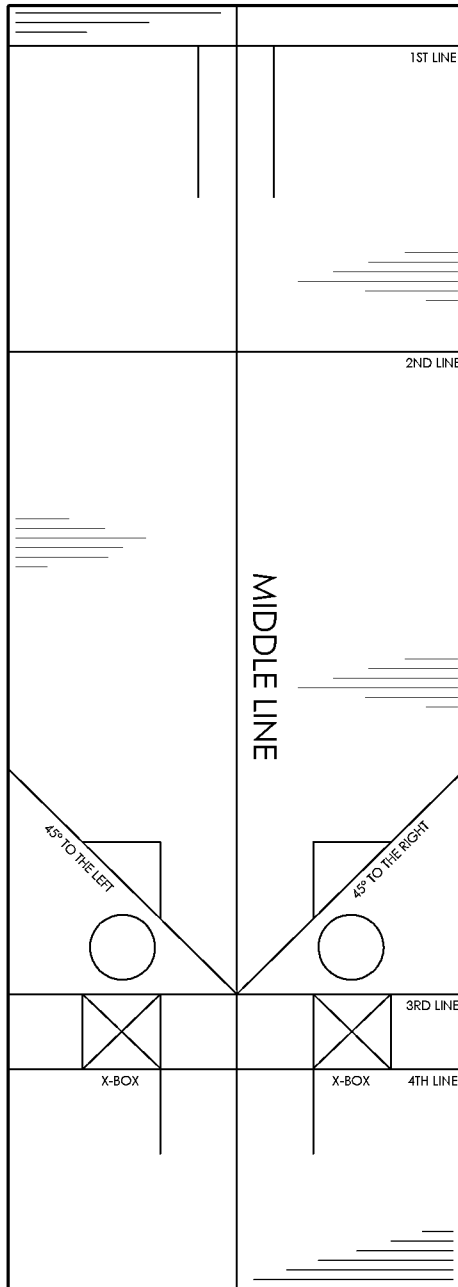
