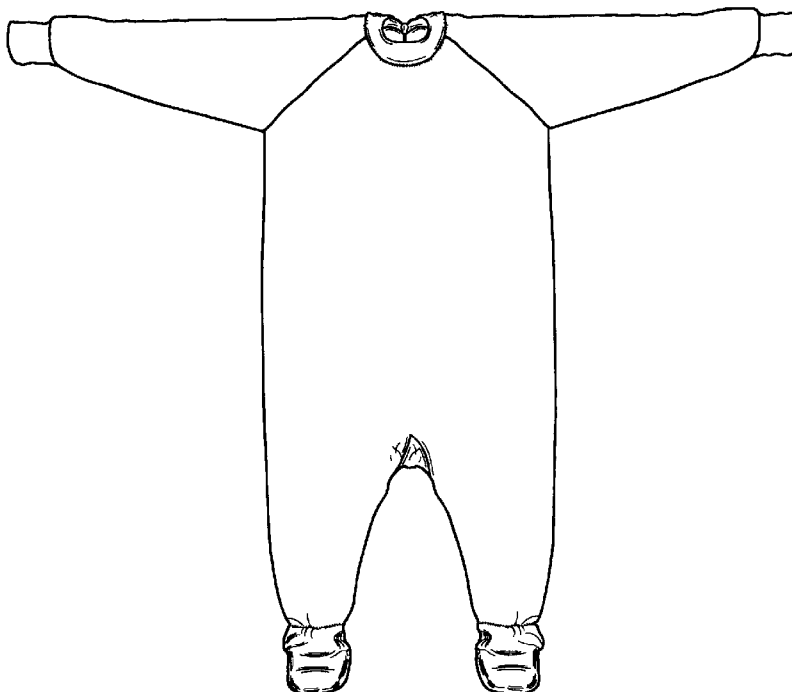
(57) **CLAIM**

The ornamental design for an infant/toddler sleeper with a posterior fastener, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an infant/toddler sleeper with a posterior fastener showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a side elevational view thereof; FIG. 6 is a front perspective view thereof; and, FIG. 7 is an enlarged front elevational view of snaps in an open position thereof.

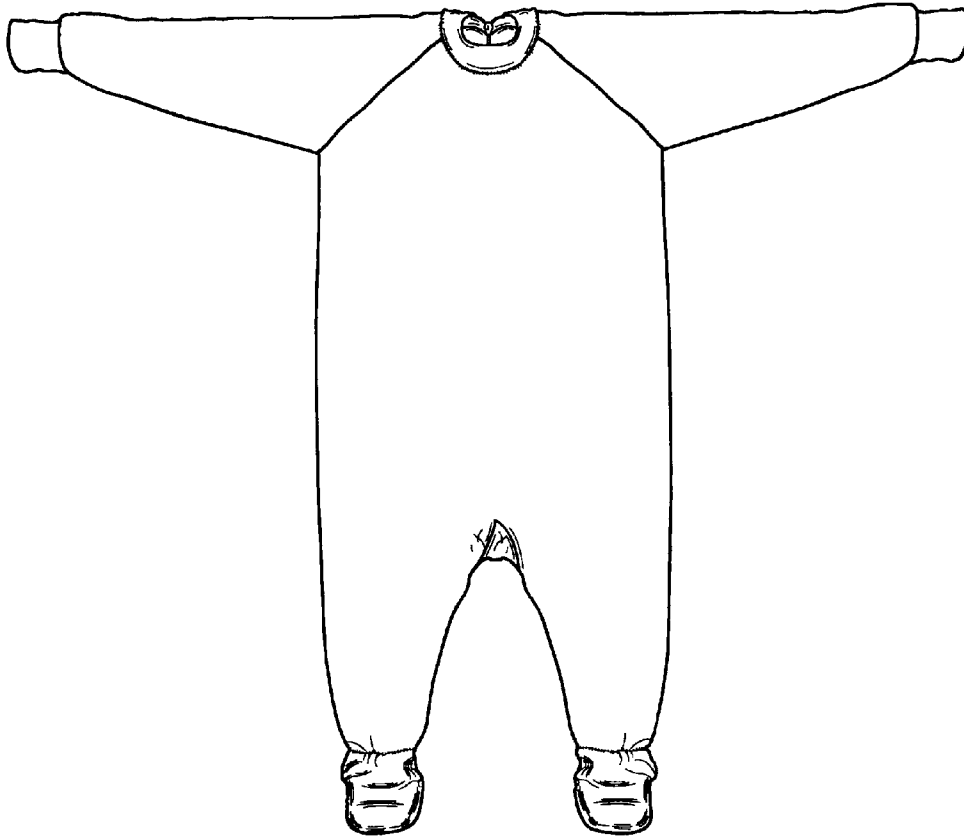

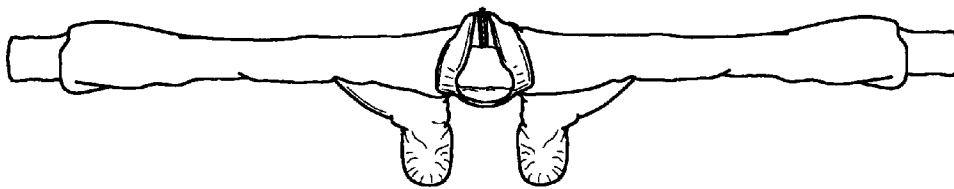

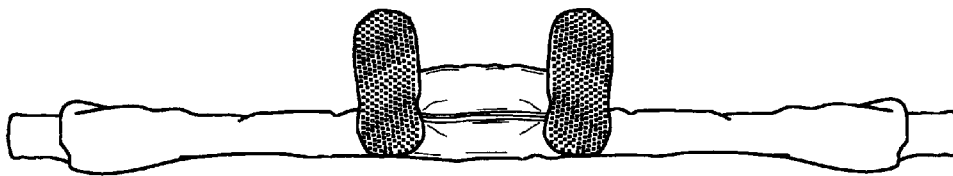

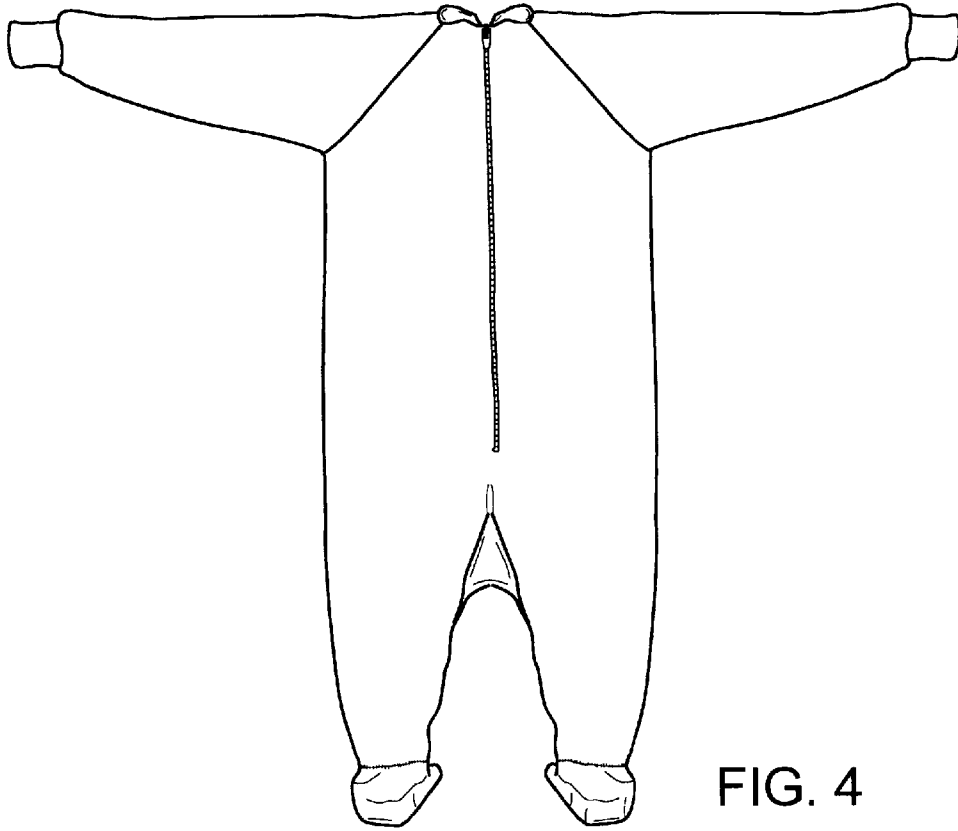

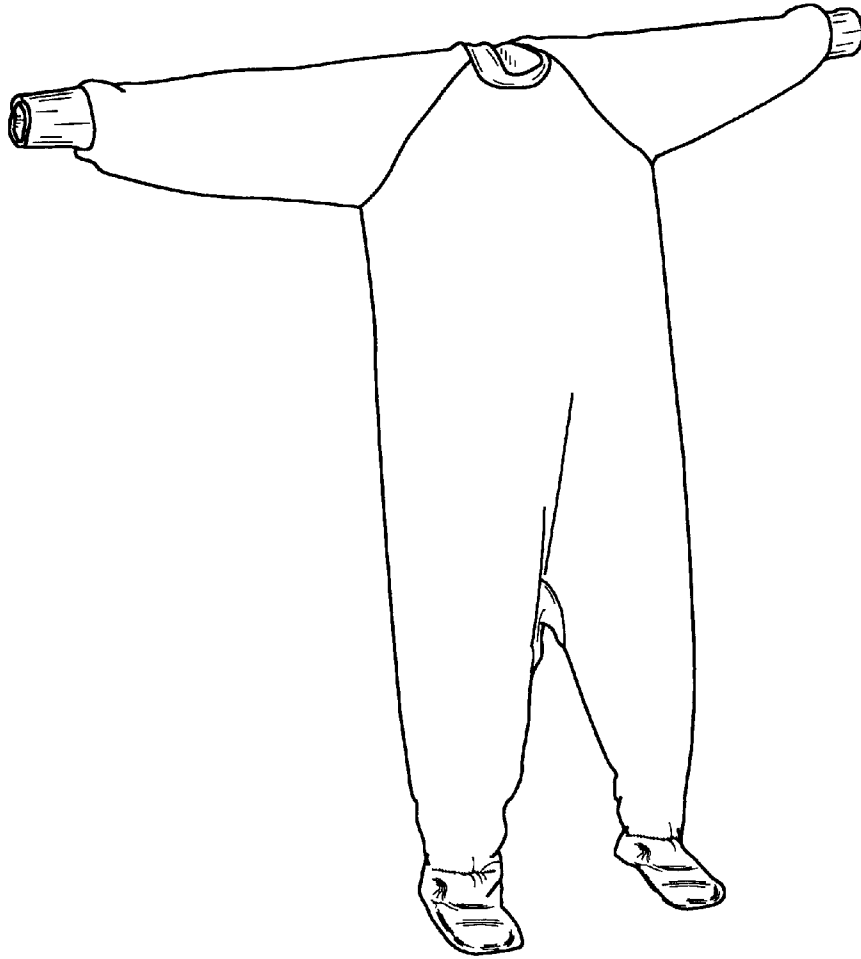

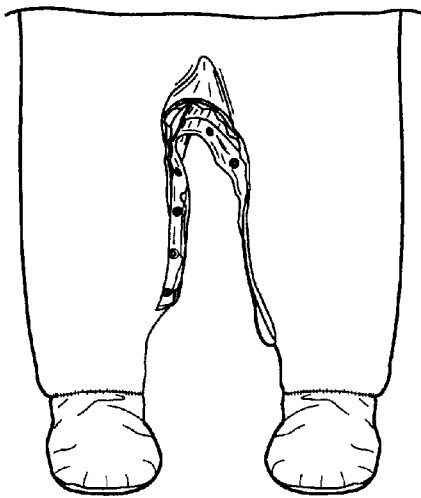
