DESCRIPTION

FIG. 10 is a front elevational view of cards 11-15 from the "purple" suit thereof;
FIG. 11 is a front elevational view of cards 1-5 from the "red" suit thereof;
FIG. 12 is a front elevational view of cards 6-10 from the "red" suit thereof;
FIG. 13 is a front elevational view of cards 11-15 from the "red" suit thereof; and,
FIG. 14 is a front elevational view of a wildcard thereof.

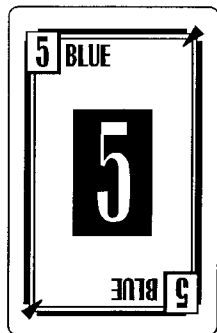
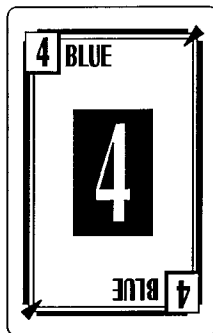
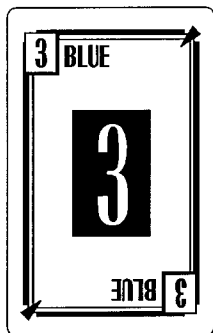
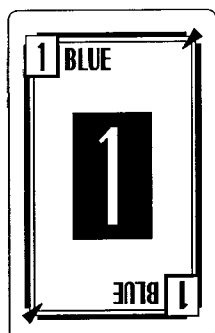
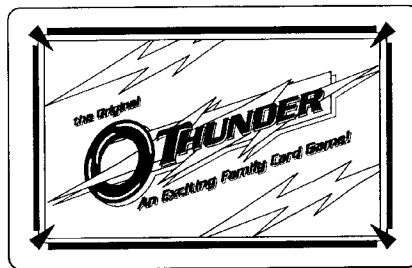

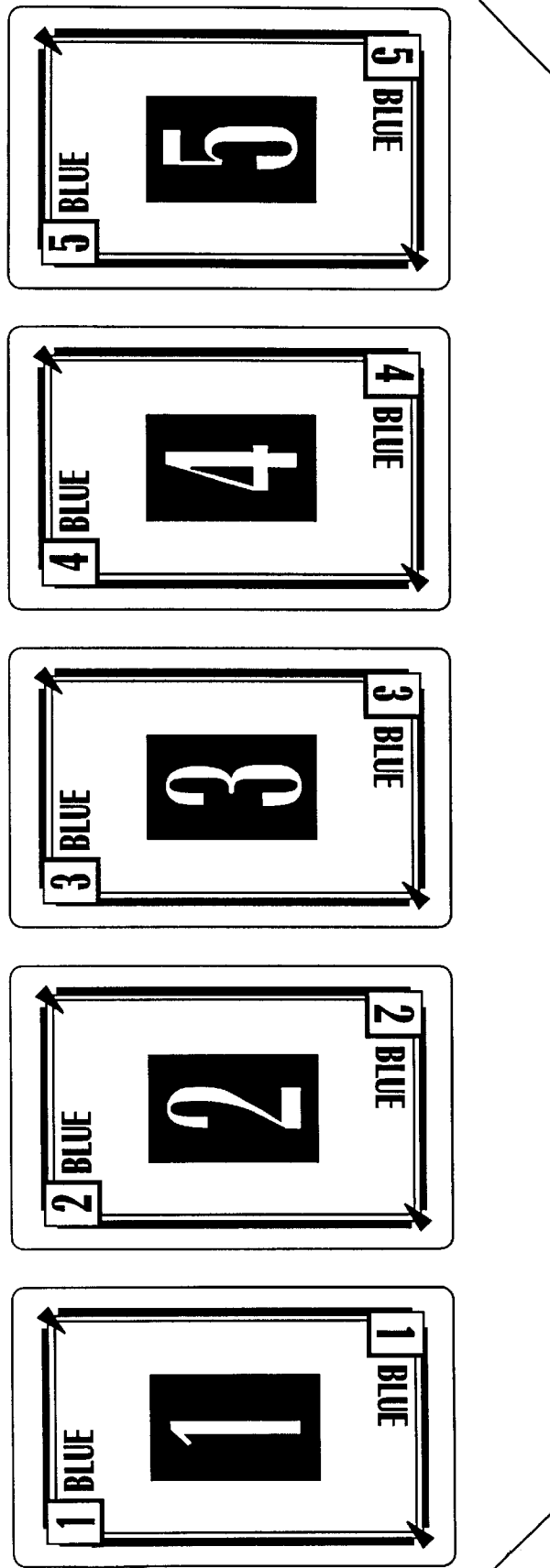

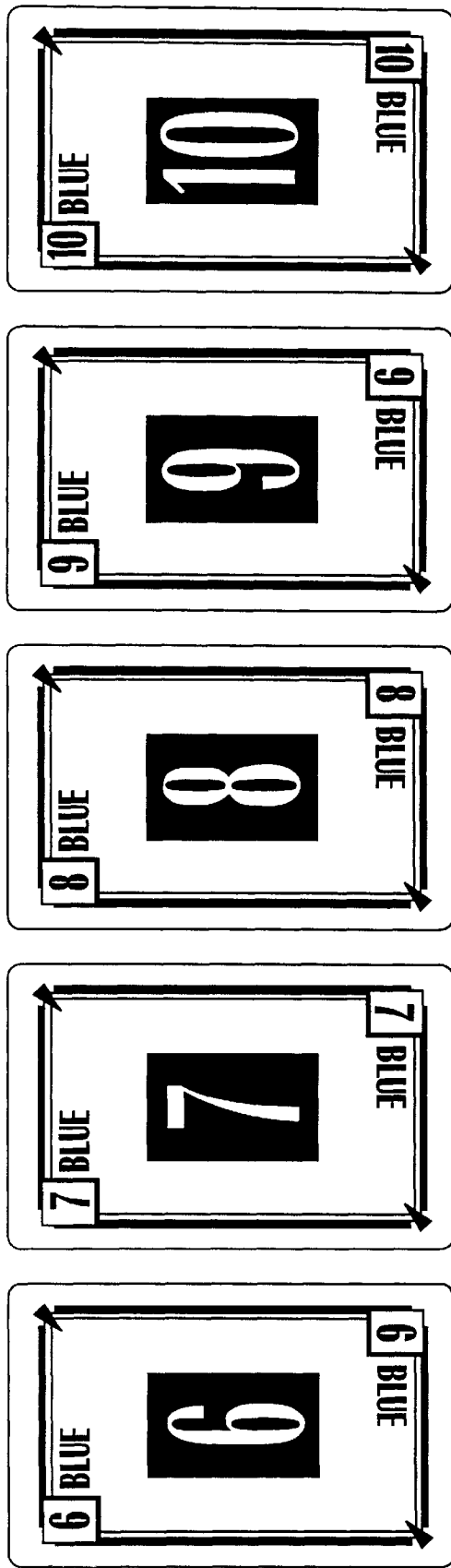

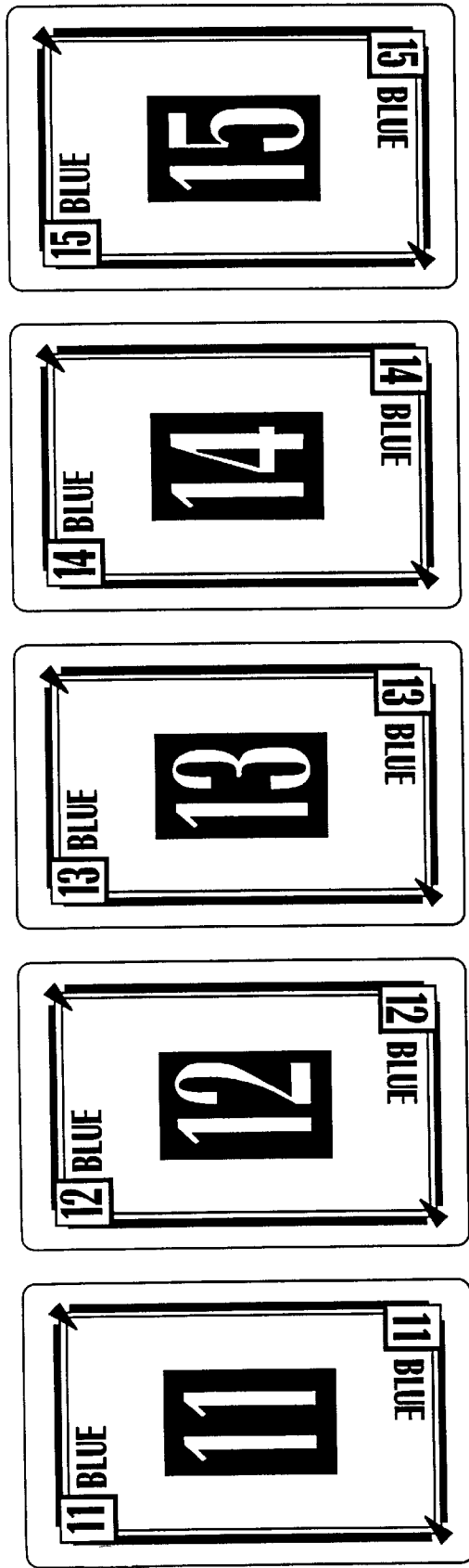

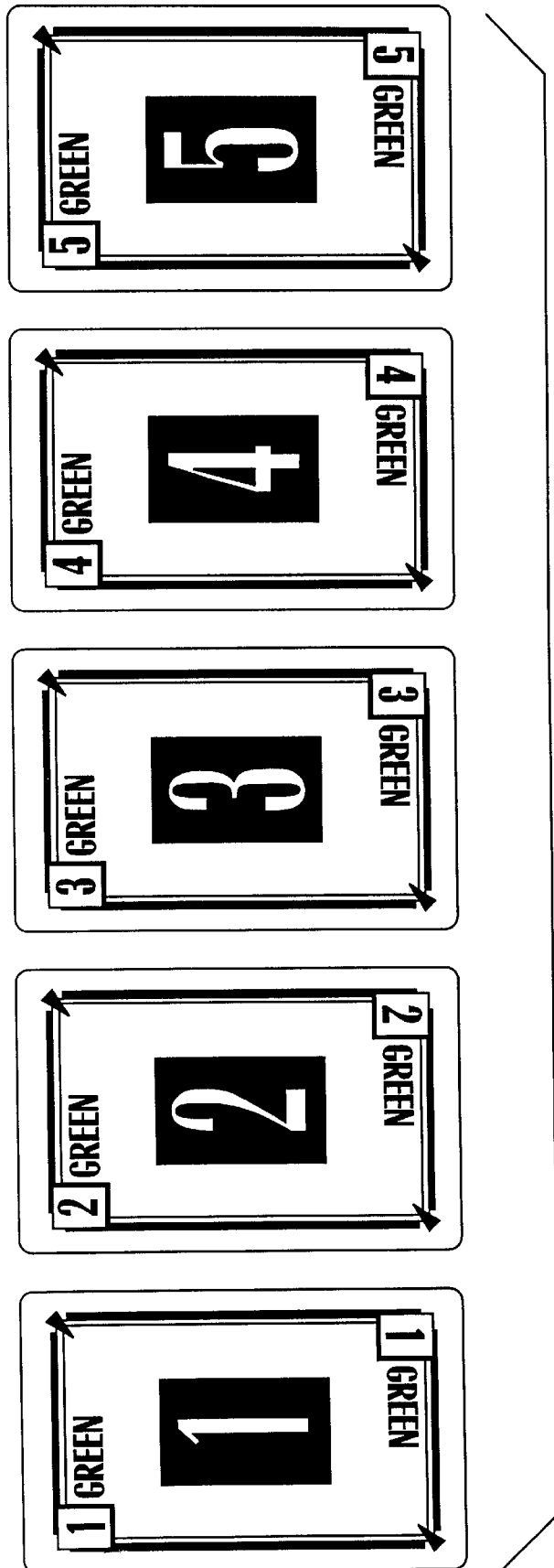

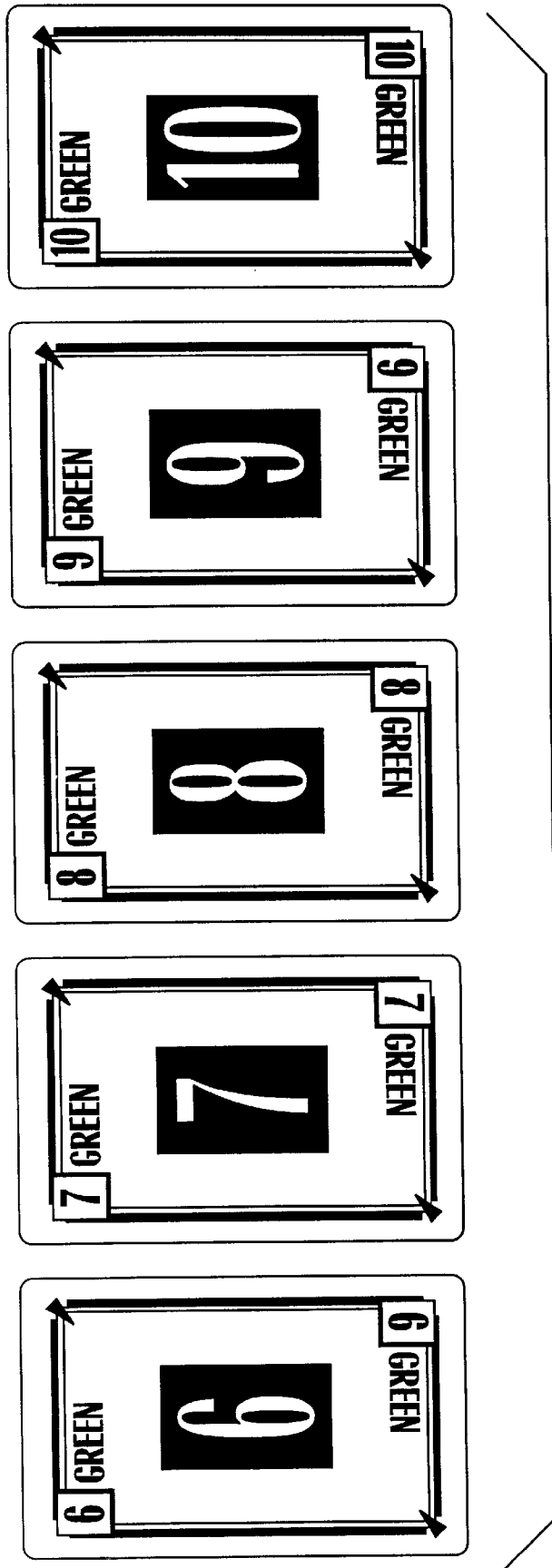

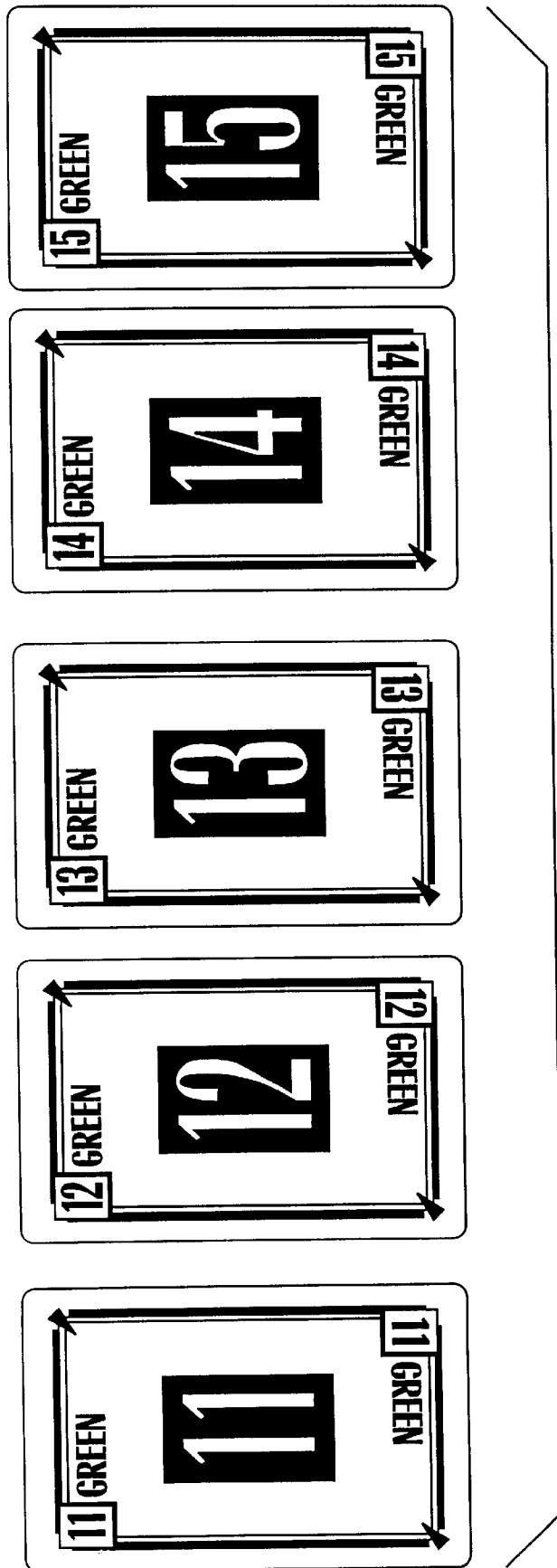

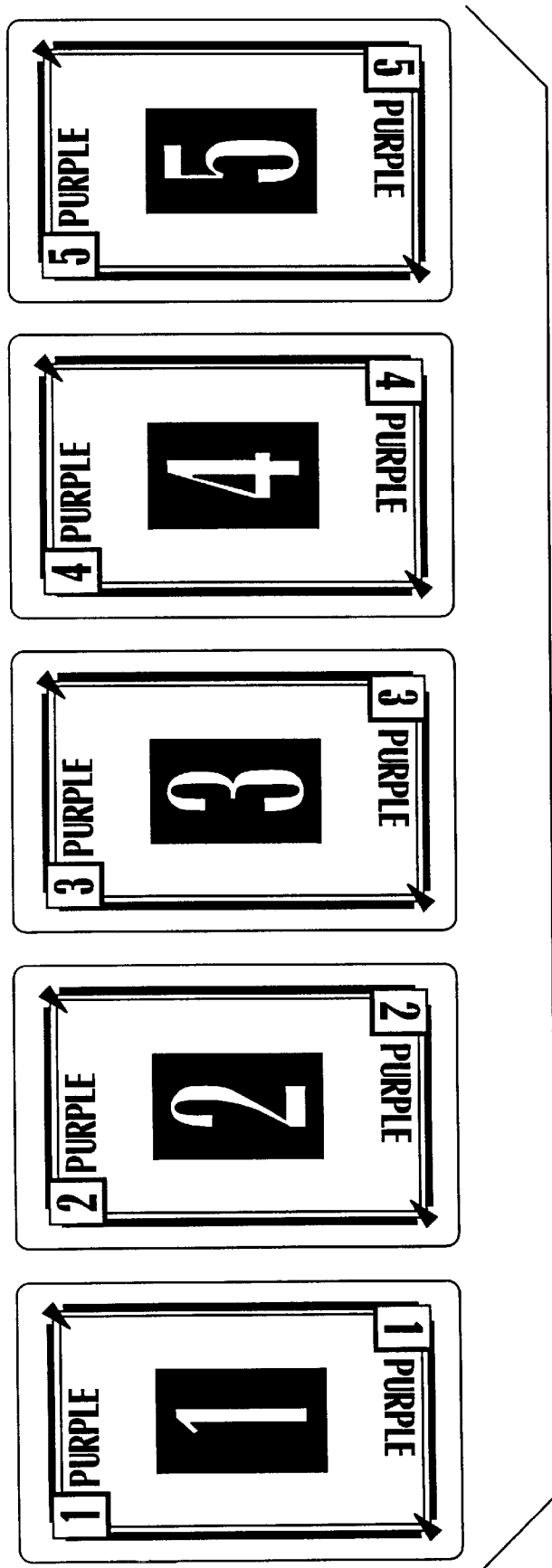

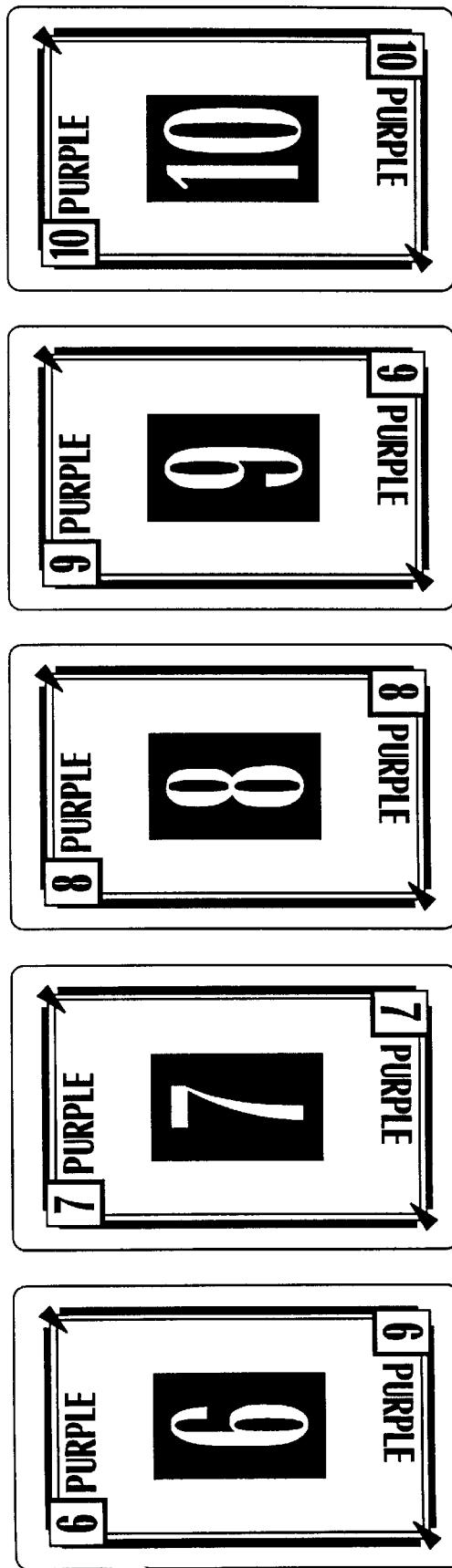

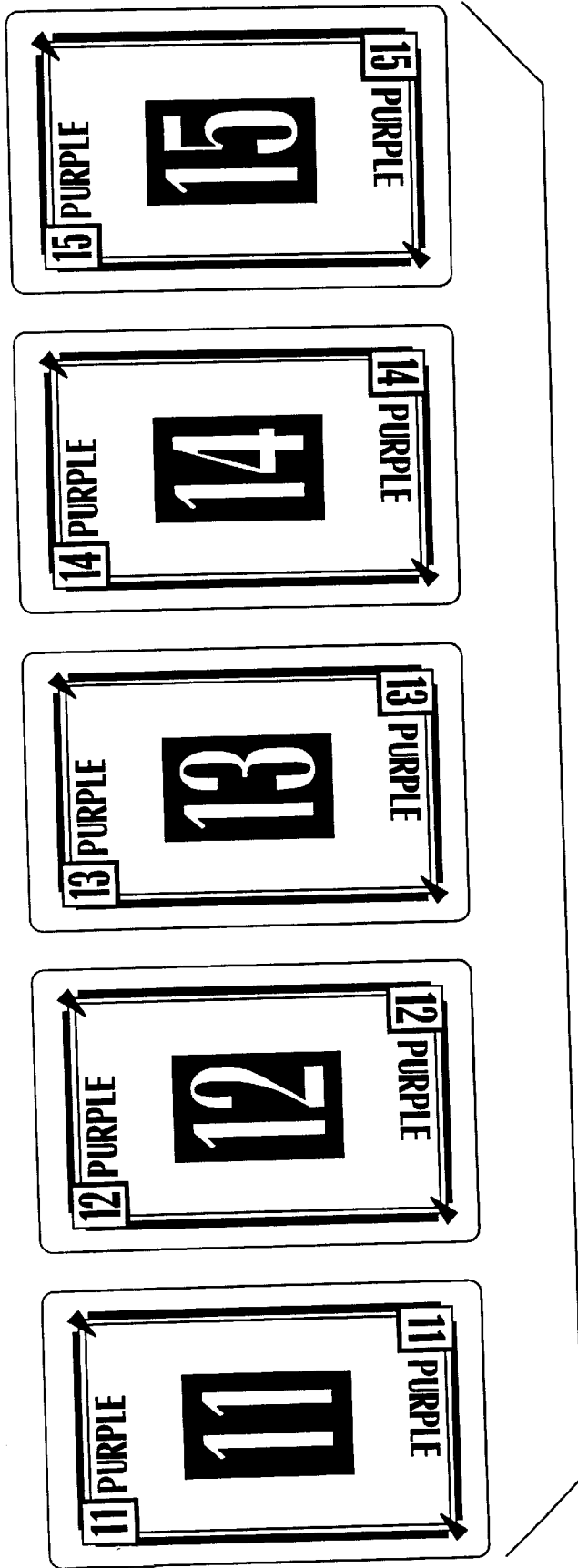

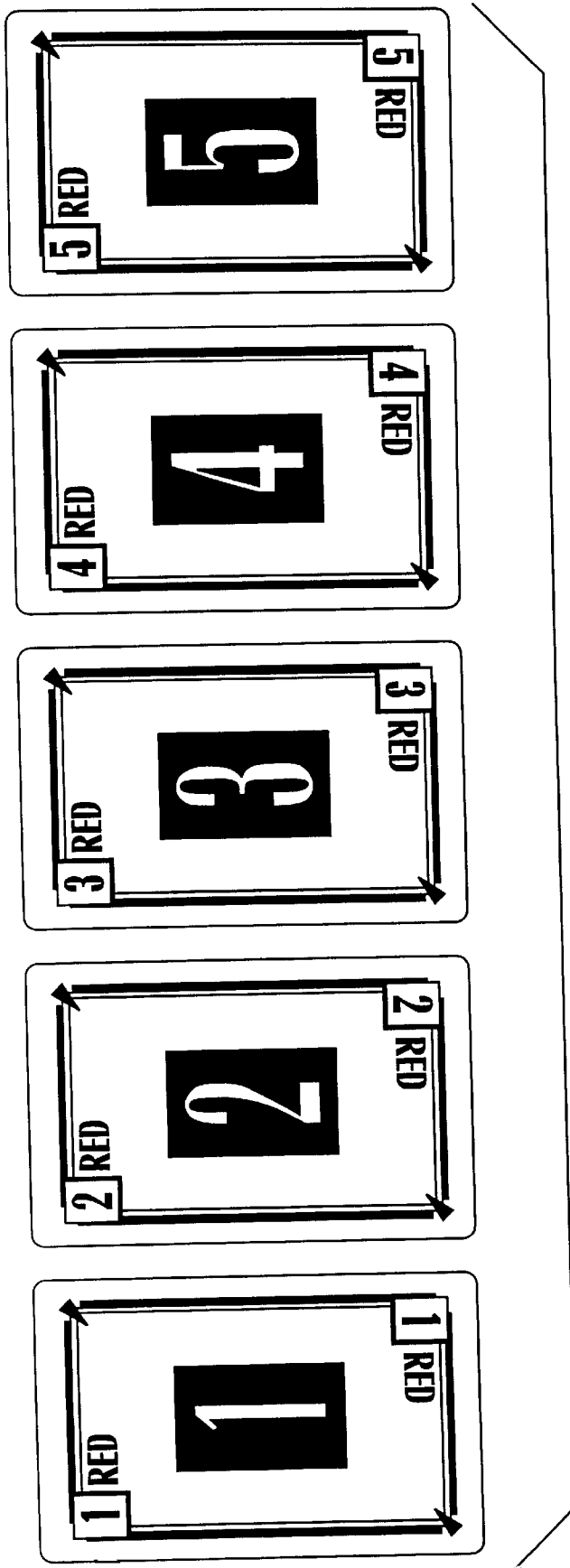

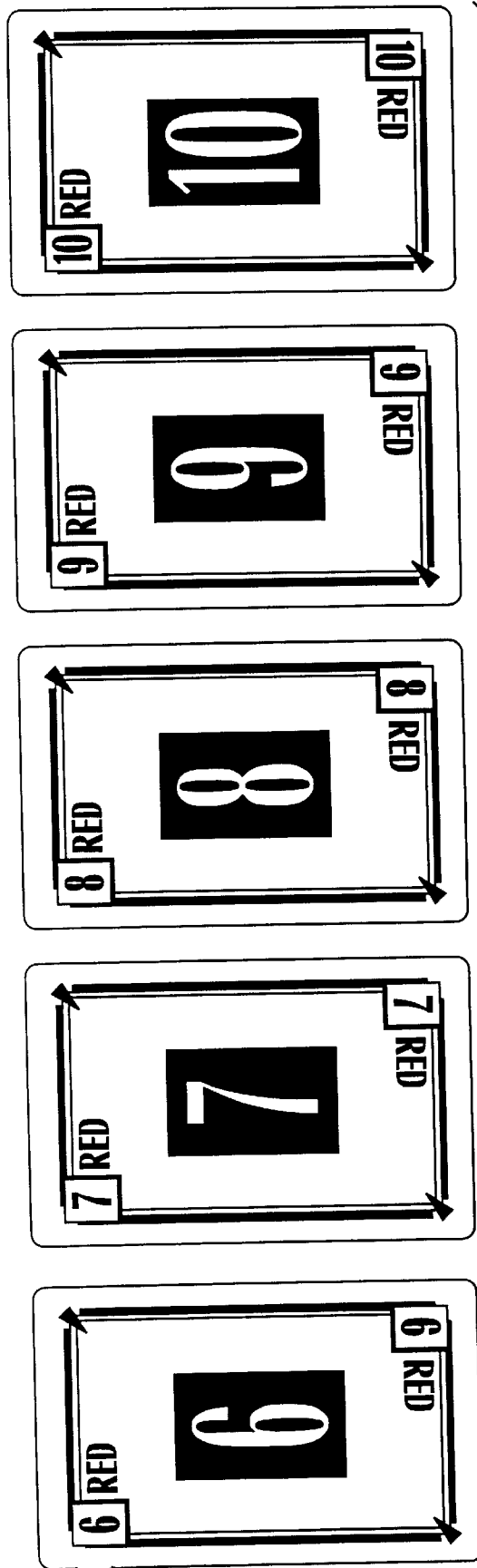

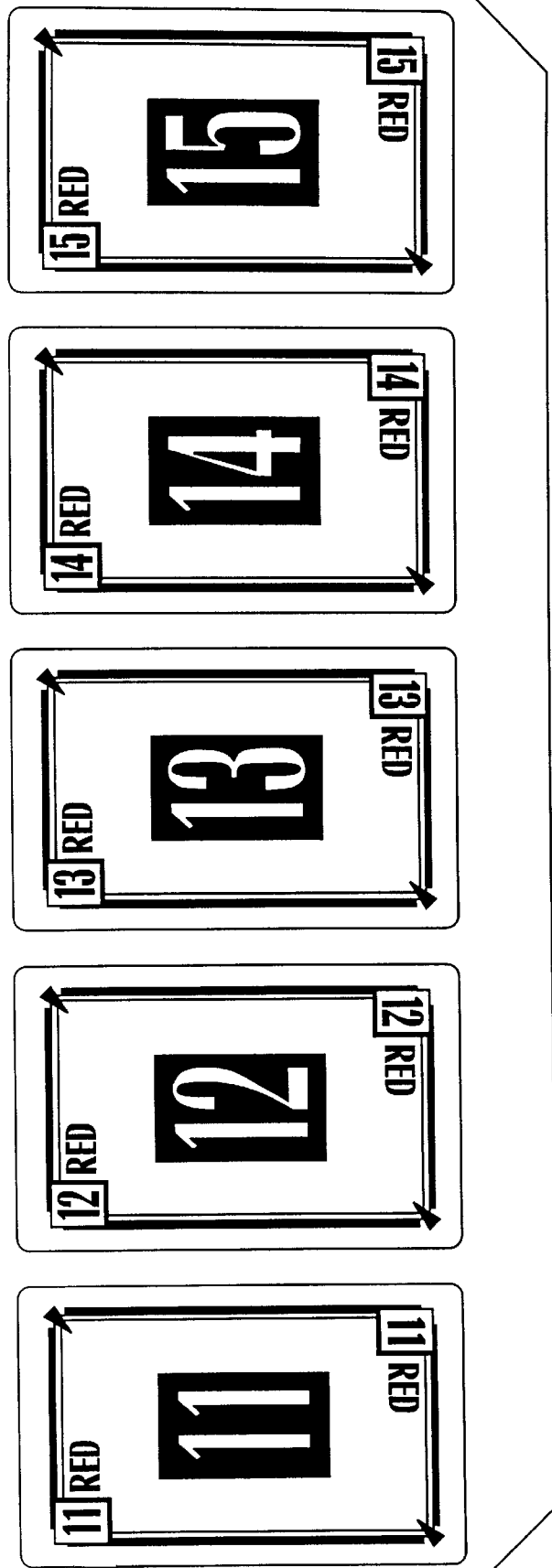
