I claim the ornamental design for a cycling helmet, as shown and described.

The broken lines are included for the purpose of illustrating environmental features and form no part of the claimed design.

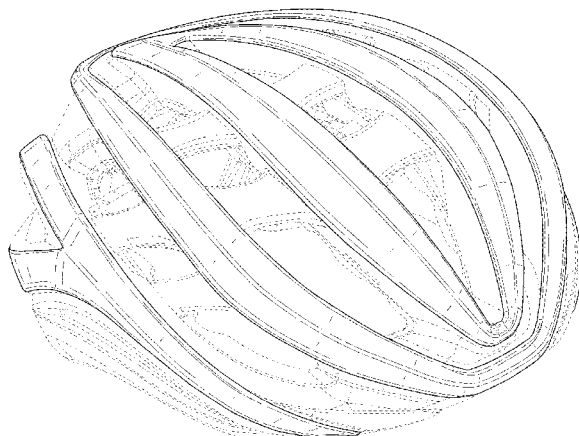

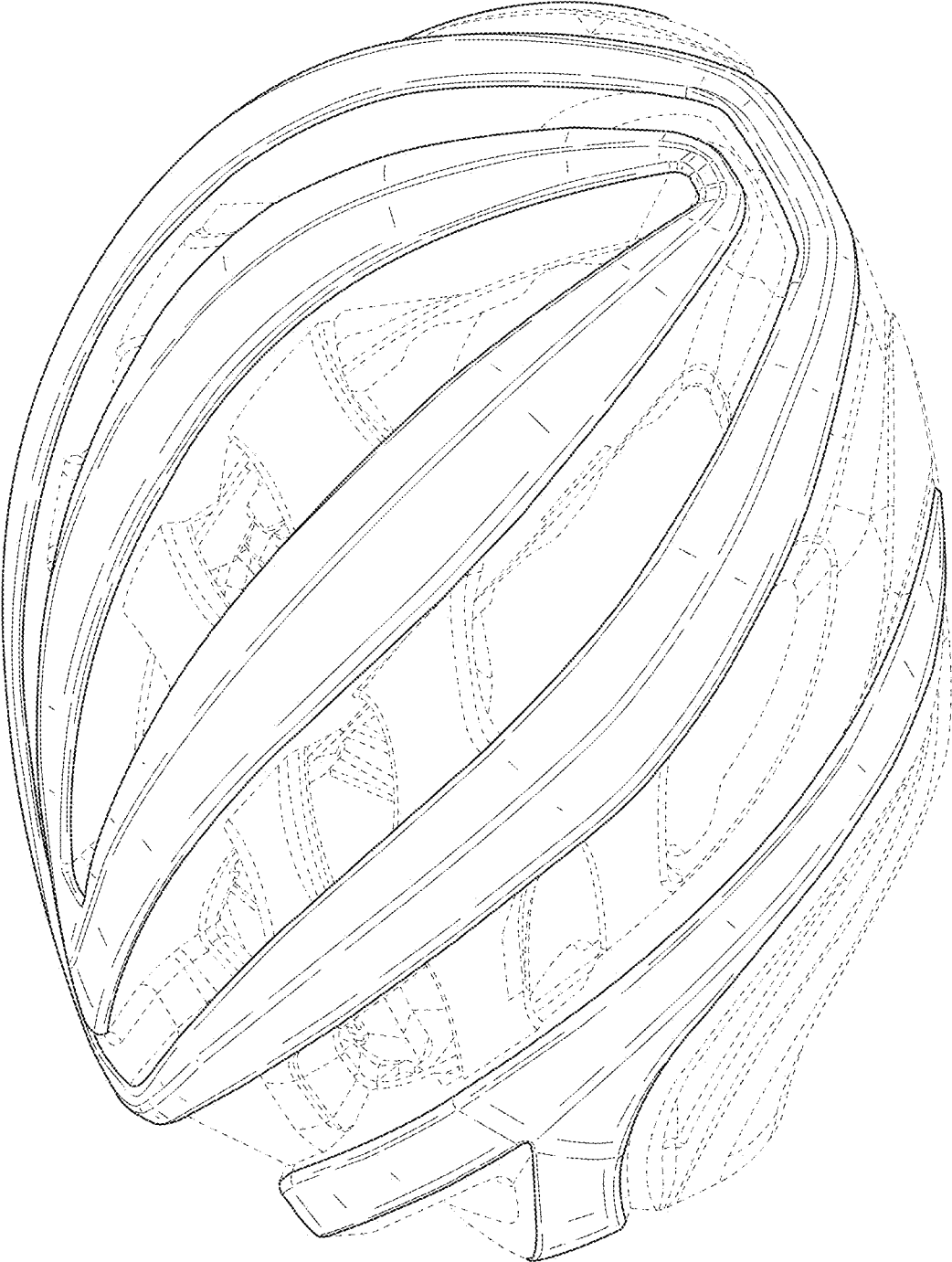

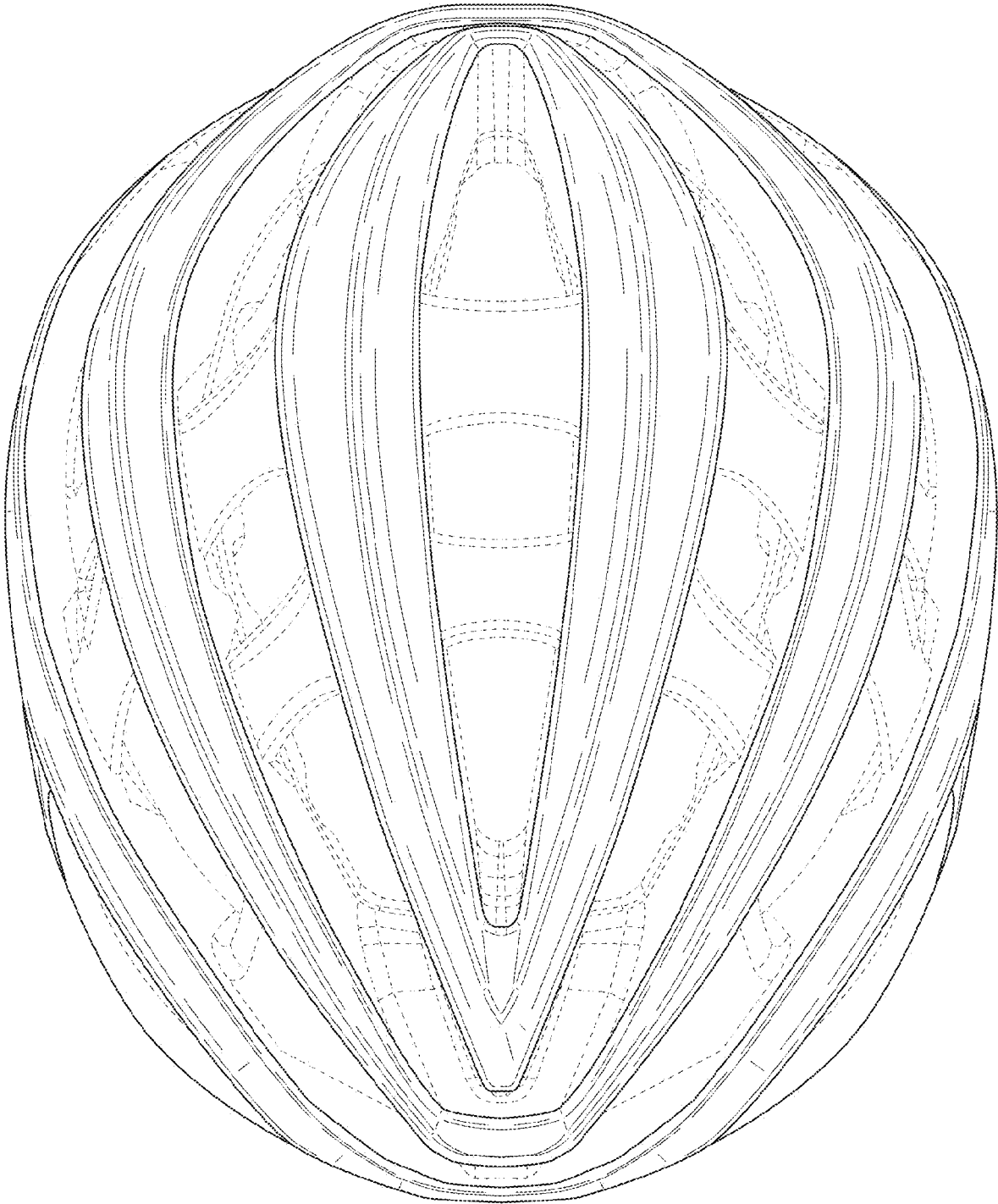

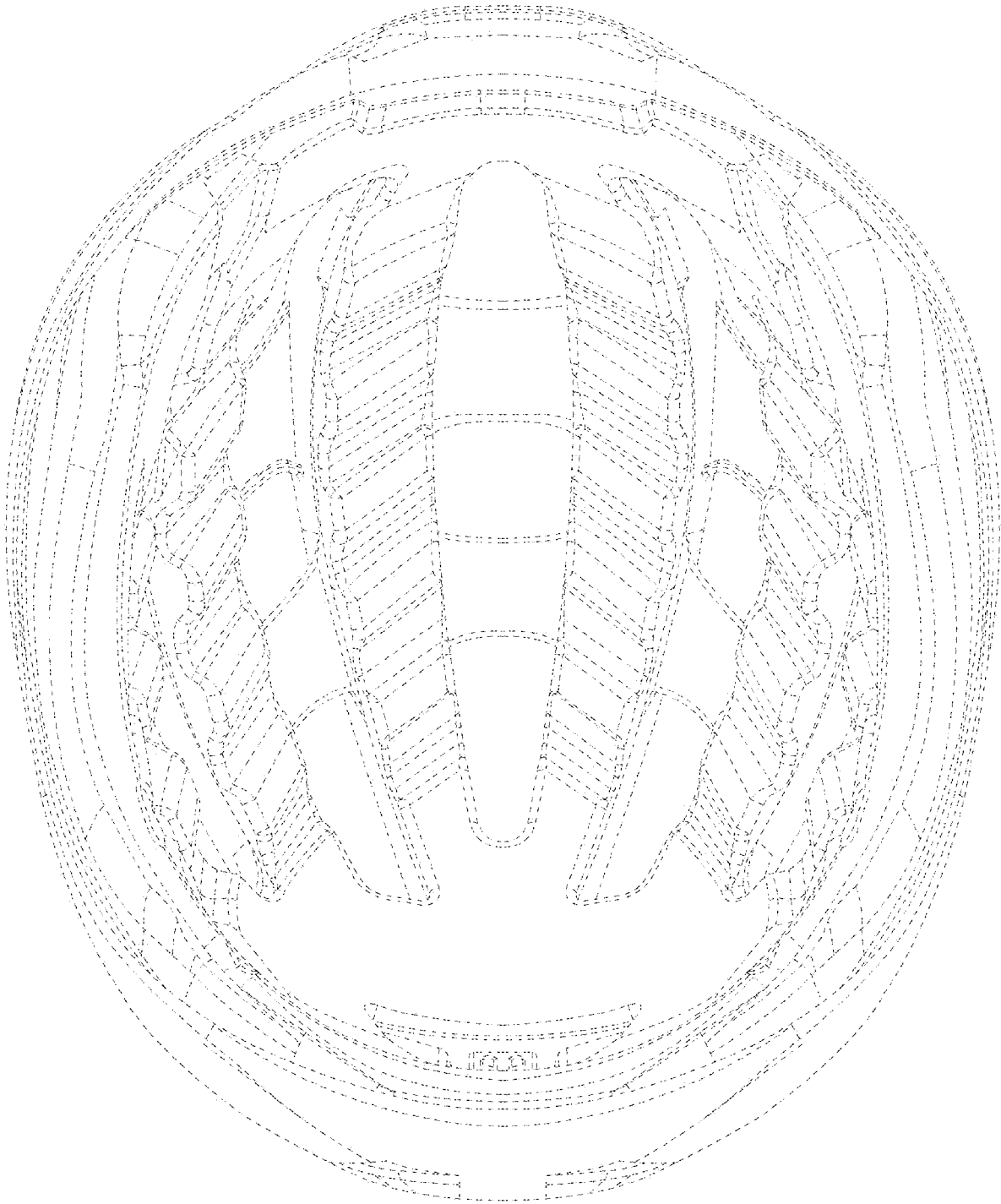

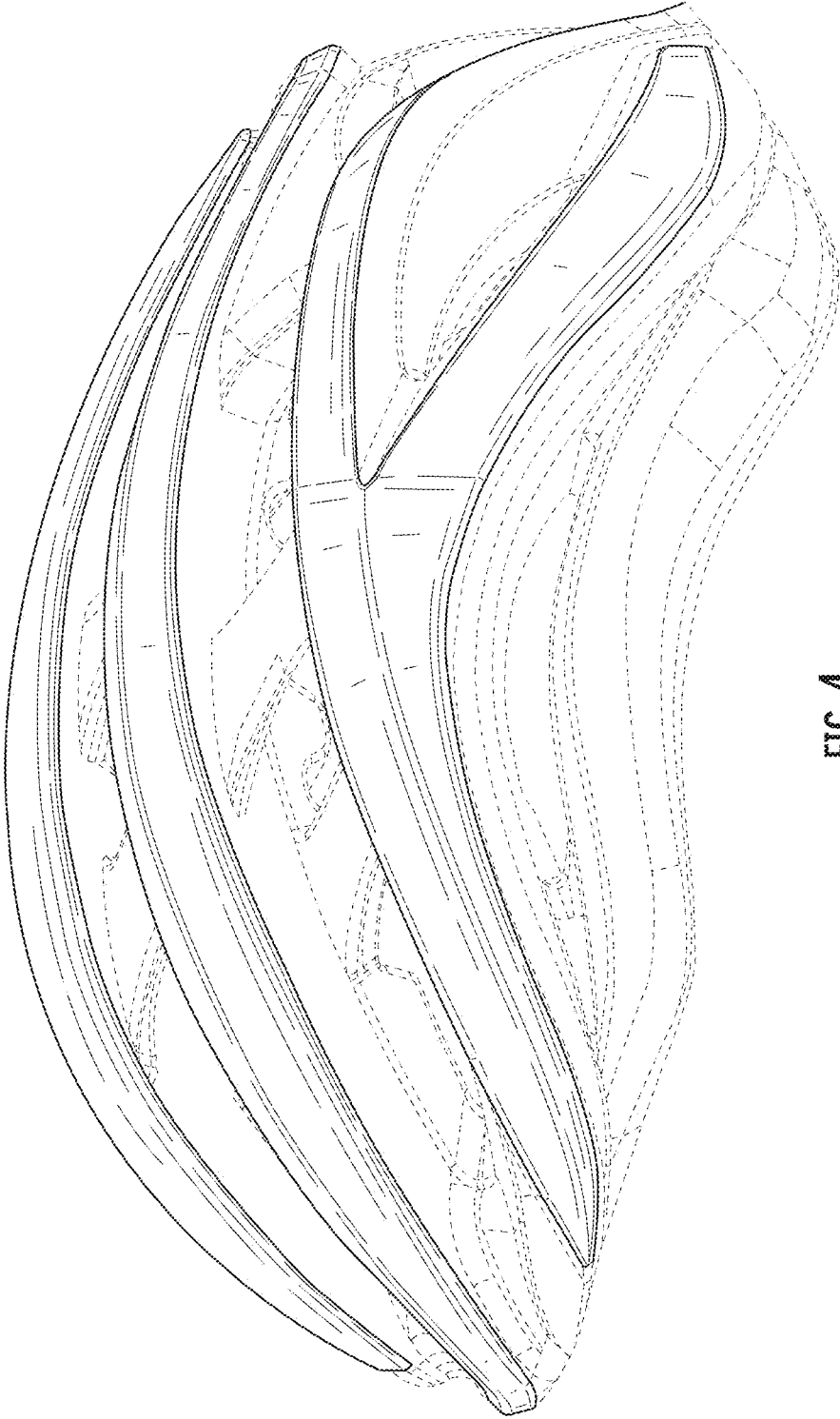

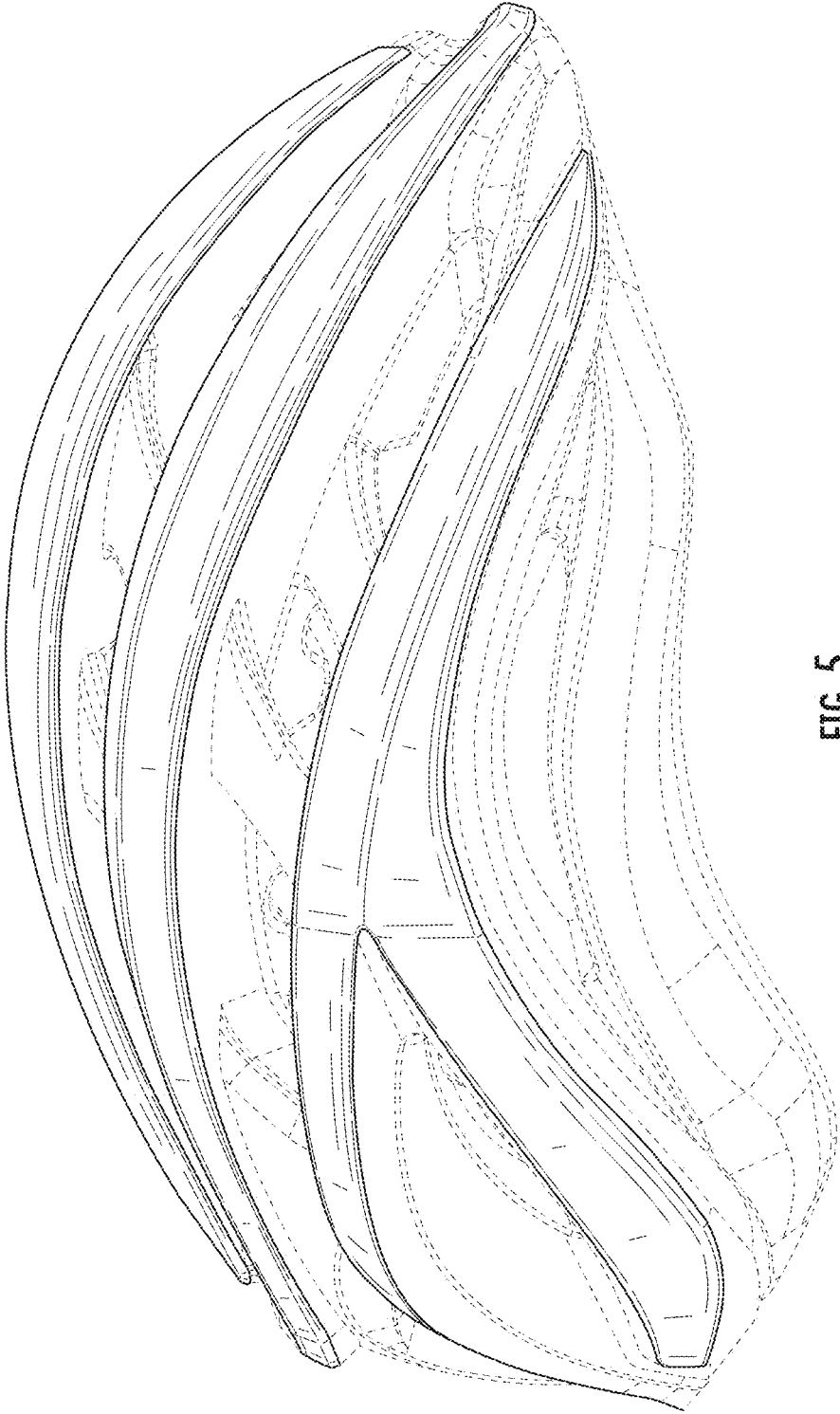

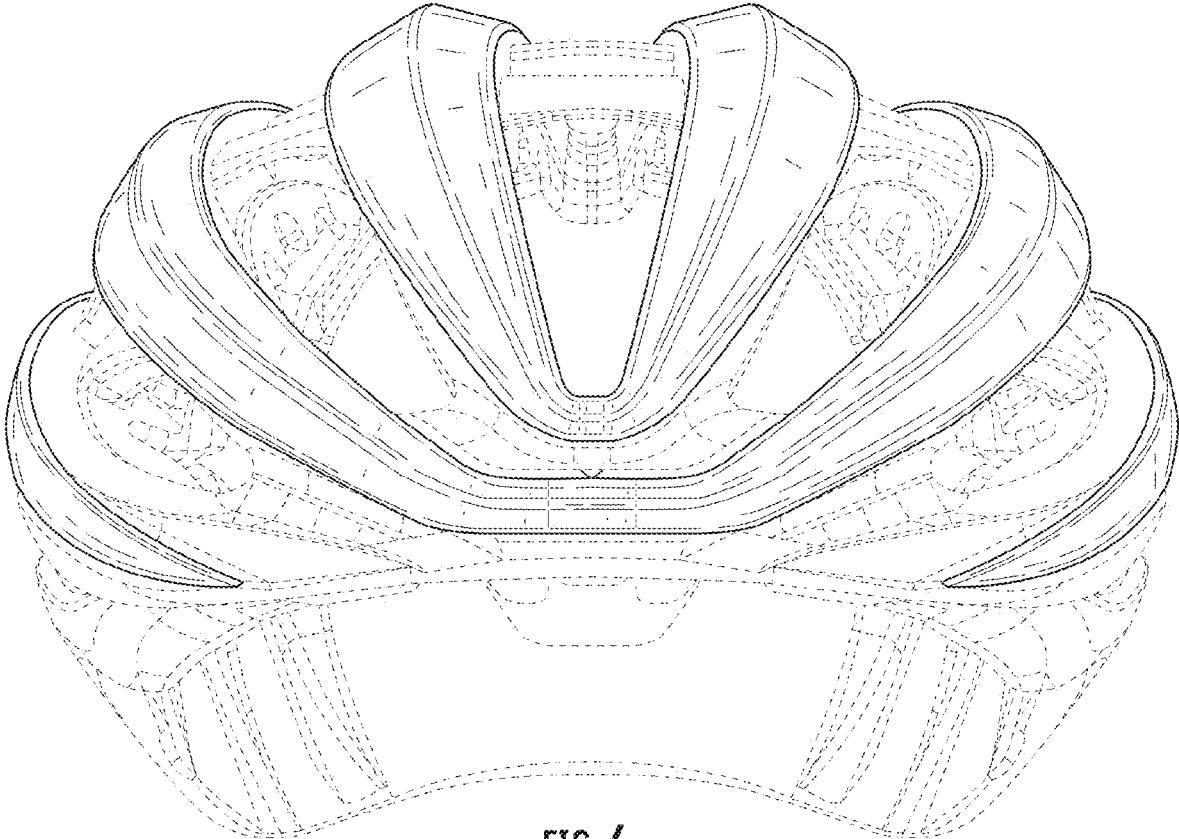

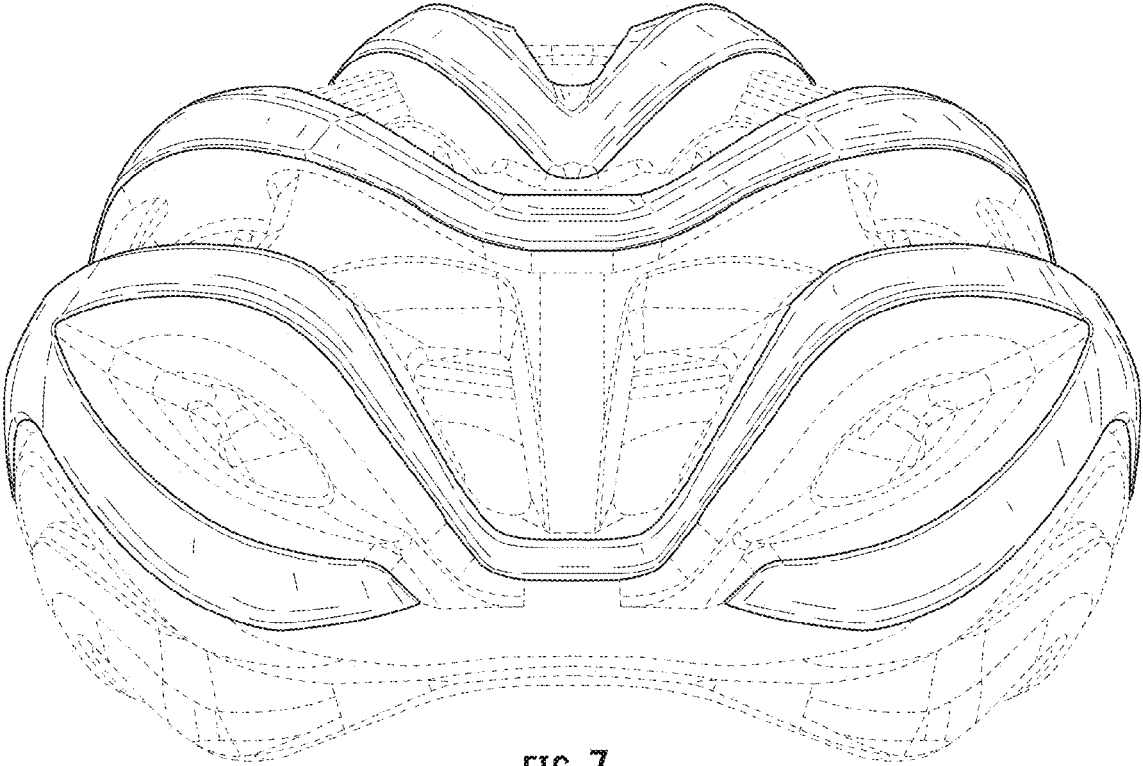
