(57) **CLAIM**

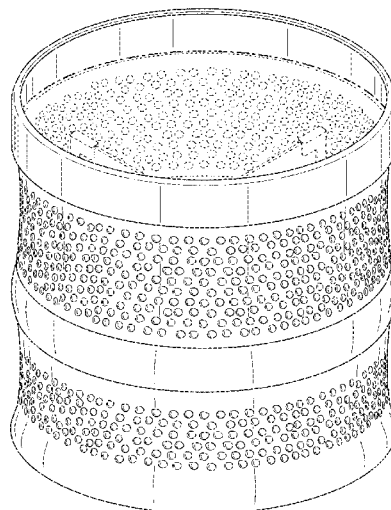
The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a container showing my new design;  
 FIG. 2 is a front view thereof, the rear view being a mirror image of the front view;  
 FIG. 3 is a right side view thereof, the left side view being a mirror image of the right side view;  
 FIG. 4 is a top view thereof; and,  
 FIG. 5 is a bottom view thereof.

The evenly-spaced broken lines illustrate portions of the container. The long dash short-dash broken lines represent the bounds of the claim. The broken lines form no part of the claimed design.

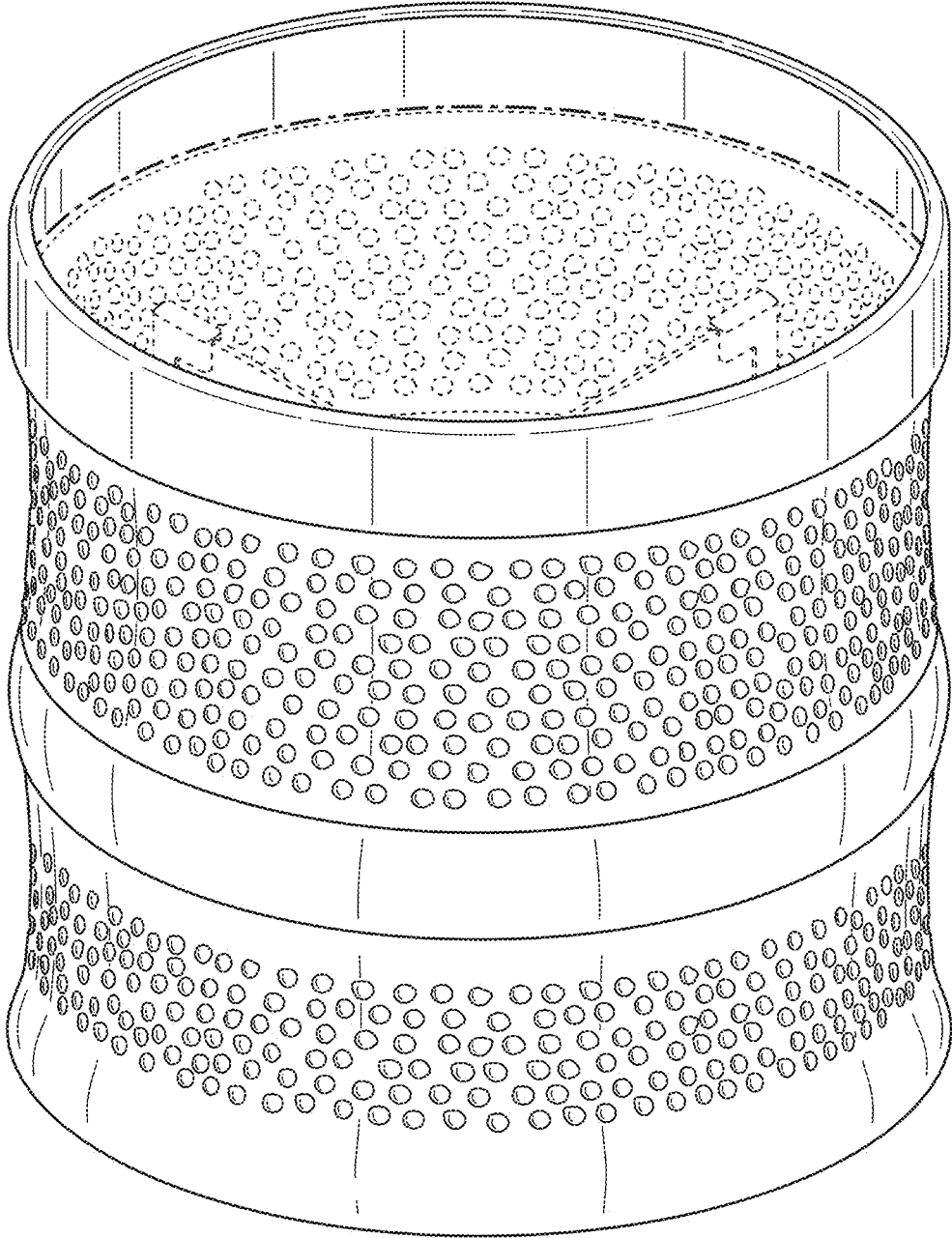

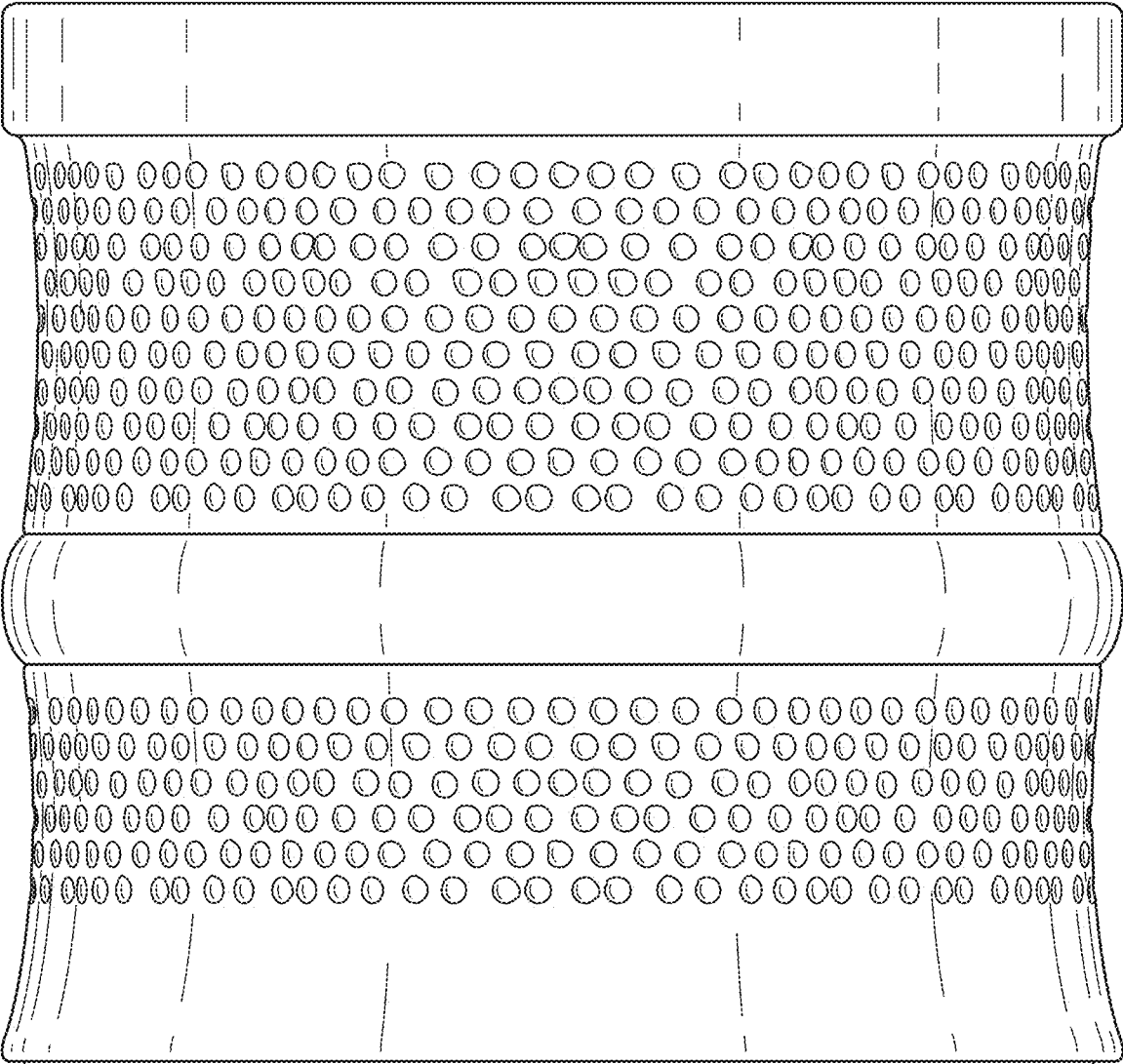
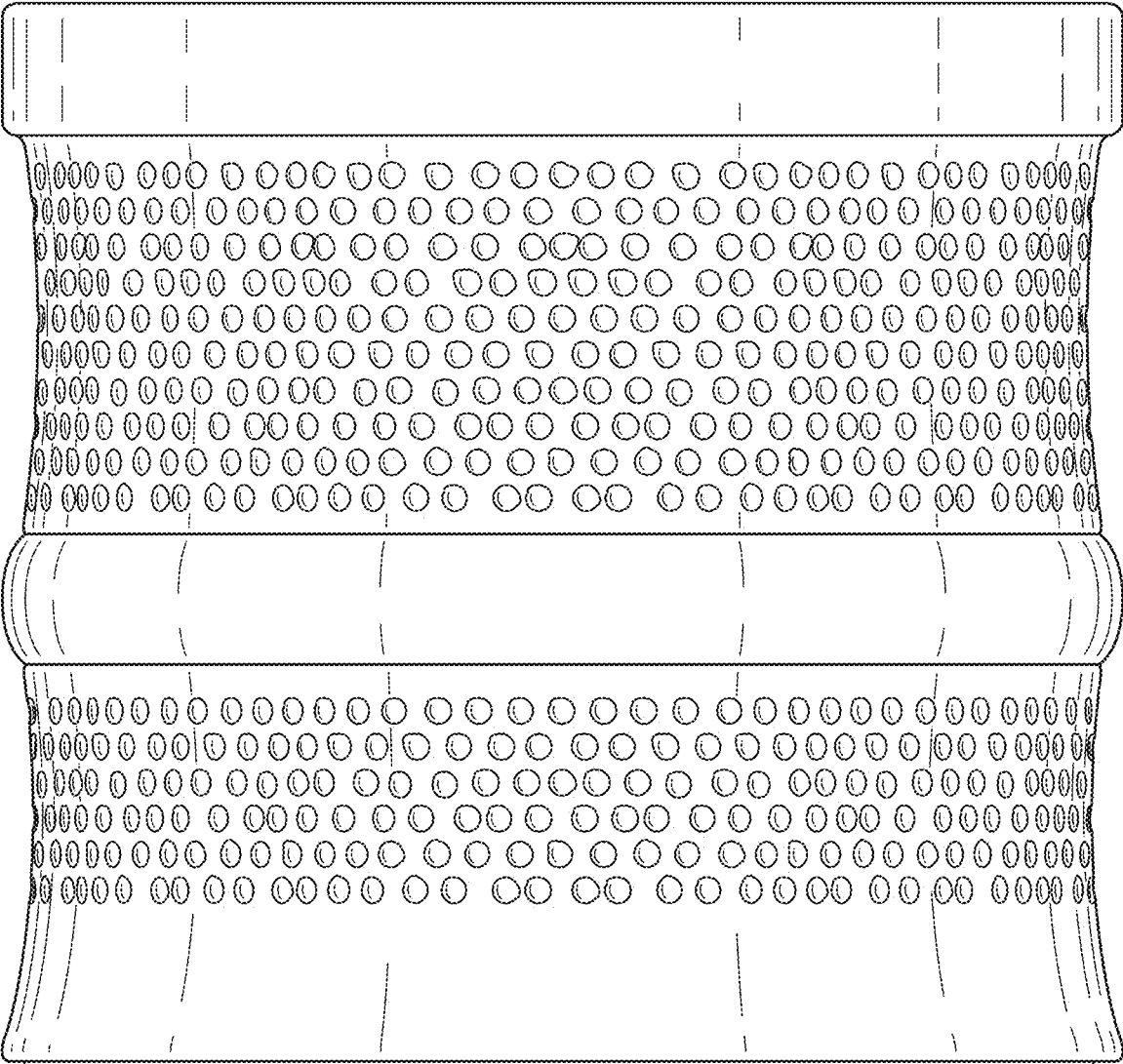
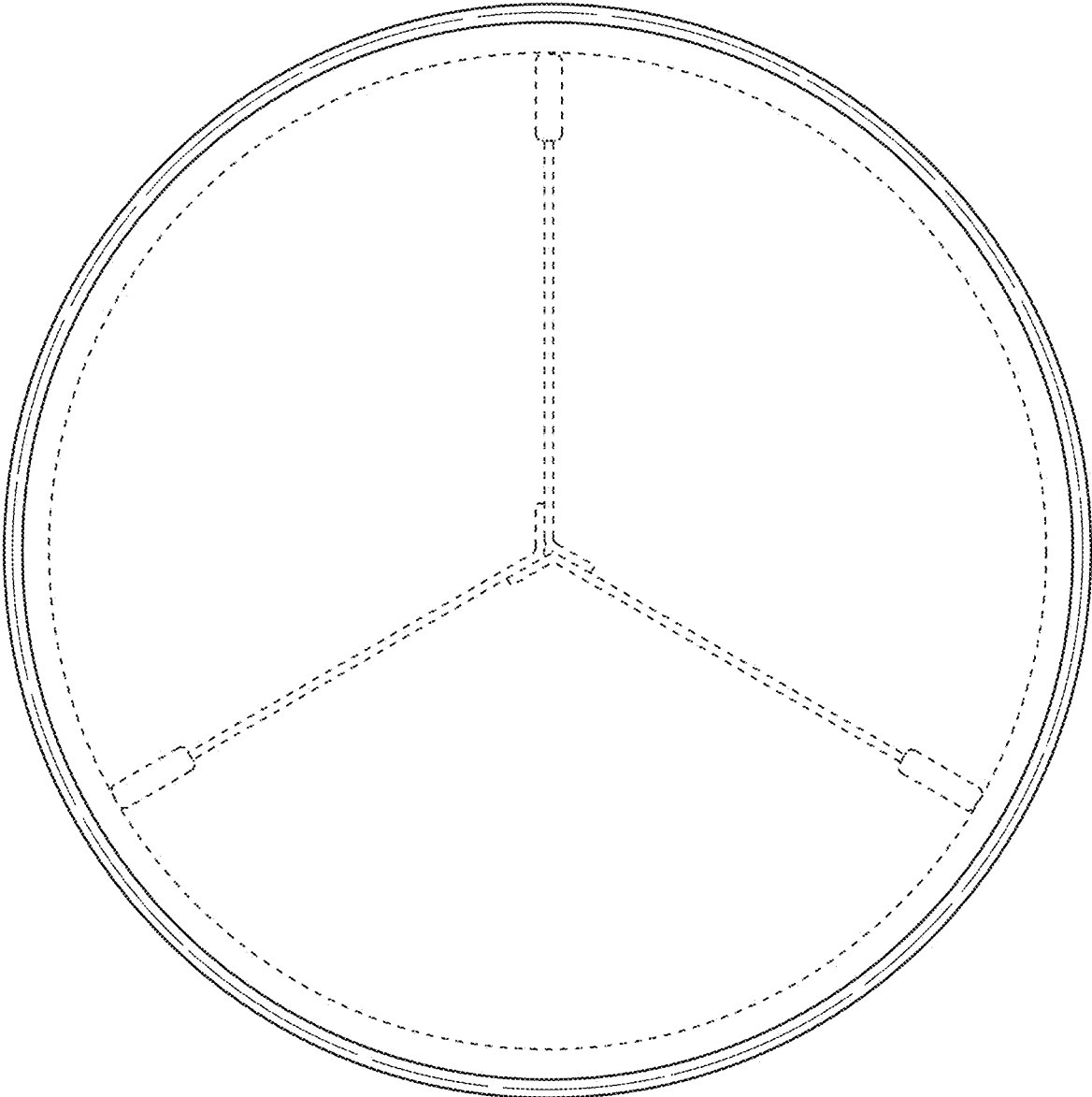


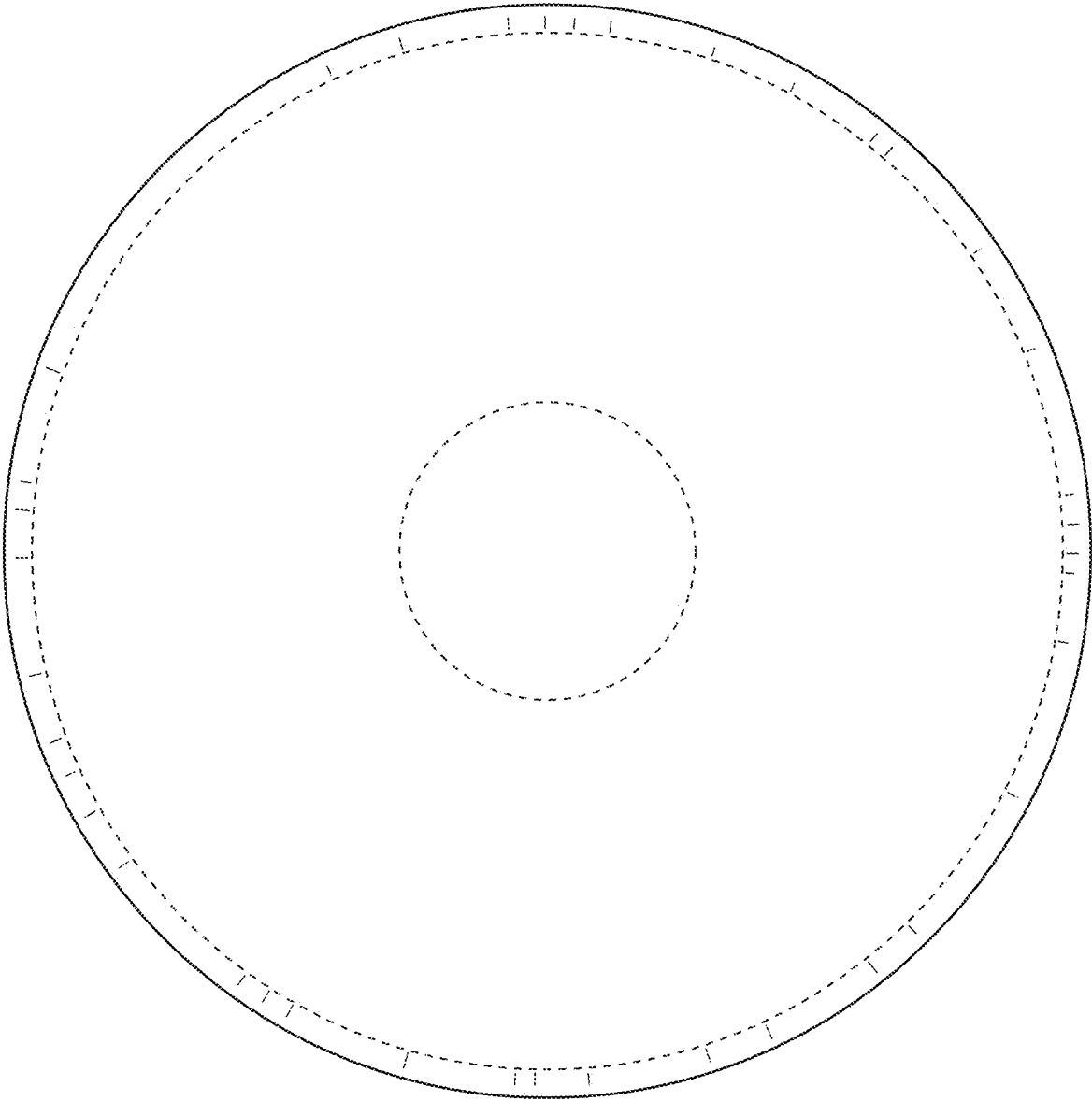
