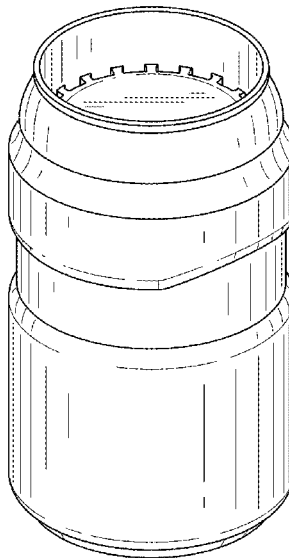
(57) **CLAIM**

The ornamental design for a container with lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the container with lid;
FIG. 2 is a front view of the container with lid;
FIG. 3 is a left side view of the container with lid;
FIG. 4 is a right side view of the container with lid;
FIG. 5 is a rear view of the container with lid;
FIG. 6 is a top view of the container with lid; and,
FIG. 7 is a bottom view of the container with lid.
The broken lines showing in the figures are included for the purpose of illustrating portions of the container with lid that form no part of the claimed design. The dash-dot lines showing in the figures are included for defining the bounds of the claimed design that form no part thereof.

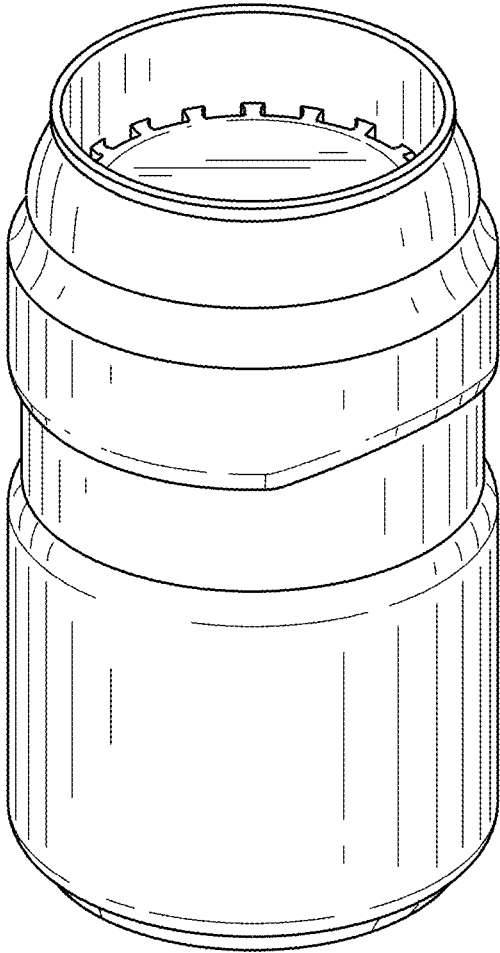

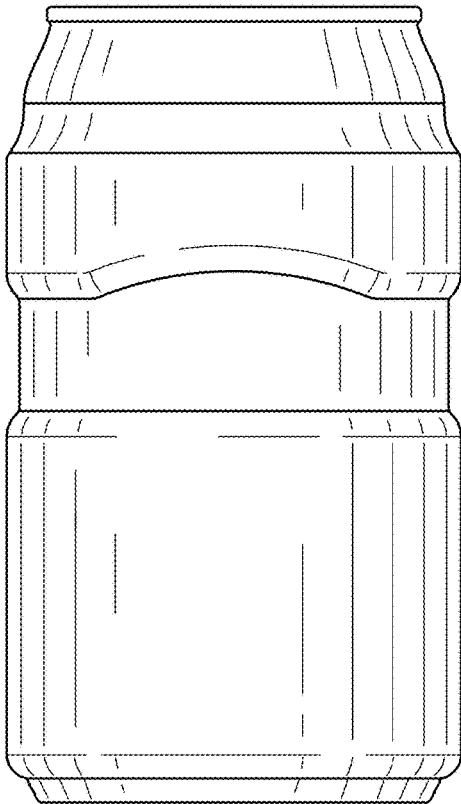

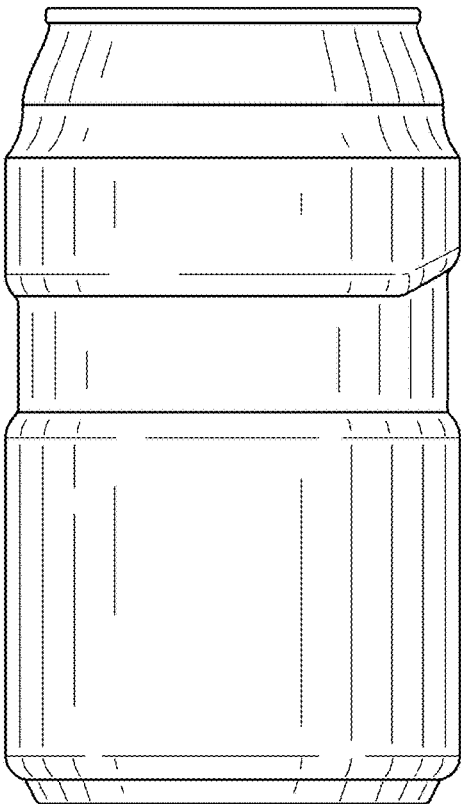

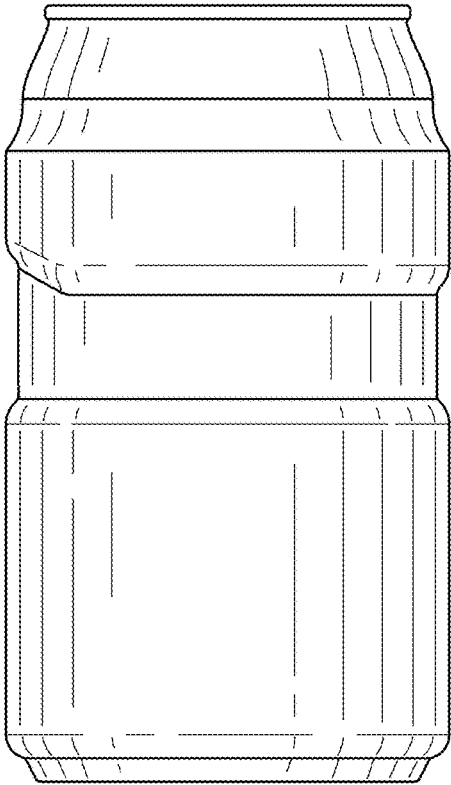

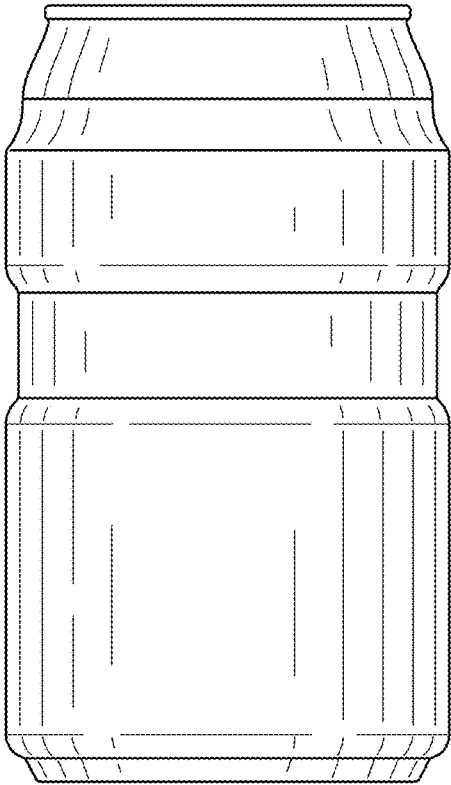

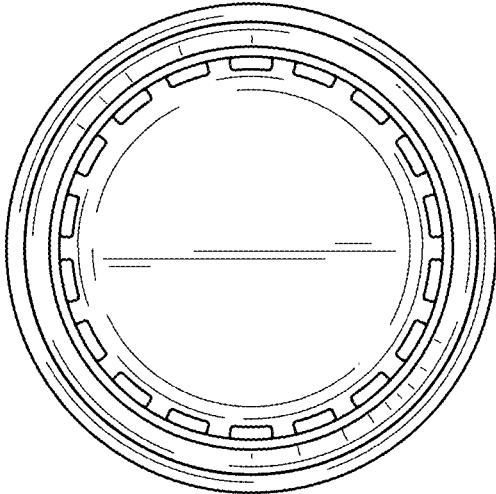

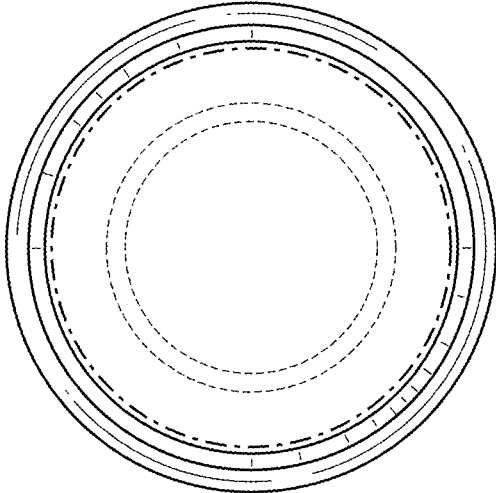
