FIG. 1 is a front elevational view of a baby food thermos showing my new design;

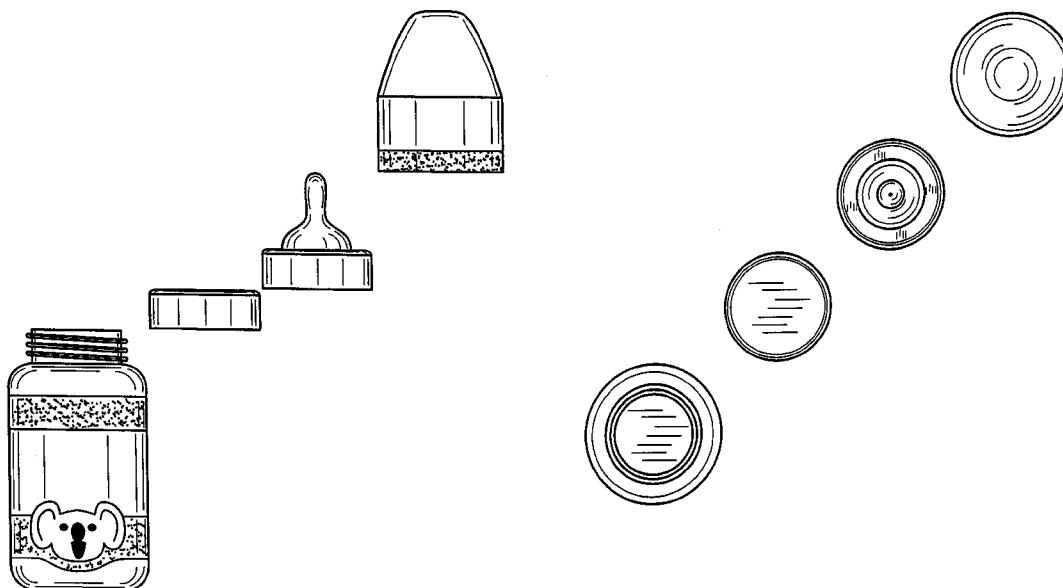
FIG. 2 is a back elevational view thereof;

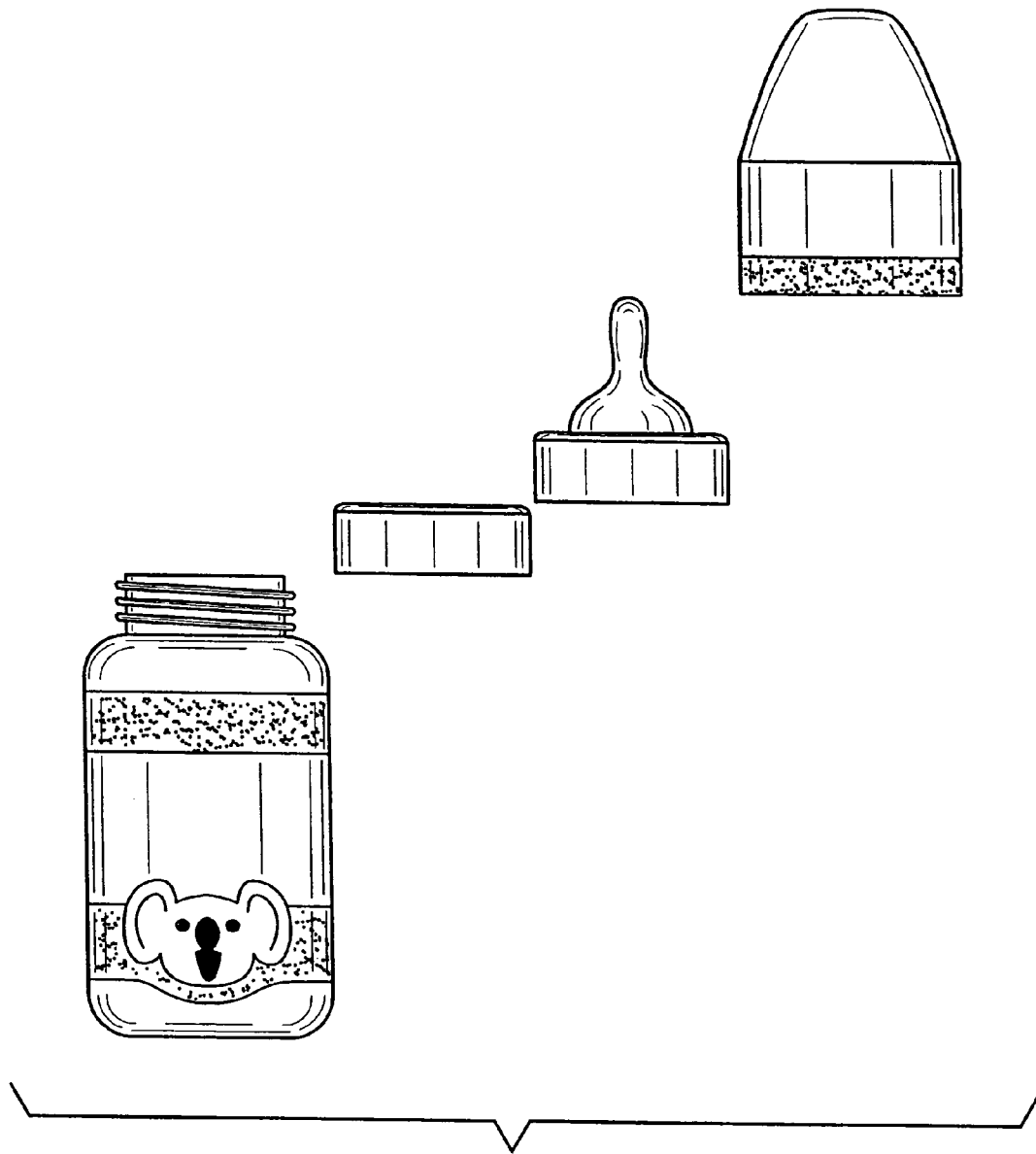

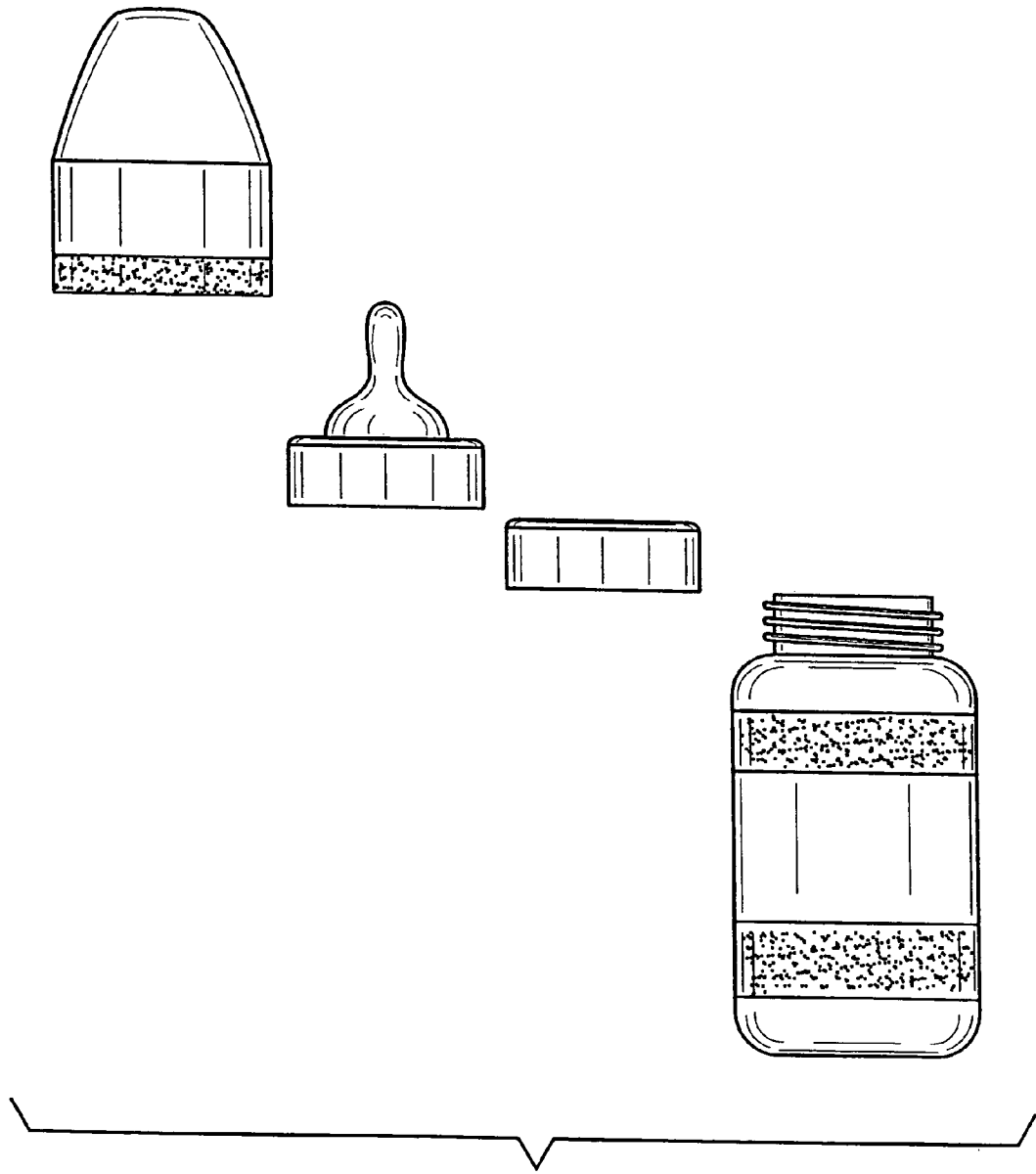

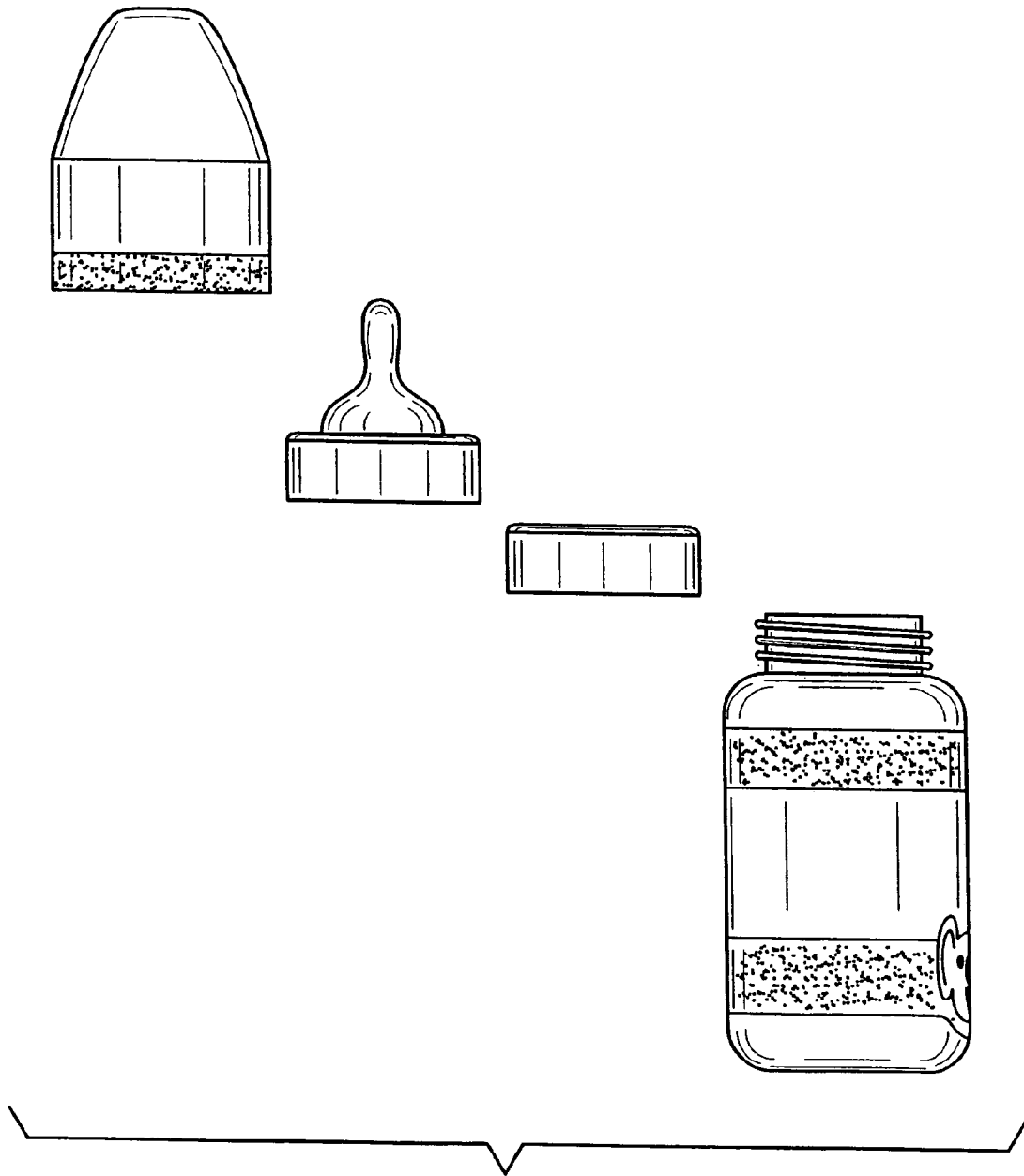

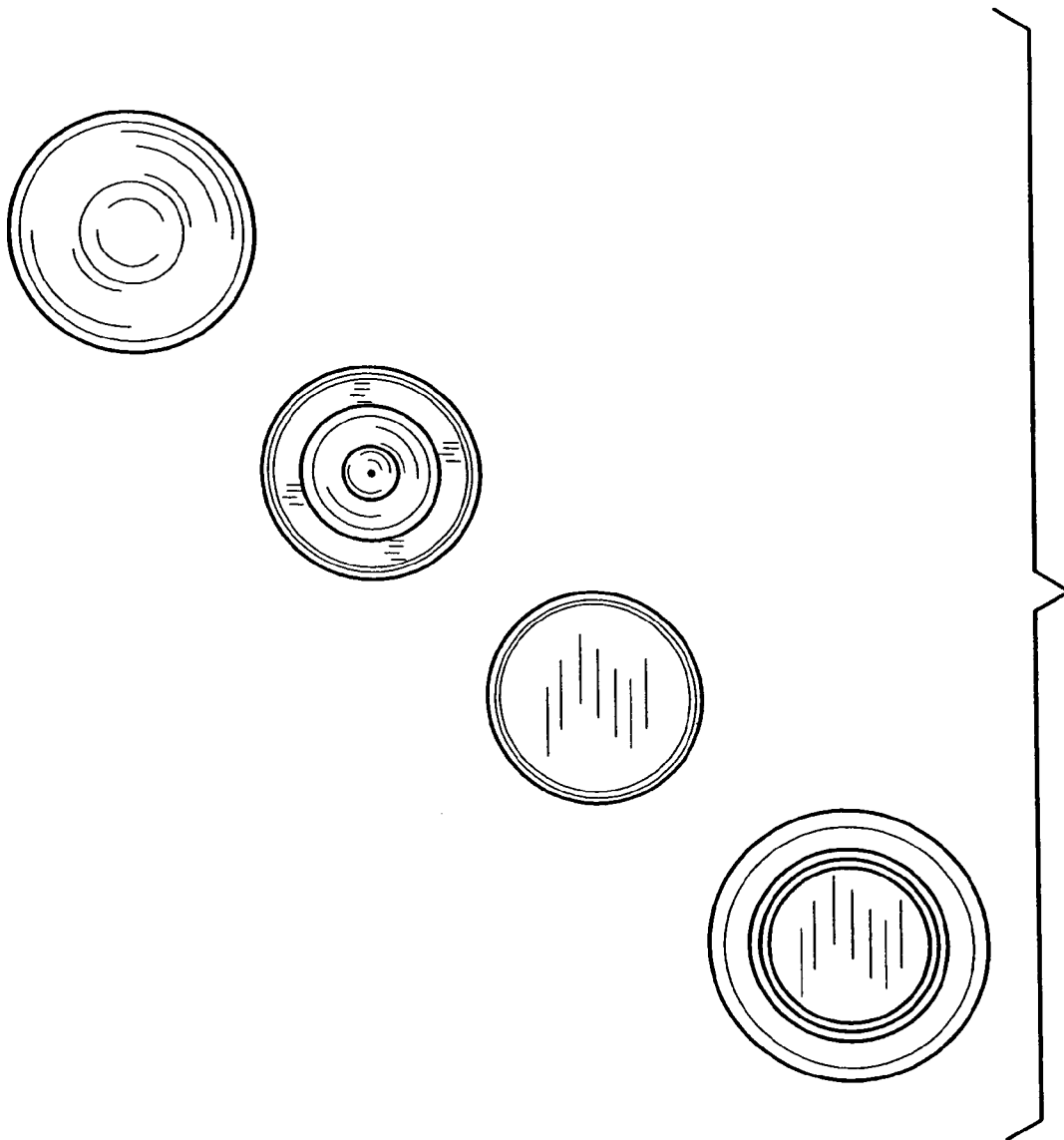
