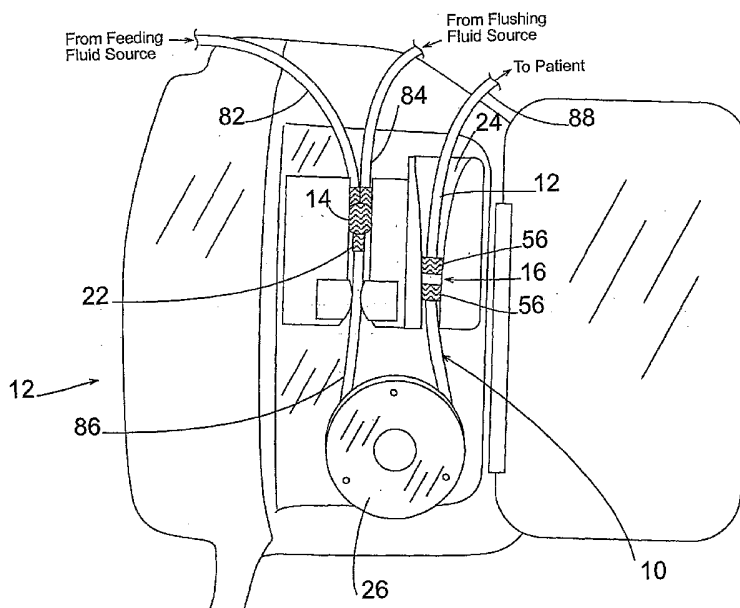

(54) Title: ADMINISTRATION FEEDING SET AND VALVE MECHANISM



(57) Abstract: An administration feeding set (10) adapted to be loaded to a flow control apparatus (12) is disclosed. The administration feeding set (10) comprises tubing (60) adapted suitably for fluid flow, a valve mechanism (14) suitable for loading the administration feeding set (10) to the flow control apparatus (12), and a mounting member (16) adapted suitably for permitting identification of the functional configuration of the administration feeding set (10). Also disclosed is a method for administering fluid utilizing the administration feeding set (10). There are also disclosed novel valve mechanisms (14).
