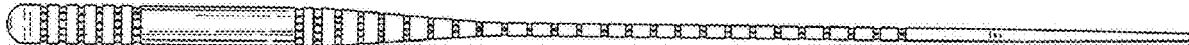
The ornamental design for a worm fishing lure, as shown.

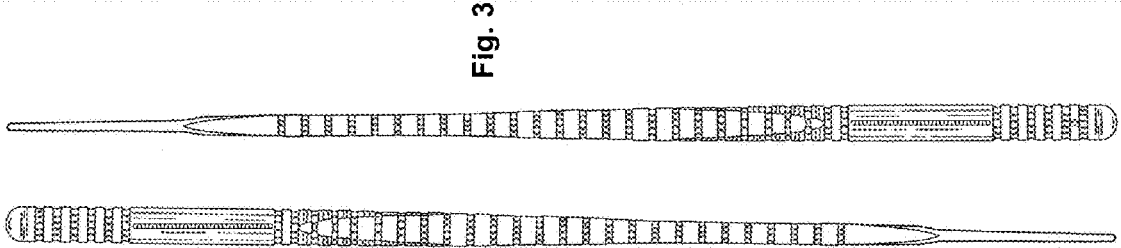
