FIG. 4 is a left plan view of a skewer;

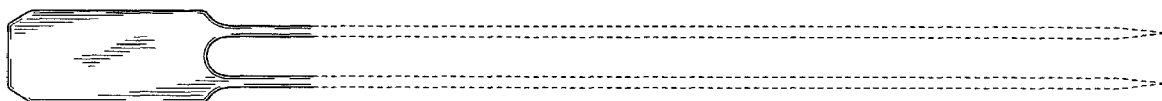
FIG. 5 is a right plan view of a skewer;

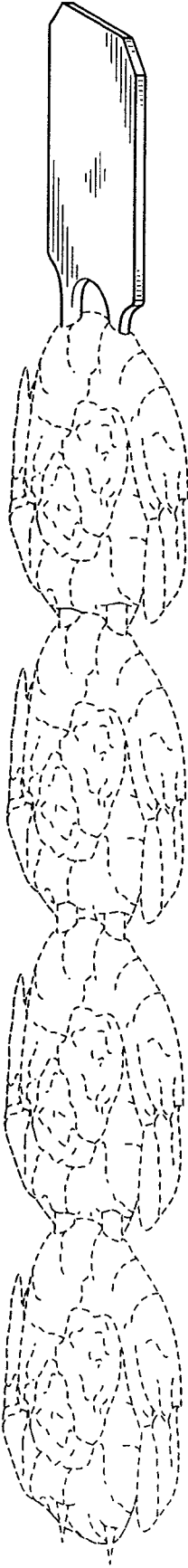

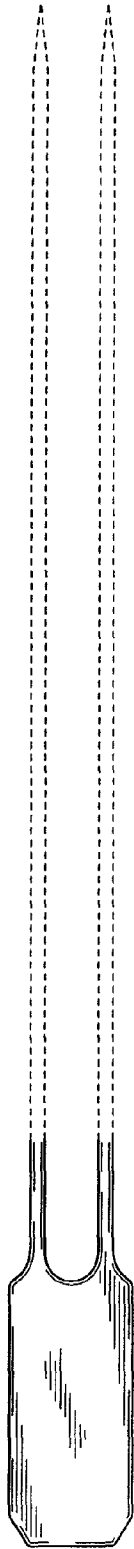

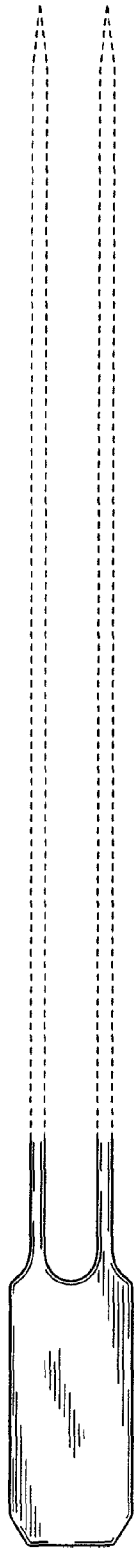

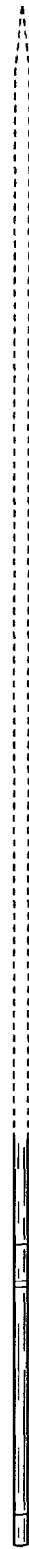

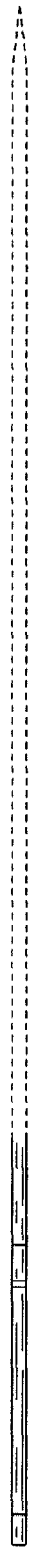

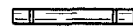
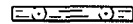
