(57) **CLAIM**

The ornamental design for garment with medical access openings, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a garment with medical access openings, illustrated with the front of the garment, the bottom of the garment and the medical access openings in a zipped position, showing my new design.

FIG. 2 is a top view thereof.

FIG. 3 is a front elevational view thereof, with all zippered access openings in a zipped position.

FIG. 4 is a bottom plan view thereof.

FIG. 5 is a rear elevational view thereof.

FIG. 6 is a left-side elevational view thereof.

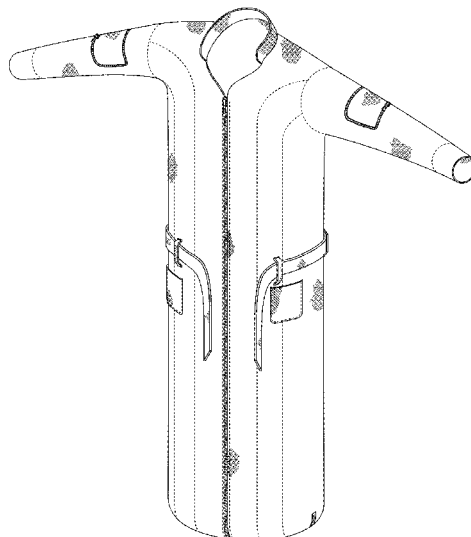
FIG. 7 is a right-side elevational view thereof.

FIG. 8 is a front perspective view thereof, with the front garment in an unzipped position, the bottom of the garment in a fully unzipped position, and the medical access openings in a partially unzipped position; and,

FIG. 9 is a front view thereof, with the medical access openings fully removed.

The dash-dash lines illustrate stitching that forms part of the claimed design.

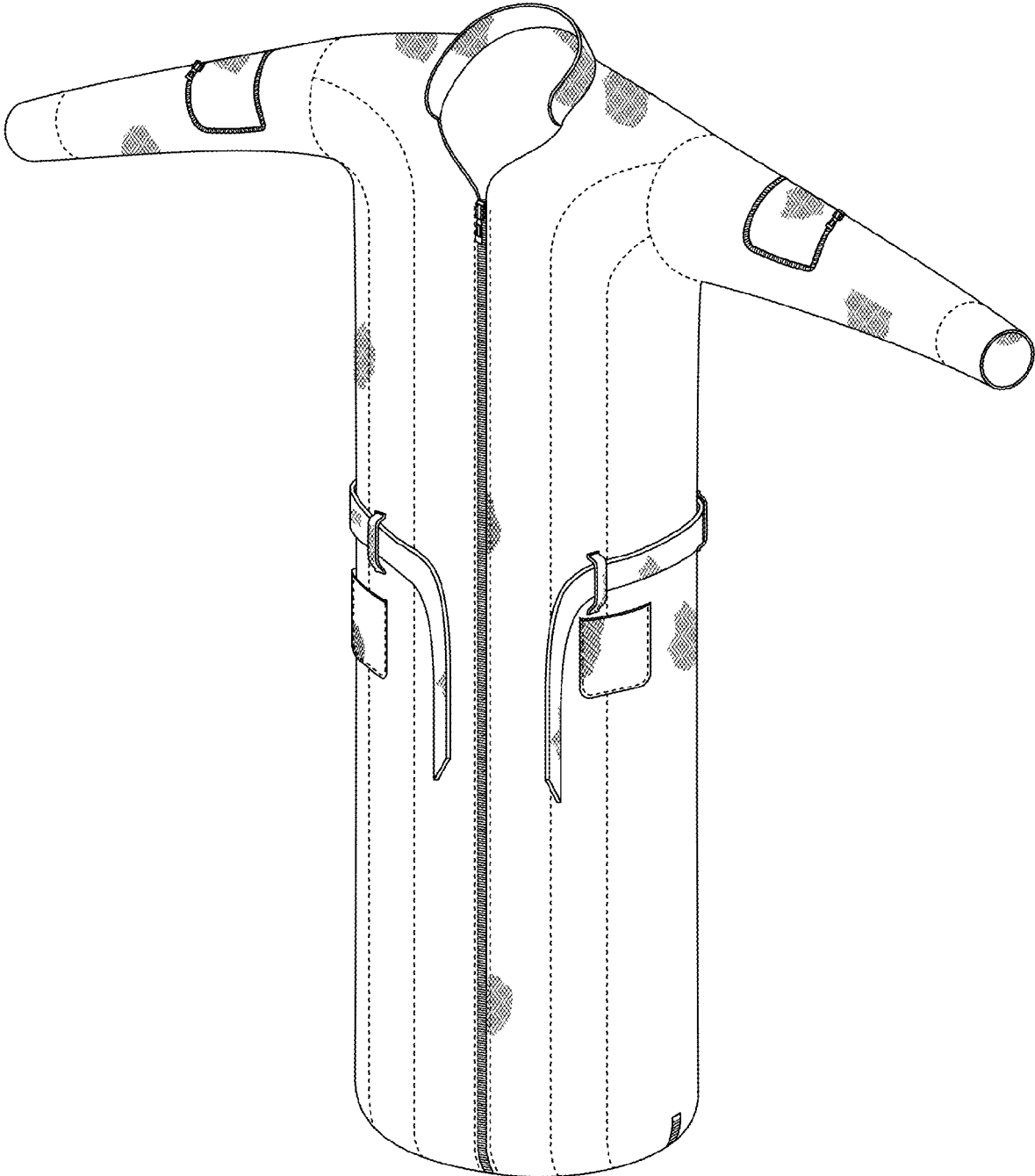

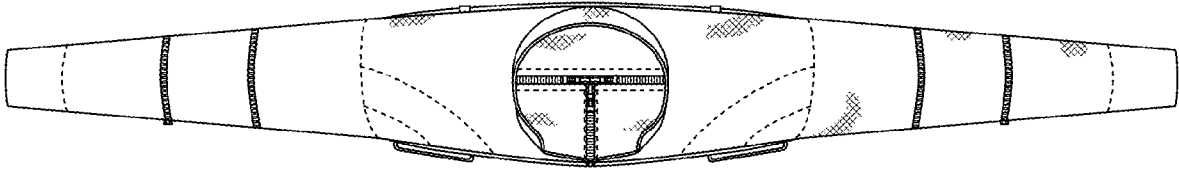

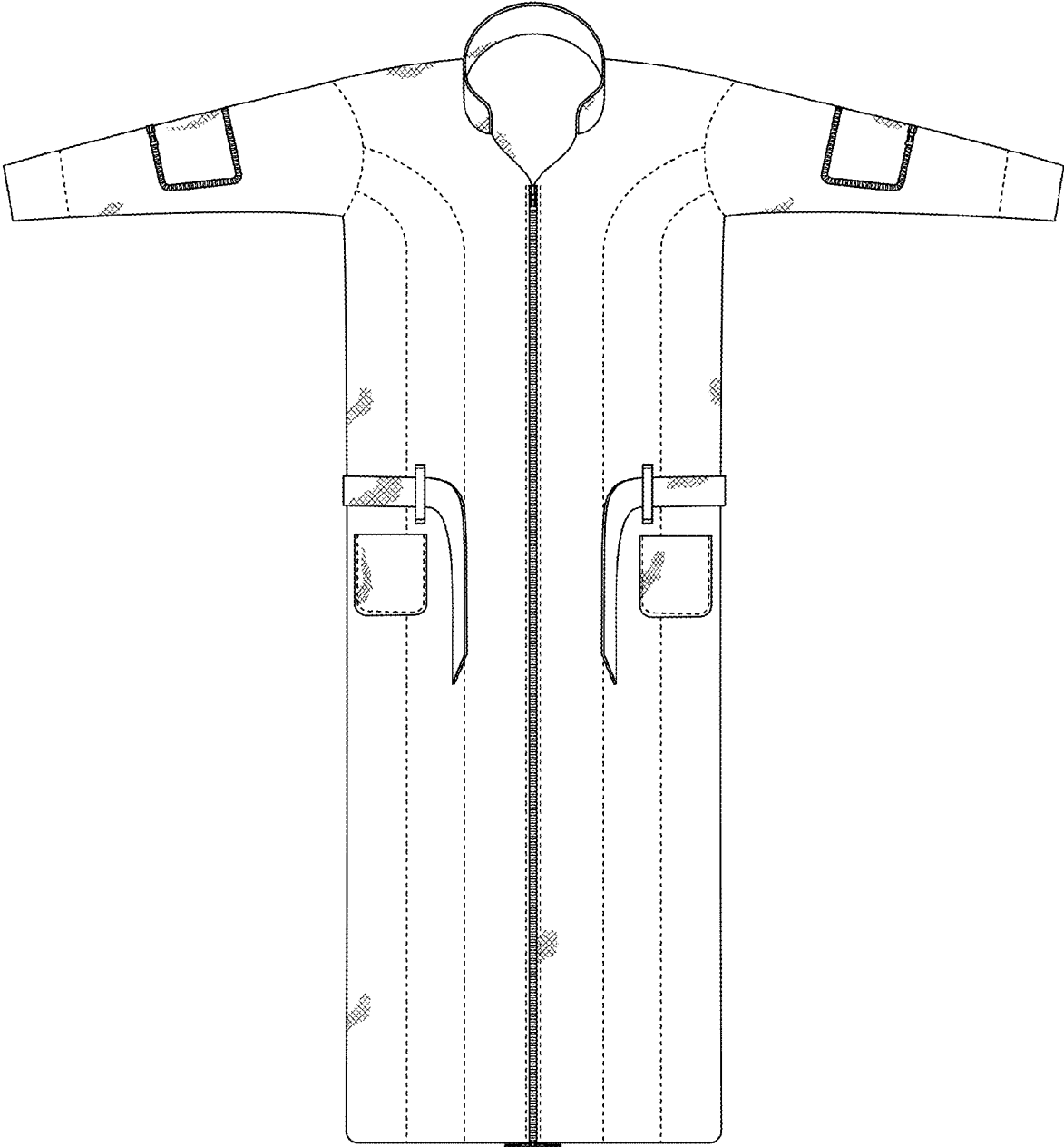

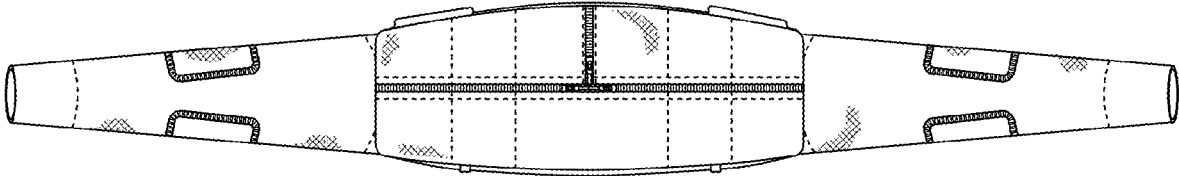

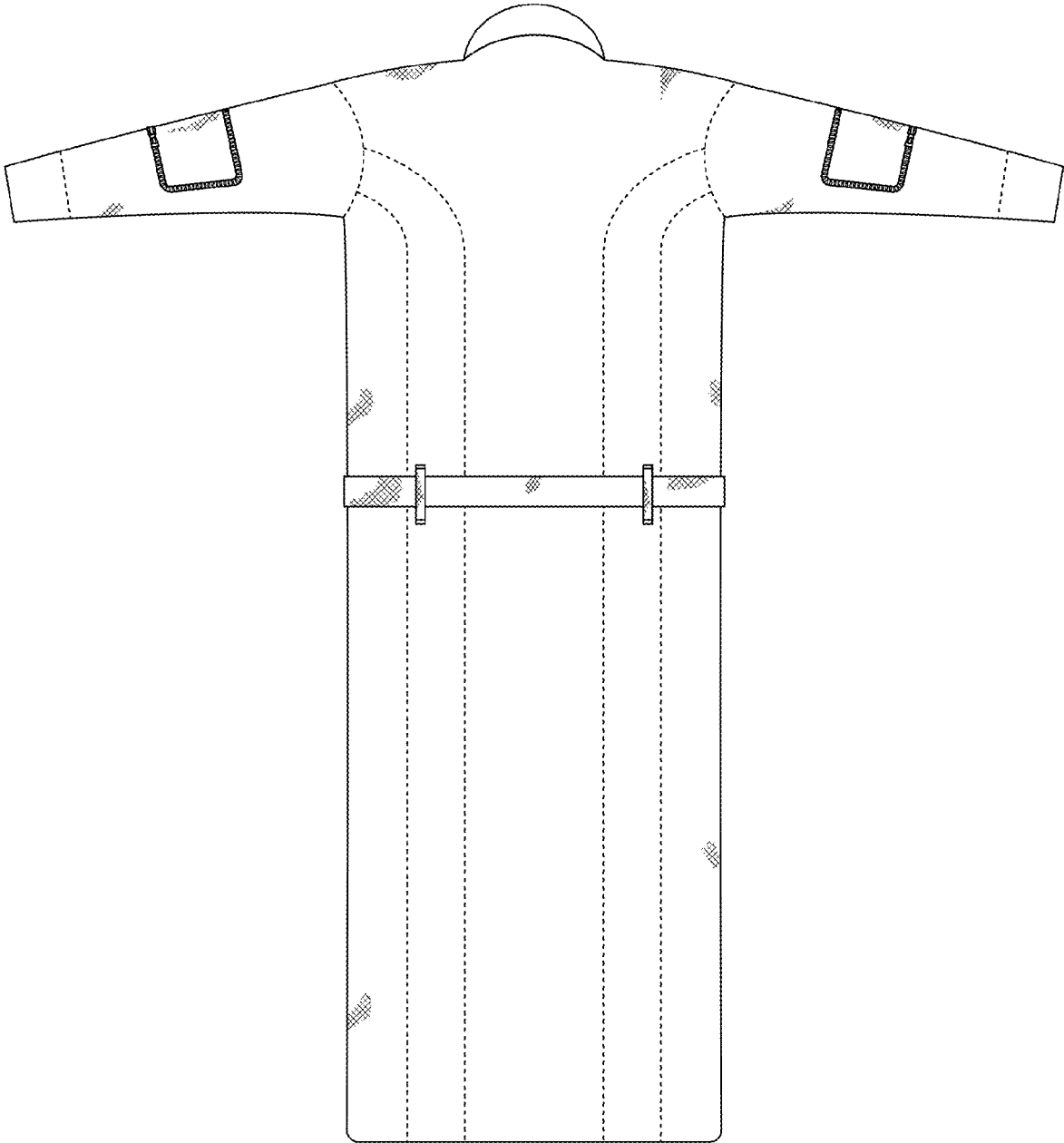

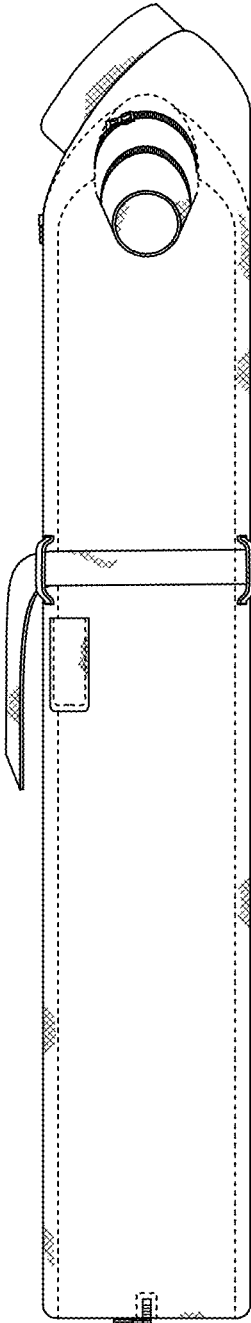

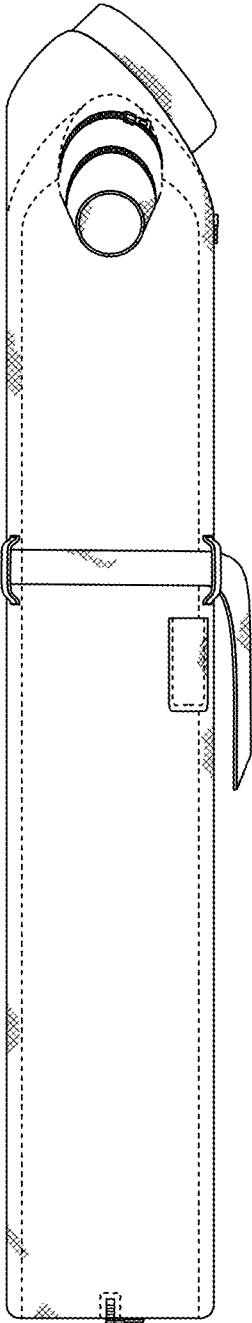

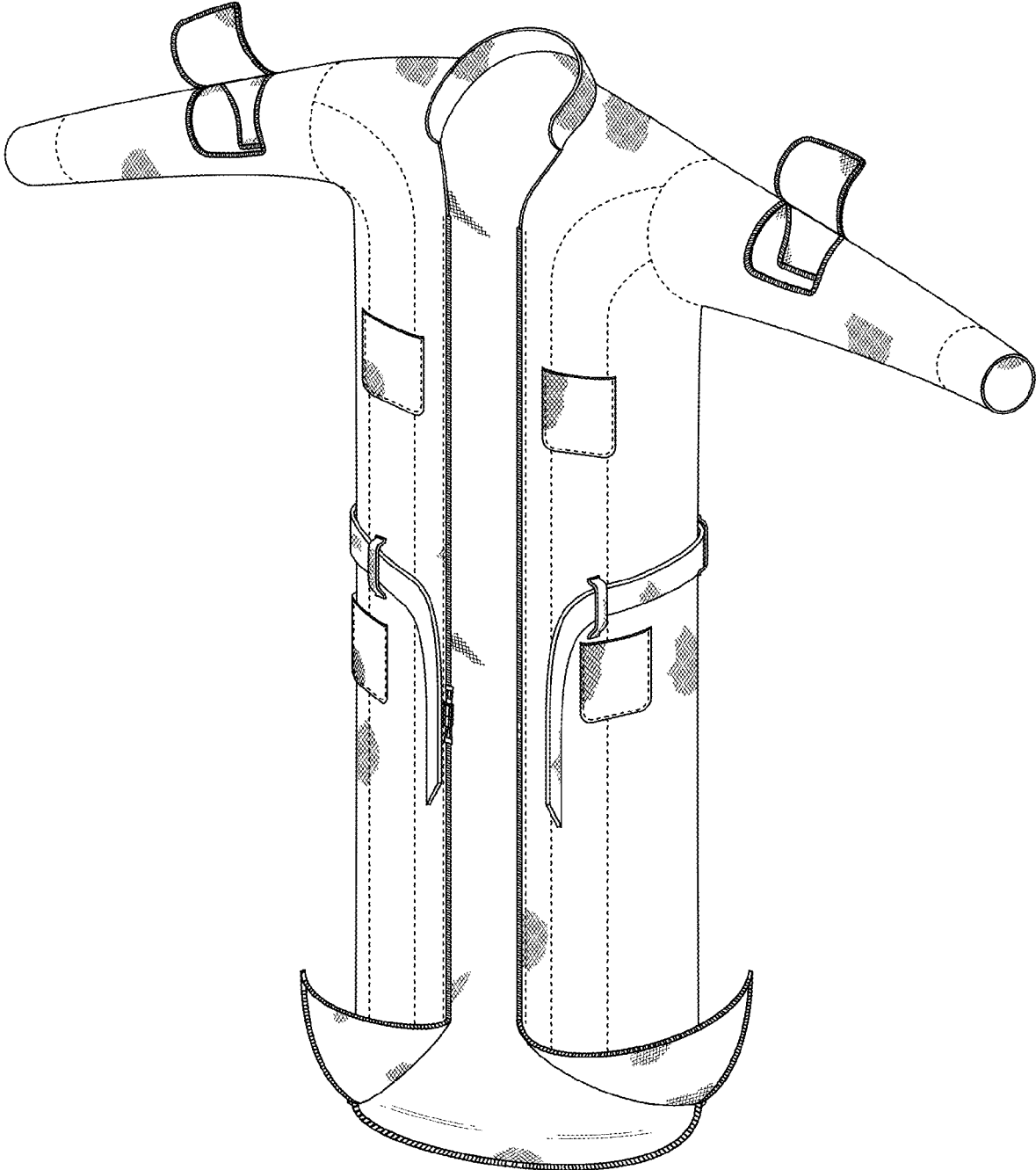

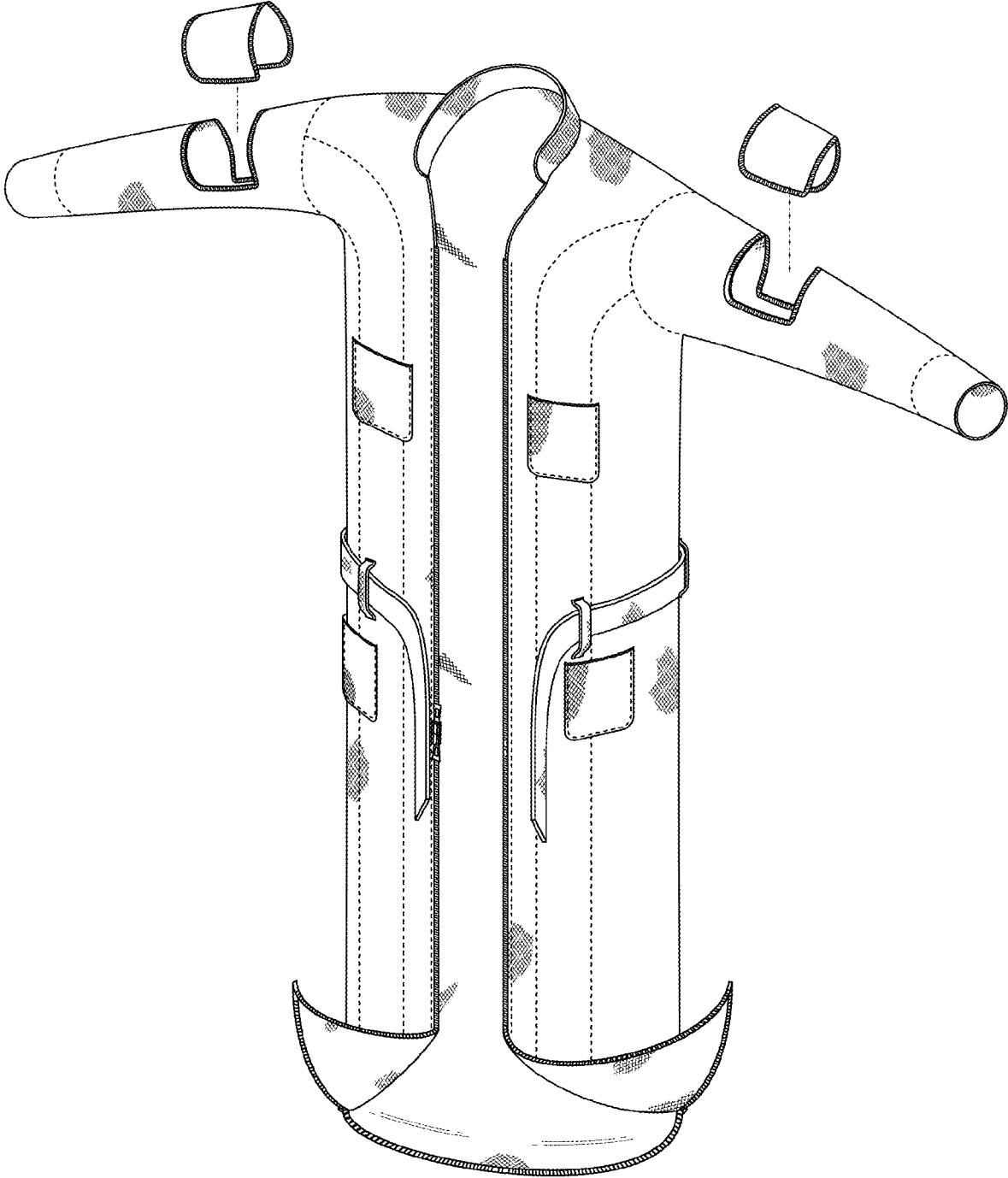
