The ornamental design for a cord lock, as shown and described.

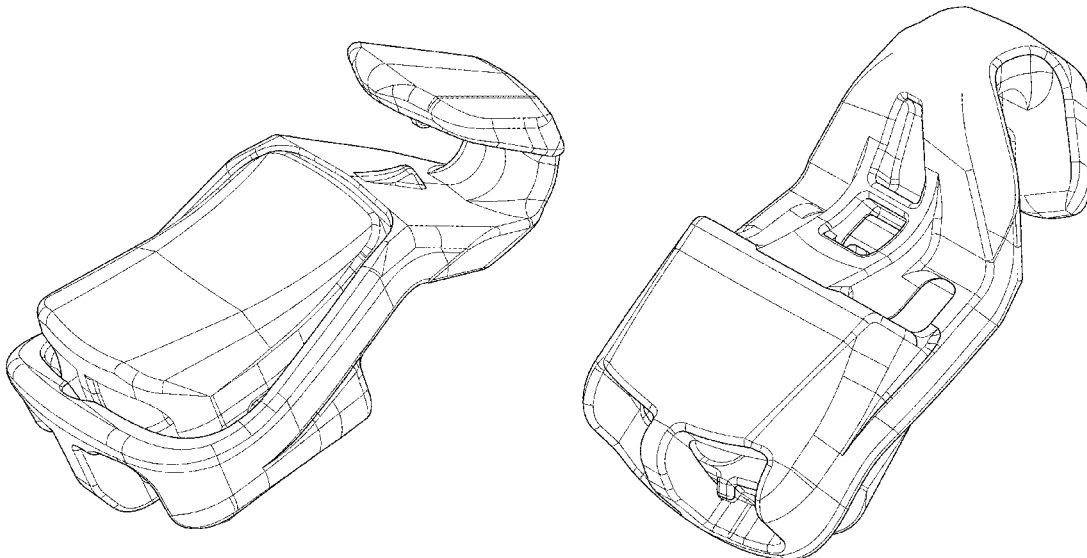
DESCRIPTION

FIG. 1 is a first perspective view of a cord lock showing my new design;
FIG. 2 is a second perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a right side view thereof;
FIG. 8 is a left side view thereof; and,
FIG. 9 is a cross-sectional view thereof along the line 9-9 in FIG. 3.

Outer thick lines indicate outer shapes of the cord lock, and inner thin lines indicate inner contour of the cord lock for illustration purpose.

The broken lines depict portions of the cord lock that form no part of claimed design.

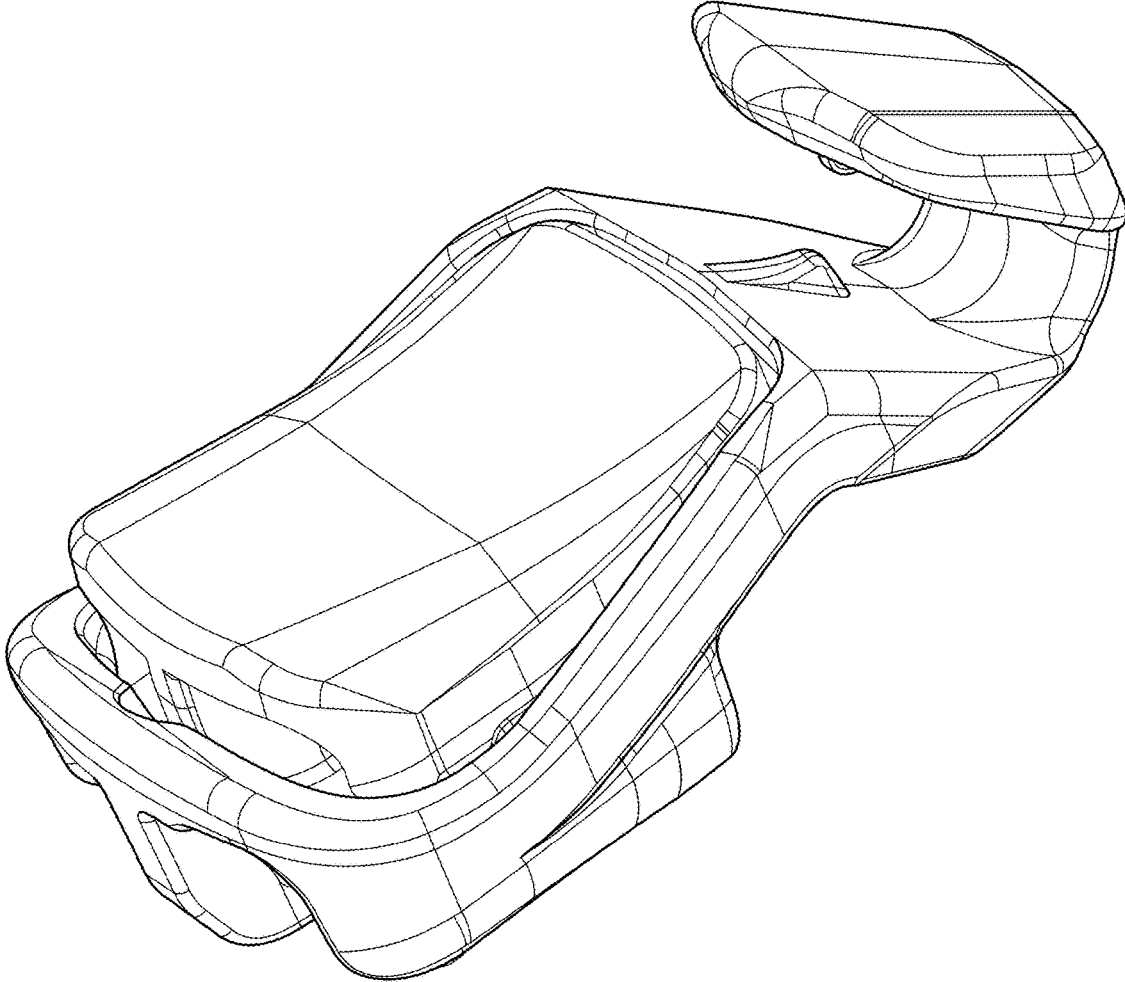

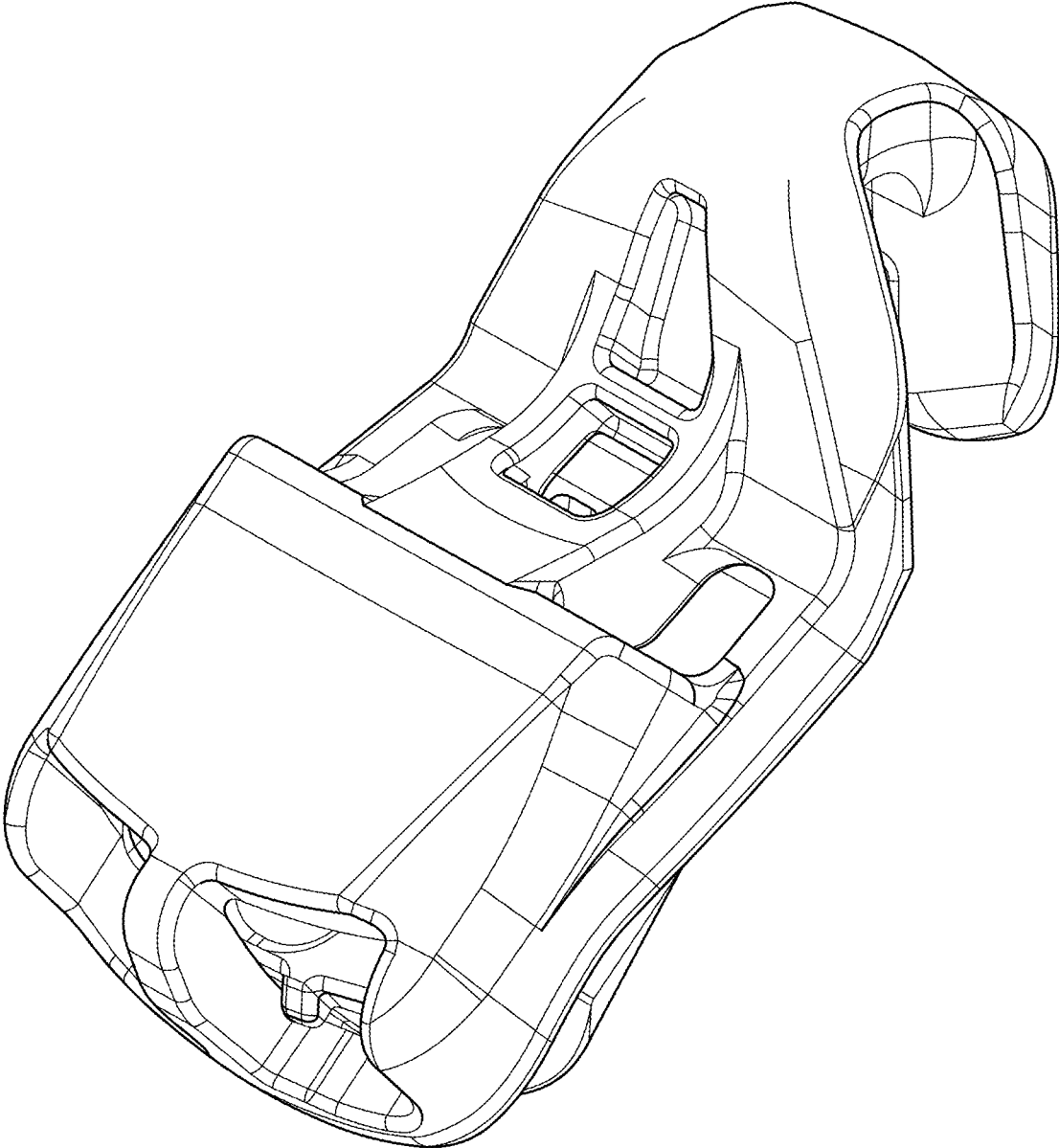

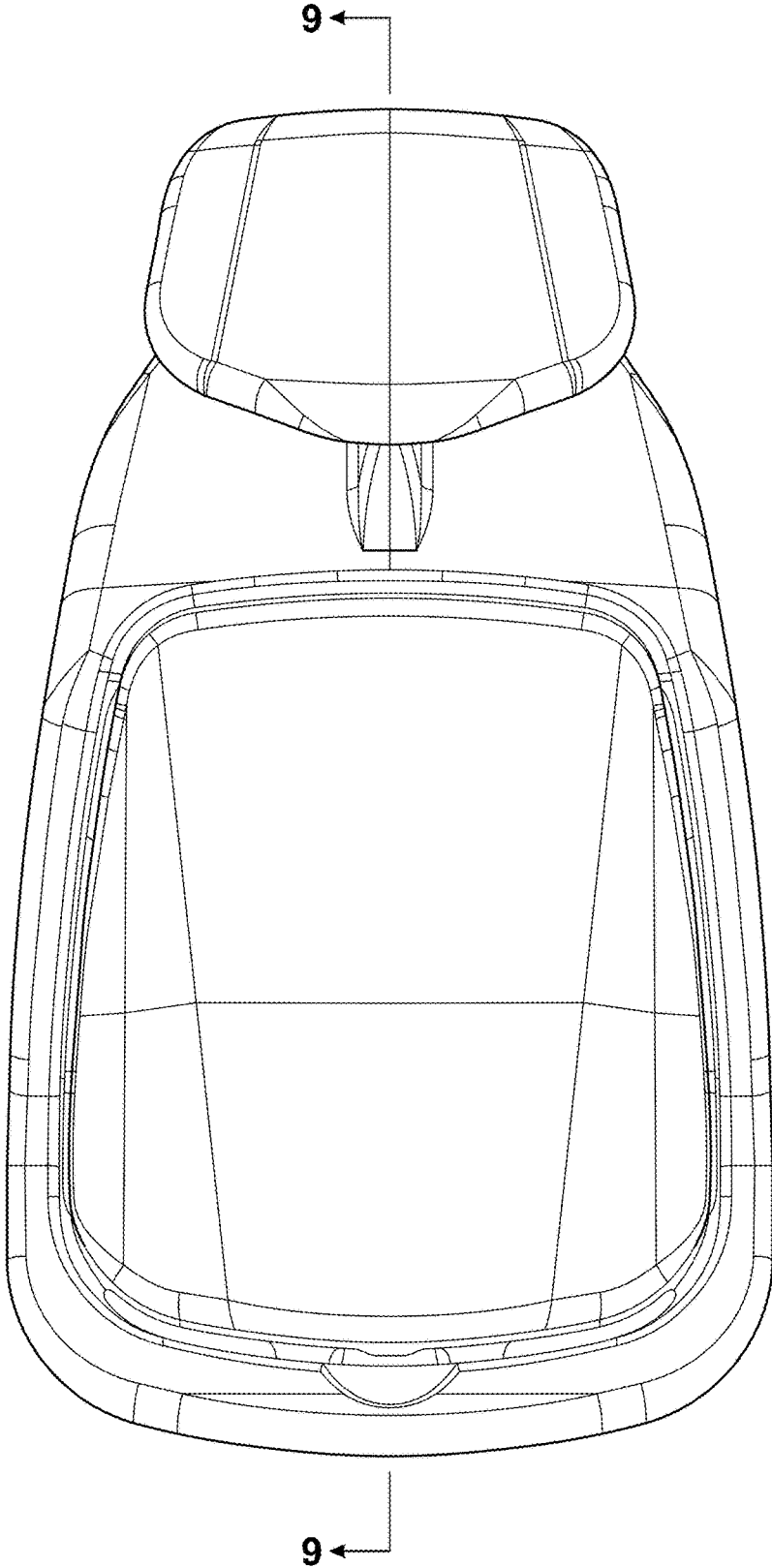

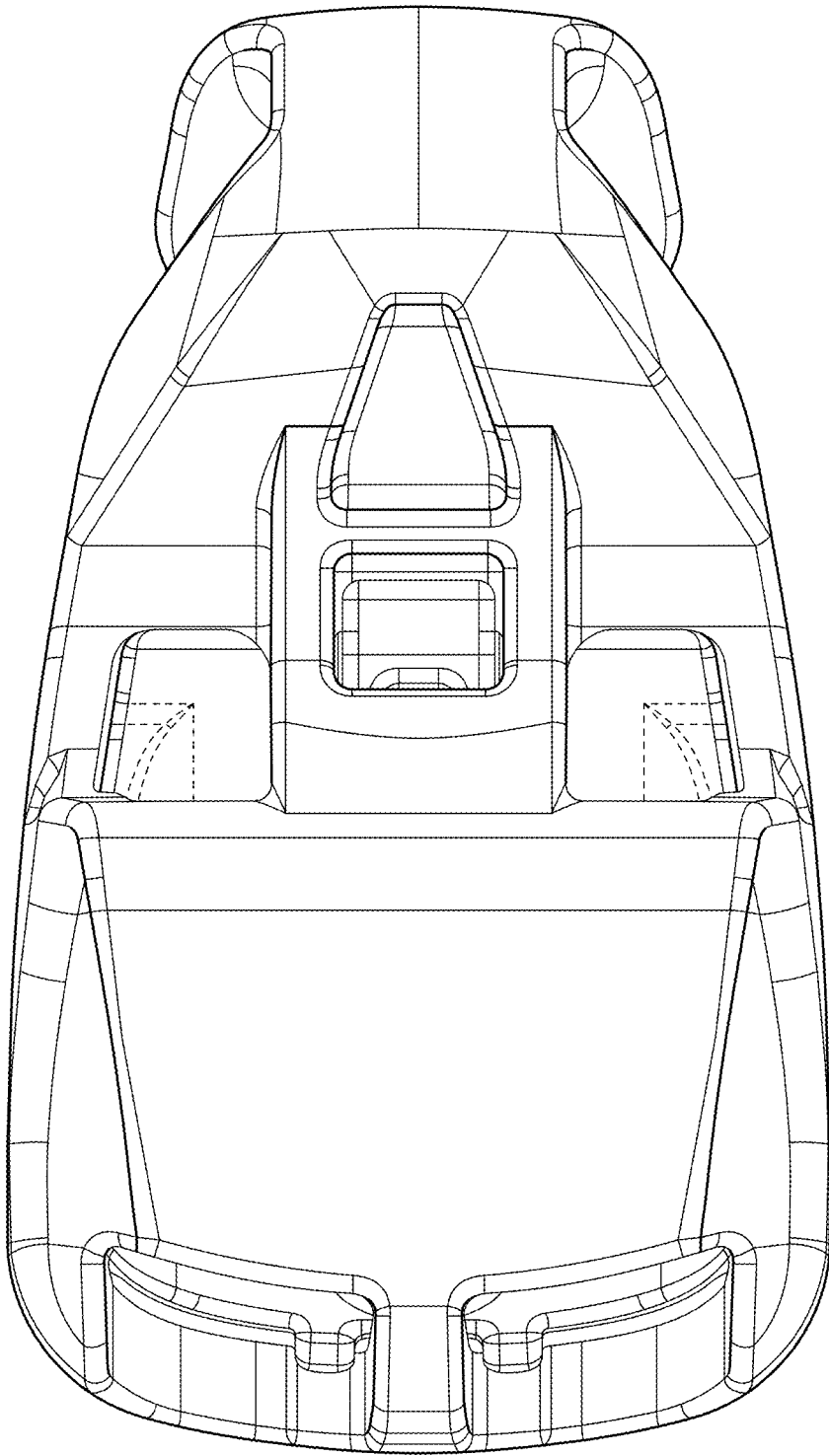

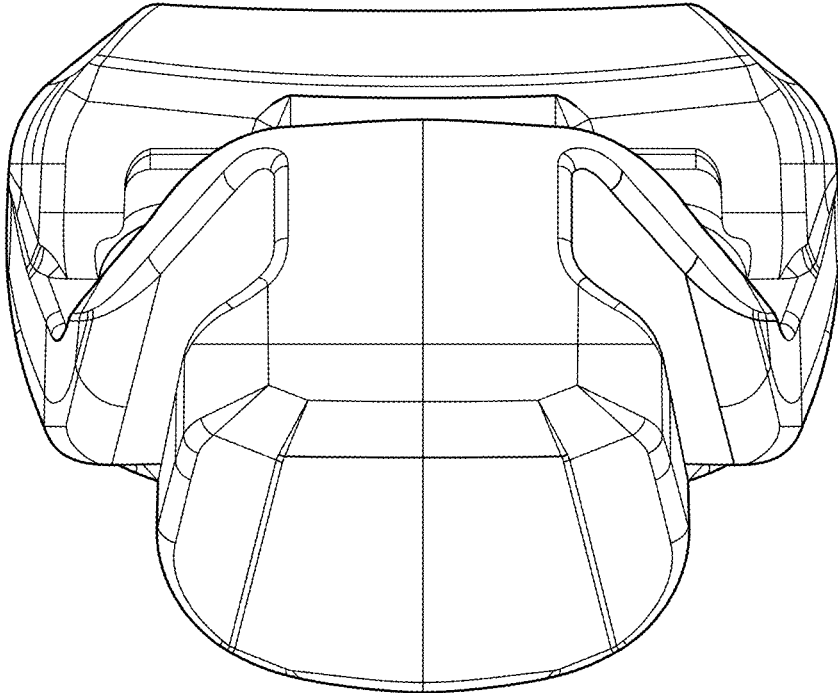

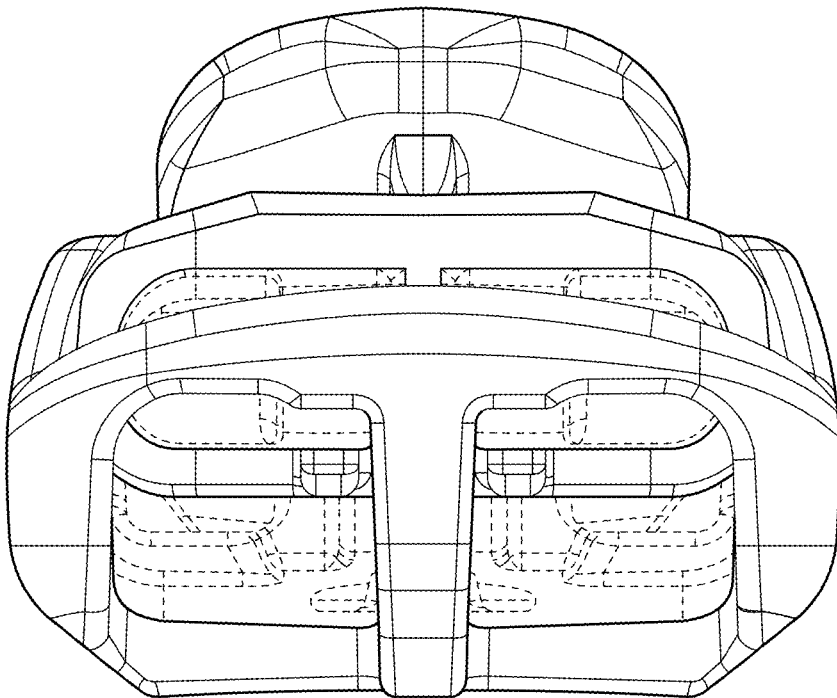

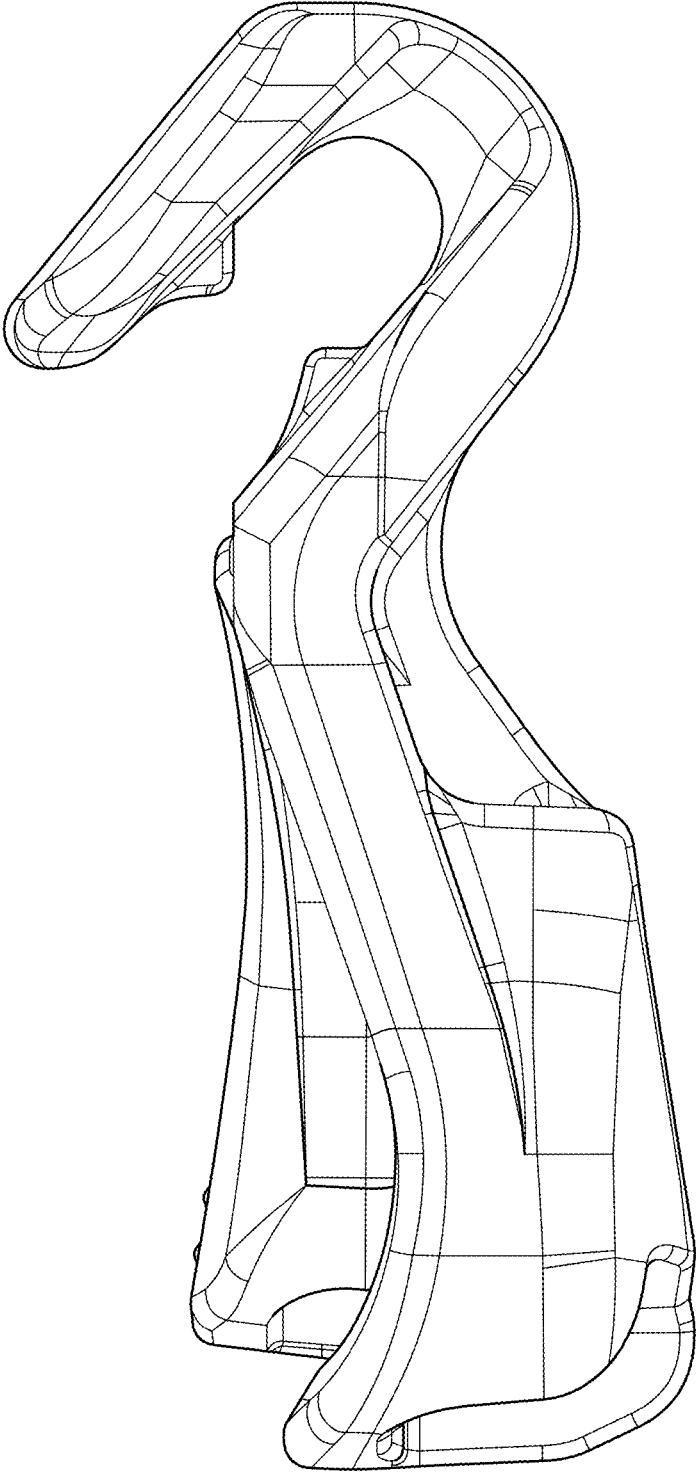

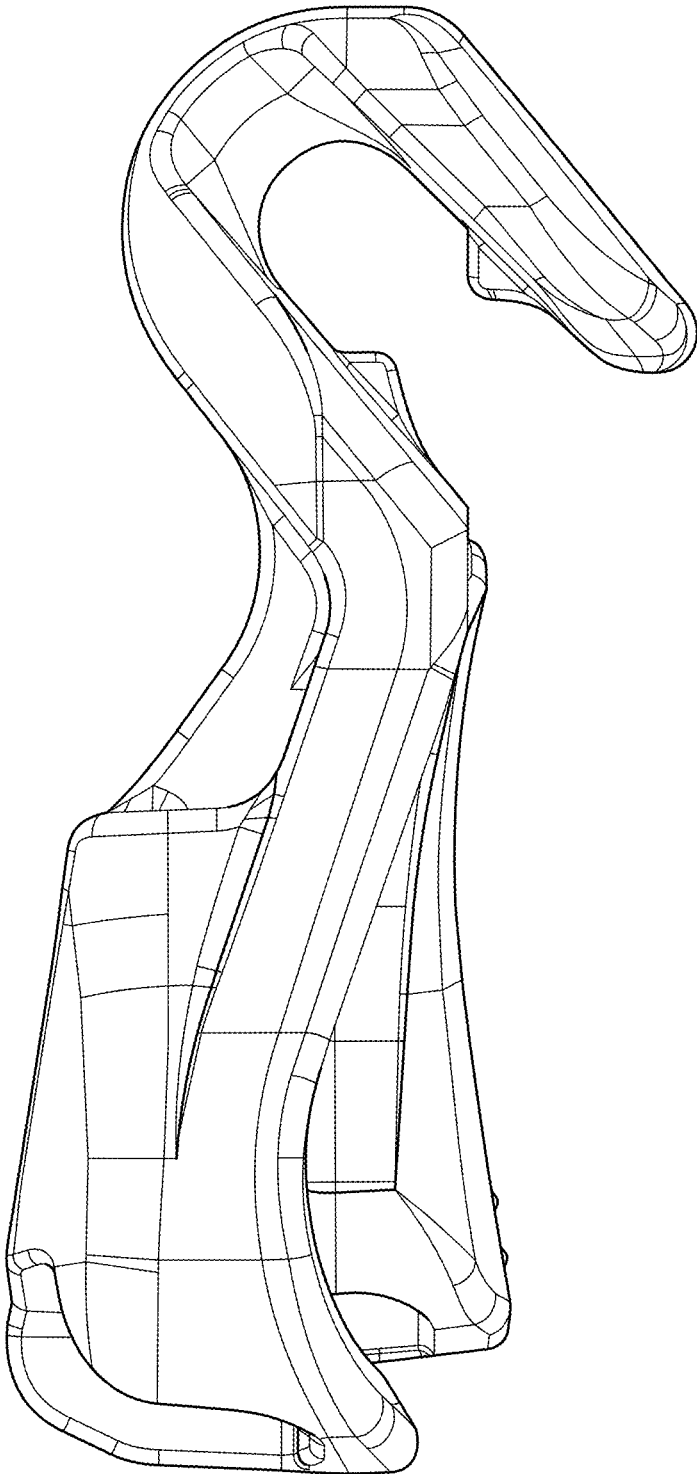

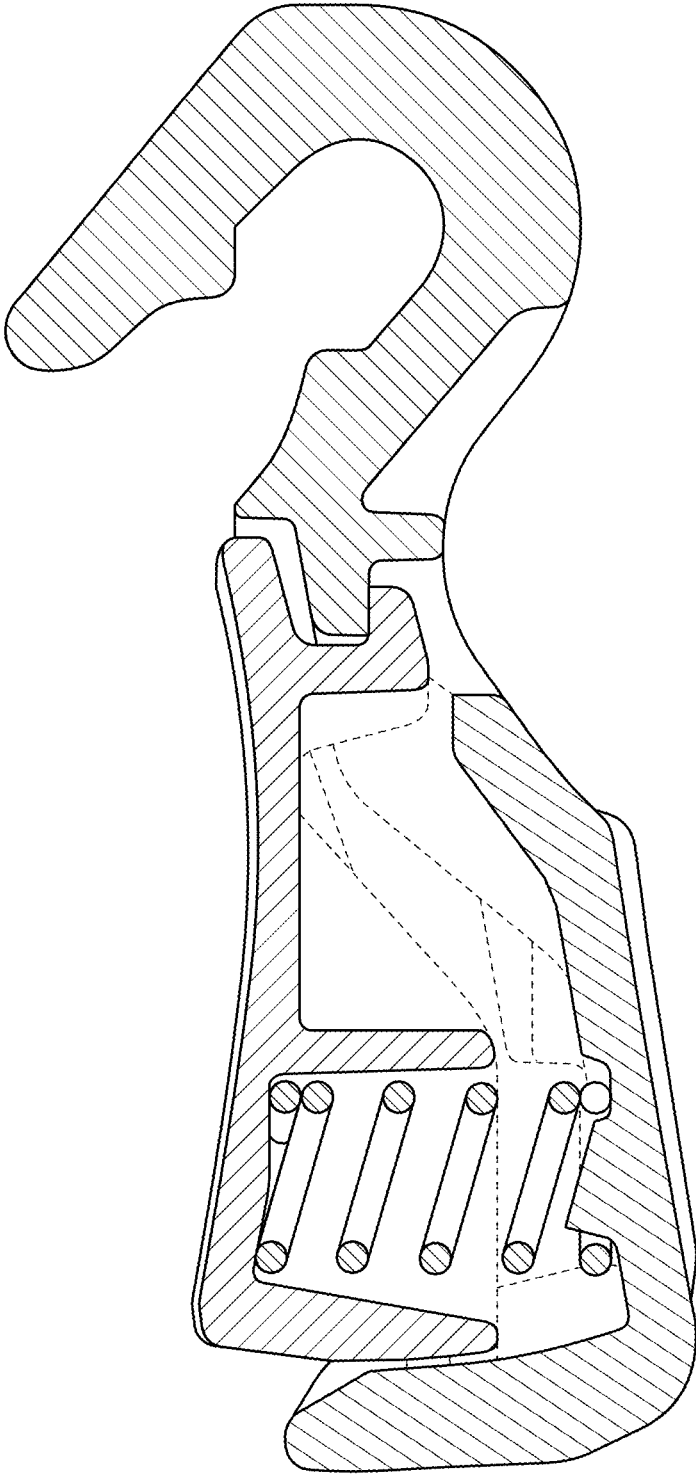
