DESCRIPTION

FIG. 3 is a side elevational view thereof from the left of FIG. 2;

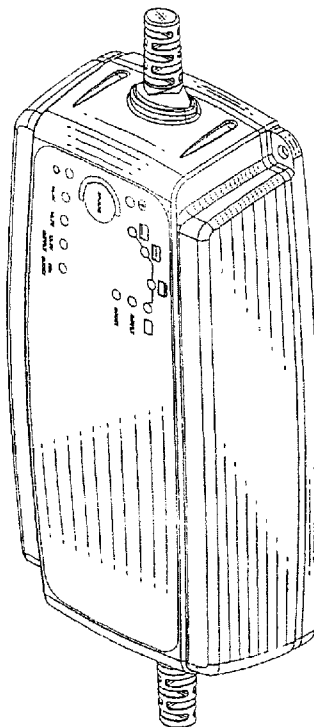
FIG. 4 is a side elevational view thereof from the right of FIG. 2;

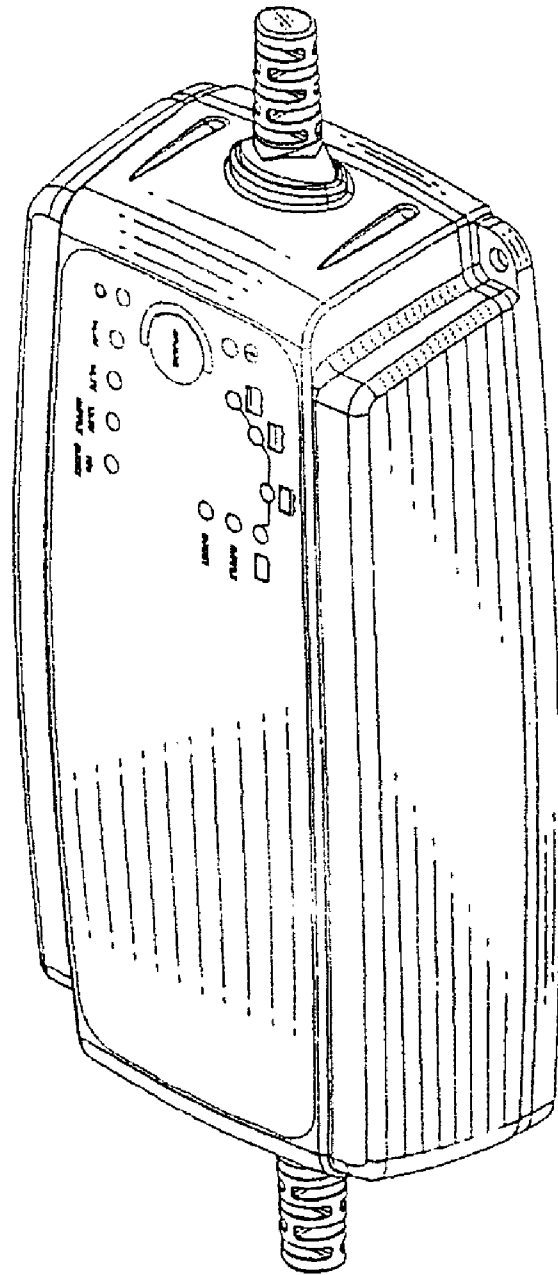

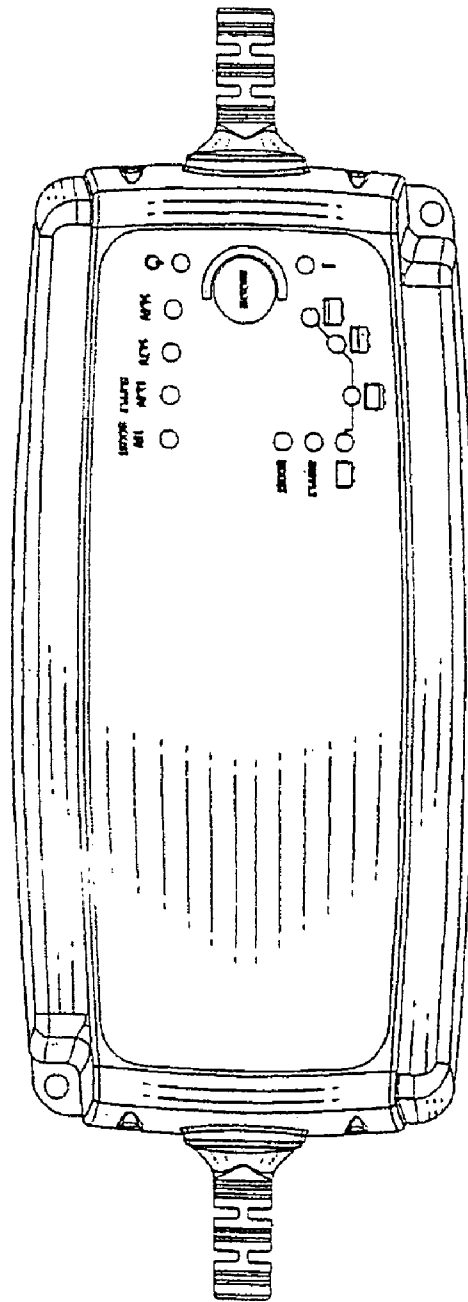

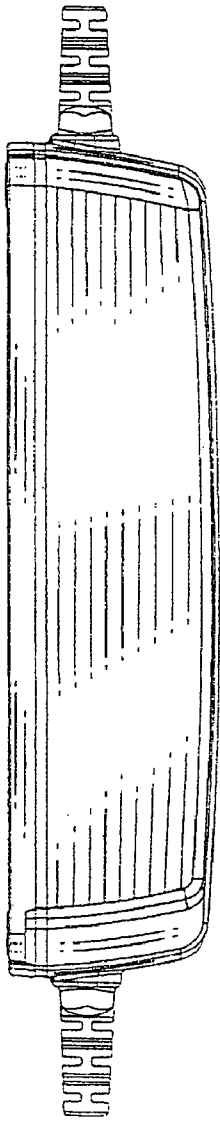

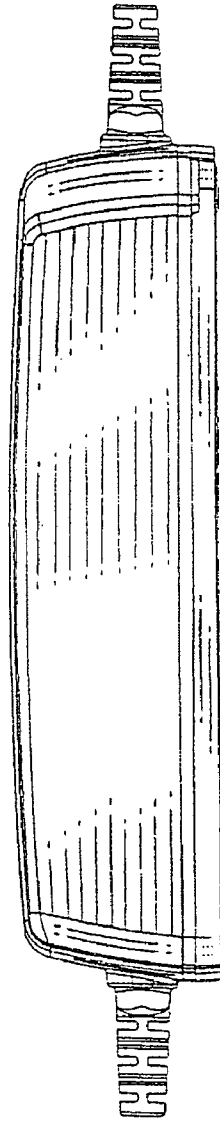

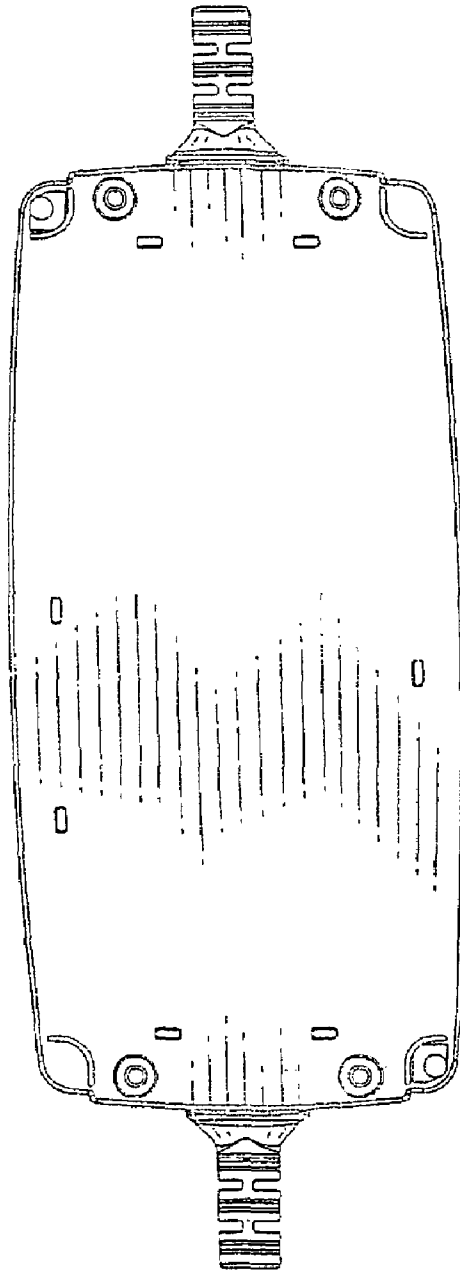

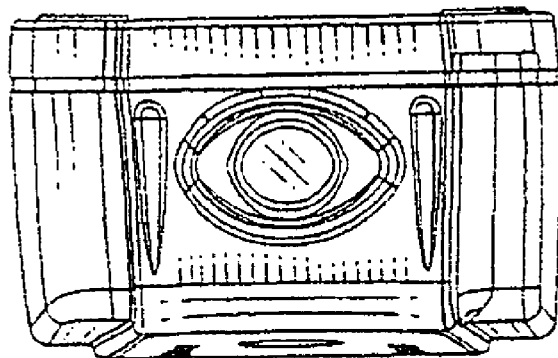

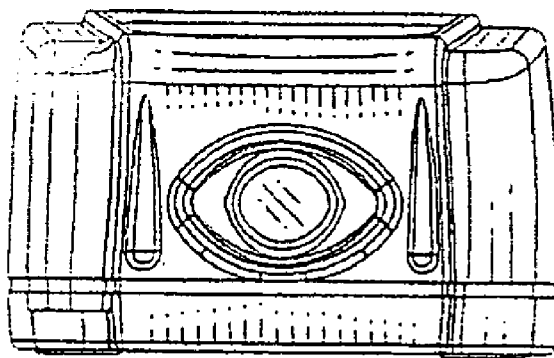
