DESCRIPTION

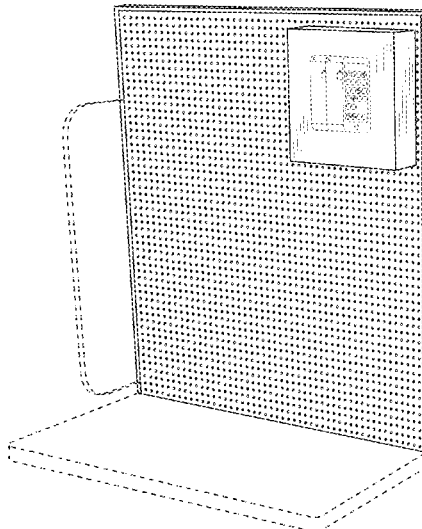
FIG. 1 is a right front side perspective view of a pop-out box display;

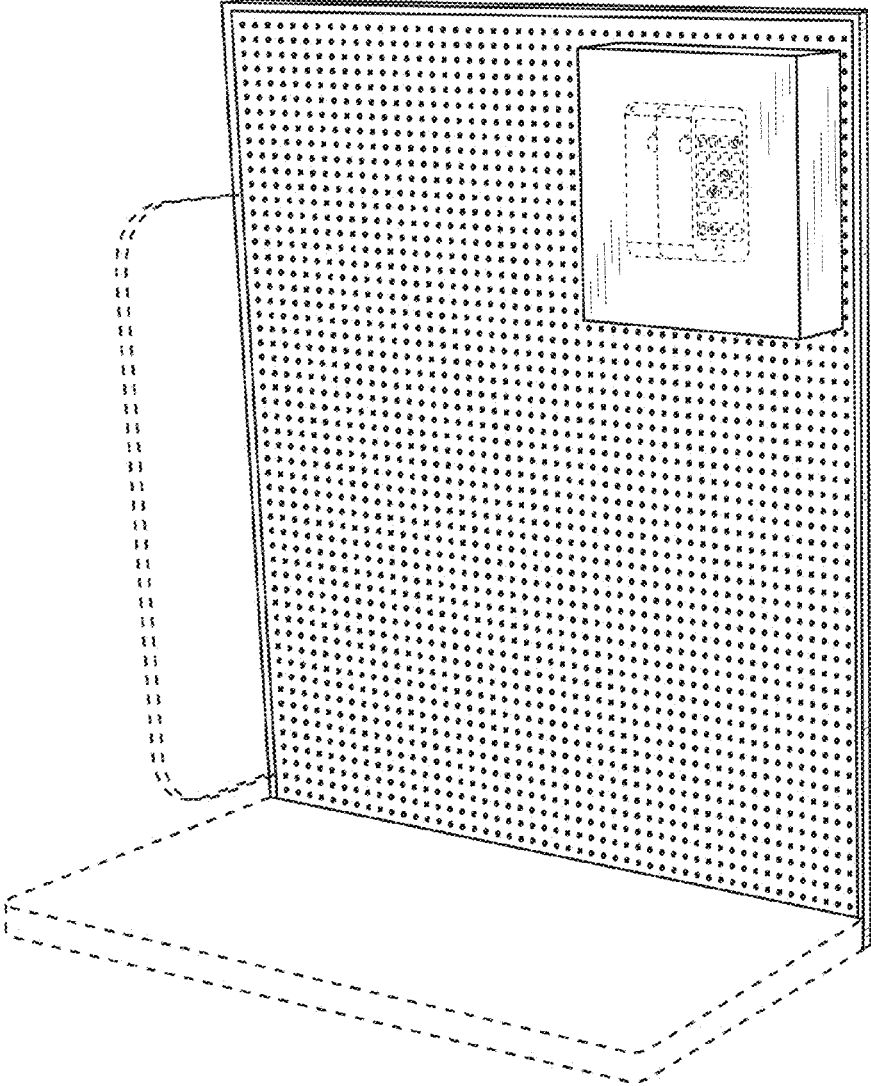

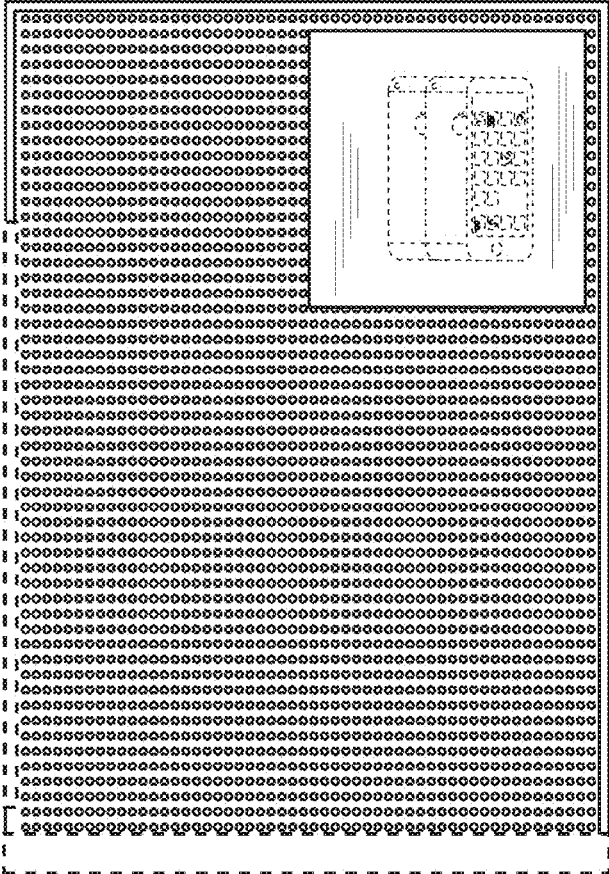

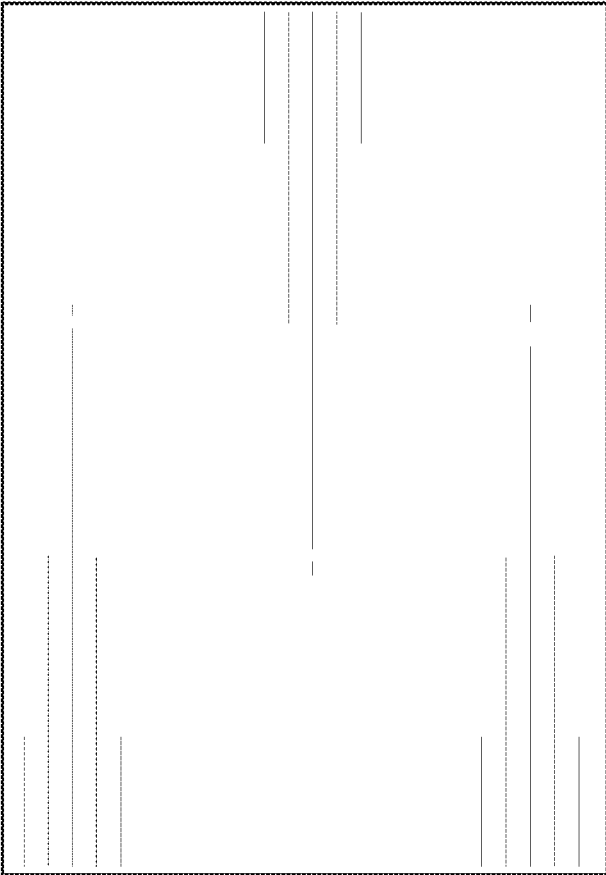

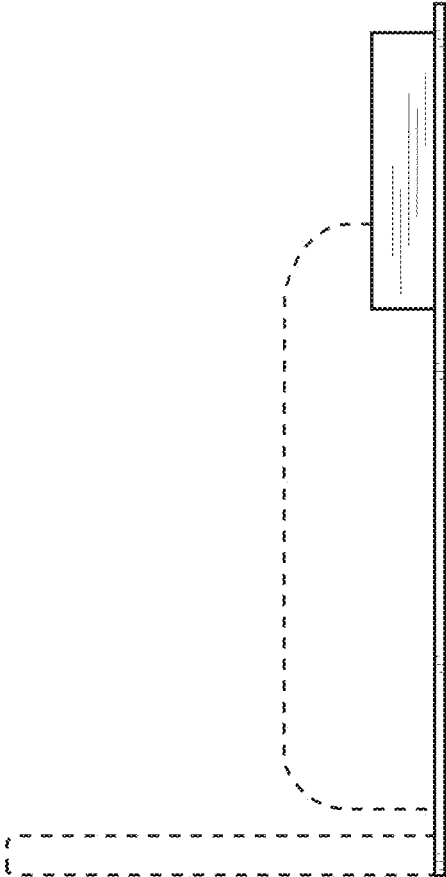

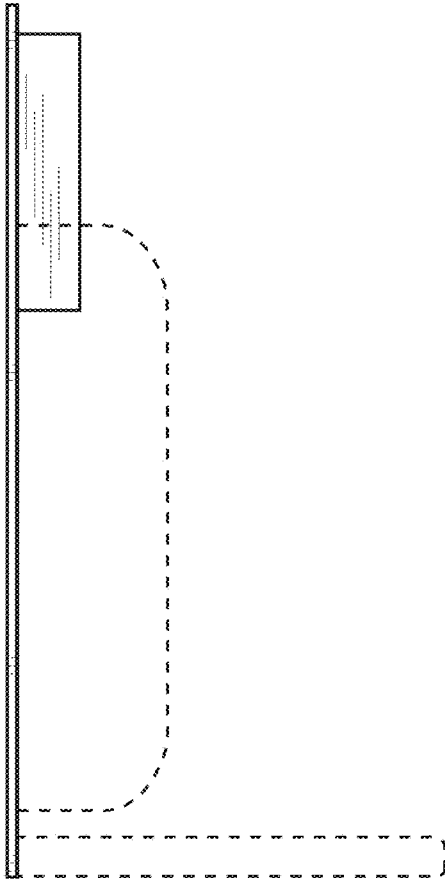

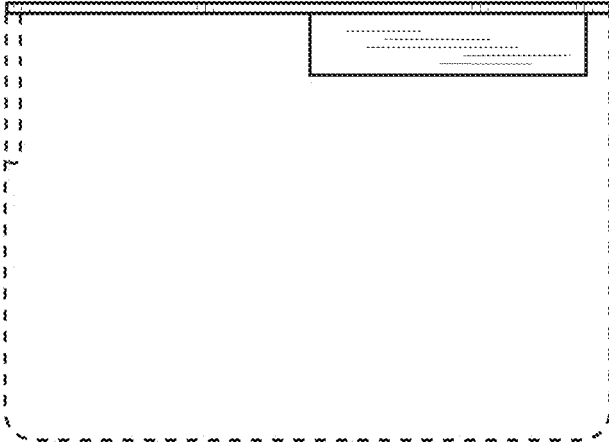

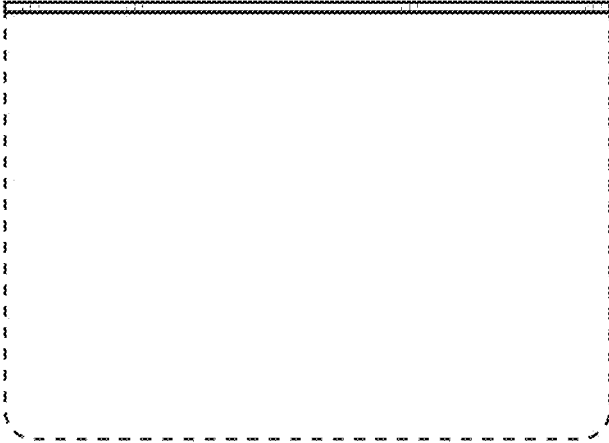
