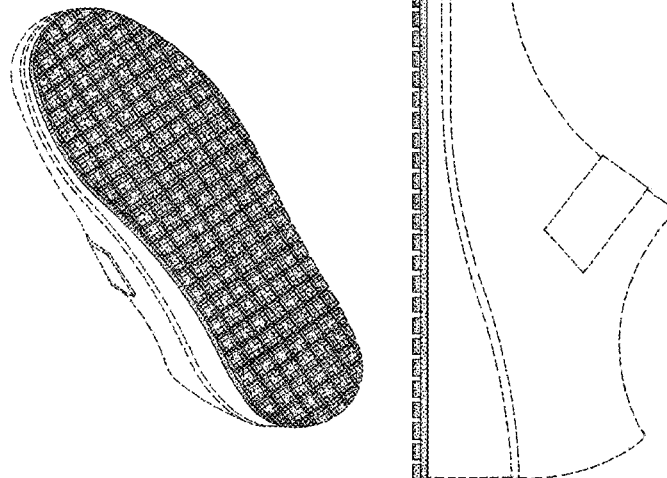
The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shoe sole showing my design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top plan view thereof; and,
 FIG. 7 is a bottom plan view thereof.
 The broken lines depict unclaimed portions of the shoe sole as well as unclaimed environment showing the shoe sole in a condition of use. The broken lines and structures they depict form no part of the claimed design.

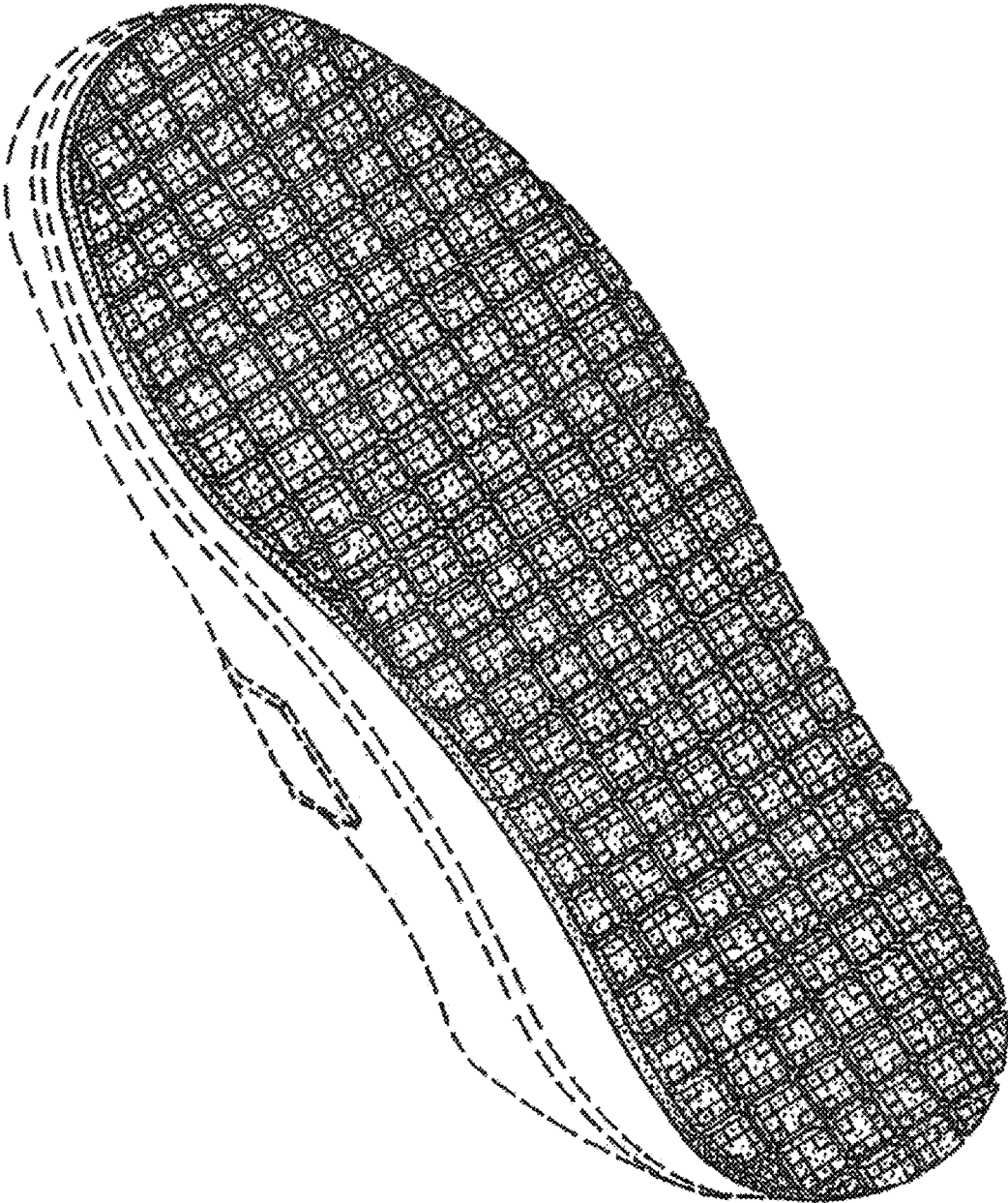

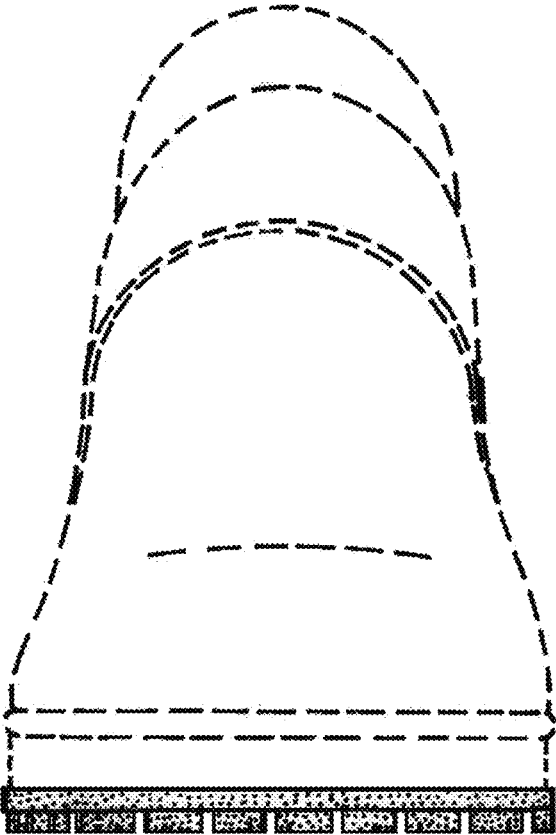

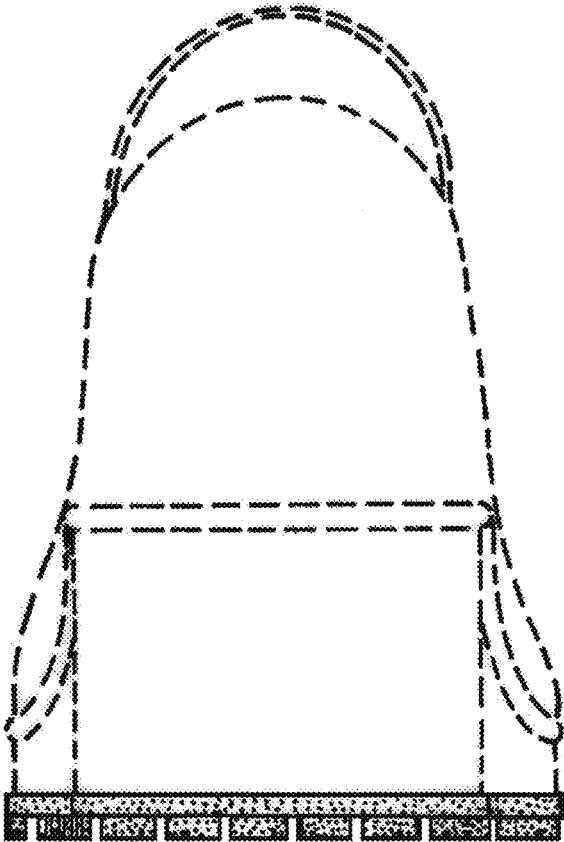

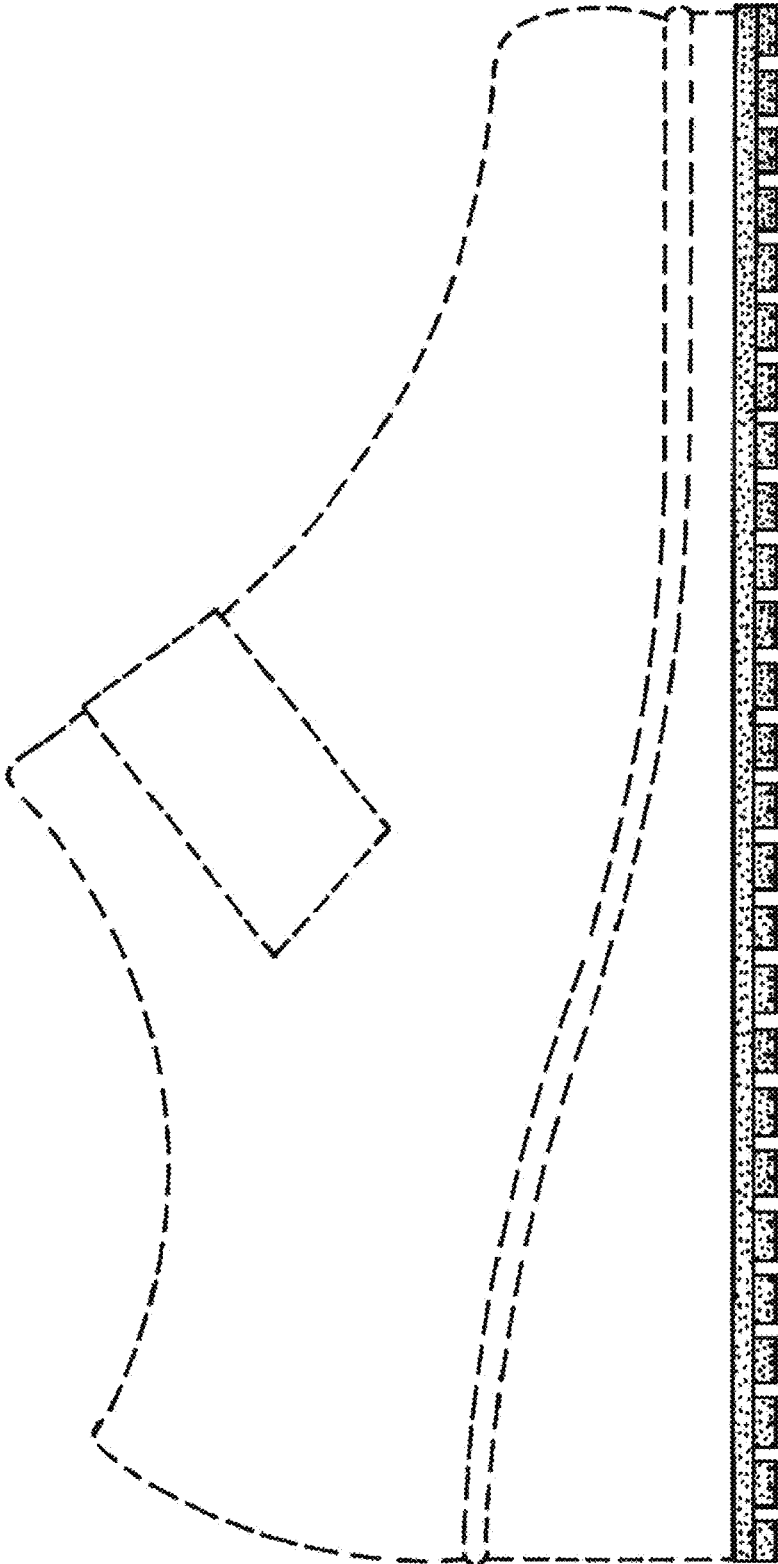

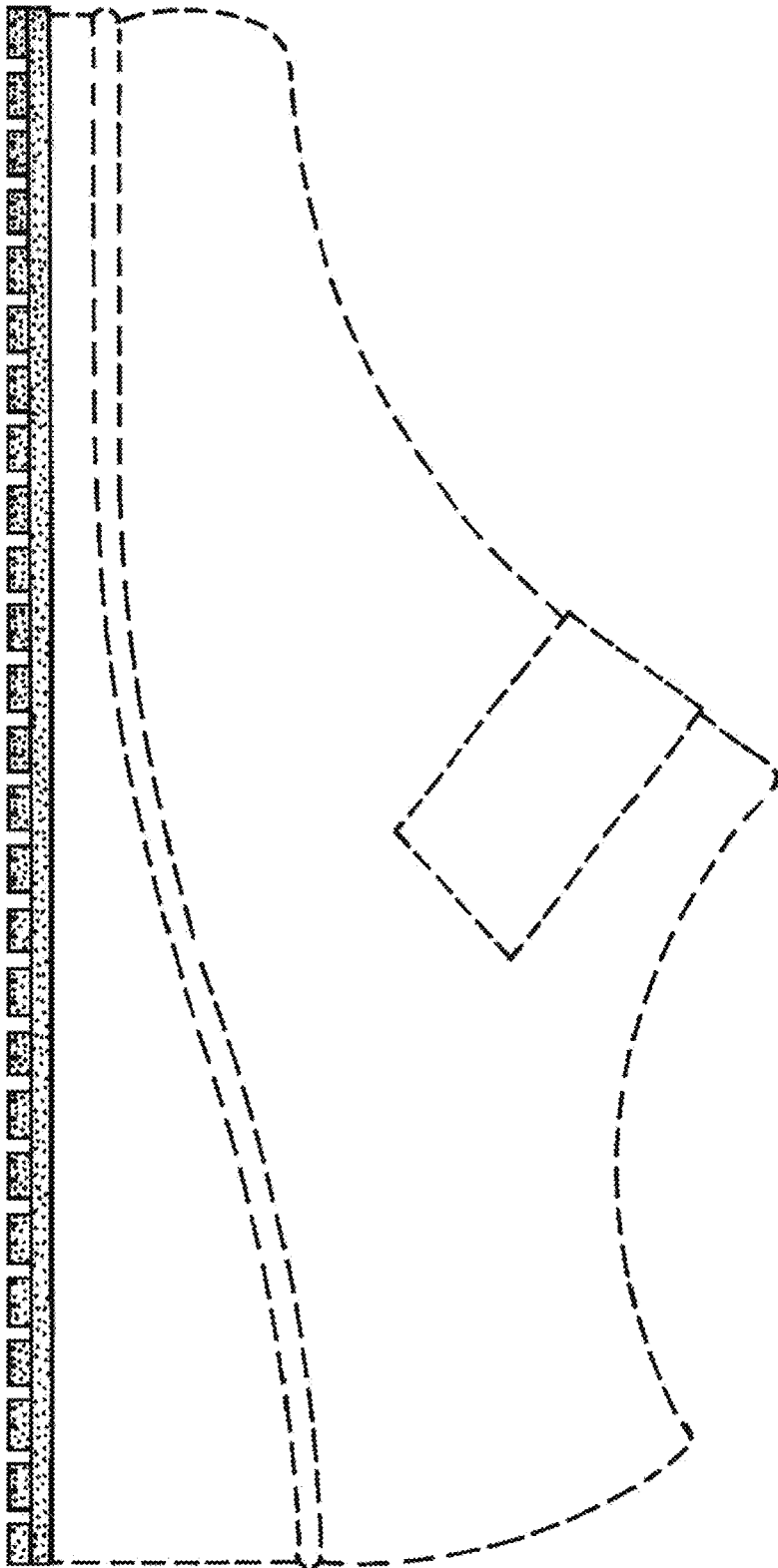

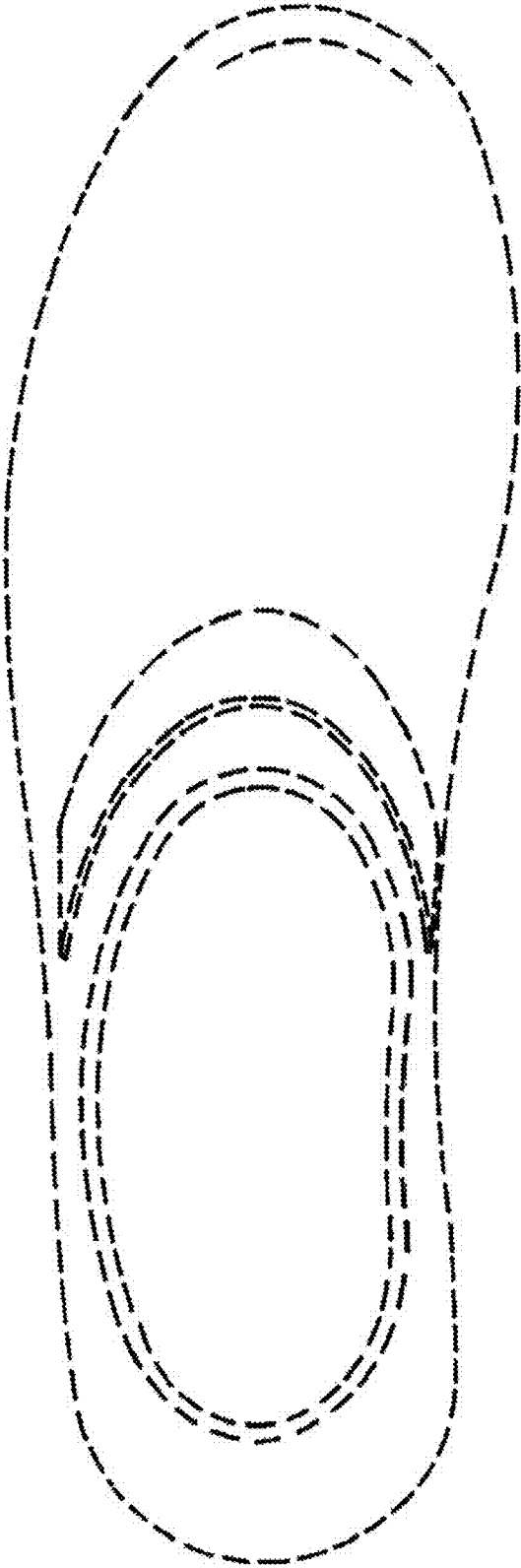

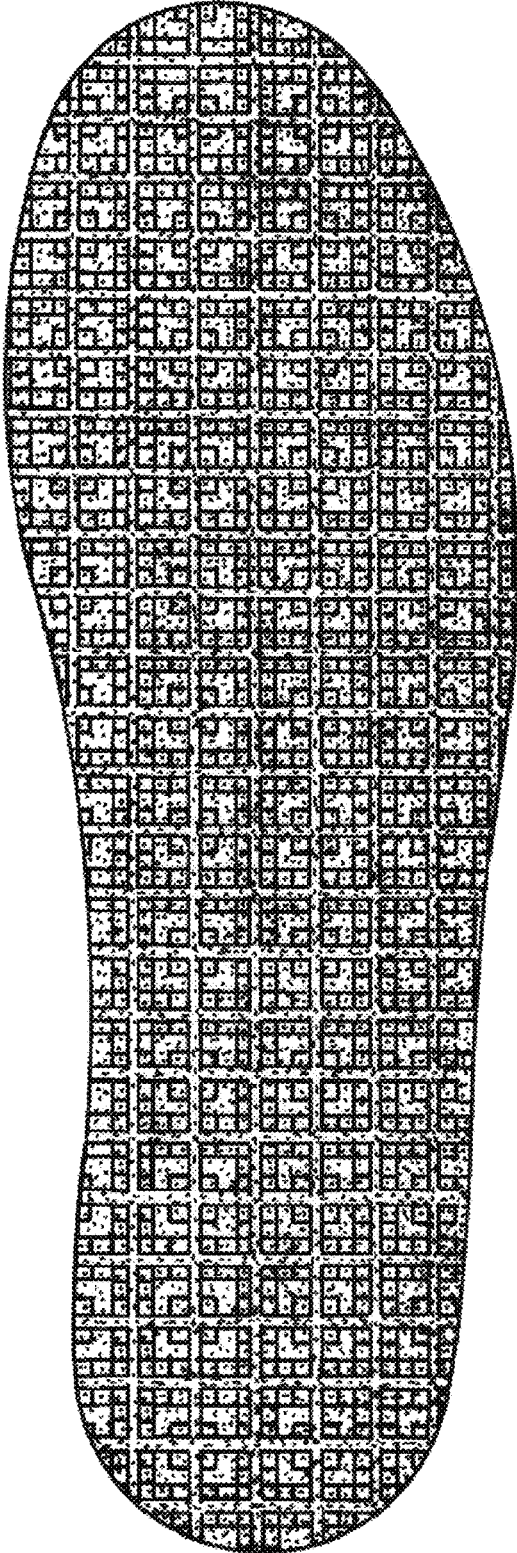
