(57) **CLAIM**

The ornamental design for a pipe fittings, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a pipe fitting, showing my new design from the front, top and left end;

FIG. 2 is a front elevational view thereof, the rear view being a mirror image;

FIG. 3 is a right end elevation view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a left end elevational view thereof;

FIG. 6 is a perspective view thereof, from the left end and above;

FIG. 7 is a top plan view of a second embodiment of a pipe fitting, from the front, top and left end;

FIG. 8 is a front elevational view of FIG. 7, the rear view being a mirror image;

FIG. 9 is a right end elevation view of FIG. 7;

FIG. 10 is a top plan view of FIG. 7;

FIG. 11 is a left end elevational view of FIG. 7;

FIG. 12 is a perspective view of FIG. 7, from the left end and above;

FIG. 13 is a top plan view of a third embodiment of a pipe fitting, from the front, top and left end;

FIG. 14 is a front elevational view of FIG. 13, the rear view being a mirror image;

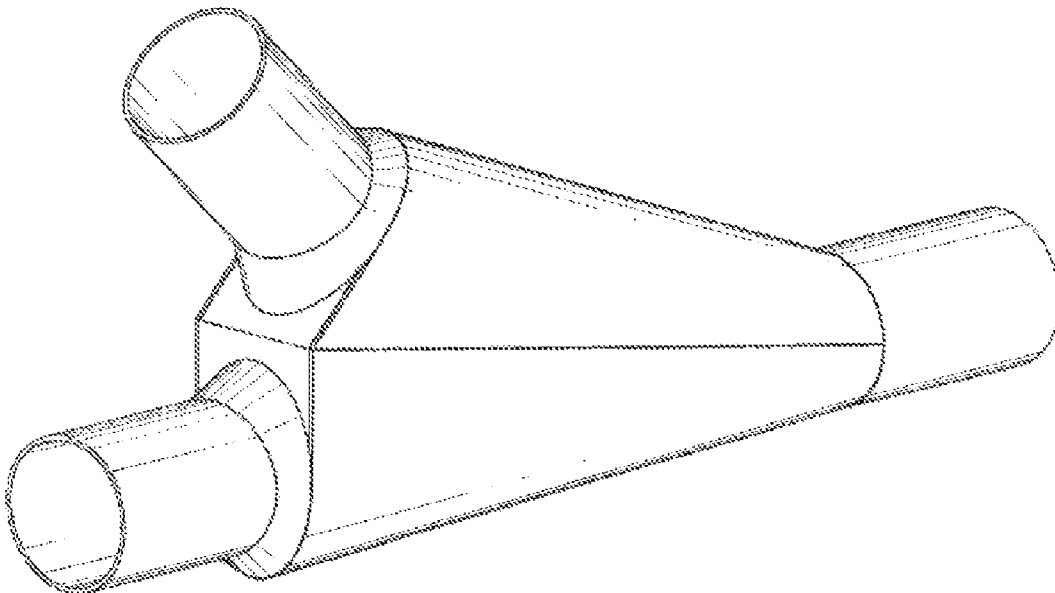
FIG. 15 is a right end elevation view of FIG. 13;

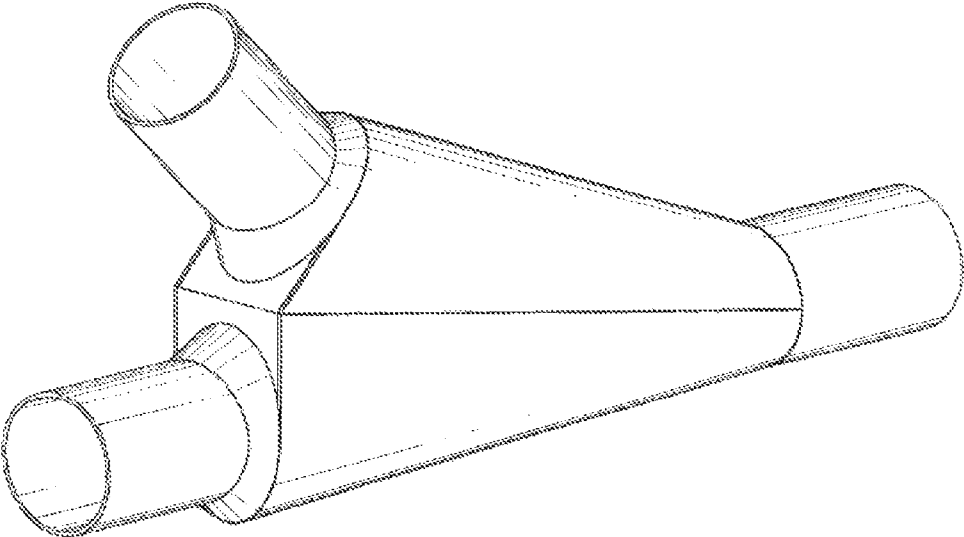

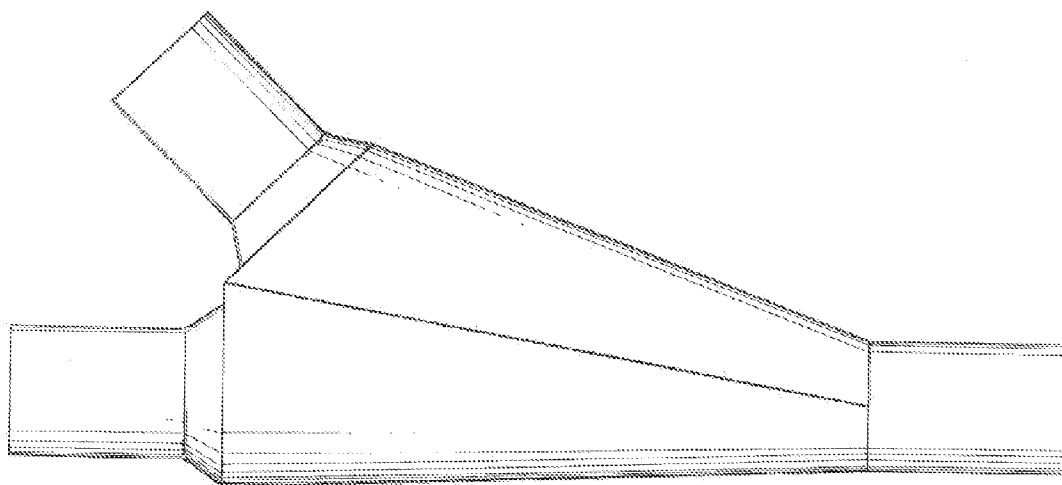

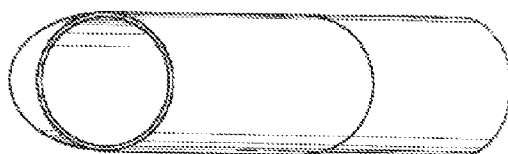

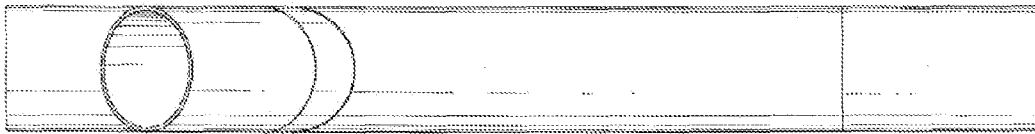

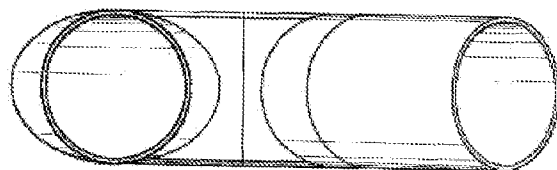

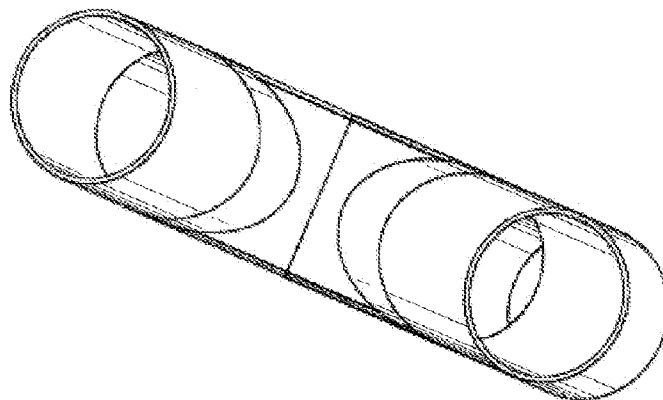

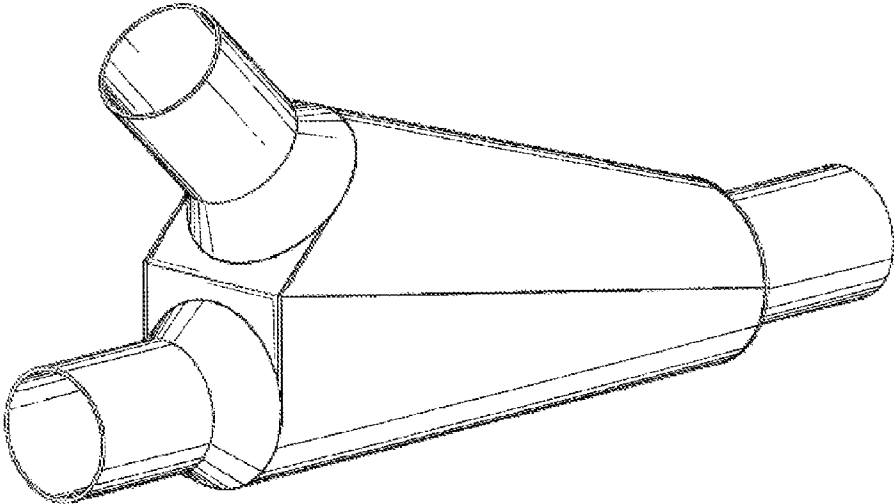

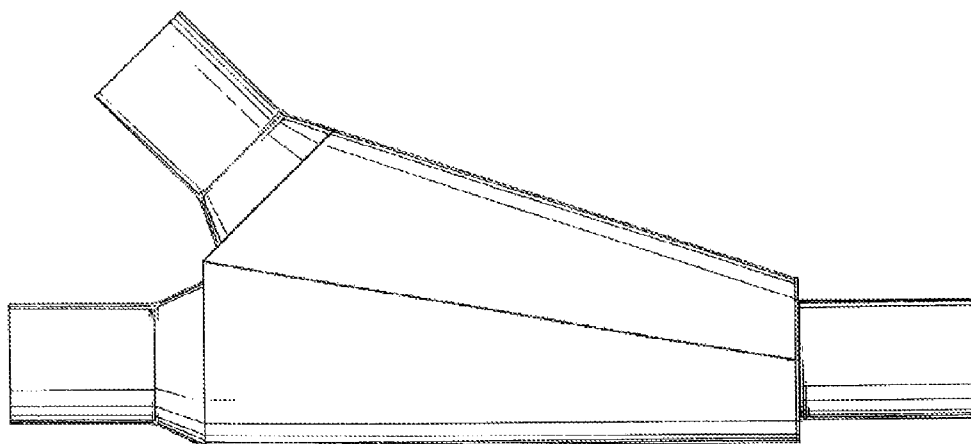

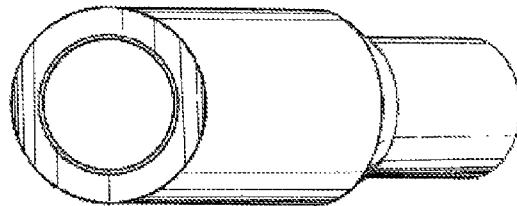

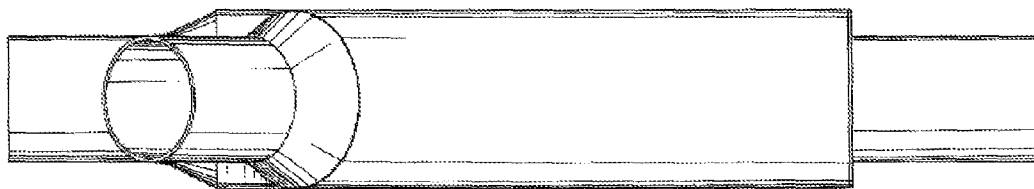

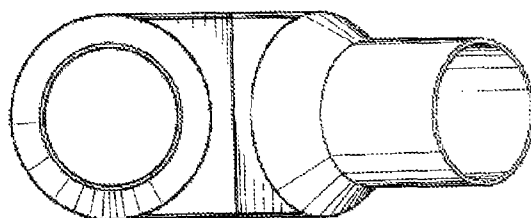

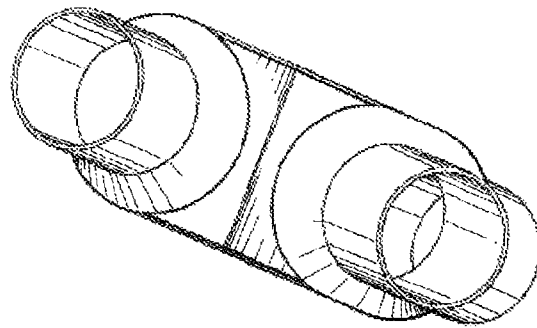

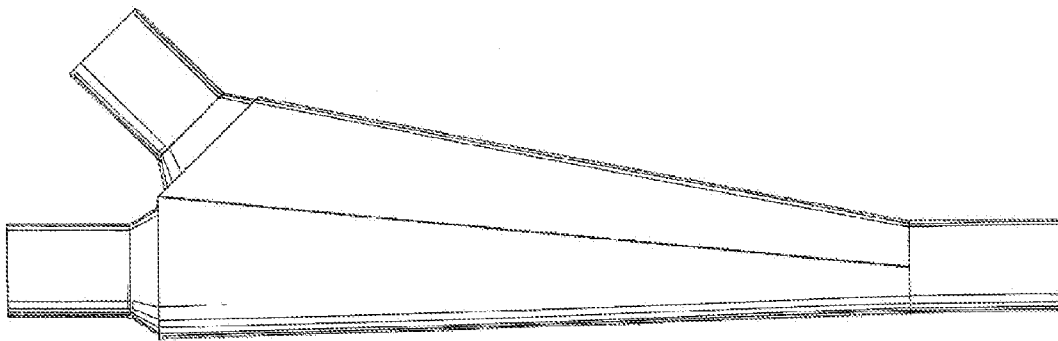

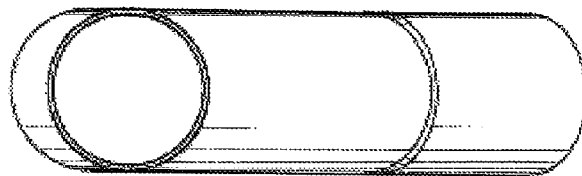

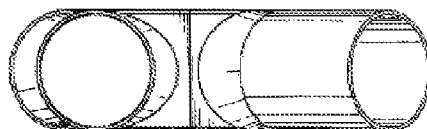

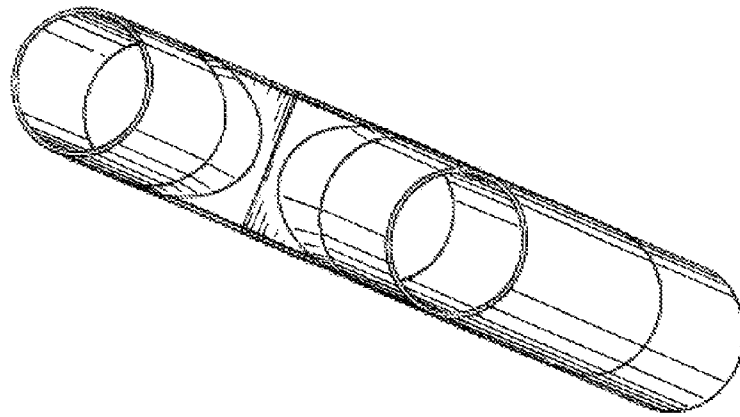
