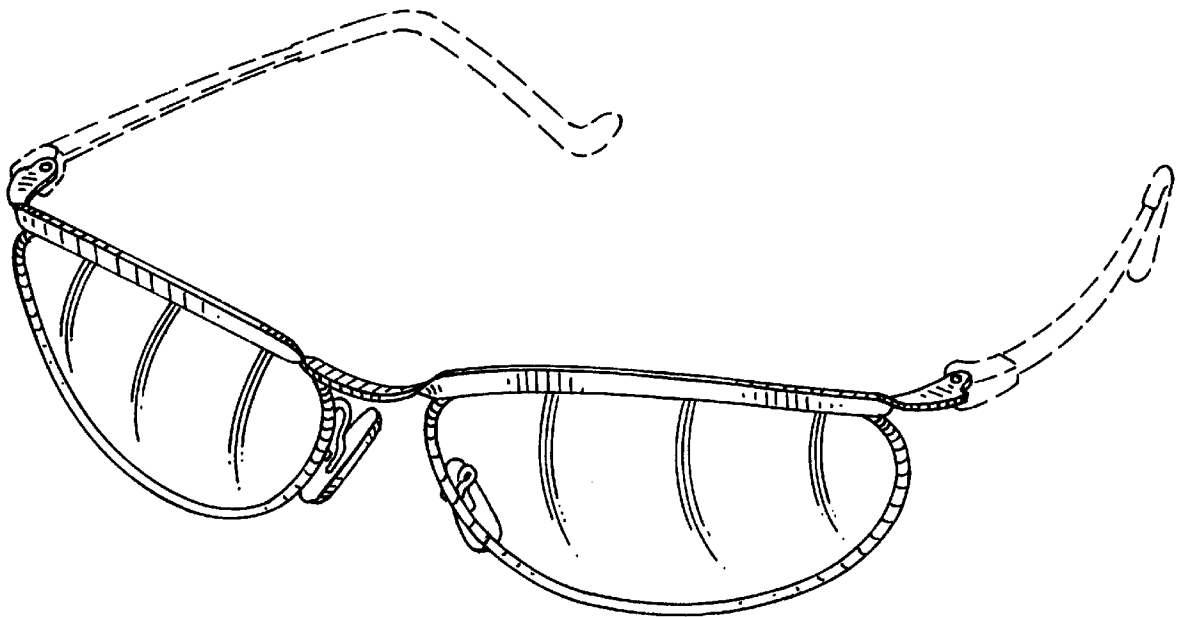
### [57] CLAIM

### DESCRIPTION

FIG. 1 is a front elevational view of an eyewear front embodying my new design;

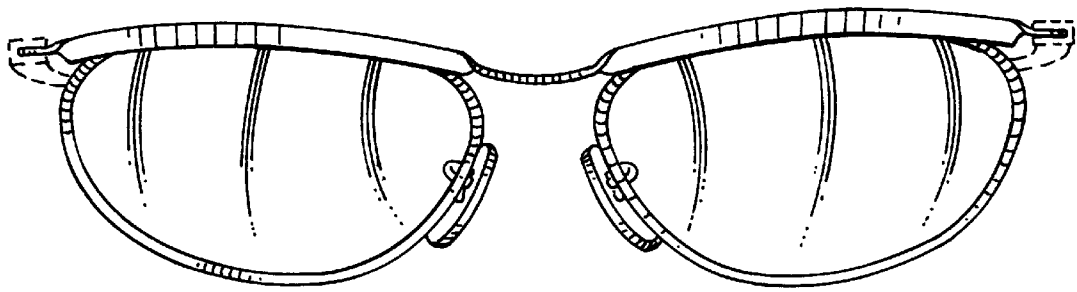

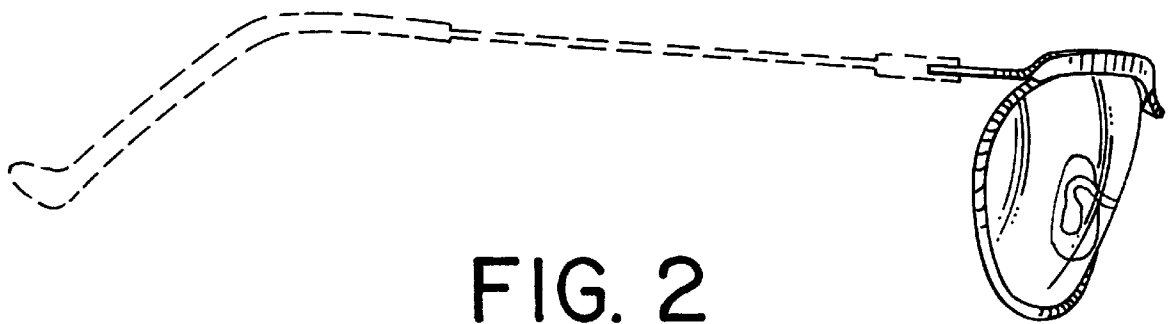

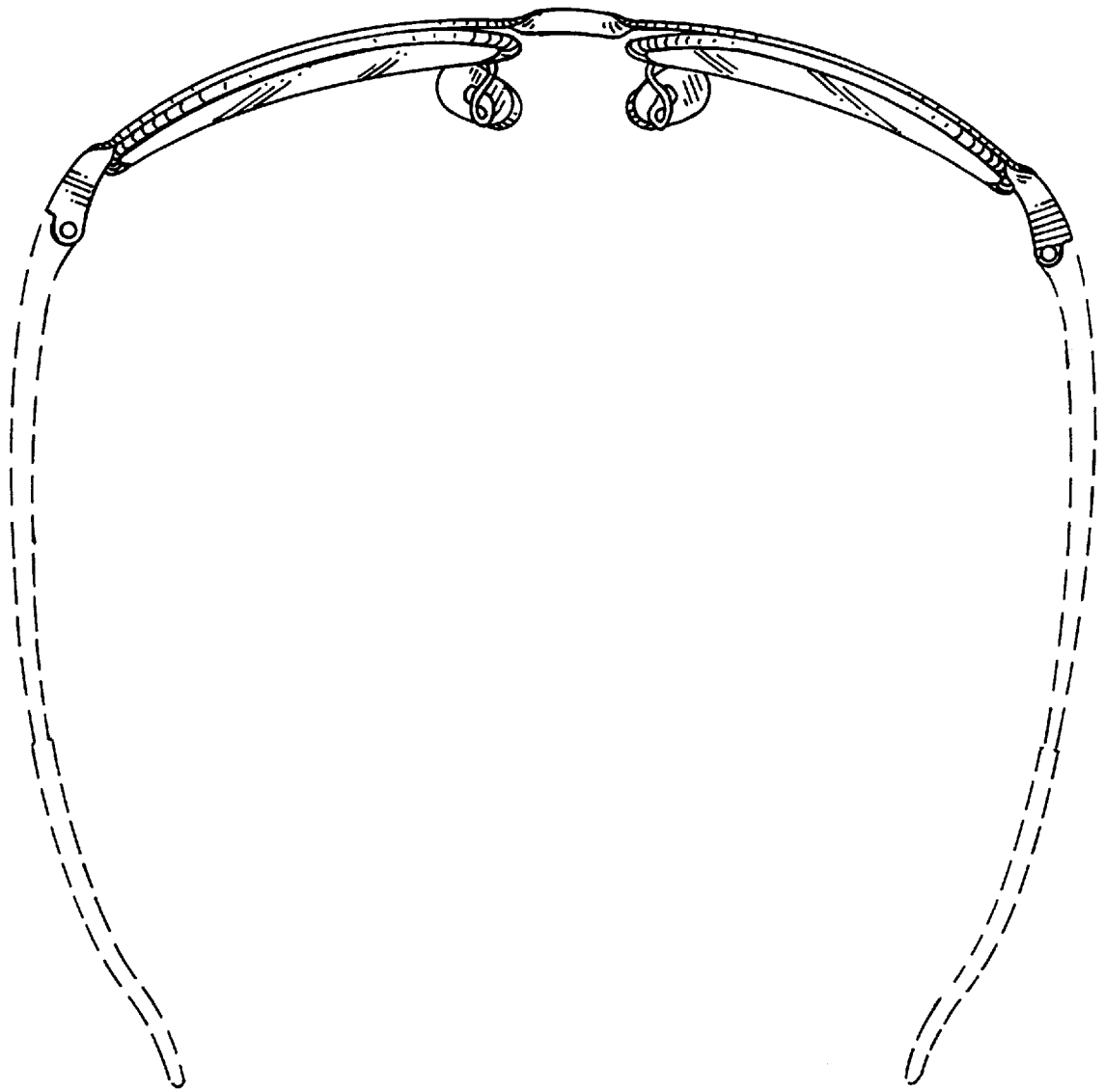

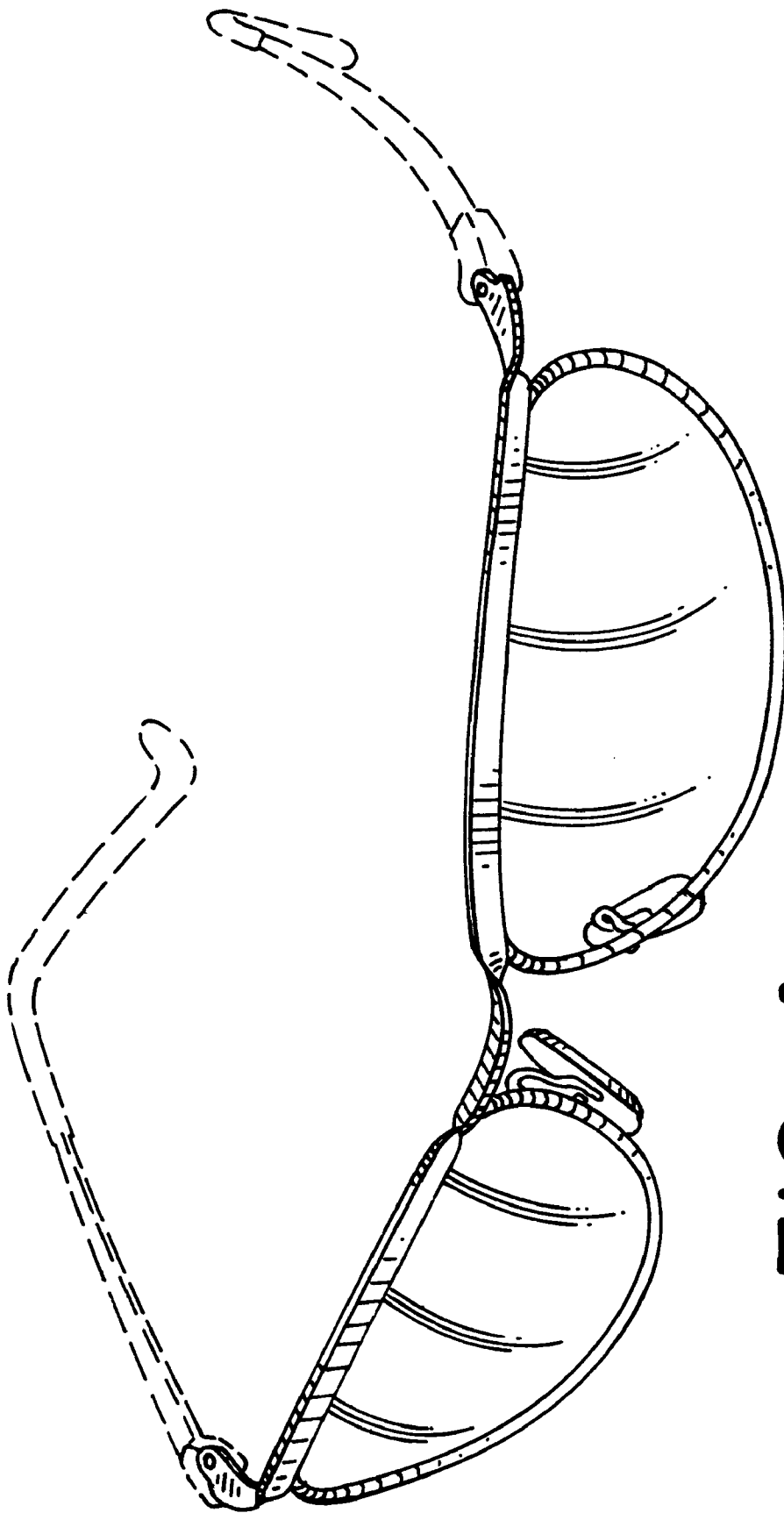
