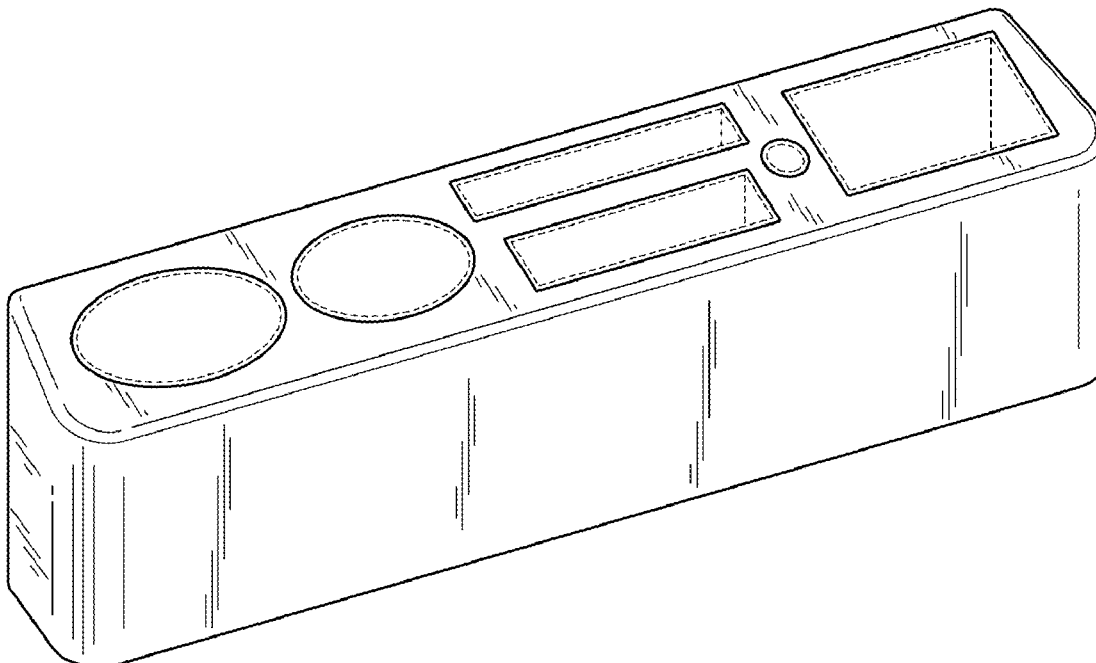
(57) **CLAIM**

The ornamental design for a vehicle organizer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view vehicle organizer; FIG. 2 is a left side elevation view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a front elevation view vehicle organizer, the rear elevation view being a mirror image thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a cross-sectional view taken on line 7-7 of FIG. 5; and, FIG. 8 is a cross-sectional view taken on line 8-8 of FIG. 5. The broken lines shown in the drawings illustrate portions of the vehicle organizer that form no part of the claimed design.

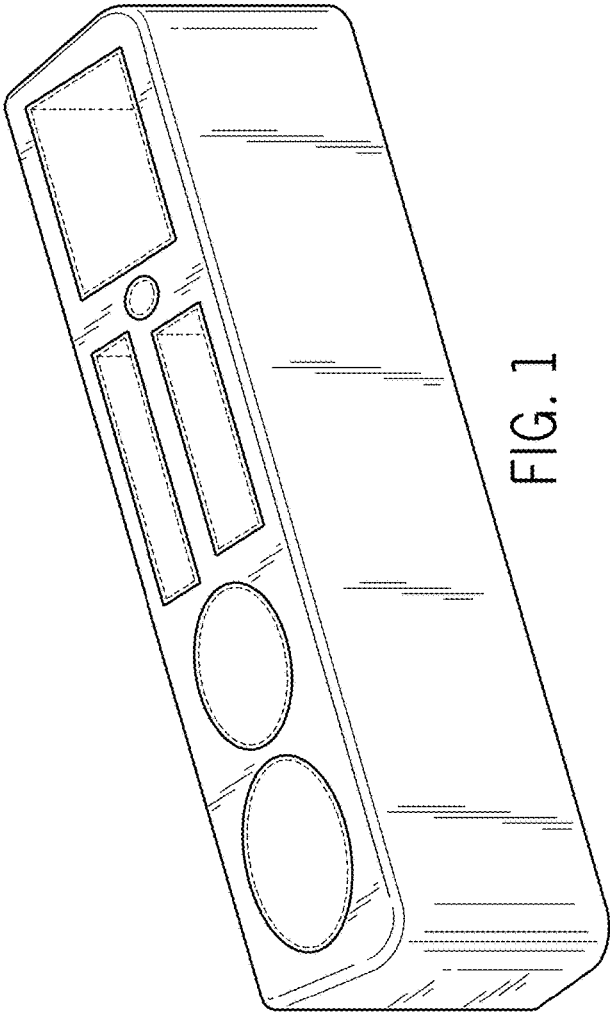

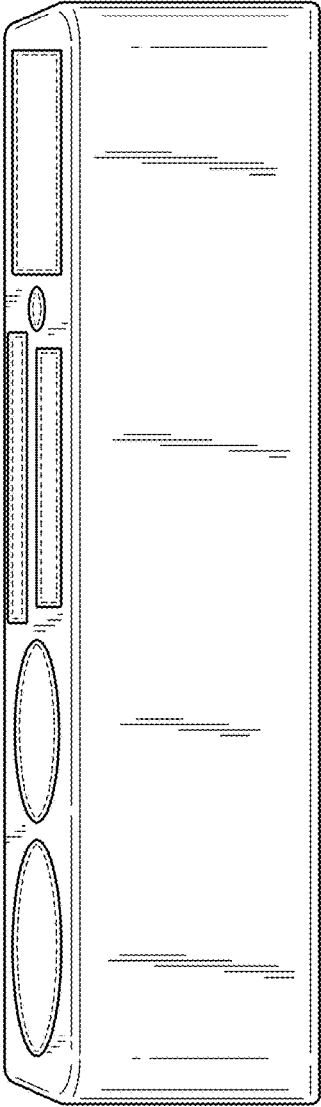

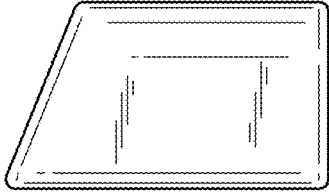

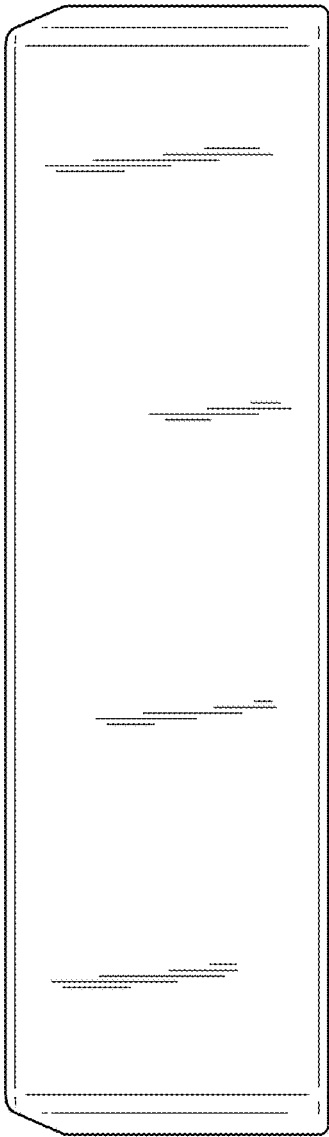

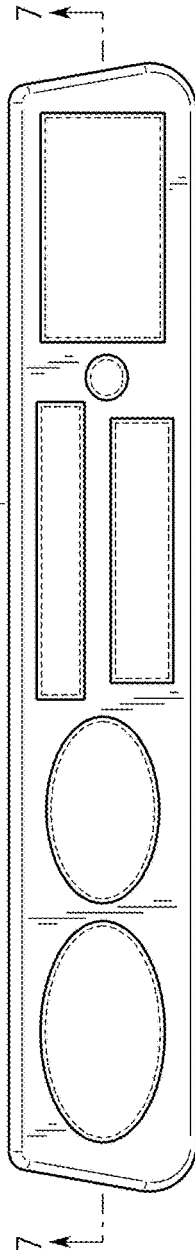

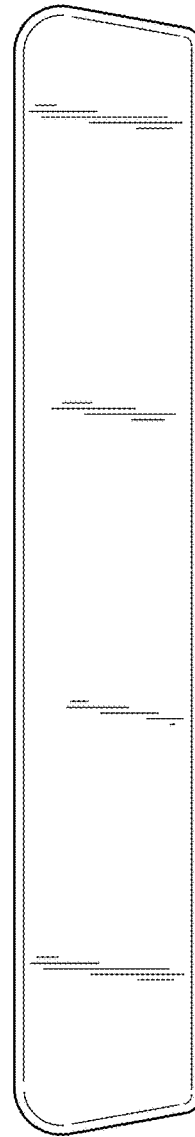

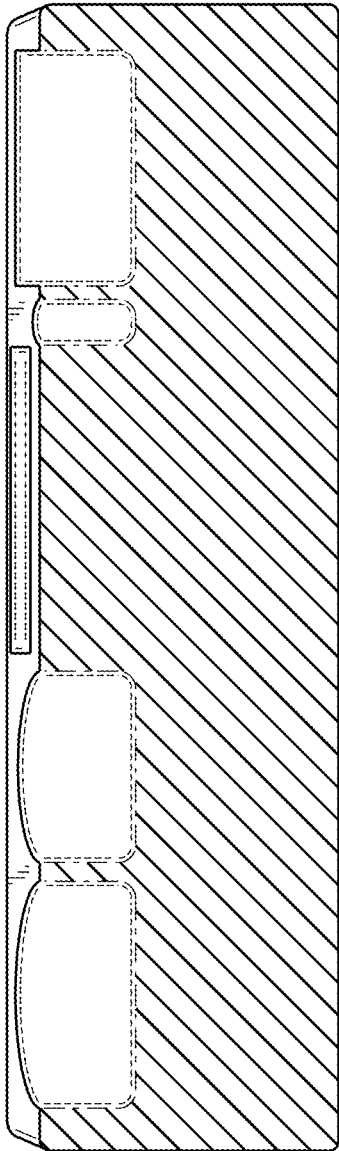

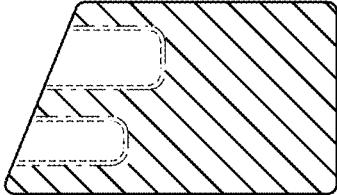
