The ornamental design for a humidifier, as shown and described.

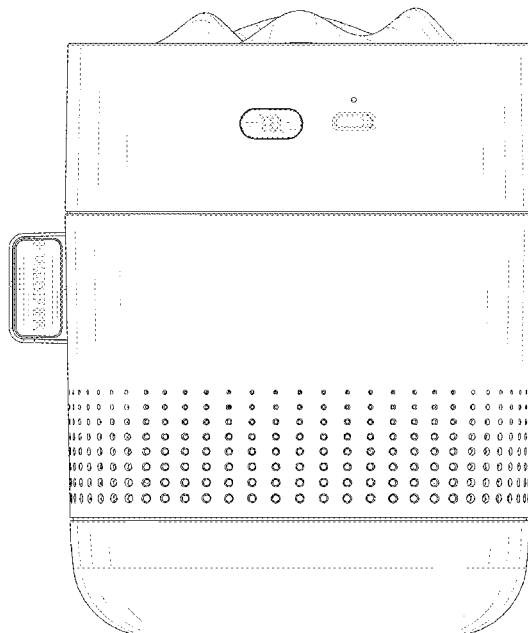
**DESCRIPTION**

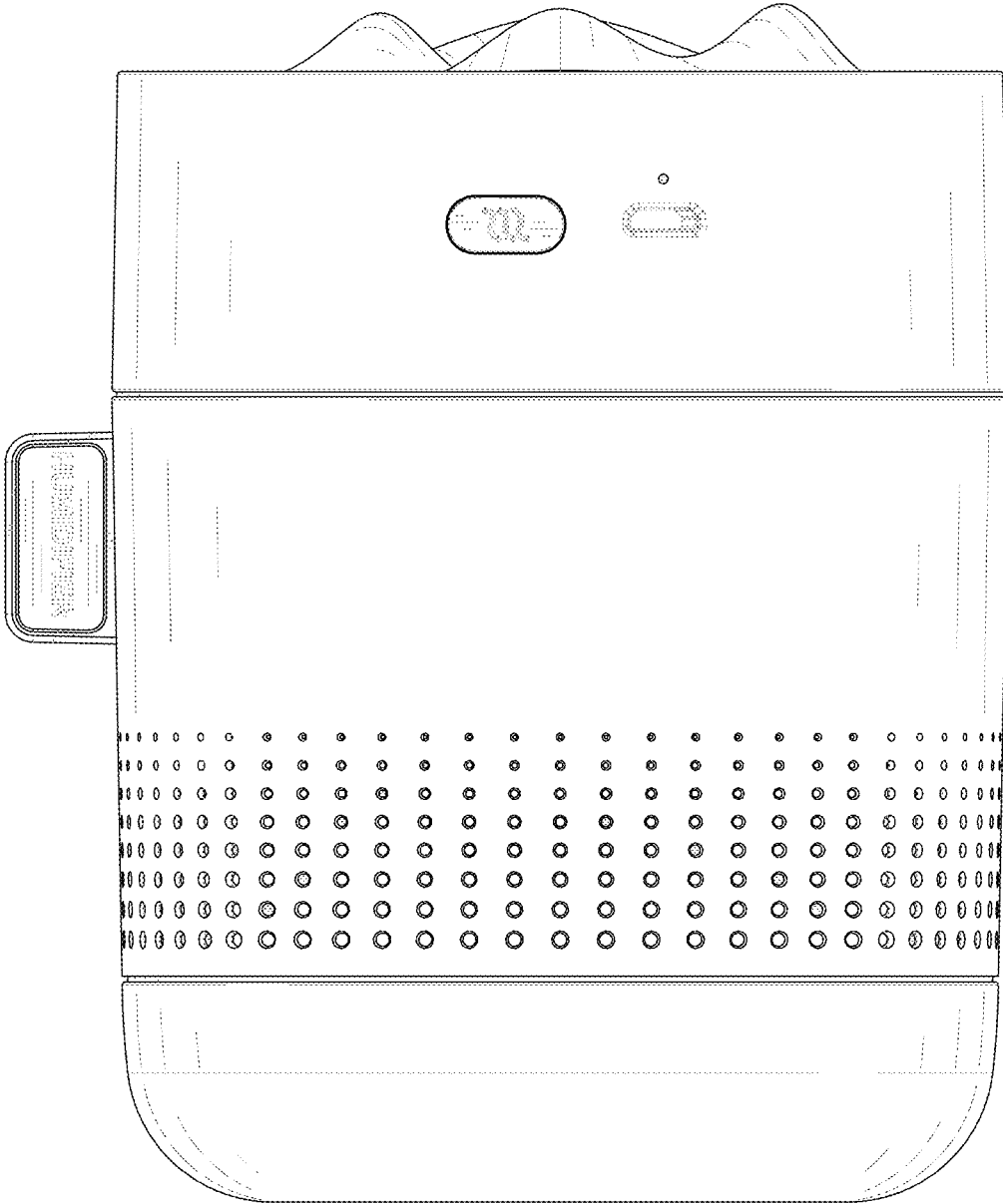
FIG. 1 is a front elevational view of a humidifier showing my new design;

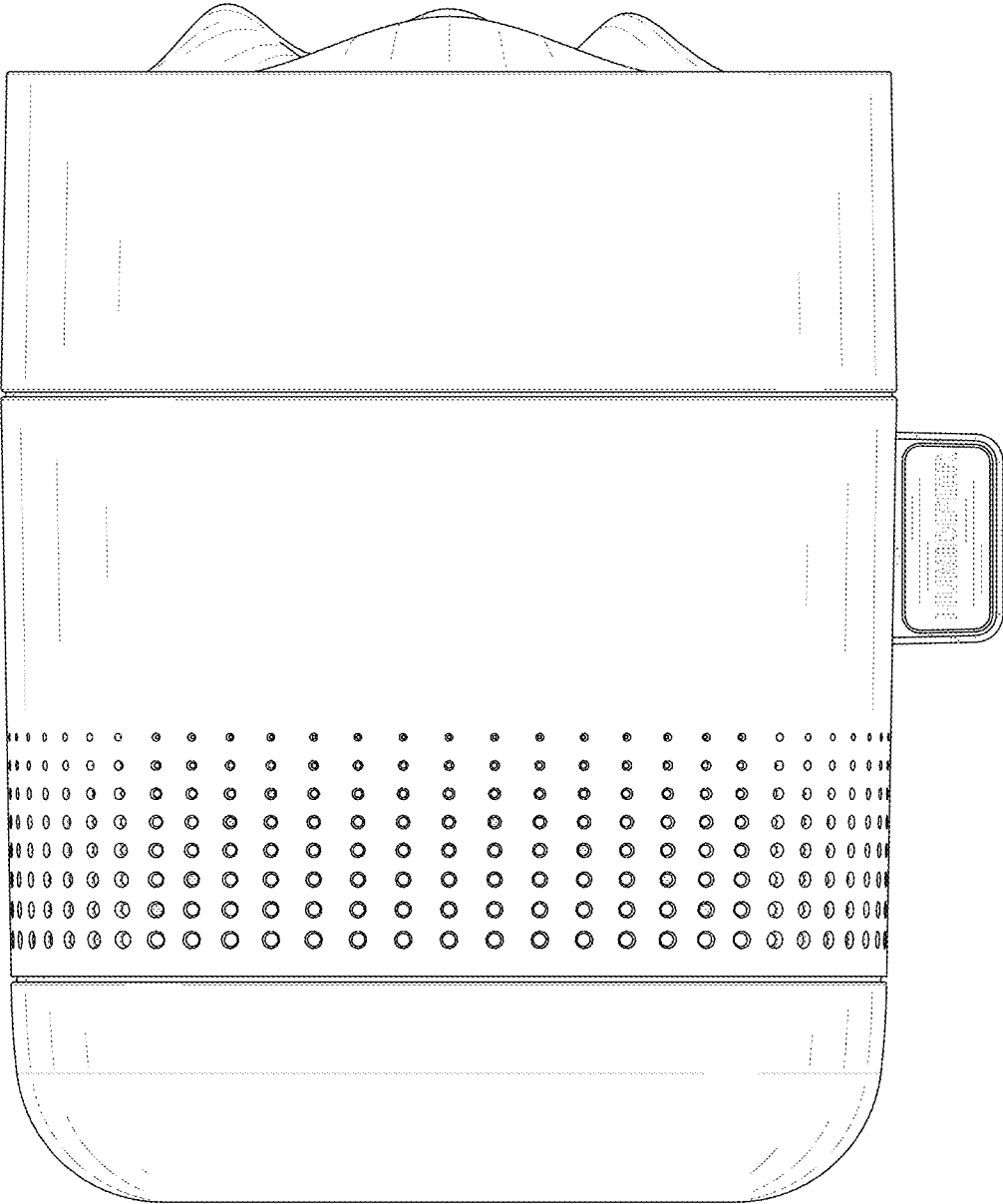

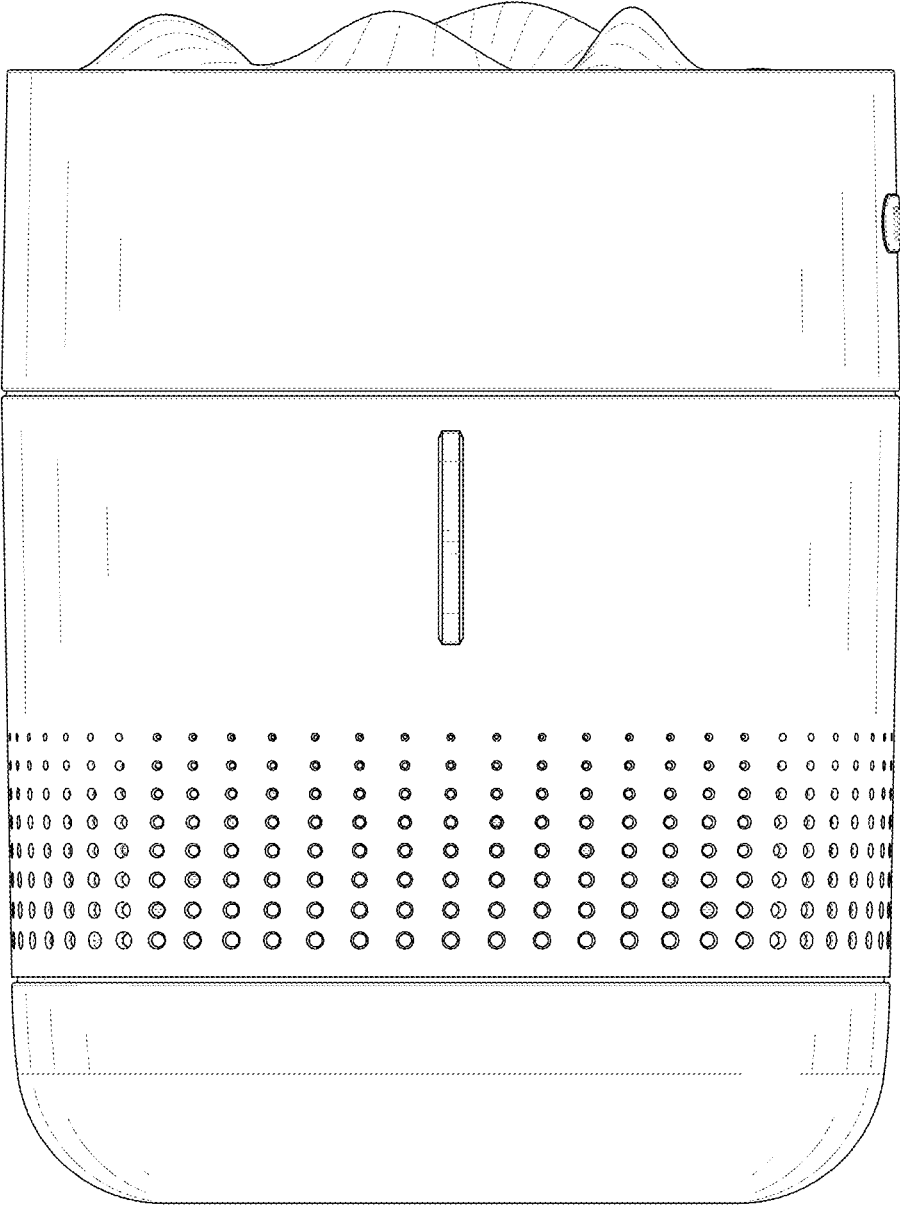




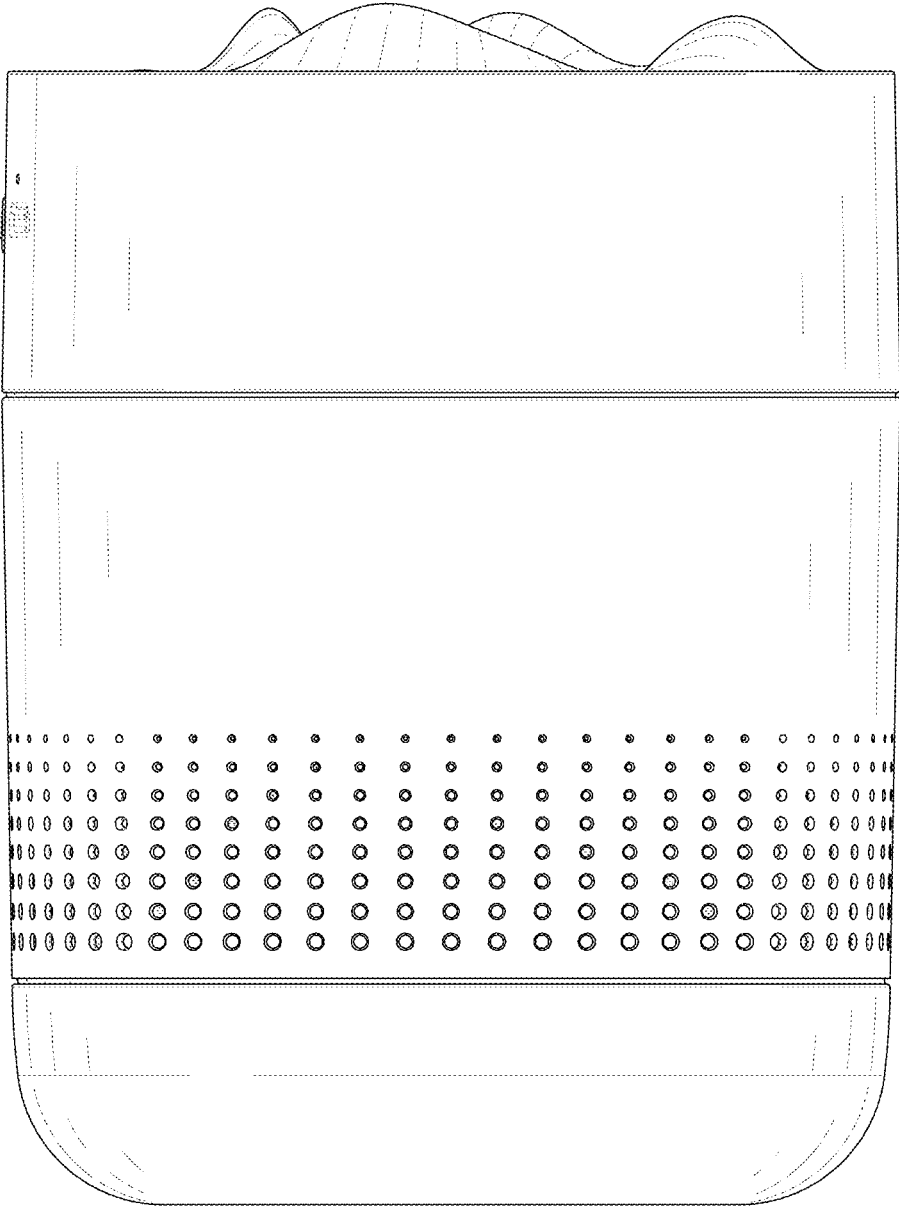

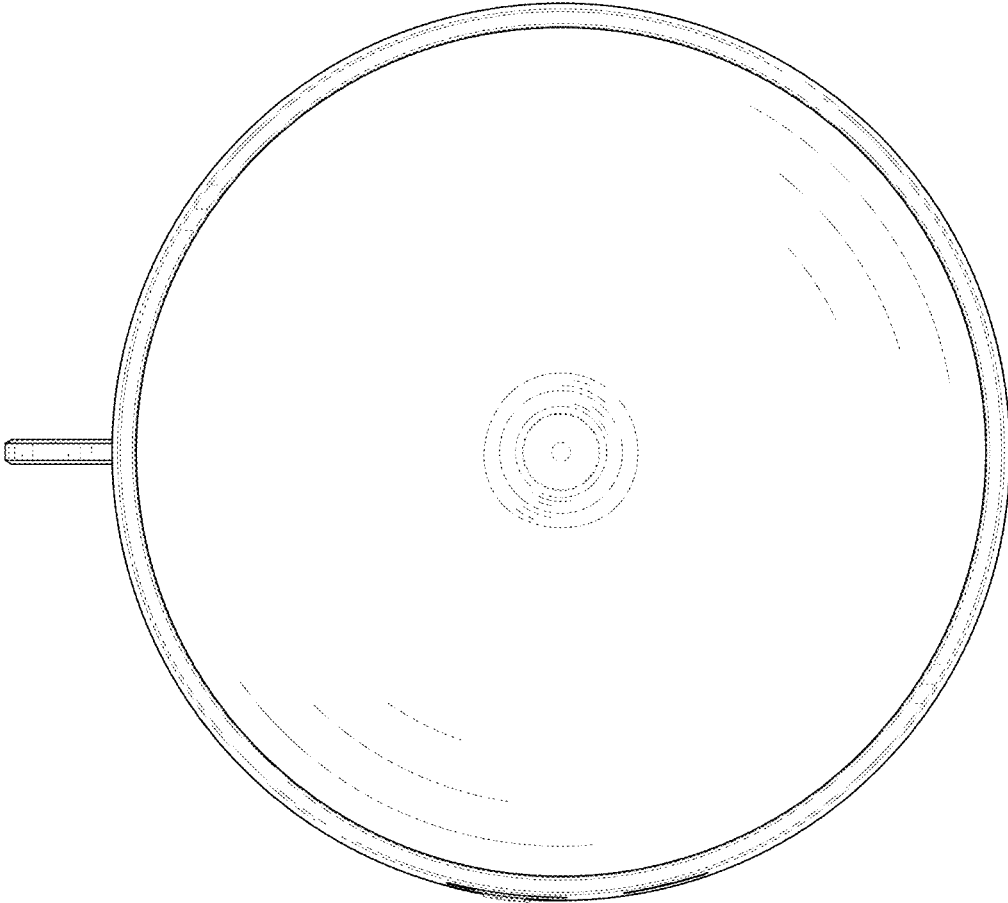

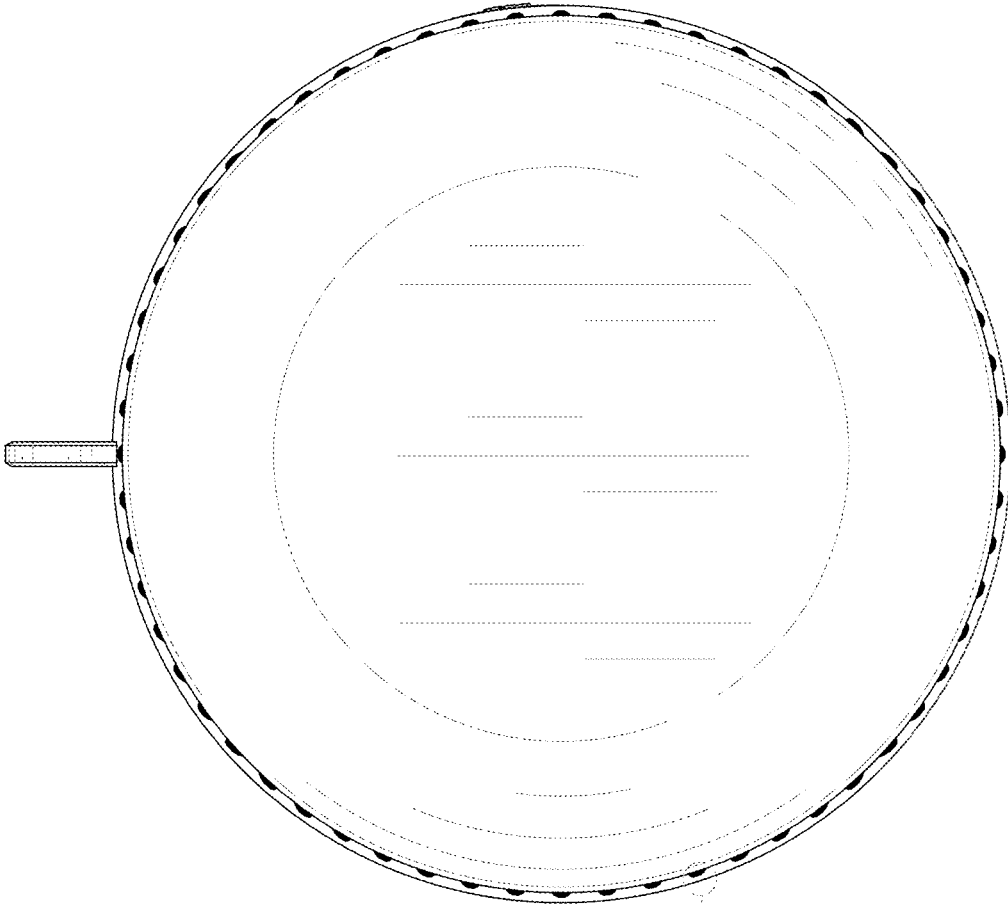

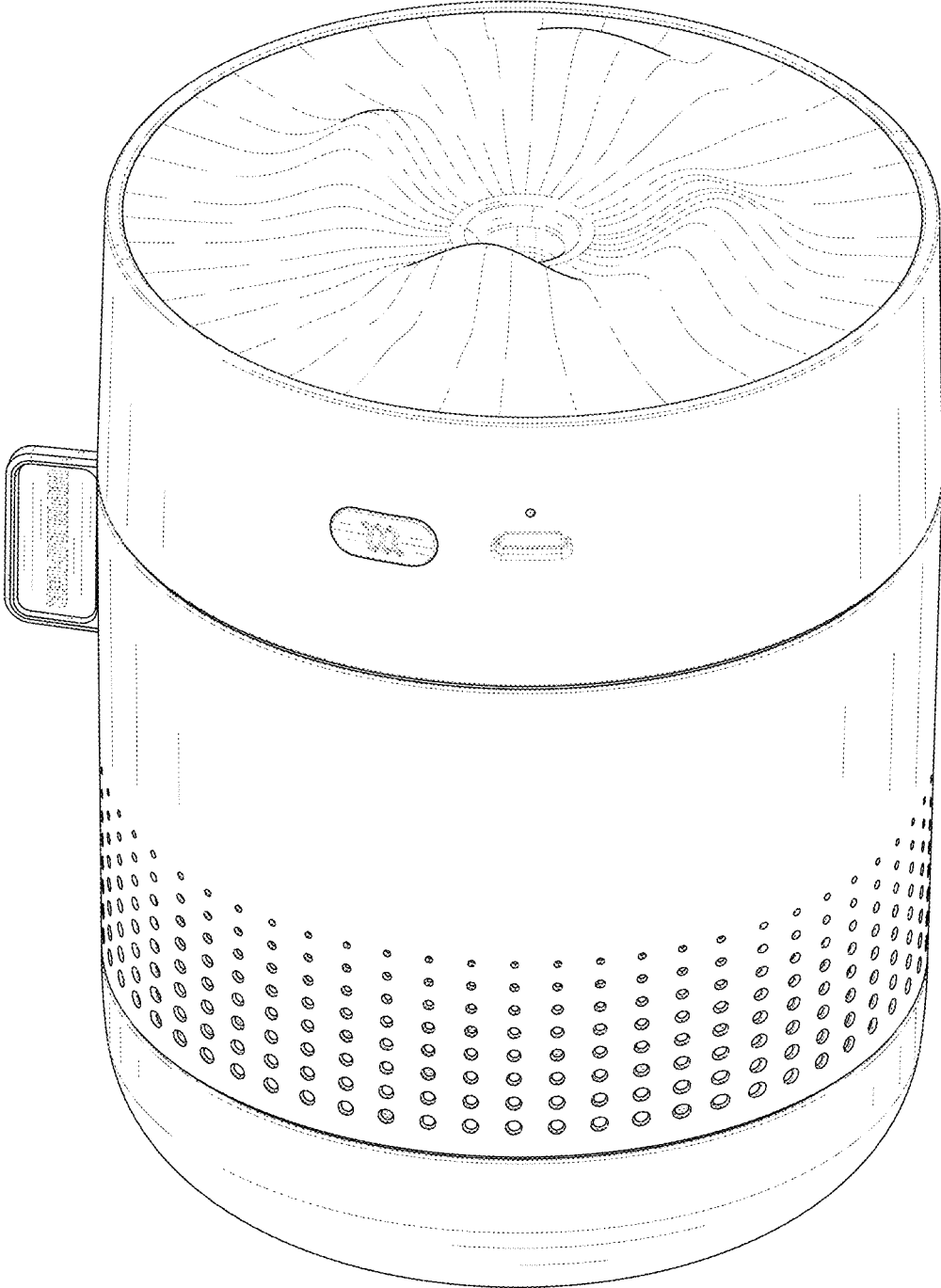

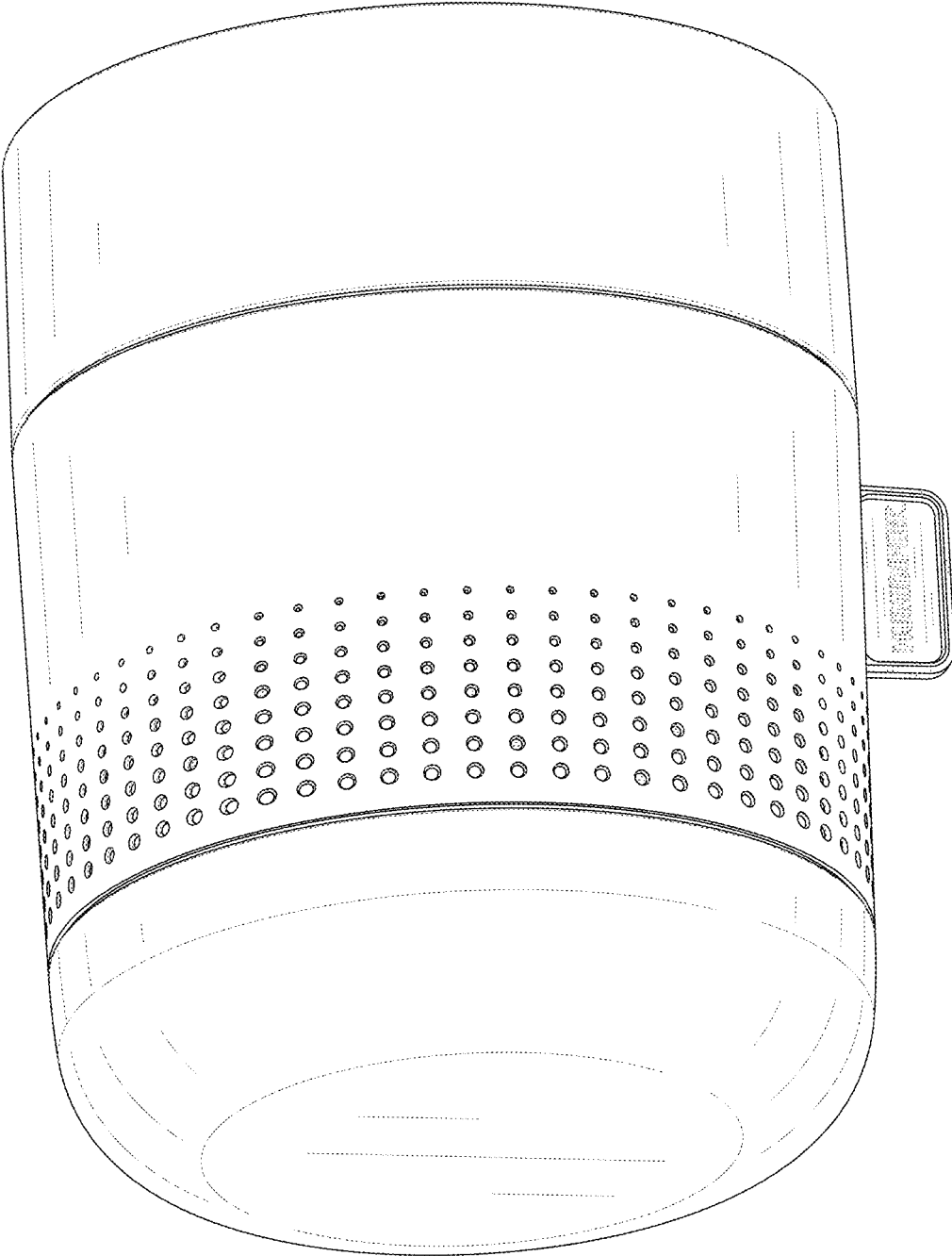

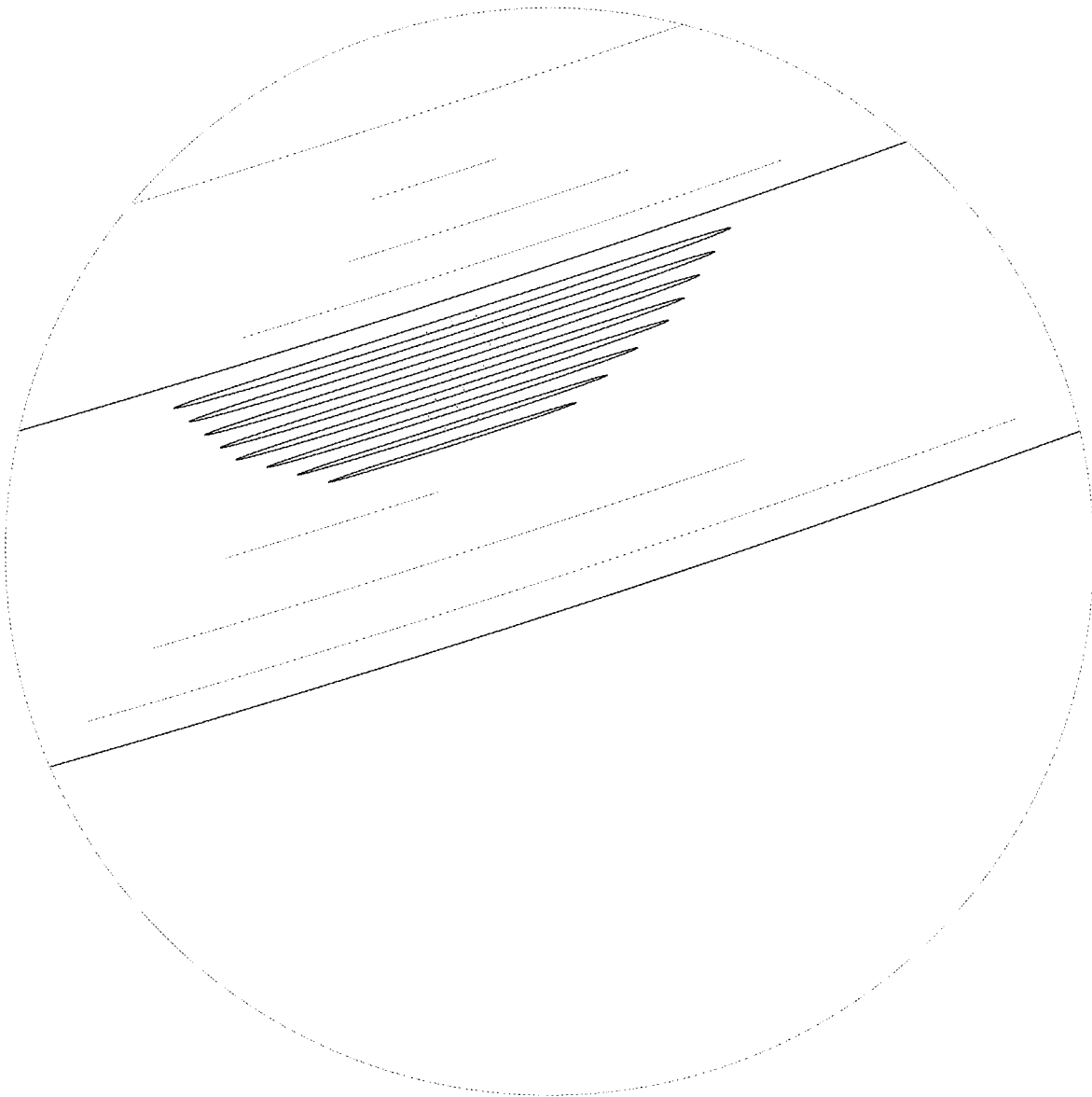
