(57) **CLAIM**

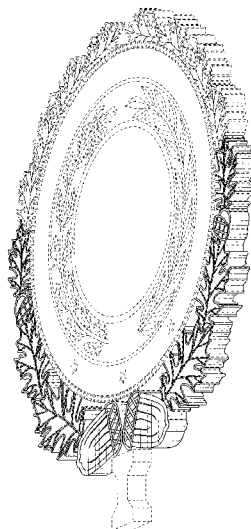
I claim the ornamental design for an emblem surround, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a design for an emblem surround, with an unclaimed Roman numeral ‘one’;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a left-side view thereof;  
 FIG. 5 is a right-side view thereof;  
 FIG. 6 is a top view thereof;  
 FIG. 7 is a bottom view thereof;  
 FIG. 8 is a front view for an emblem surround, with an unclaimed Roman numeral ‘two’;  
 FIG. 9 is a front view for an emblem surround shown in an alternate environment of use, with an unclaimed Roman numeral ‘three’;  
 FIG. 10 is a front view for an emblem surround shown in an alternate environment of use, with an unclaimed number ‘two’; and,  
 FIG. 11 is a front view for an emblem surround shown in an alternate environment of use, with an unclaimed number ‘three’.

The broken lines depict portions of the emblem surround, that form no part of the claimed design.

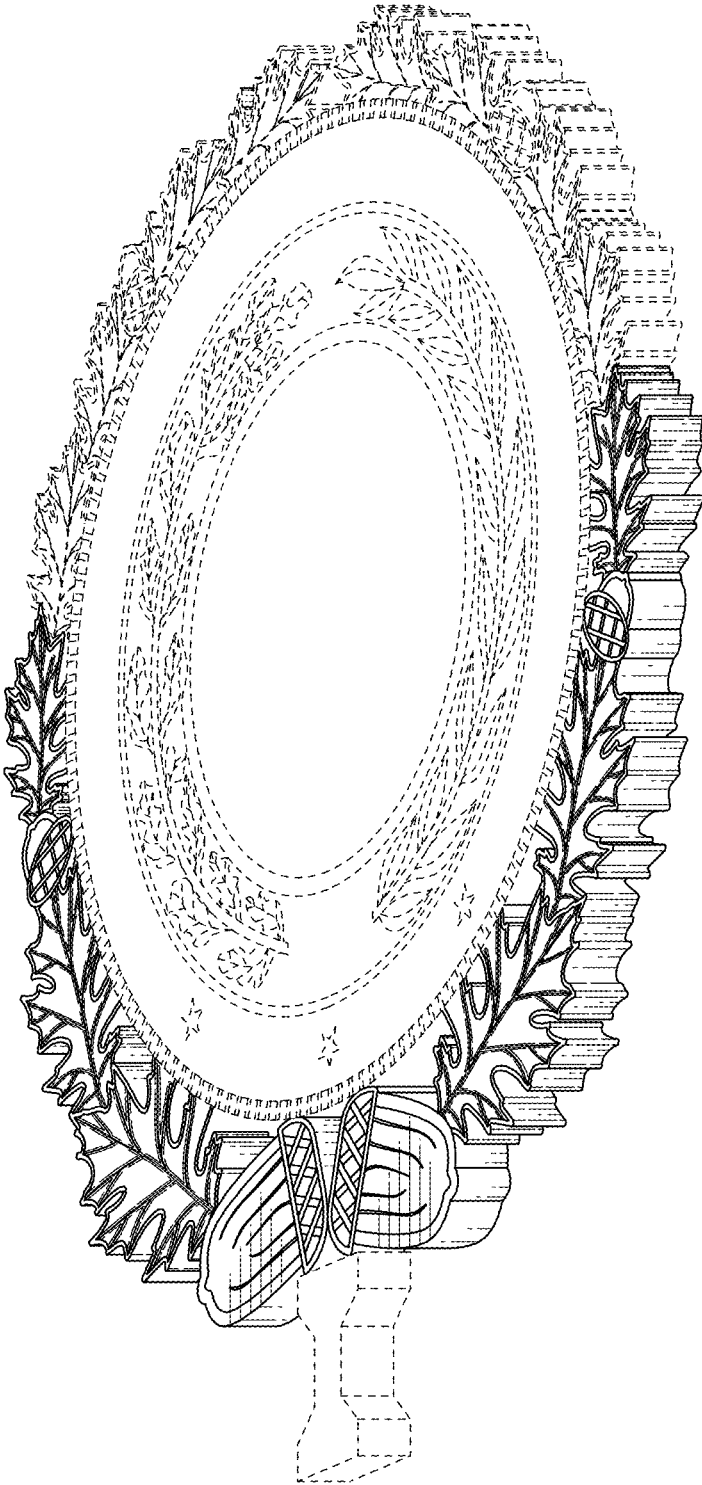

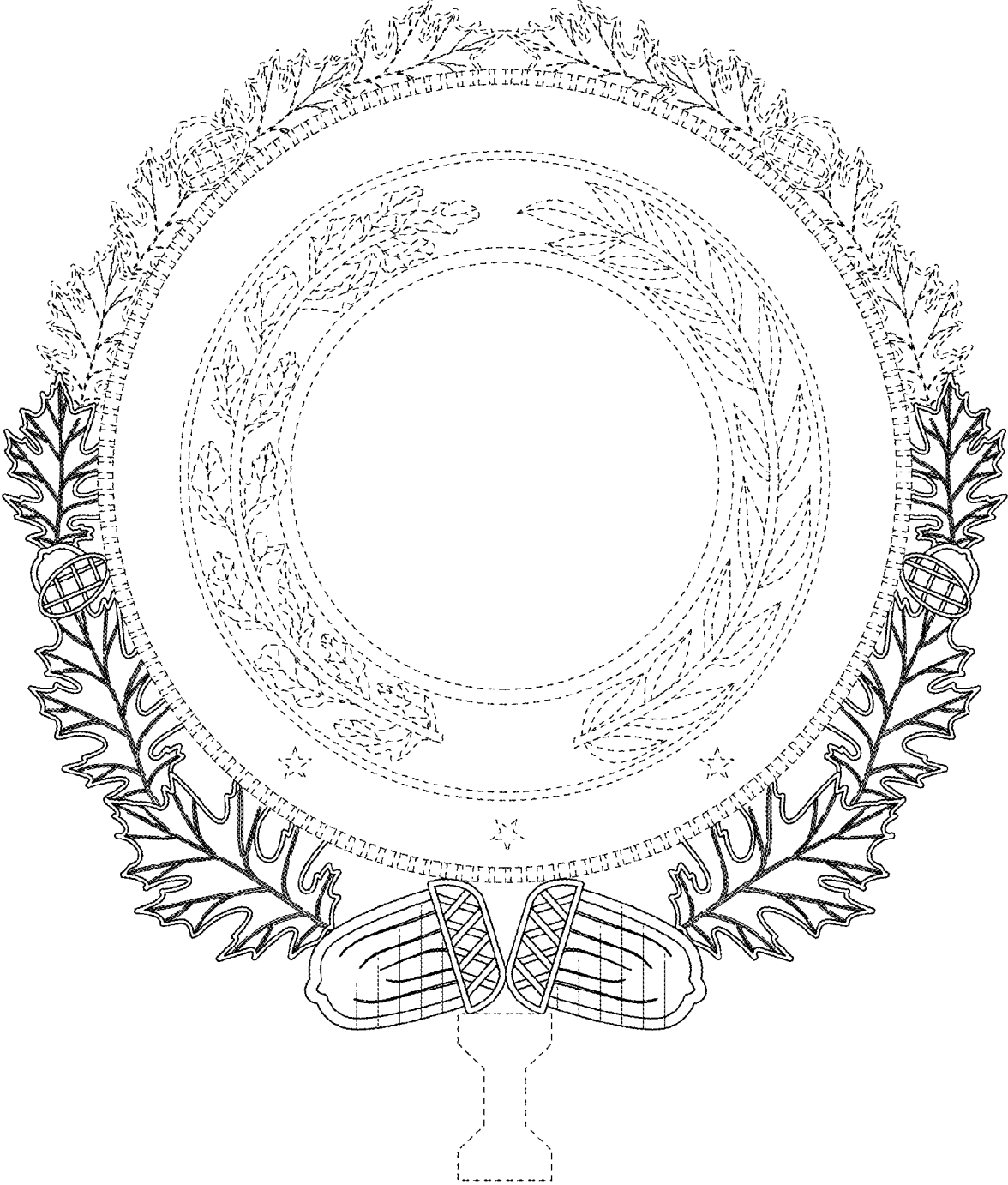

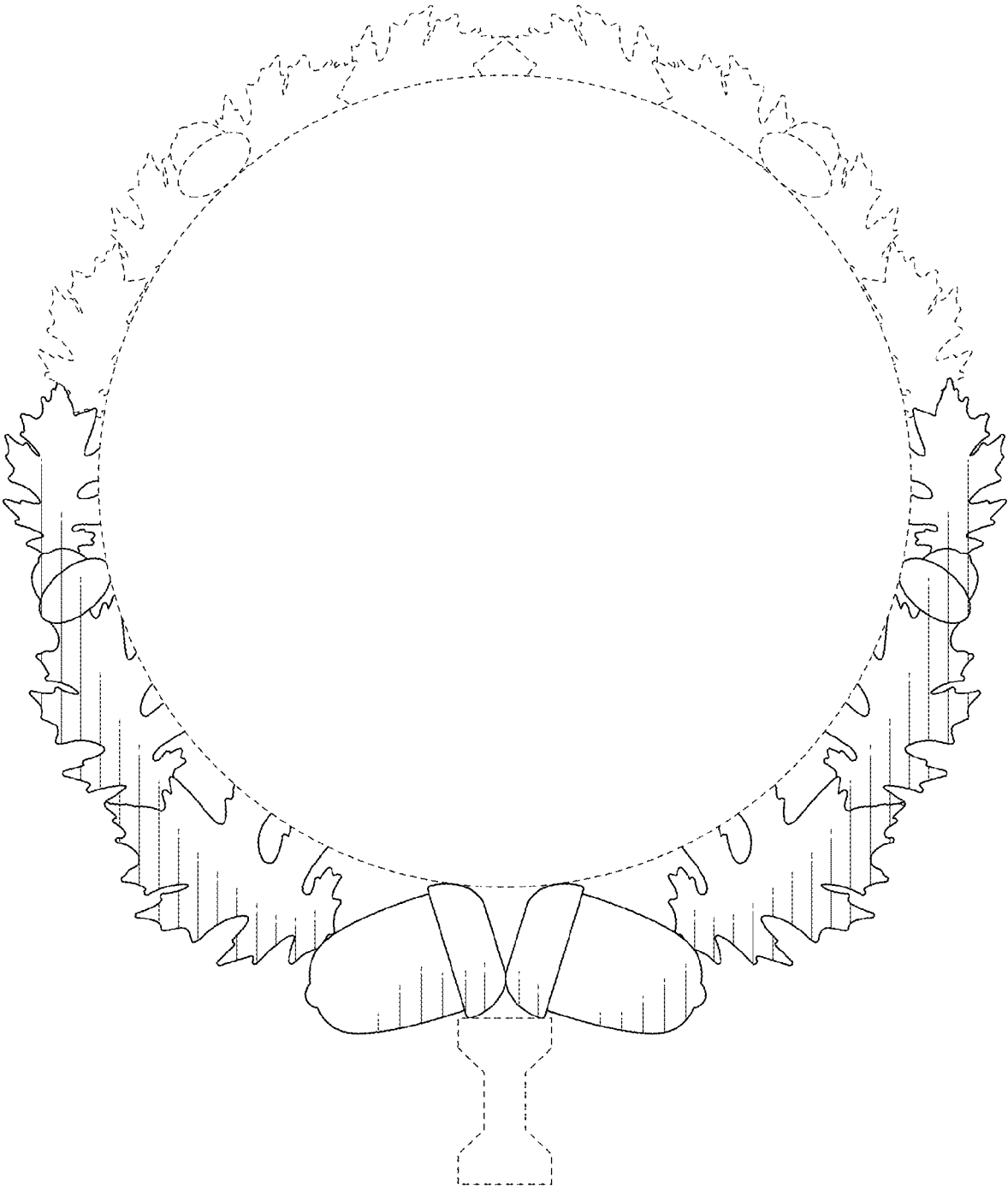

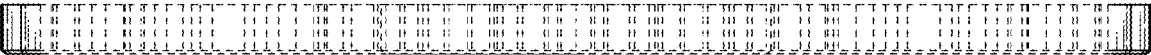

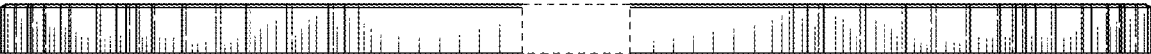

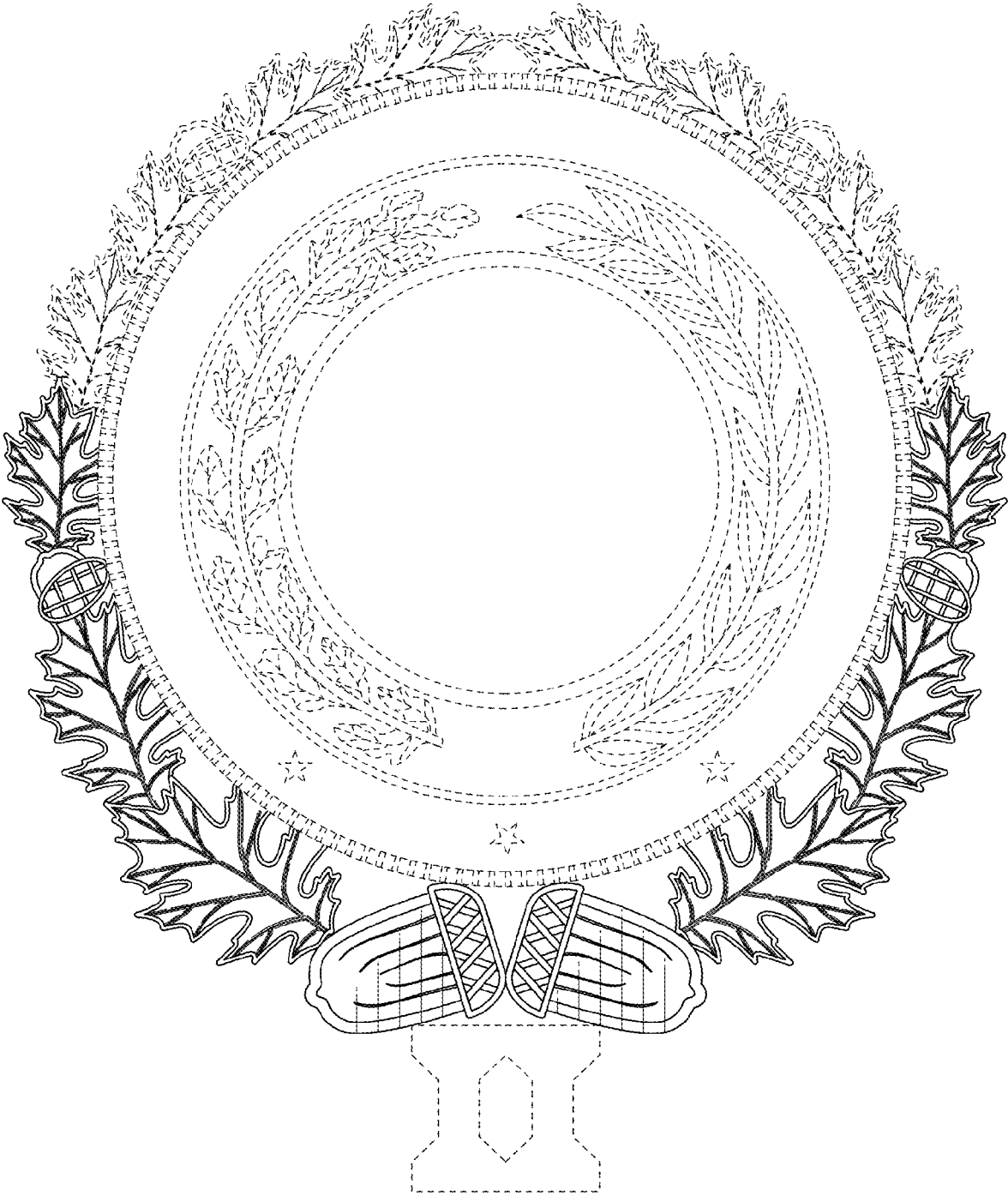

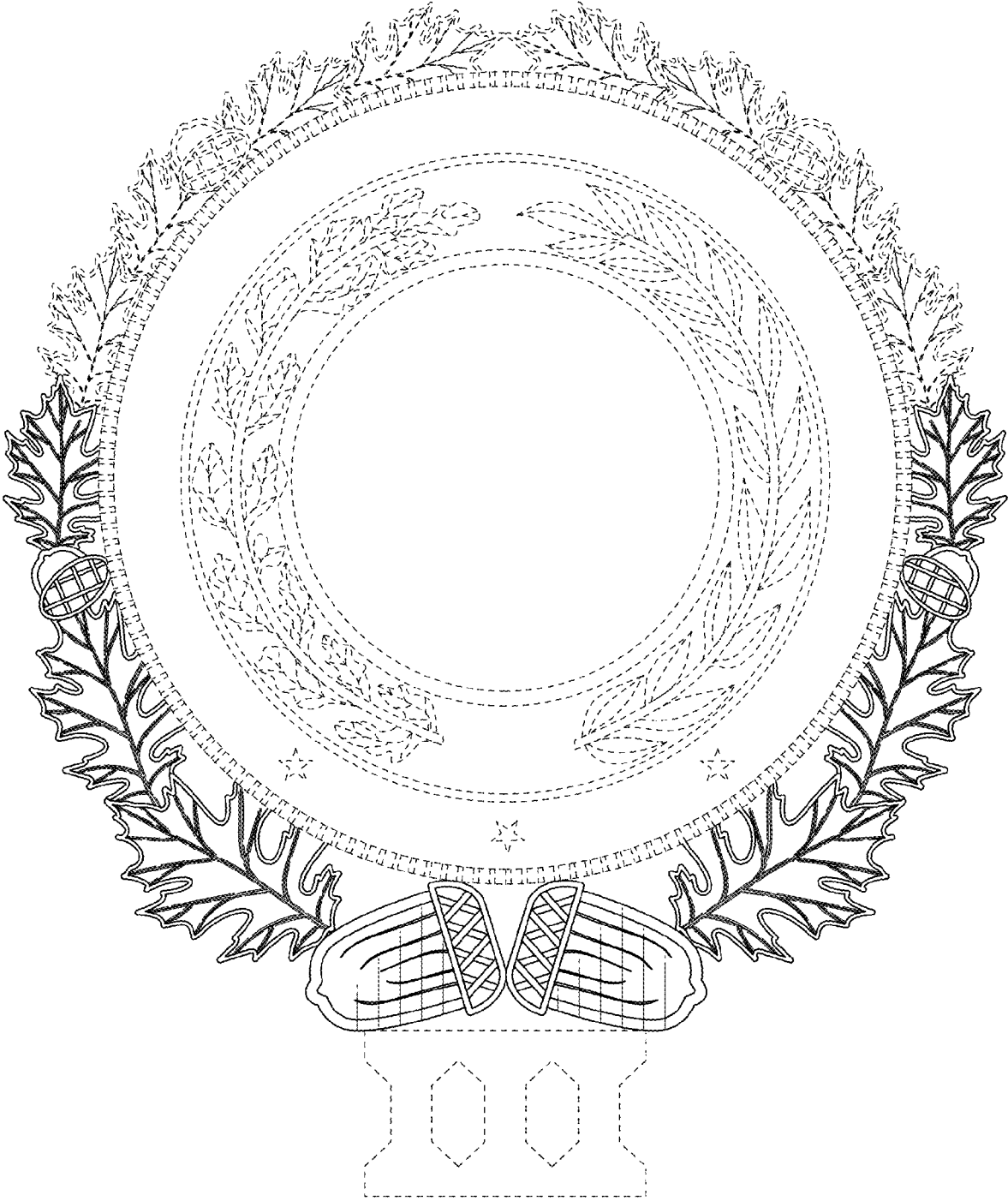

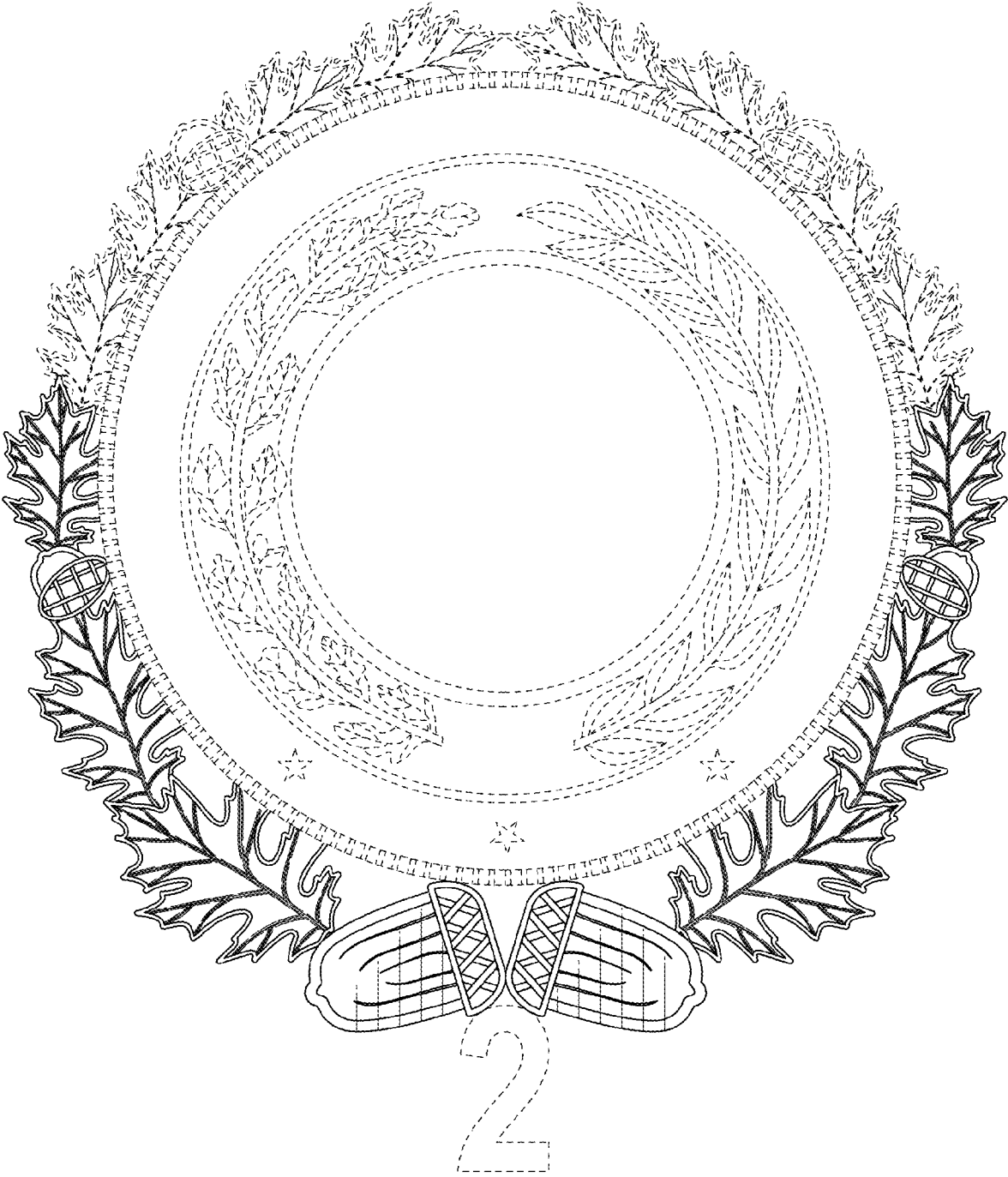

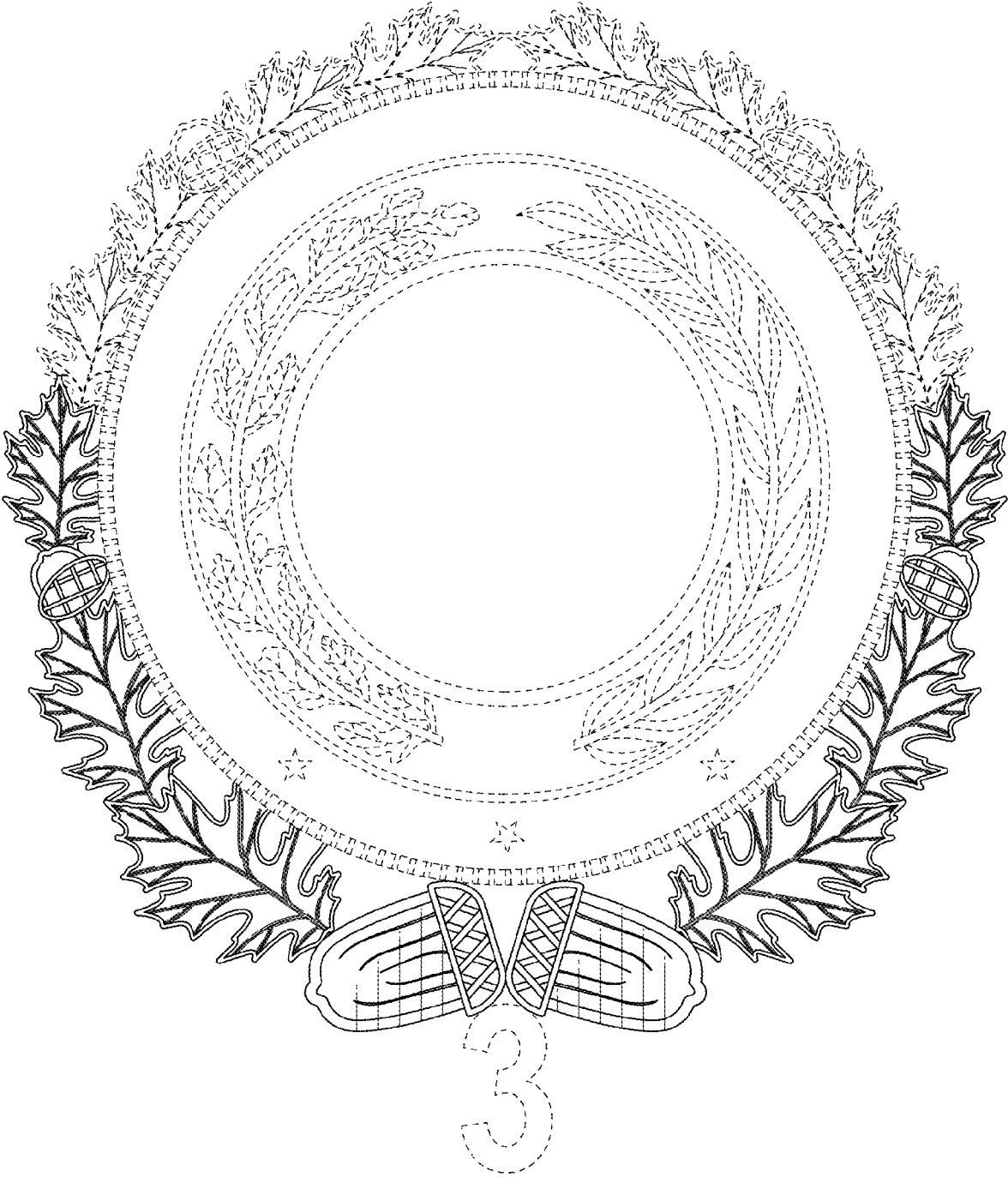
