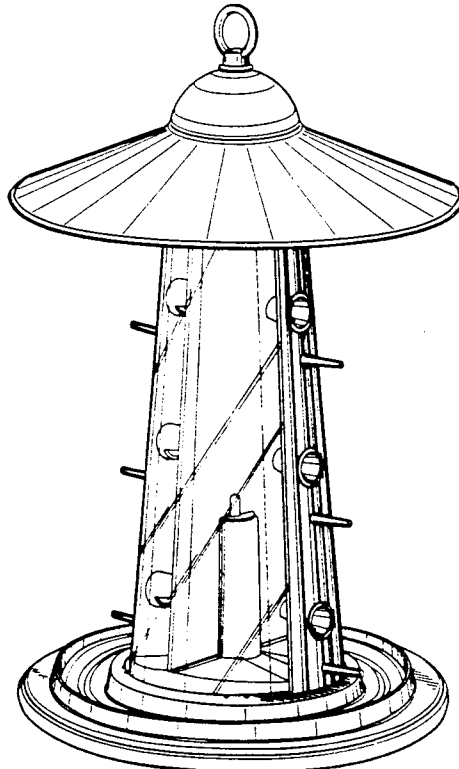

[57] **CLAIM**

The ornamental design for a perch bird feeder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a perch bird feeder showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof; the rear being a mirror image of the front view shown;
FIG. 5 is a side elevational view thereof; the opposite side being a mirror image of the side shown; and
FIG. 6 is a cross-sectional view thereof taken along line 6-6 of FIG. 2.



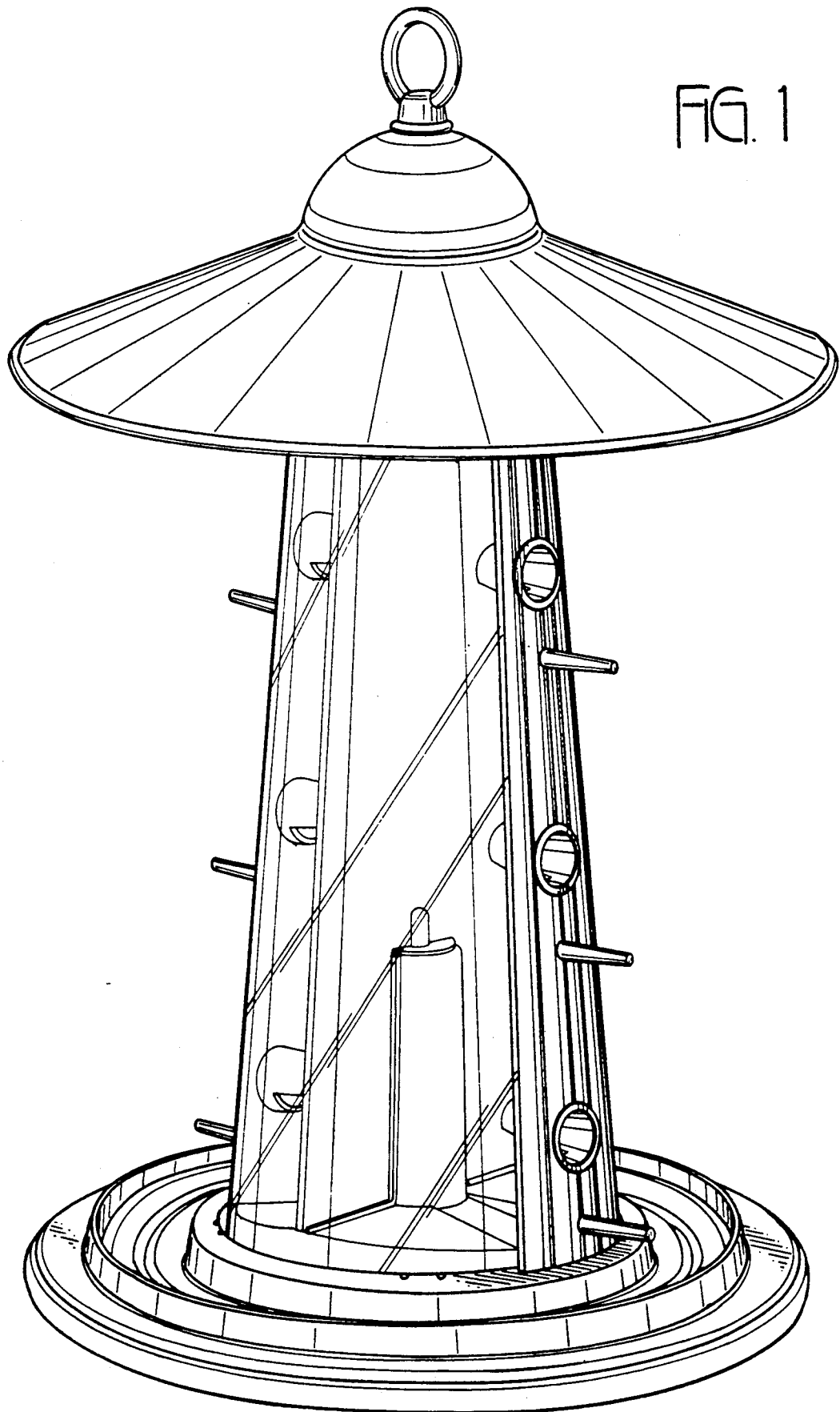
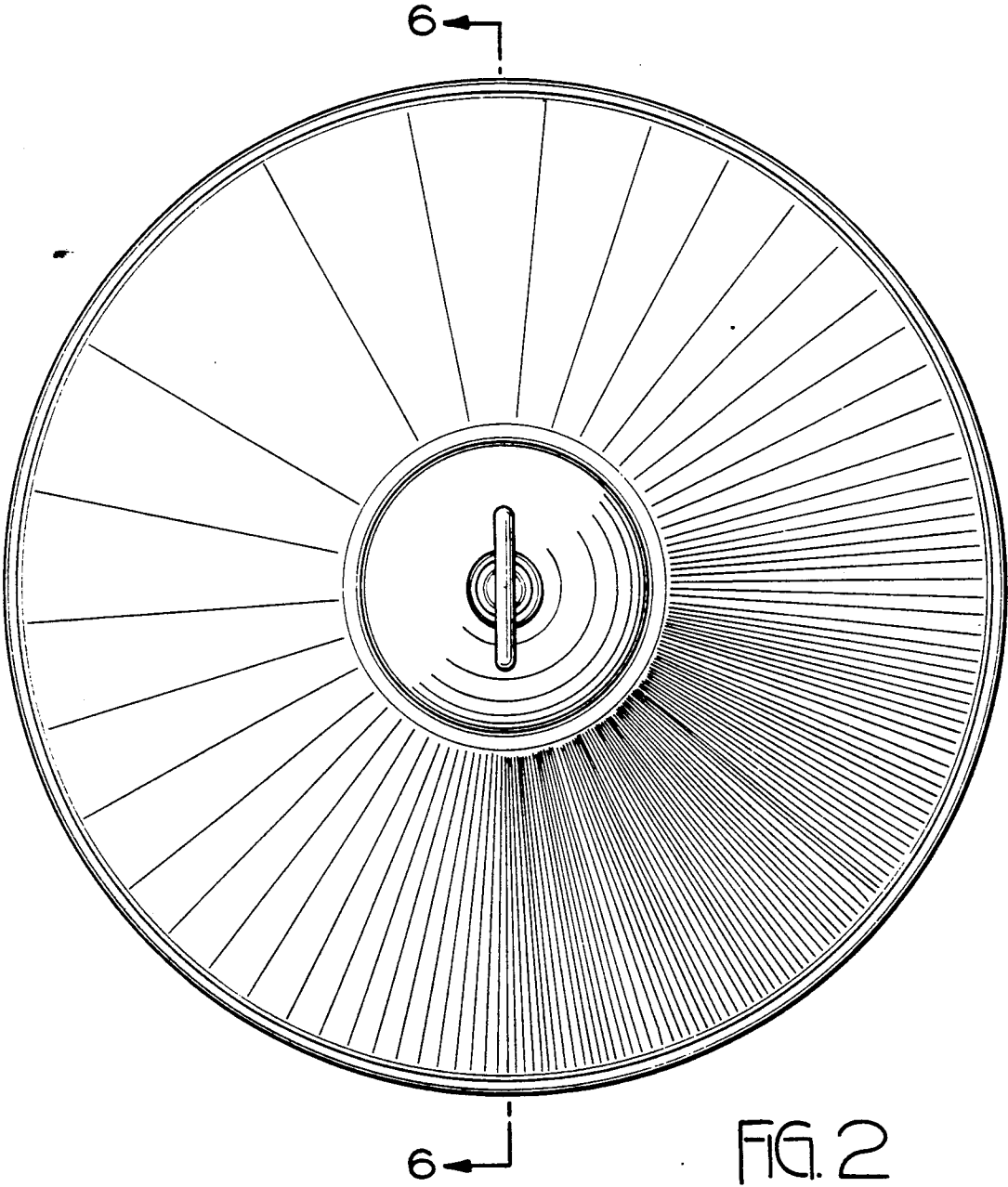

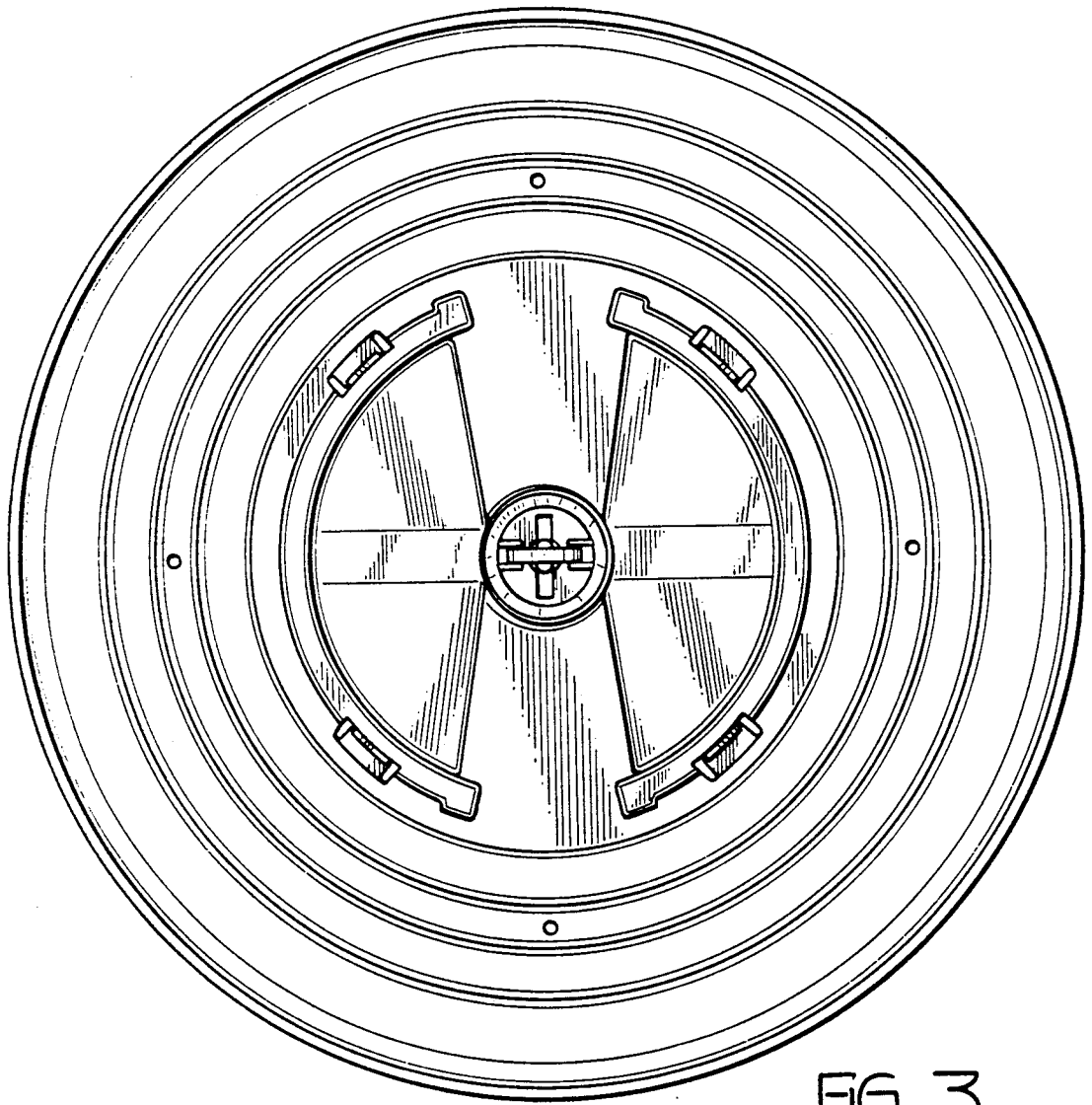

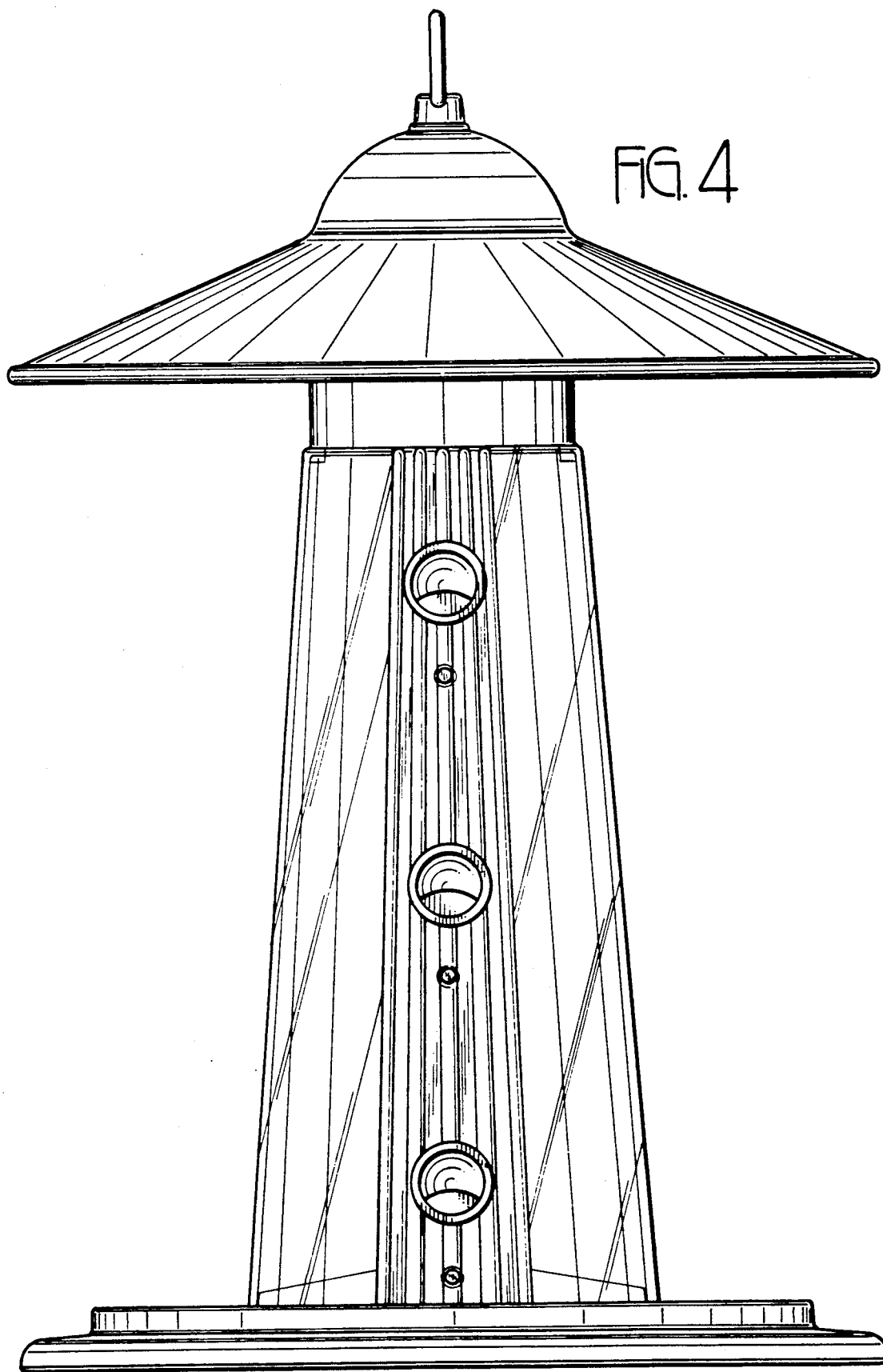

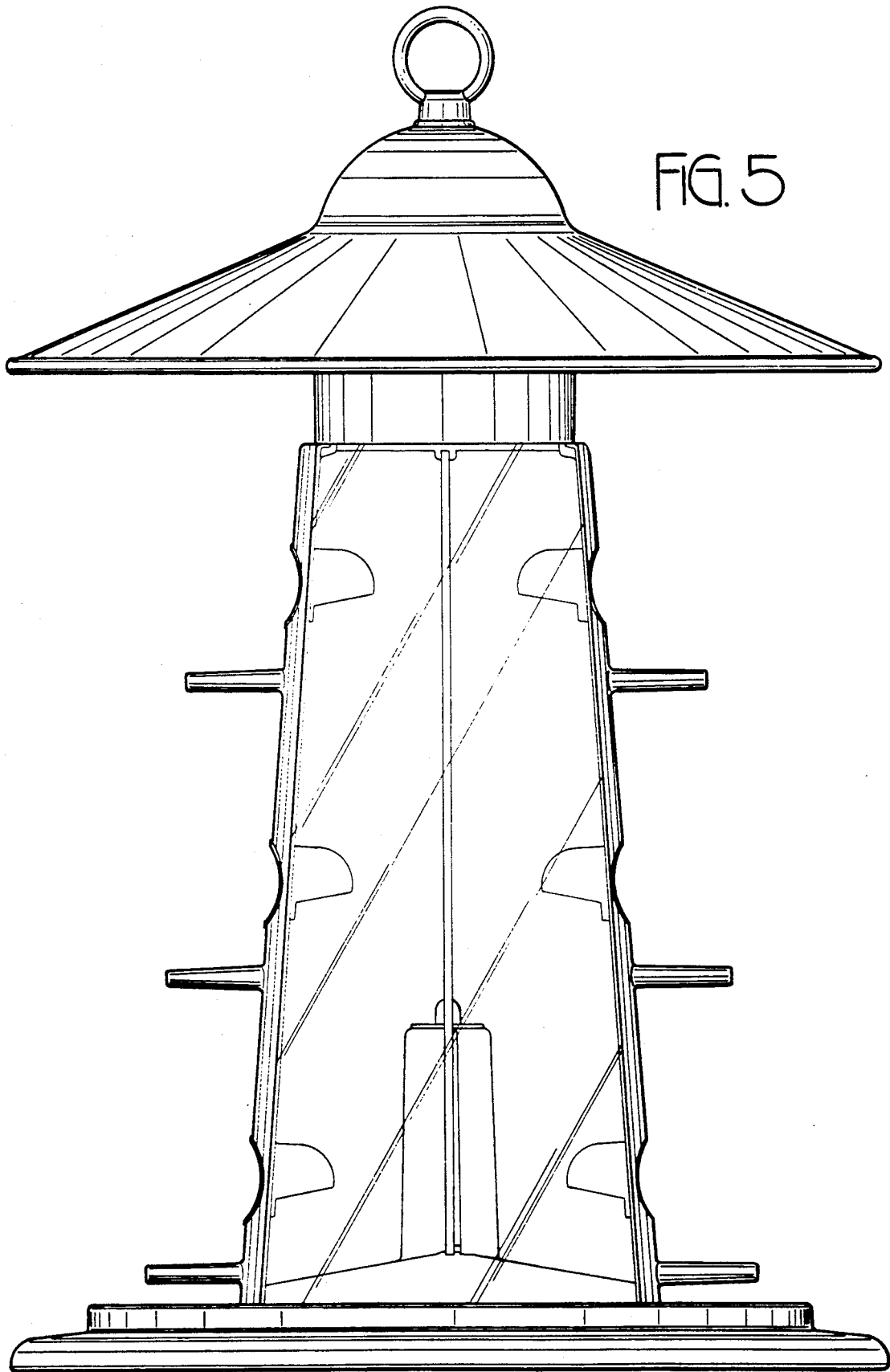
