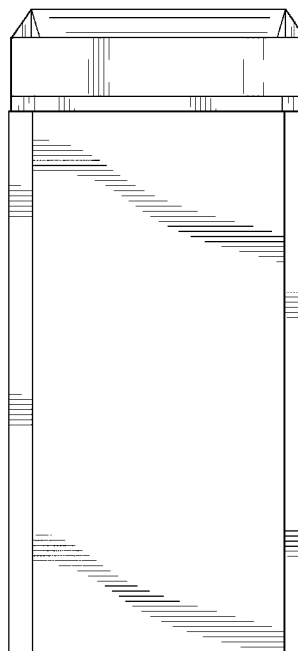
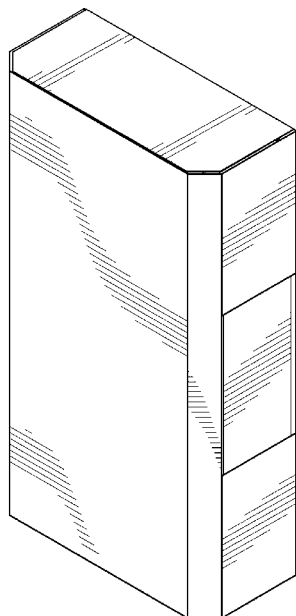
(57) **CLAIM**

The ornamental design for a cigarette pack, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cigarette pack according to our new ornamental design, with lid closed;
FIG. 2 is a reverse perspective view thereof;
FIG. 3 is a front perspective view thereof, with lid open and inner shell protruding;
FIG. 4 is a front view thereof, with lid open and inner shell protruding;
FIG. 5 is a right side view thereof, with lid open and inner shell protruding;
FIG. 6 is a front view thereof, with lid closed; and,
FIG. 7 is a top view thereof.

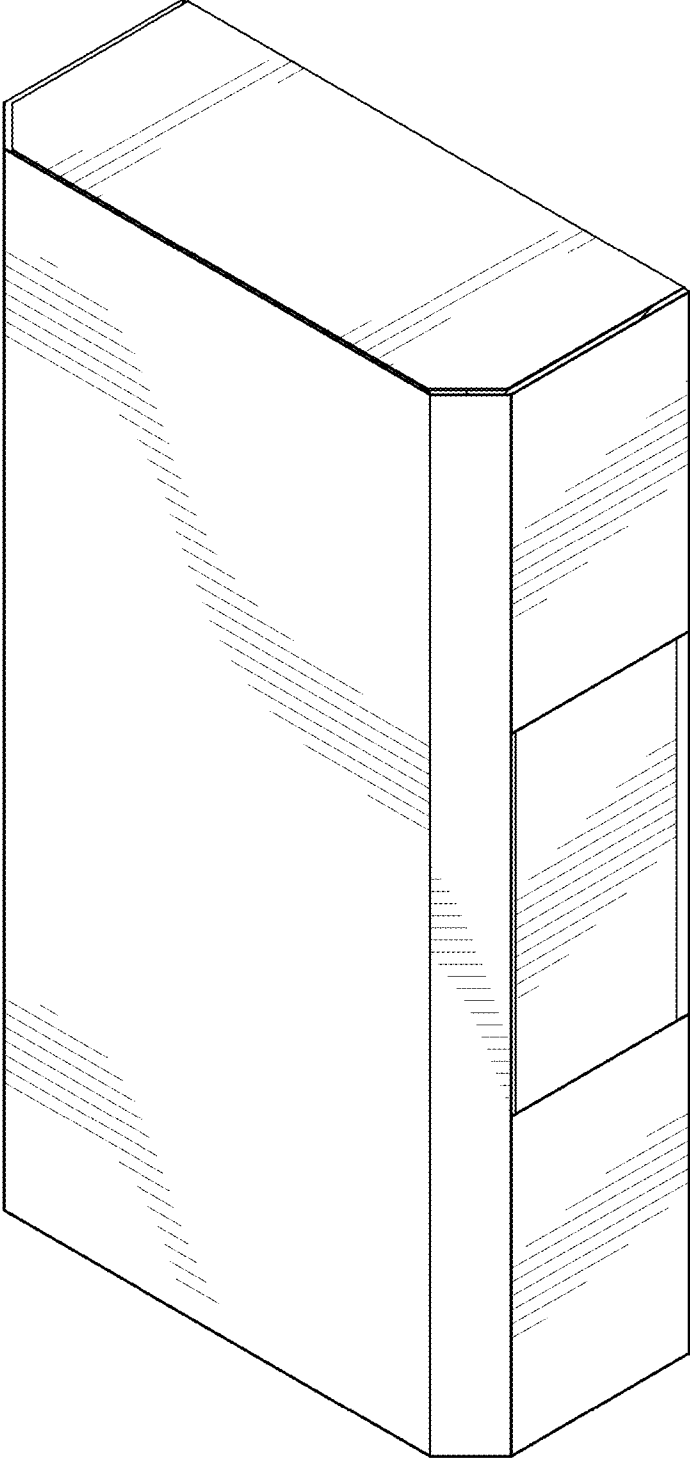

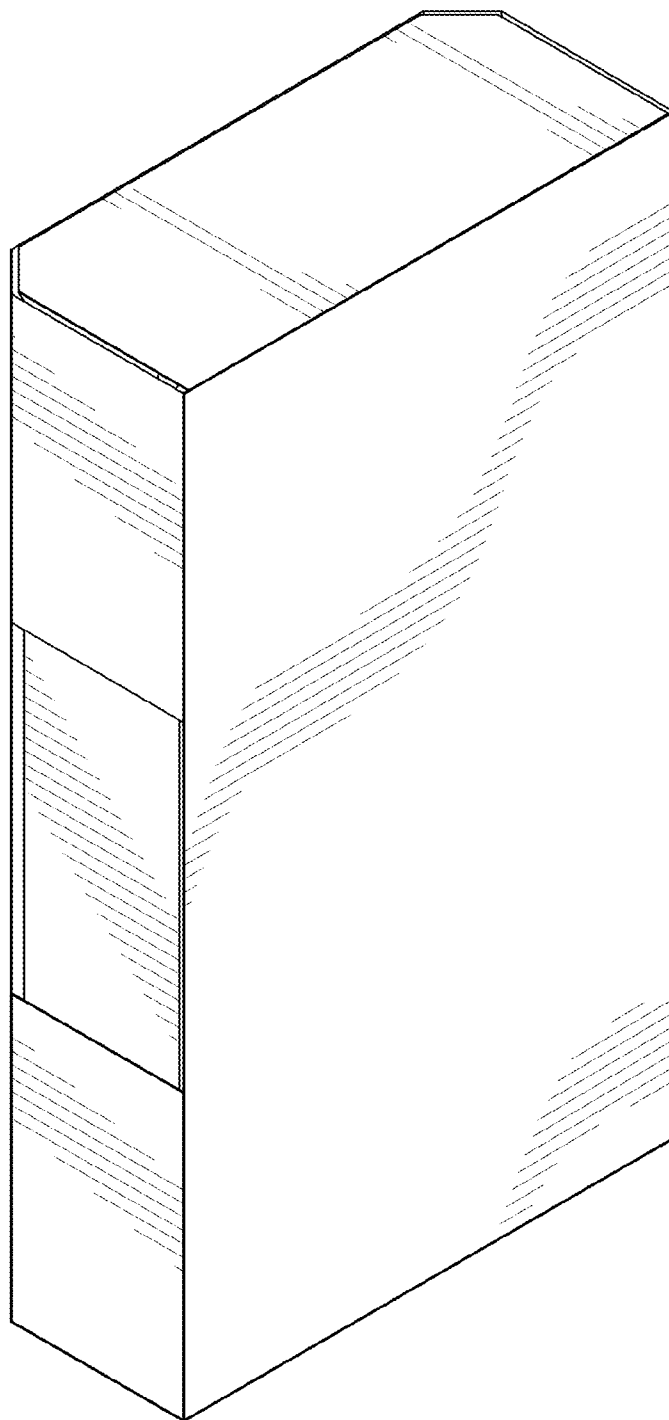

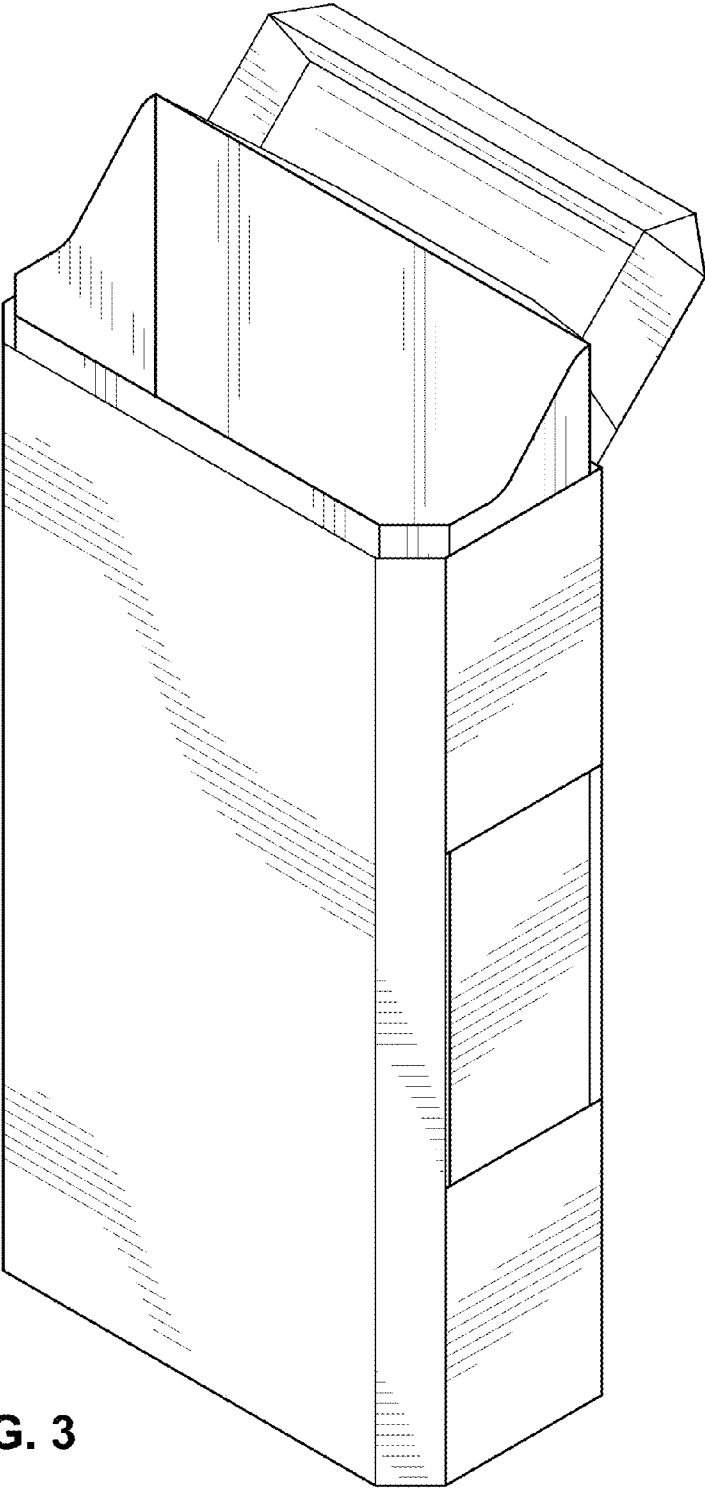

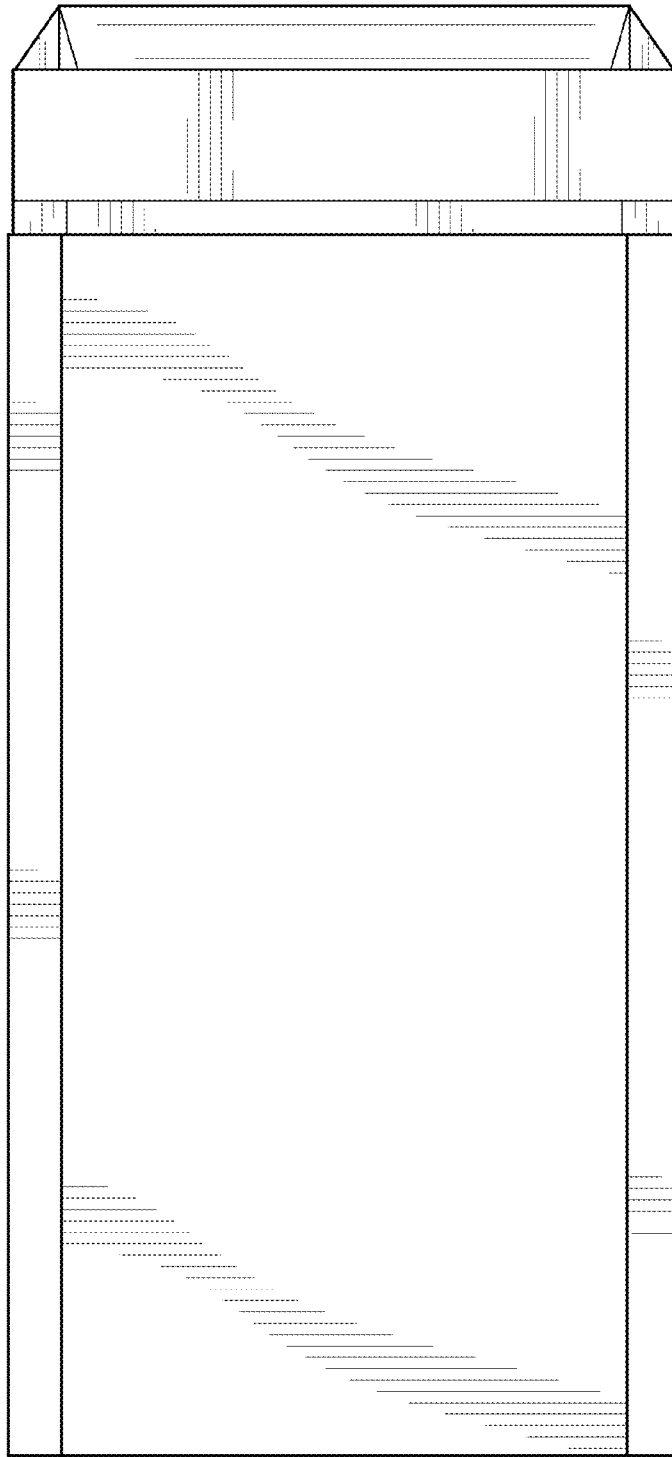

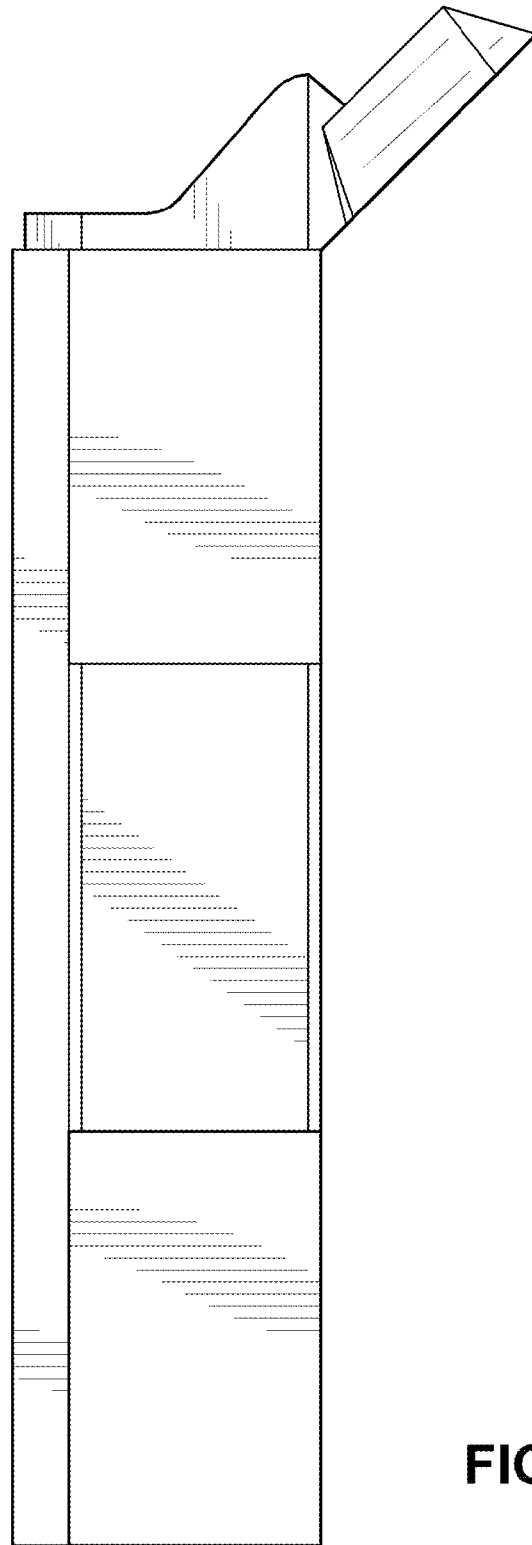

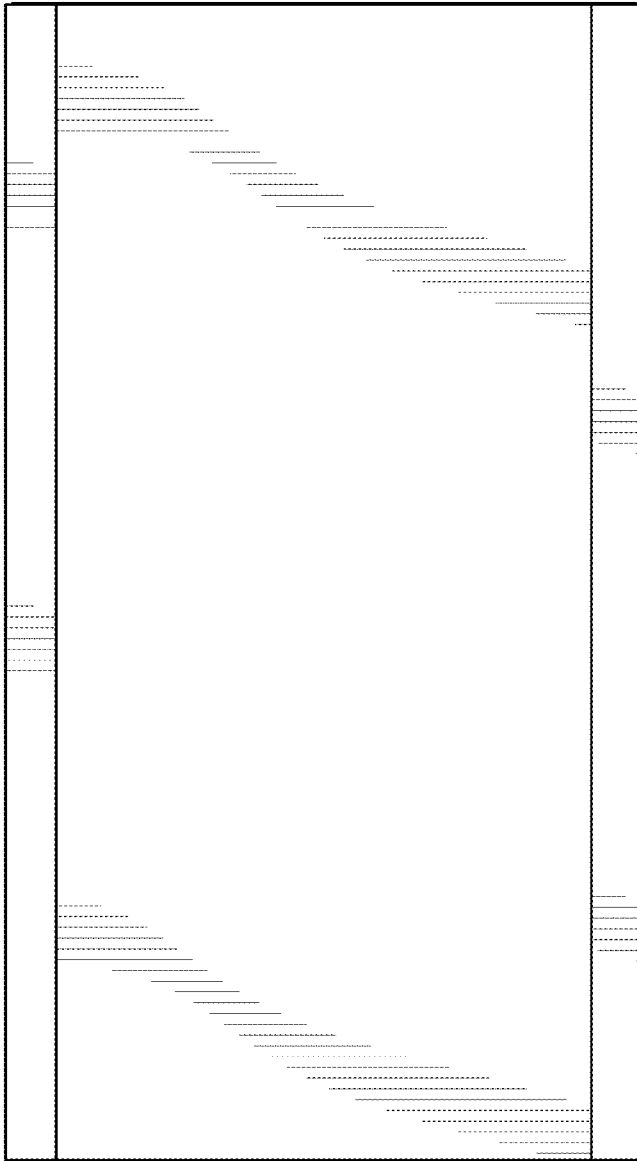

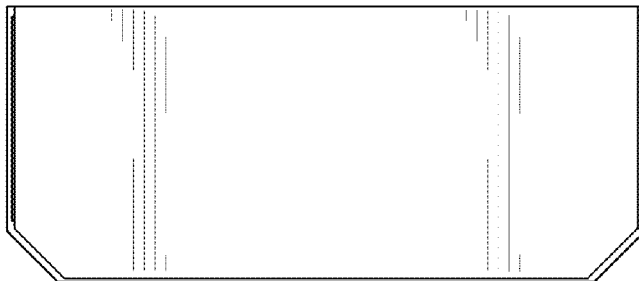
