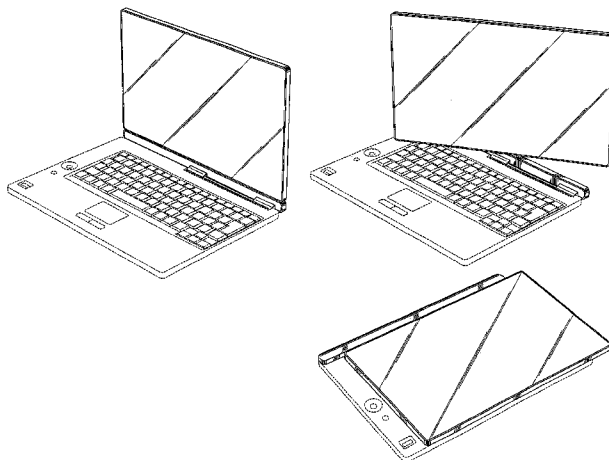
(57) **CLAIM**

The ornamental design for a portion of an electronic computer, as shown and described.

DESCRIPTION

FIG. 1 is a reduced top, front and right side perspective view of an electronic computer showing my new design, FIG. 2 is a front elevational view thereof, FIG. 3 is a rear elevational view thereof, FIG. 4 is a left side elevational view thereof, FIG. 5 is a right side elevational view thereof, FIG. 6 is a top plan view thereof, FIG. 7 is a bottom plan view thereof, FIG. 8 is a front elevational view thereof showing the article in a closed position, FIG. 9 is a right side elevational view thereof showing the article in the closed position, FIG. 10 is a top plan view thereof showing the article in the closed position, FIG. 11 is a top plan view thereof showing the article in the closed position with the display being turned 180 degrees, FIG. 12 is a front elevational view thereof showing the article in the closed position with the display being turned 180 degrees, FIG. 13 is a reduced perspective view thereof showing the article with the display being turned to a midway position, FIG. 14 is a perspective view thereof showing the article in the closed position with the display being turned 180 degrees, FIG. 15 is a perspective view thereof showing the article in the closed position; and, FIG. 16 is a front elevational view thereof showing the article in the condition where a power source is on. The broken lines are shown in the views for illustrative purposes only and form no part of the claimed design.

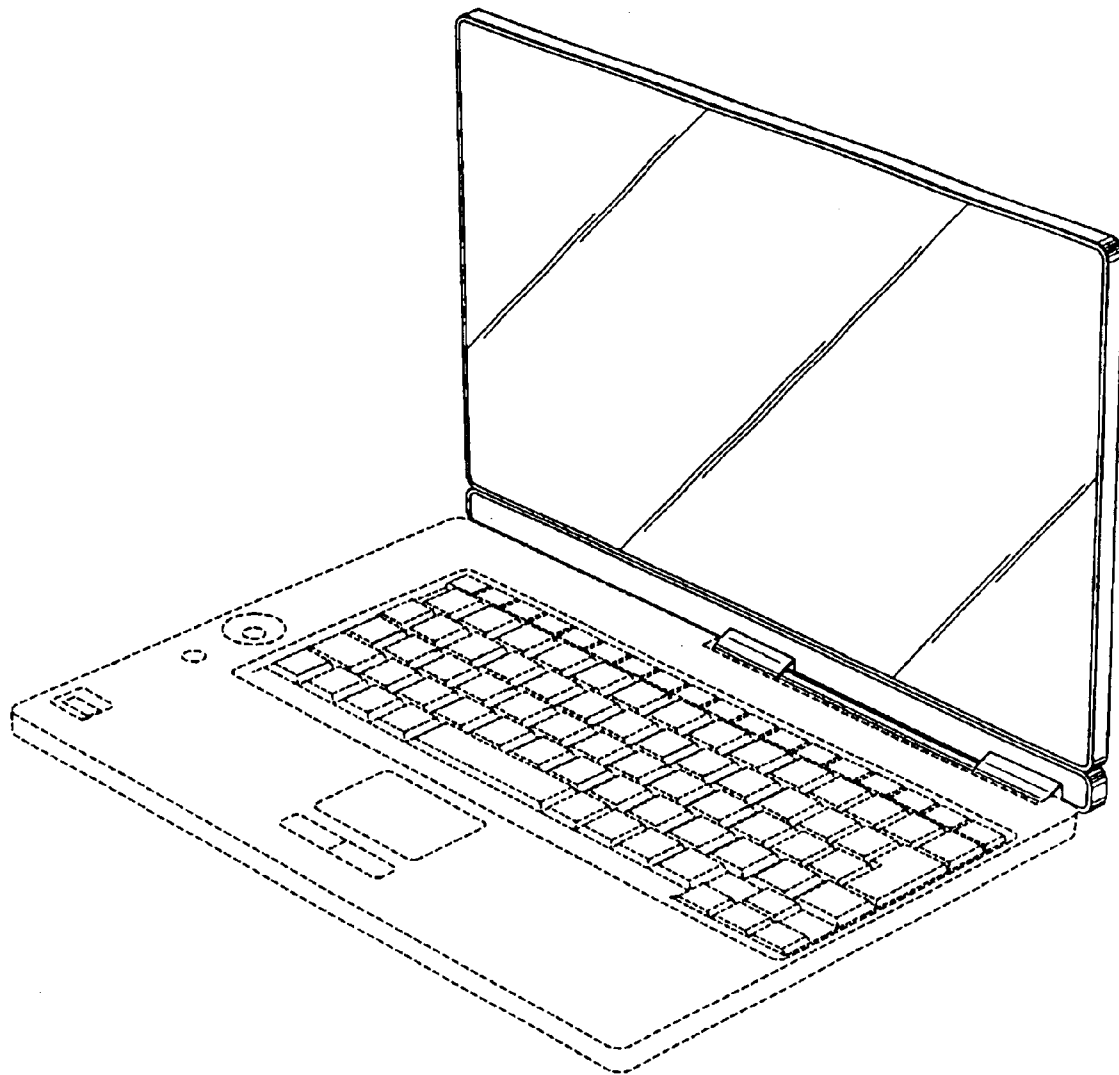

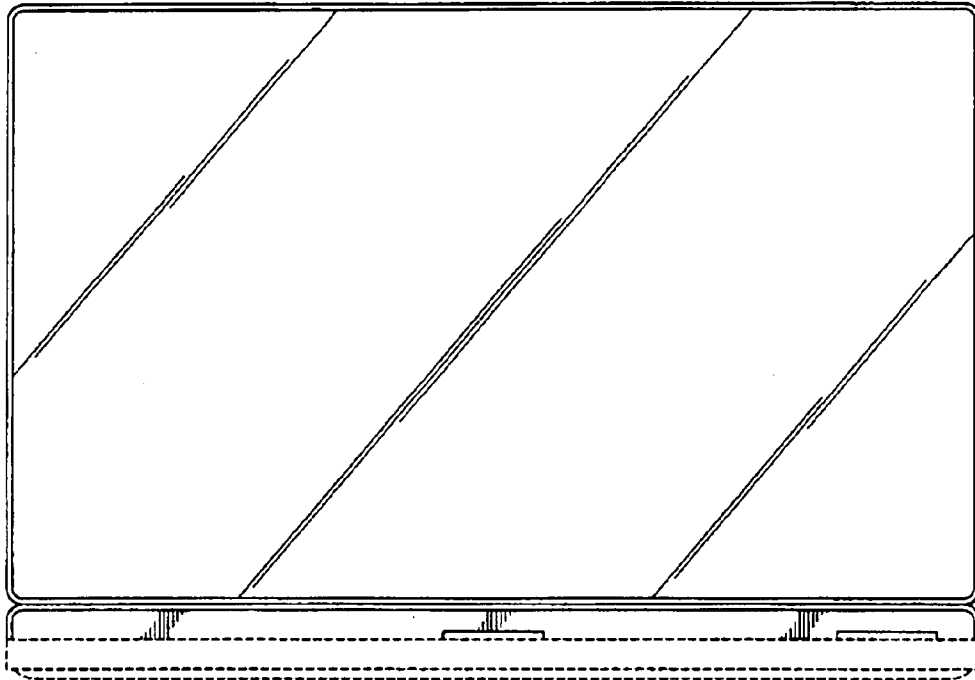

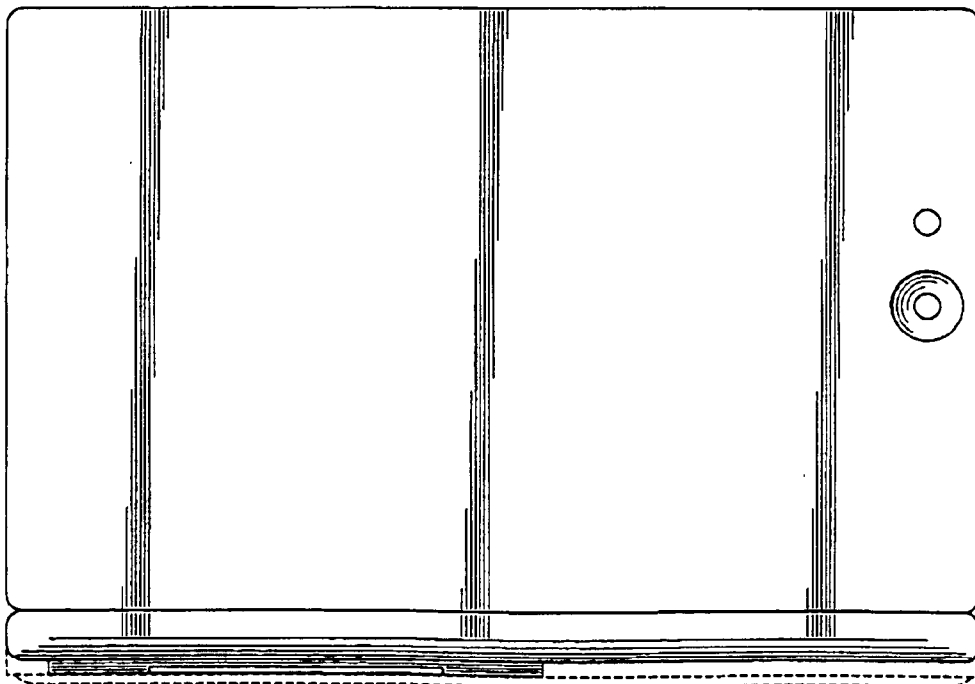

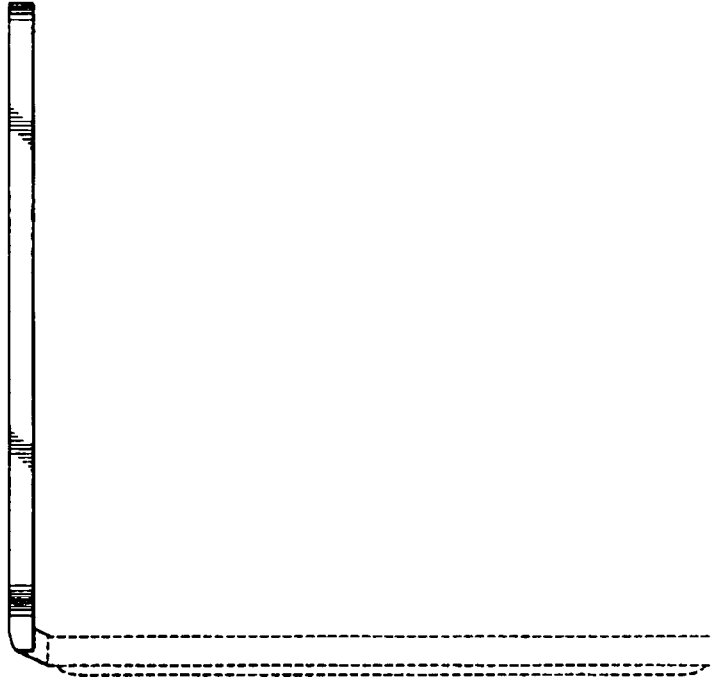

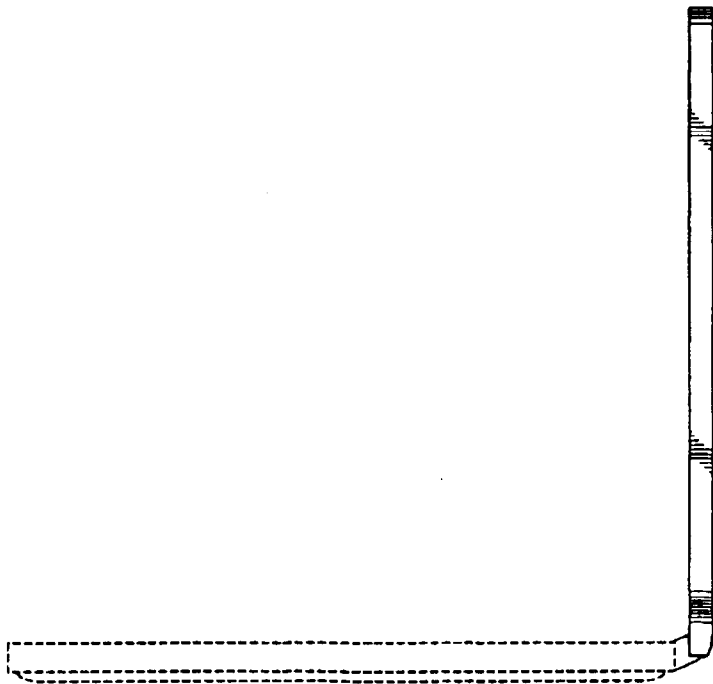

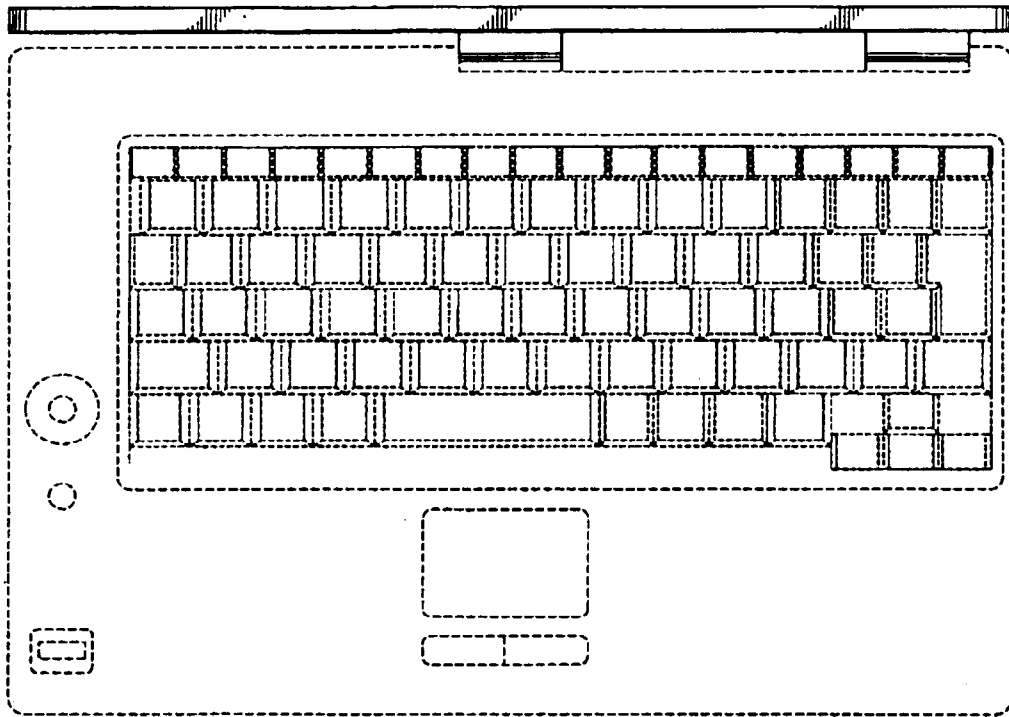

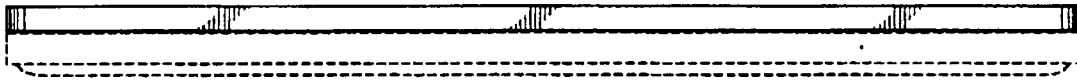

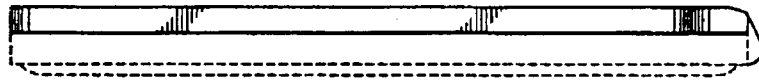

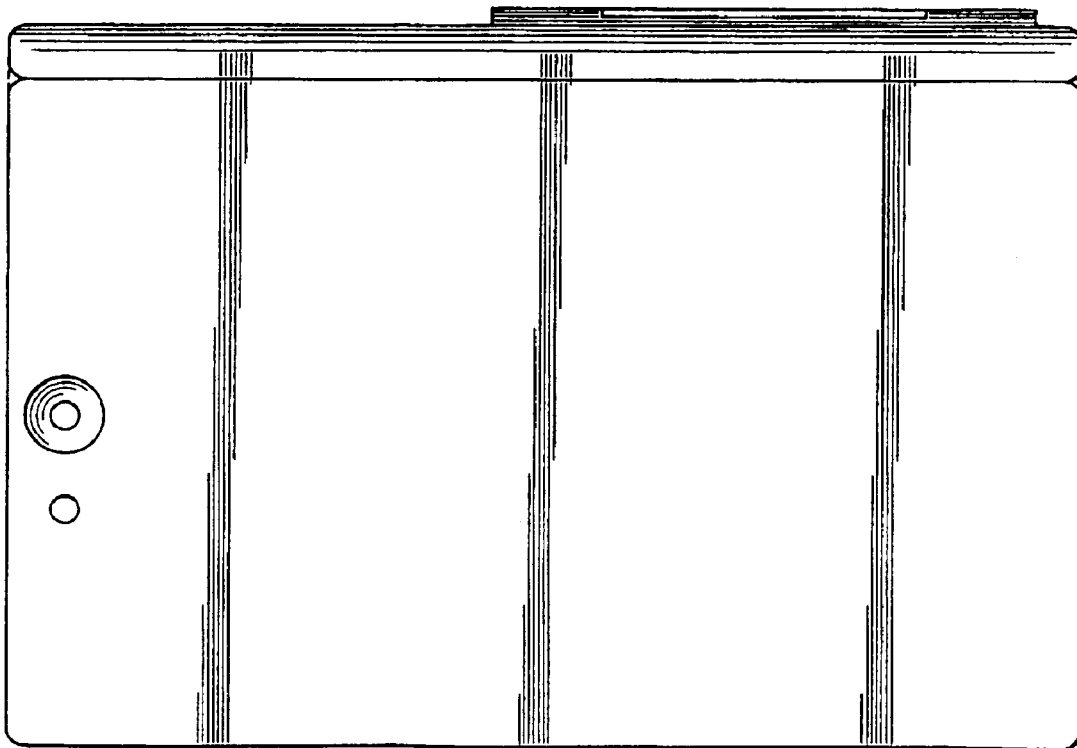

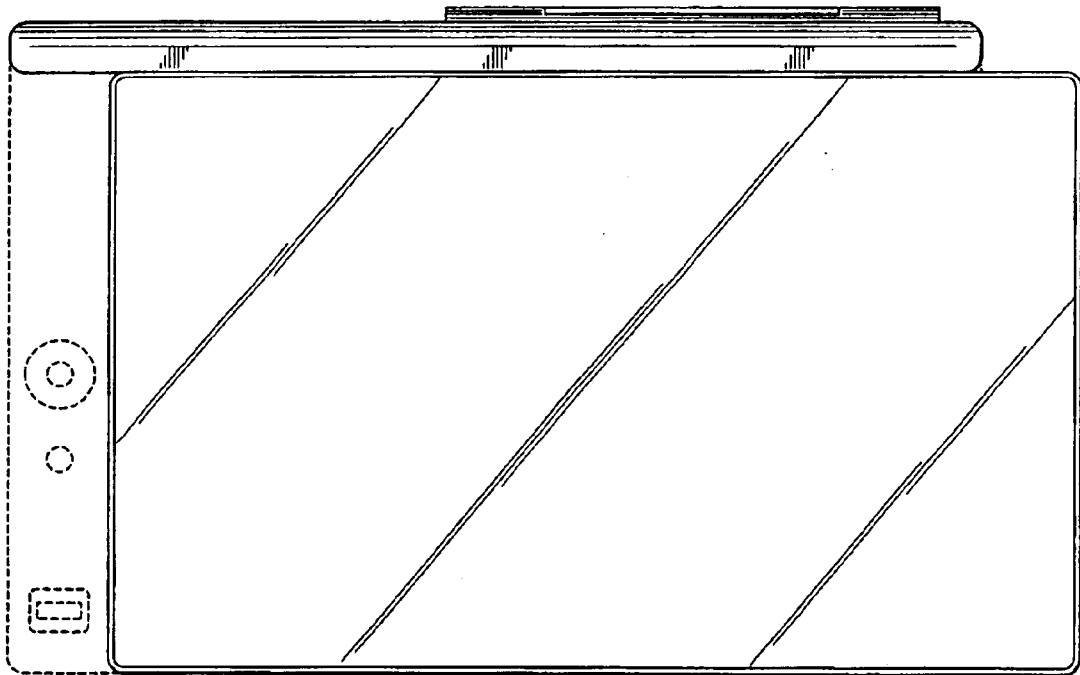

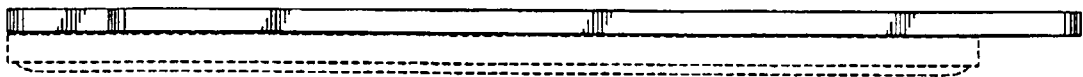

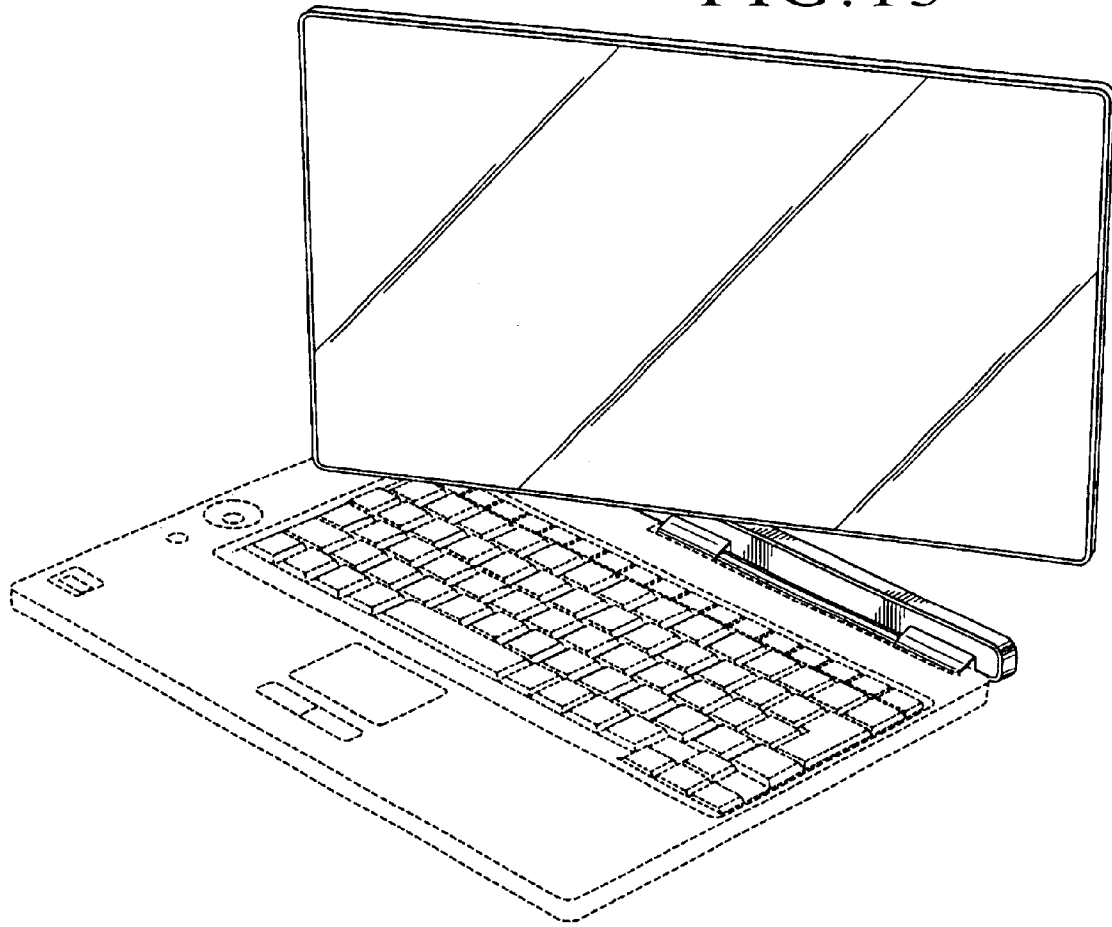

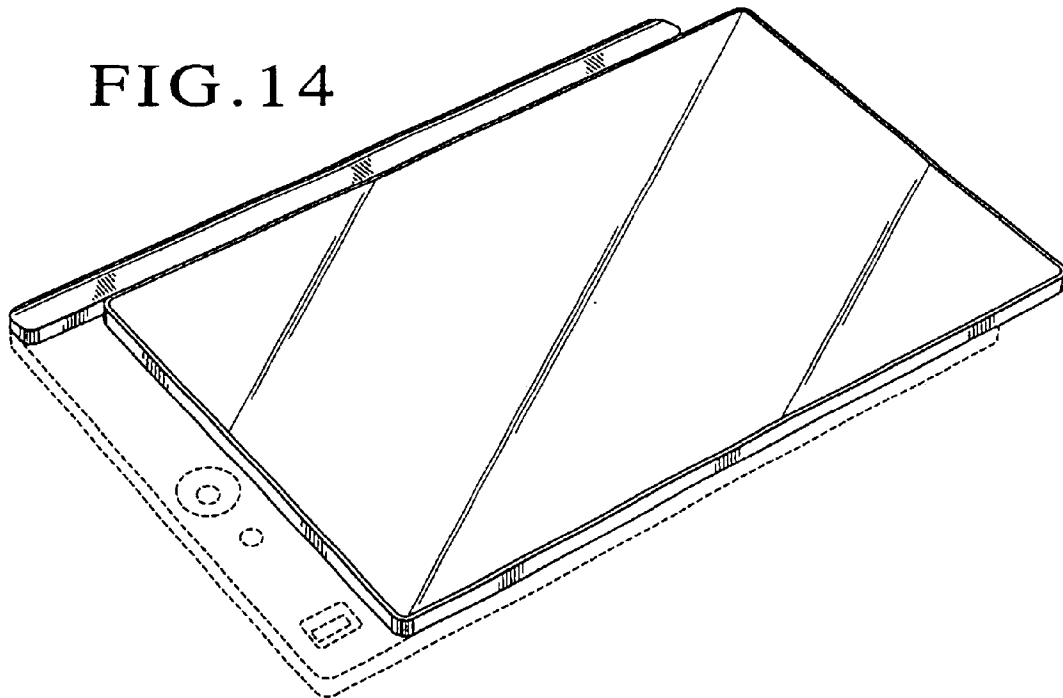

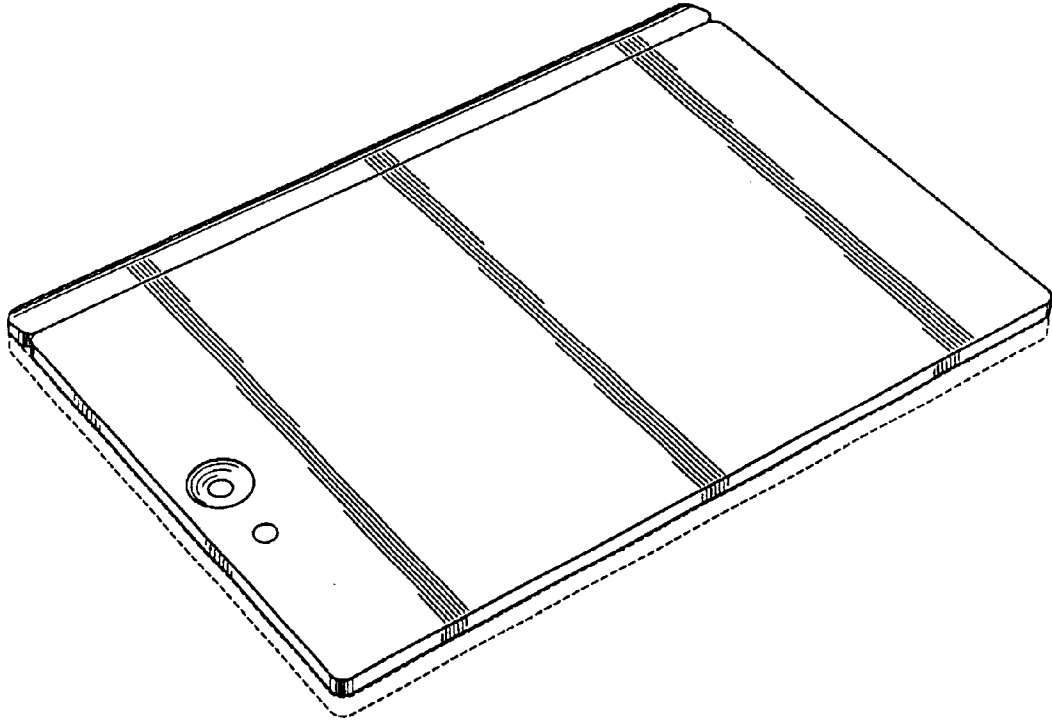
