The ornamental design for a shoe upper material, as shown and described.

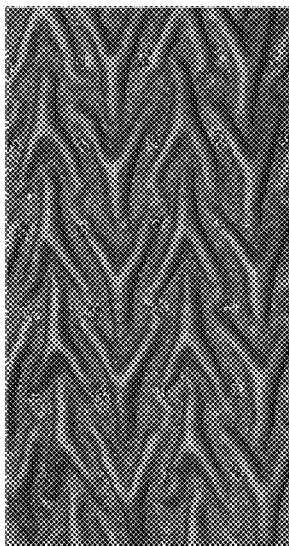
**DESCRIPTION**
