DESCRIPTION

FIG. 1 is a perspective view of a portion of a shoe sole showing my new design;

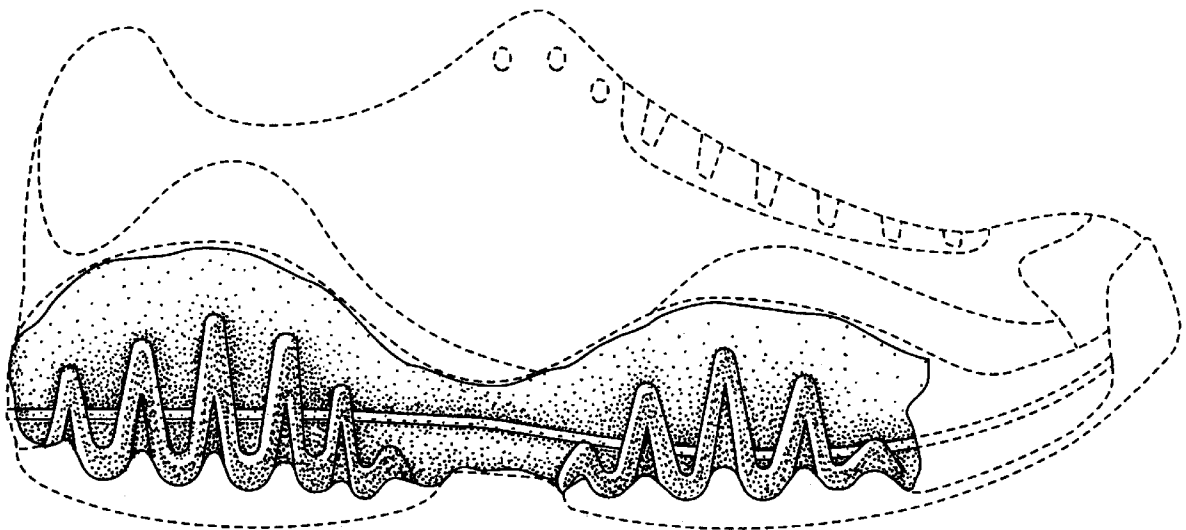
FIG. 2 is a front elevational view thereof;

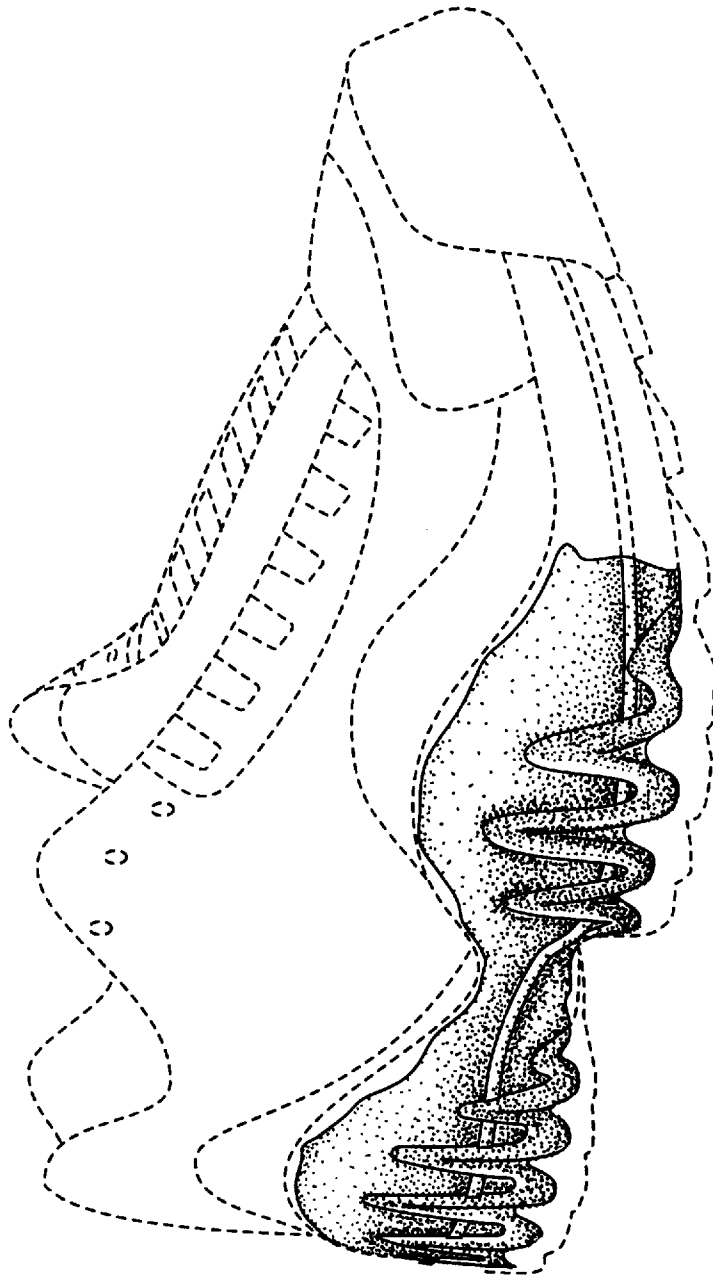

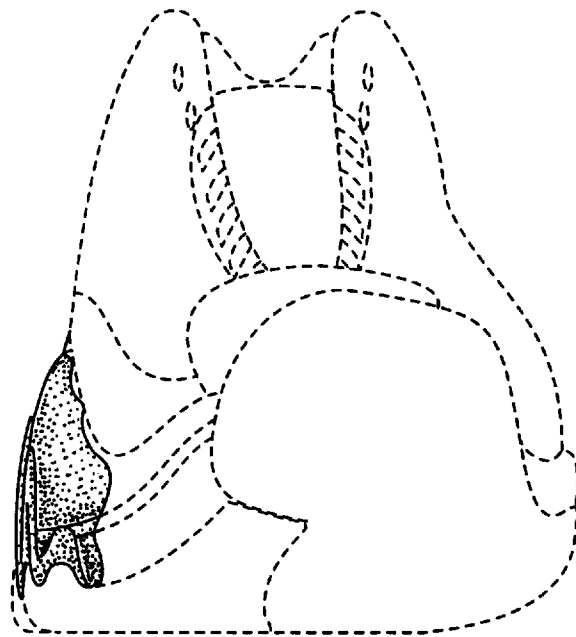

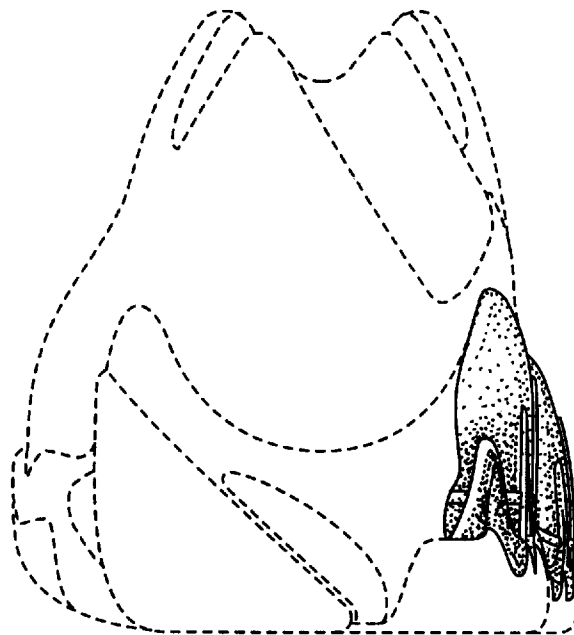

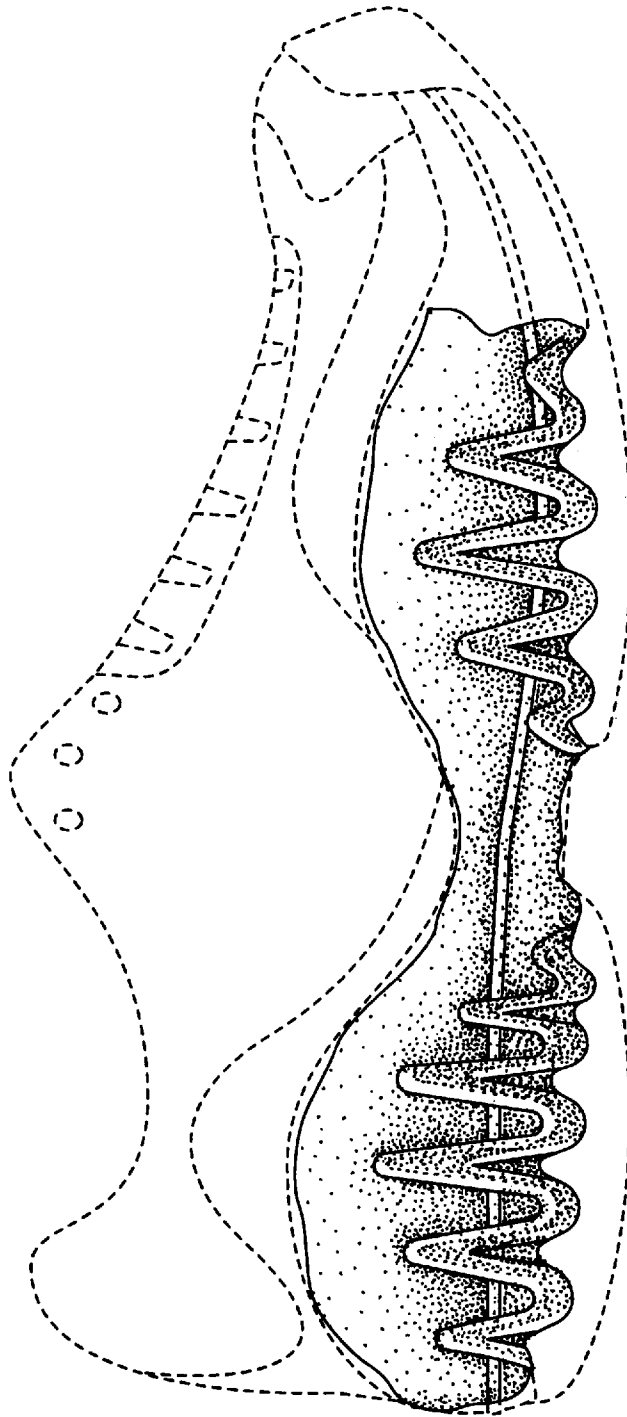
