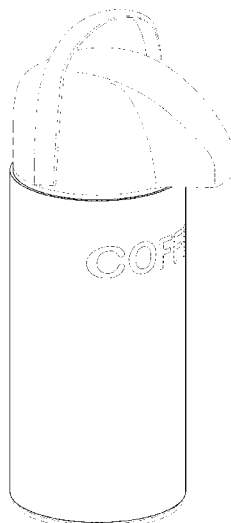
(57) **CLAIM**

I claim the ornamental design for a removable neoprene sleeve for an airport beverage dispenser, as shown and described.

DESCRIPTION

FIG. 1 is an environmental perspective view of a removable neoprene sleeve for an airport dispenser showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof showing a hot weld seam thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof; and,
FIG. 6 is a top view thereof, the bottom view being a mirror image.
The broken lines in the drawings show environmental structure that form no part of the claimed design.

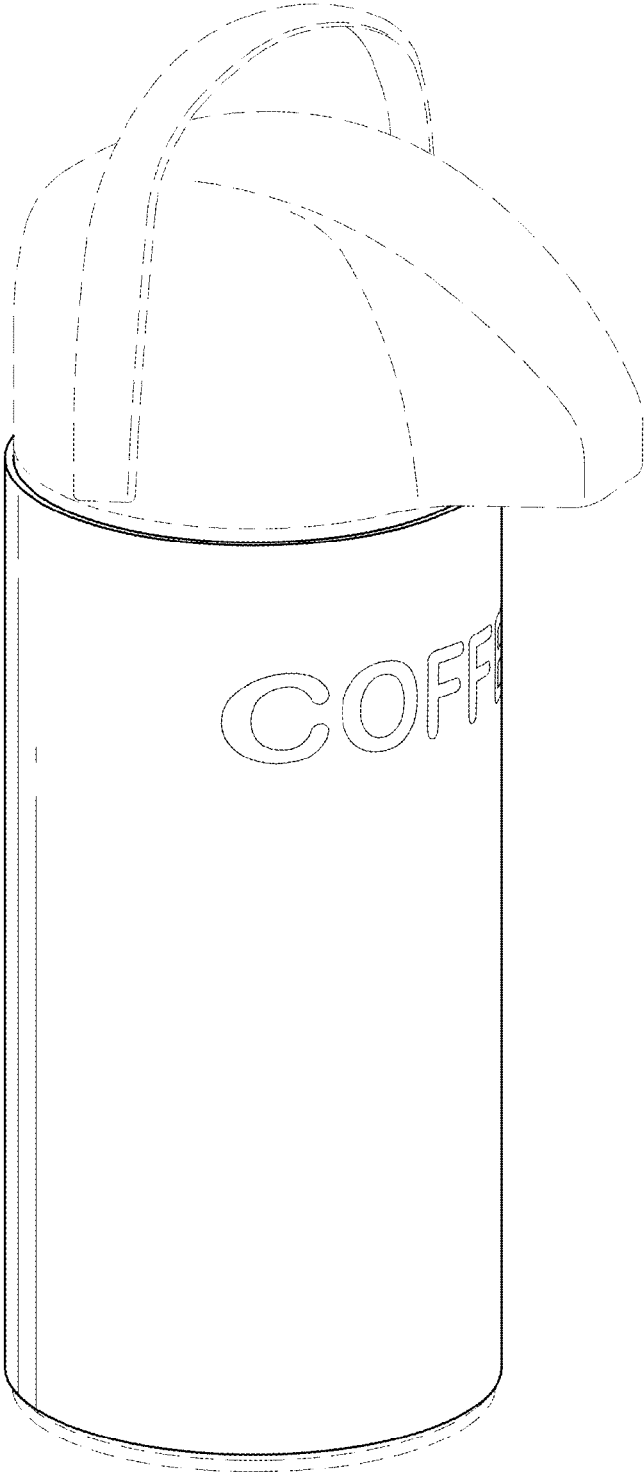

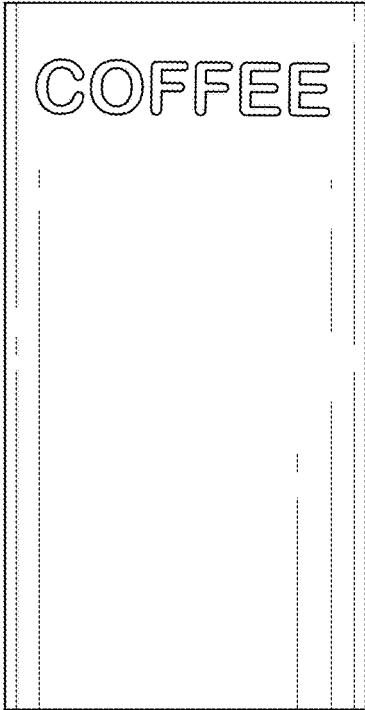

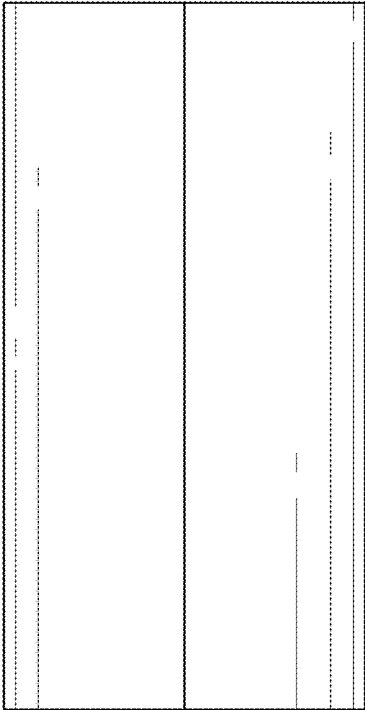

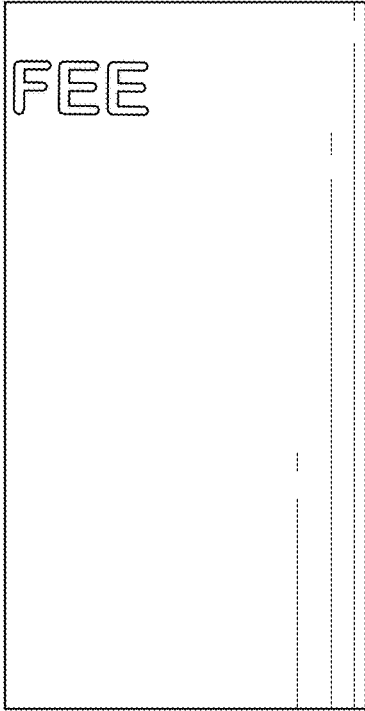

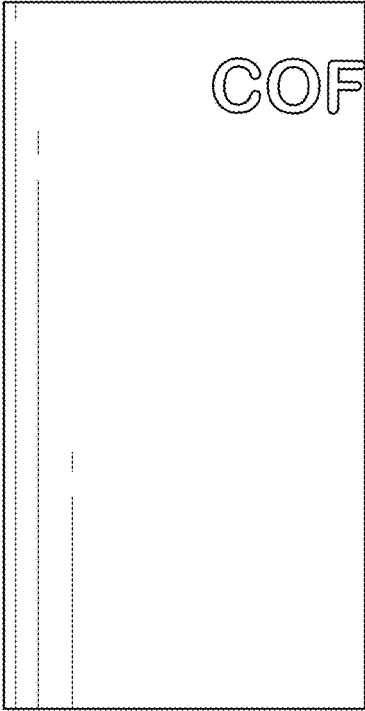

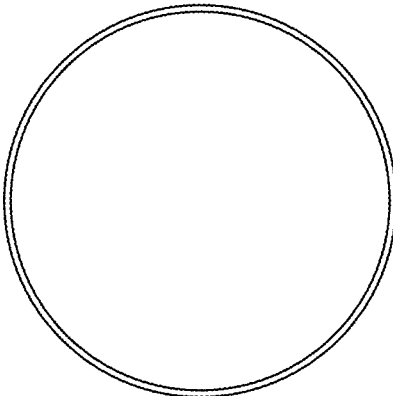
