We claim the ornamental design for a charger for electric vehicle, as shown and described.

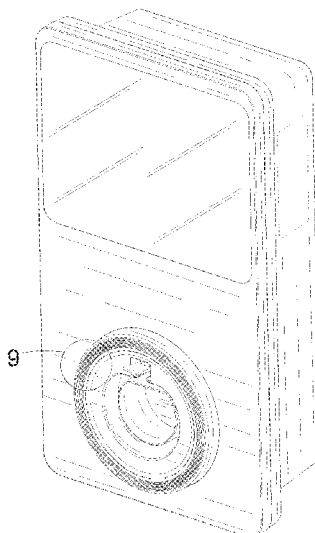
DESCRIPTION

FIG. 1 is a front, right and top perspective view of a charger for electric vehicle showing our new design;

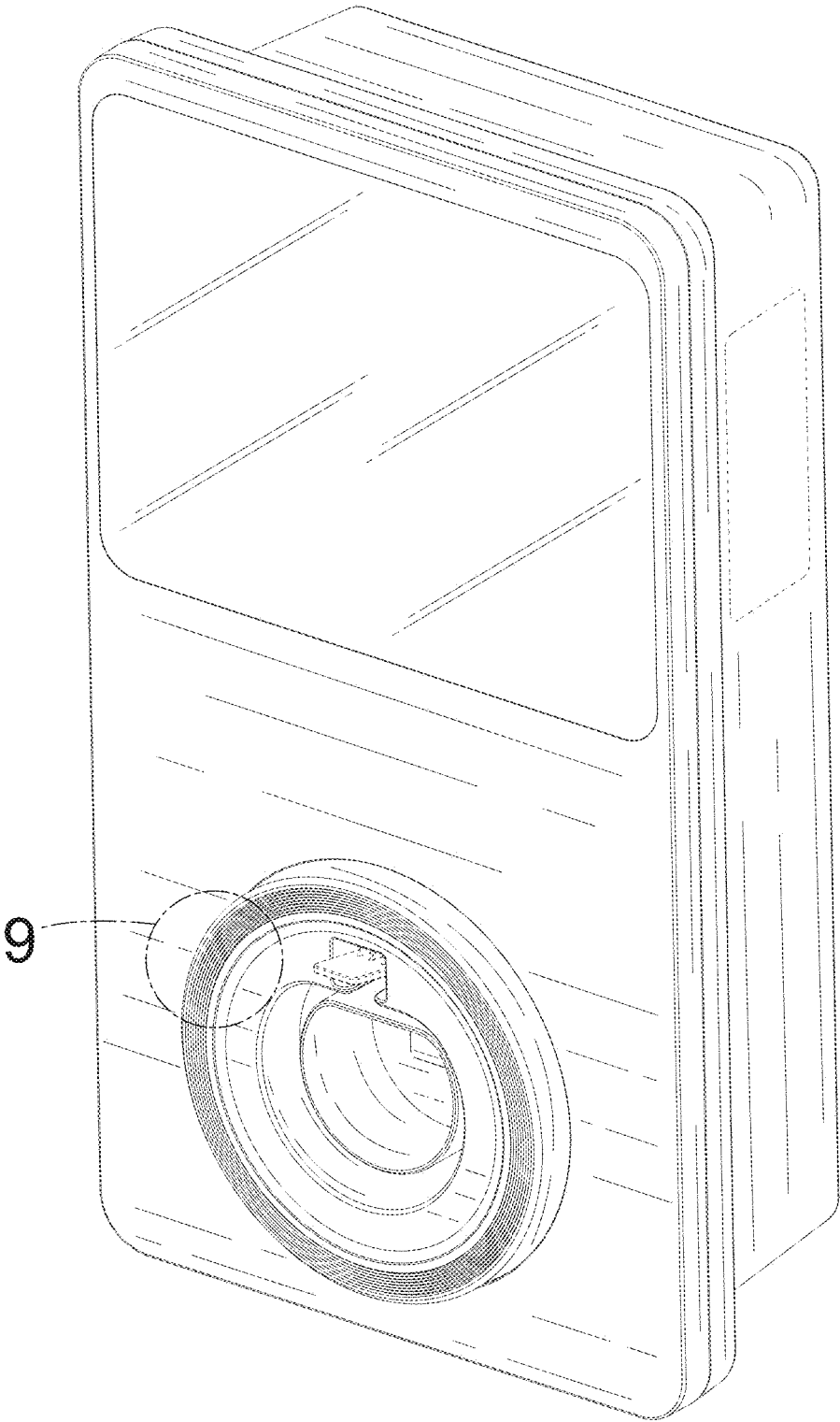

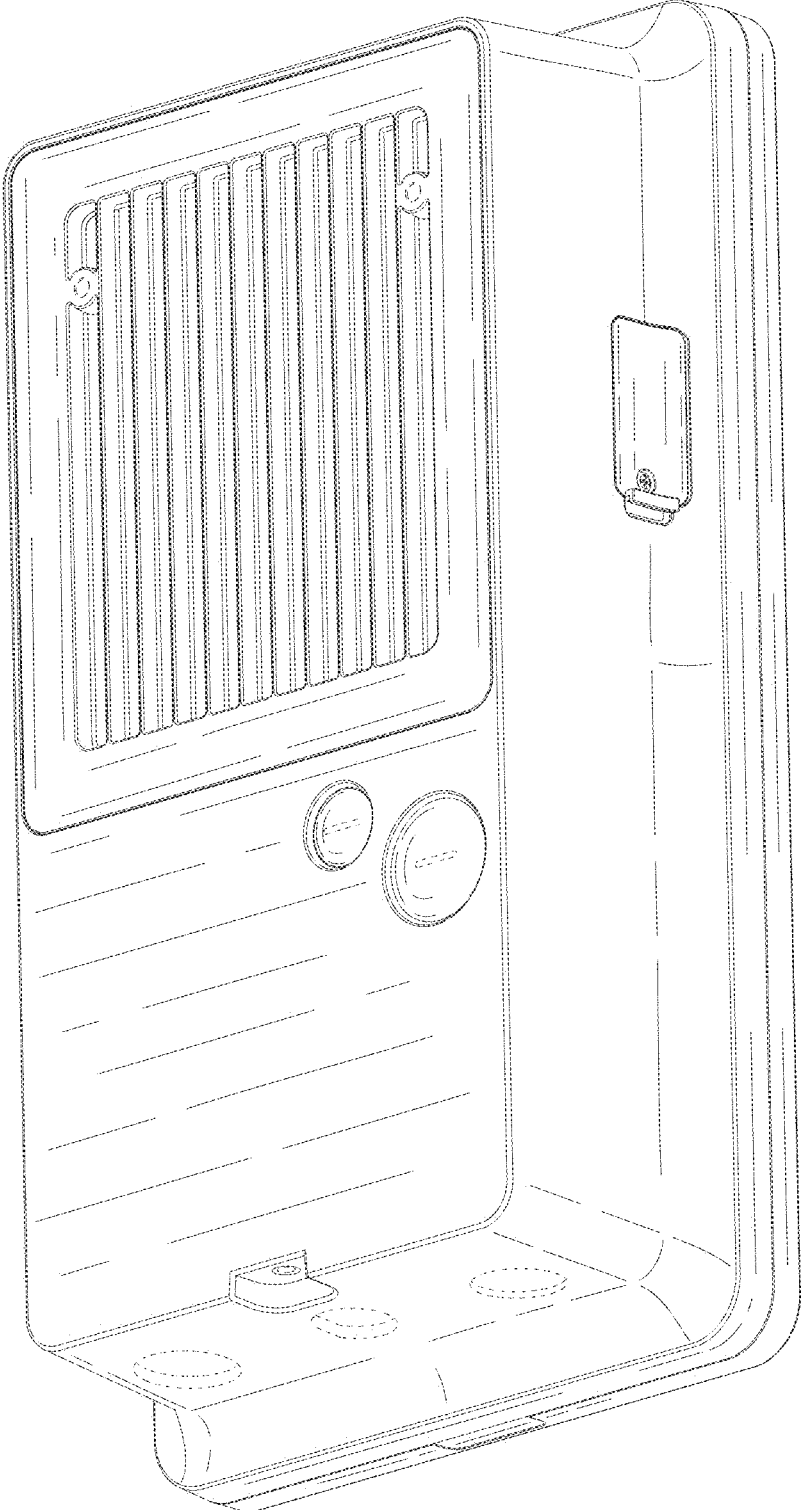

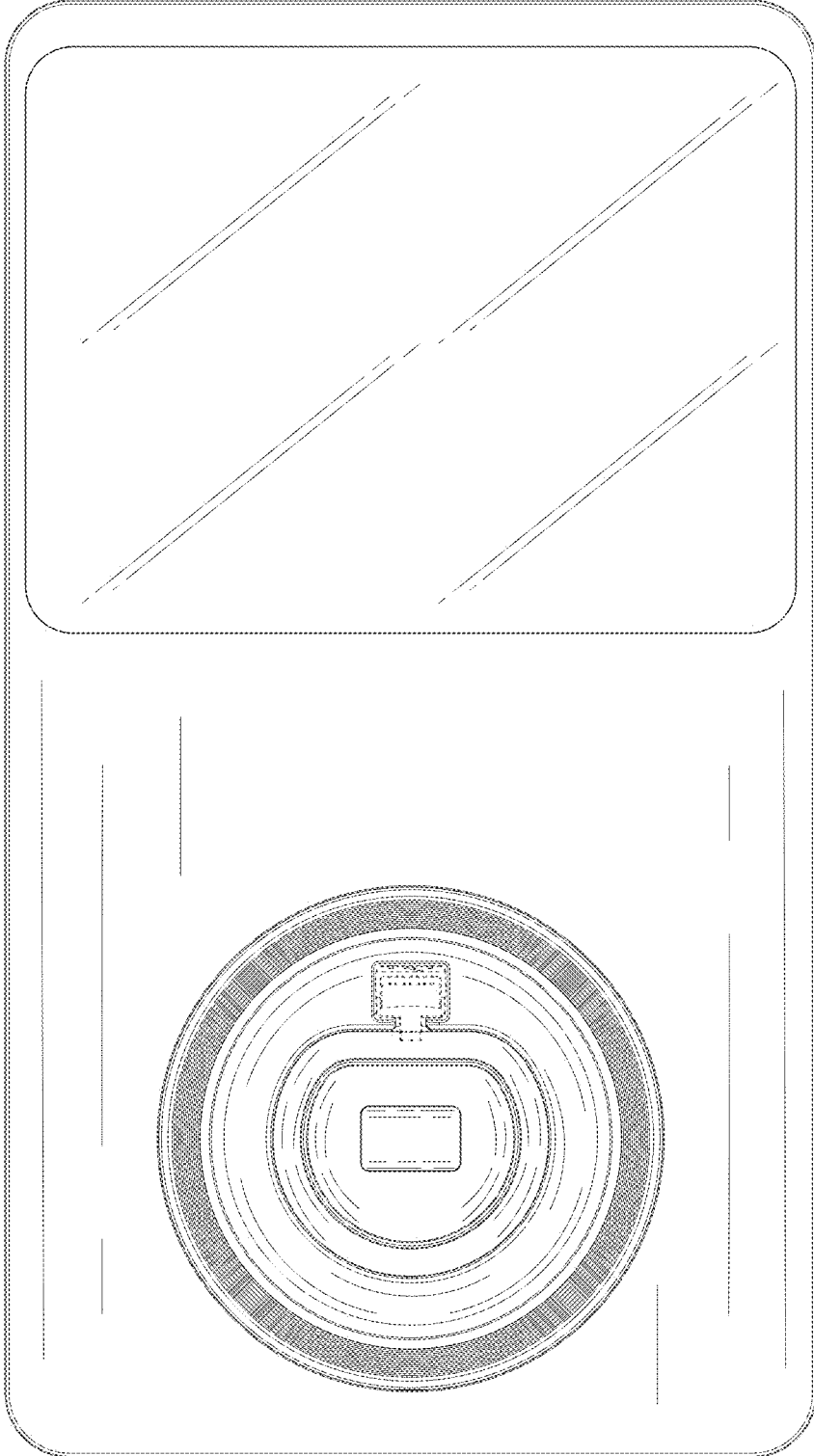

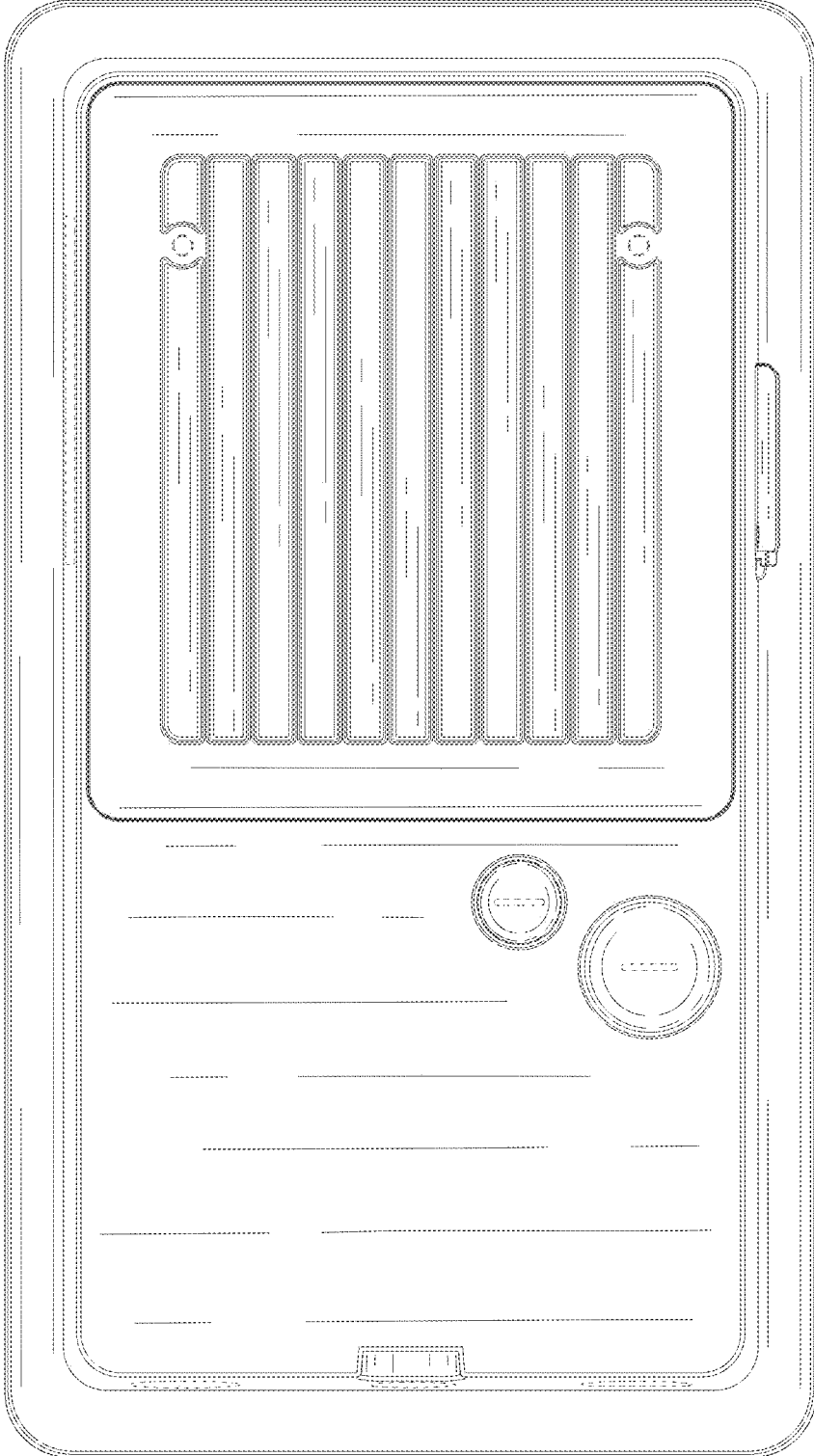

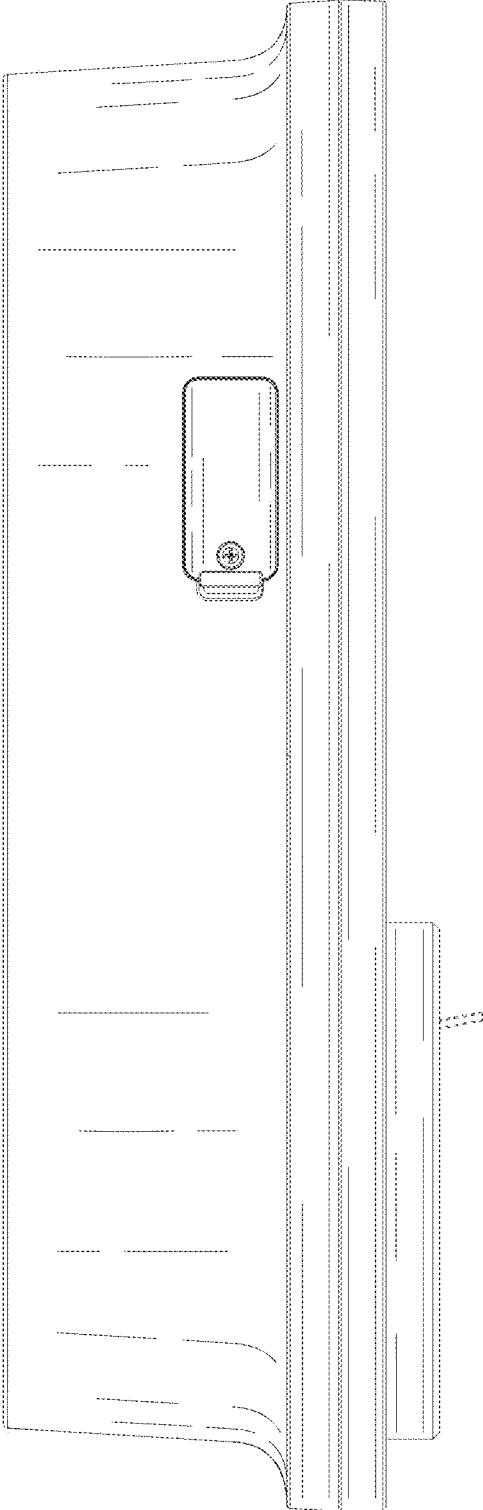

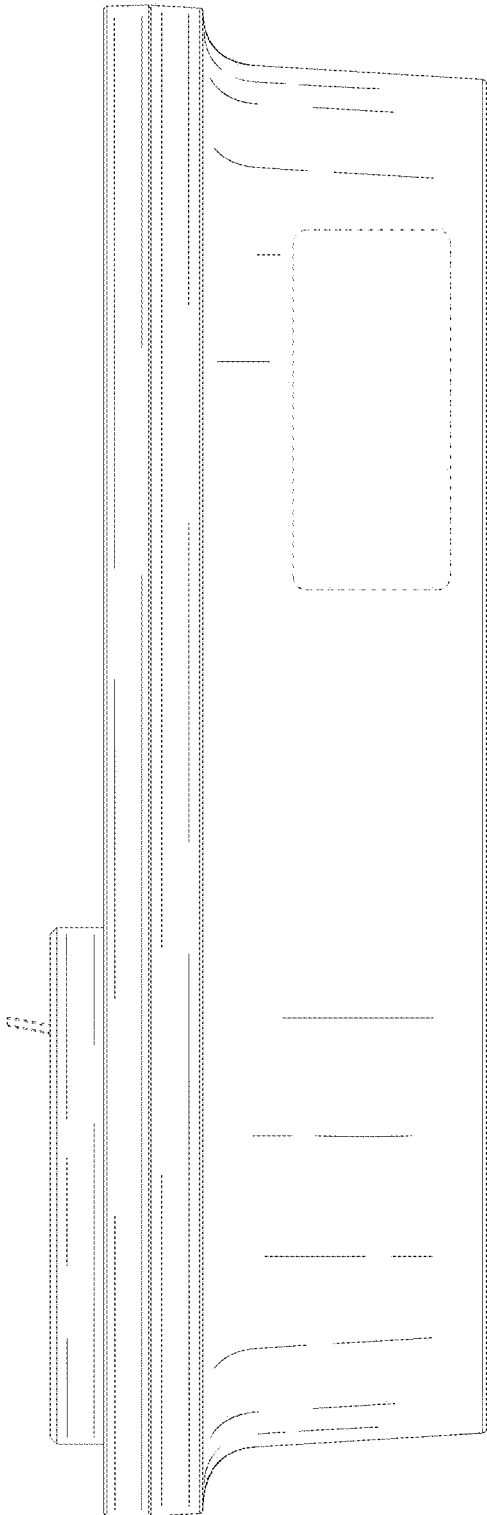

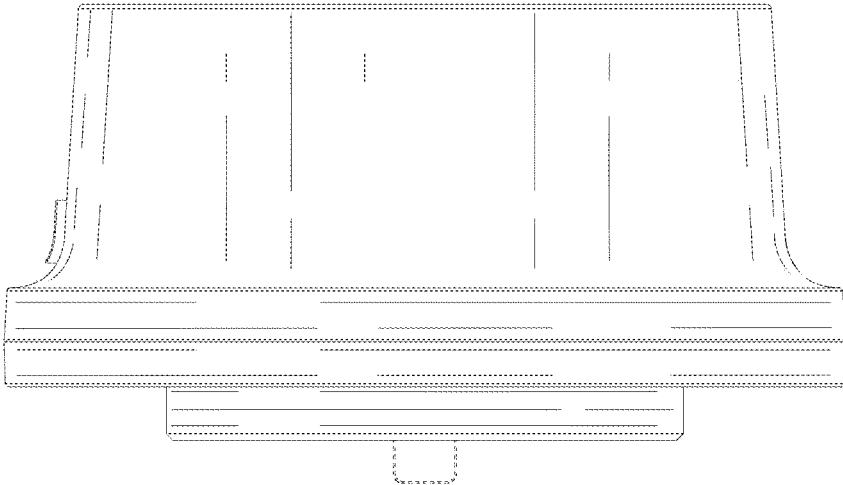

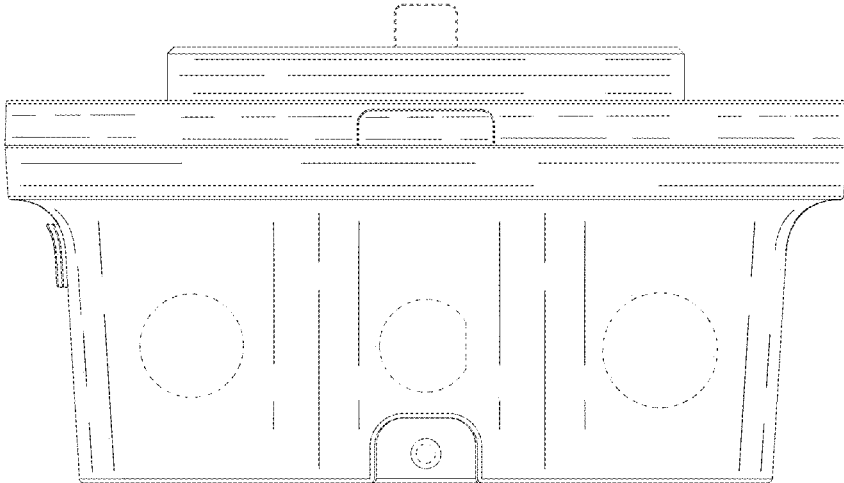

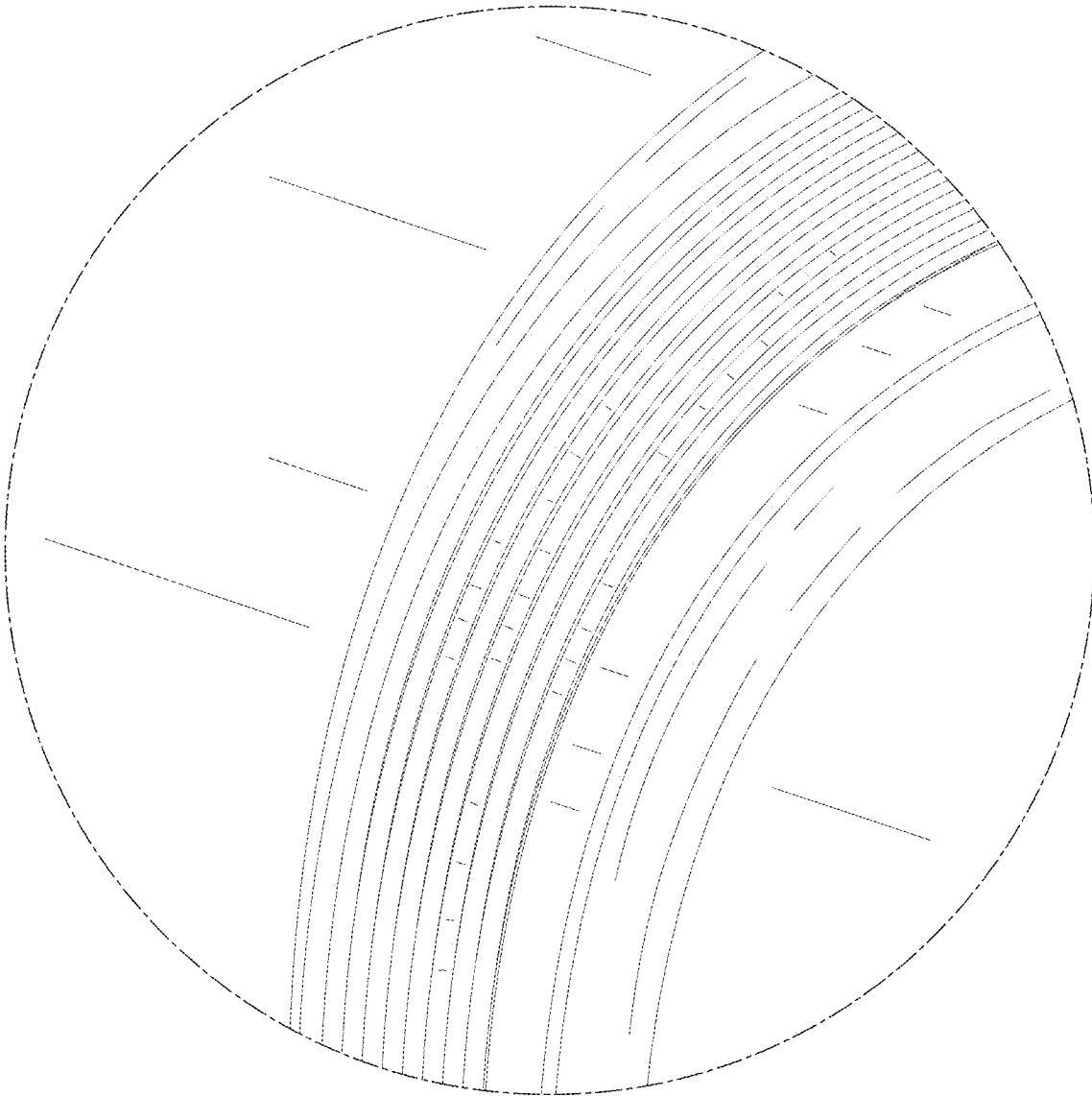
