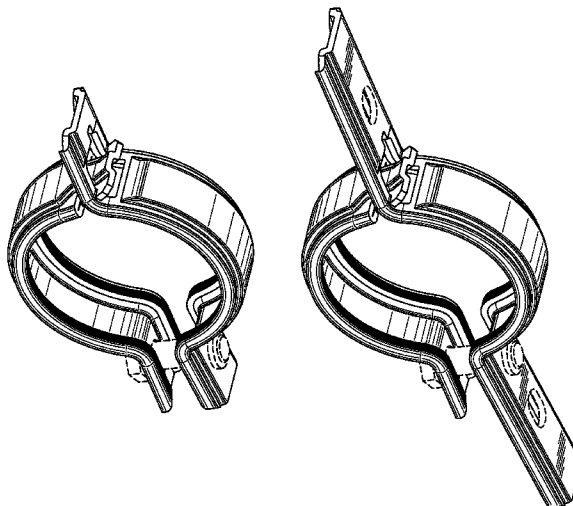
(57) **CLAIM**

The ornamental design for a riser clamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, right, front perspective view of a first embodiment of a riser clamp according to our design;

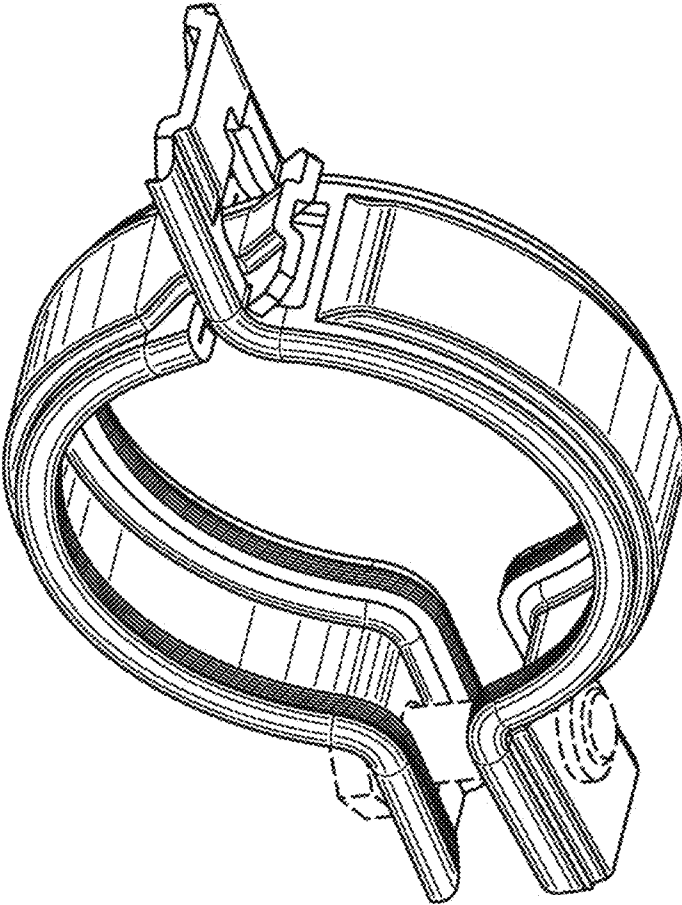

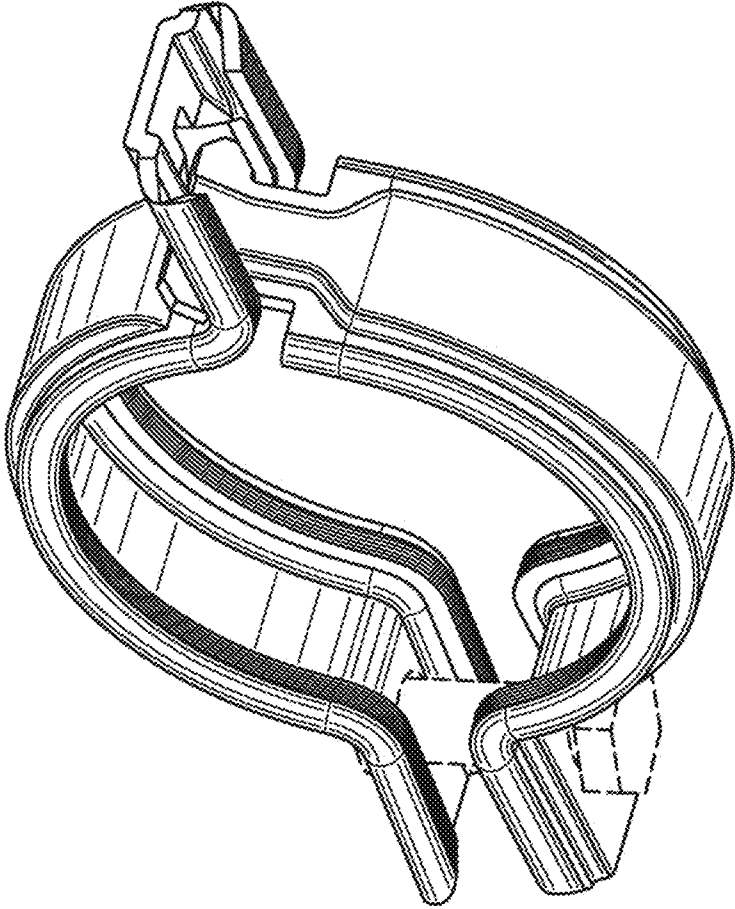

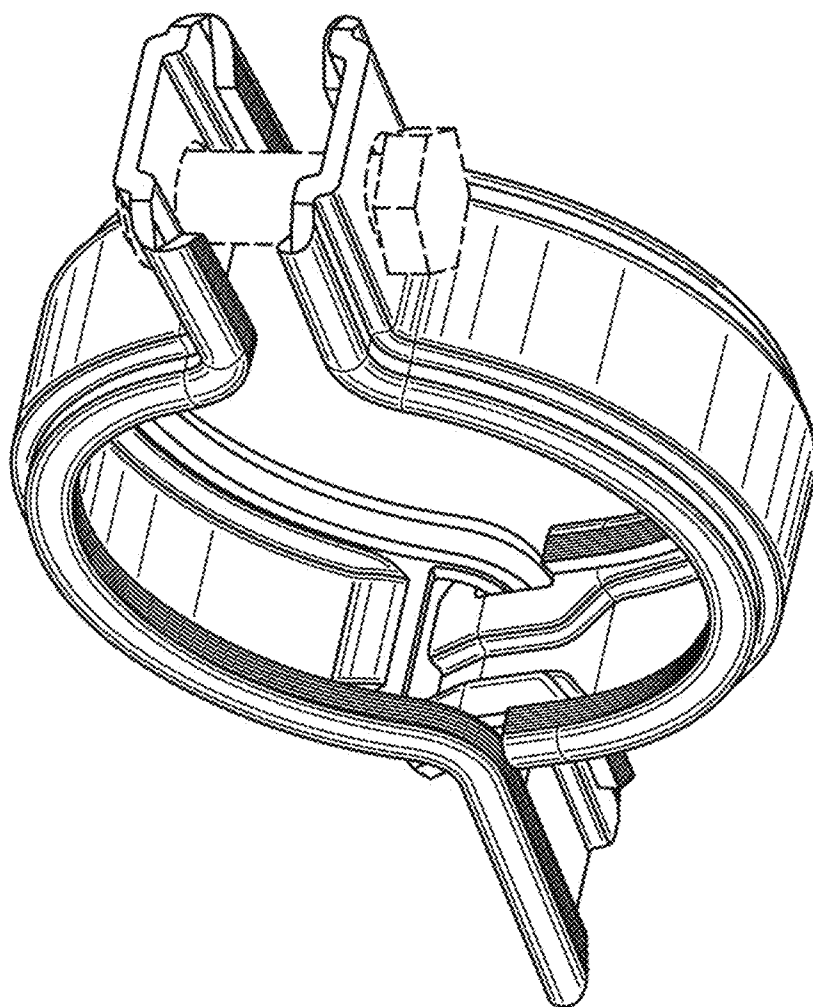

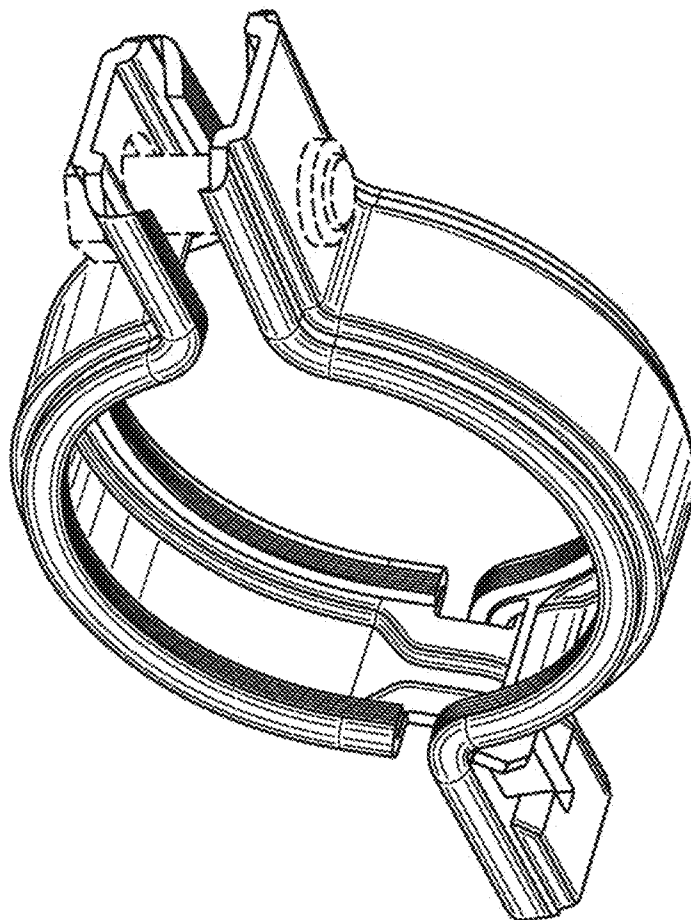

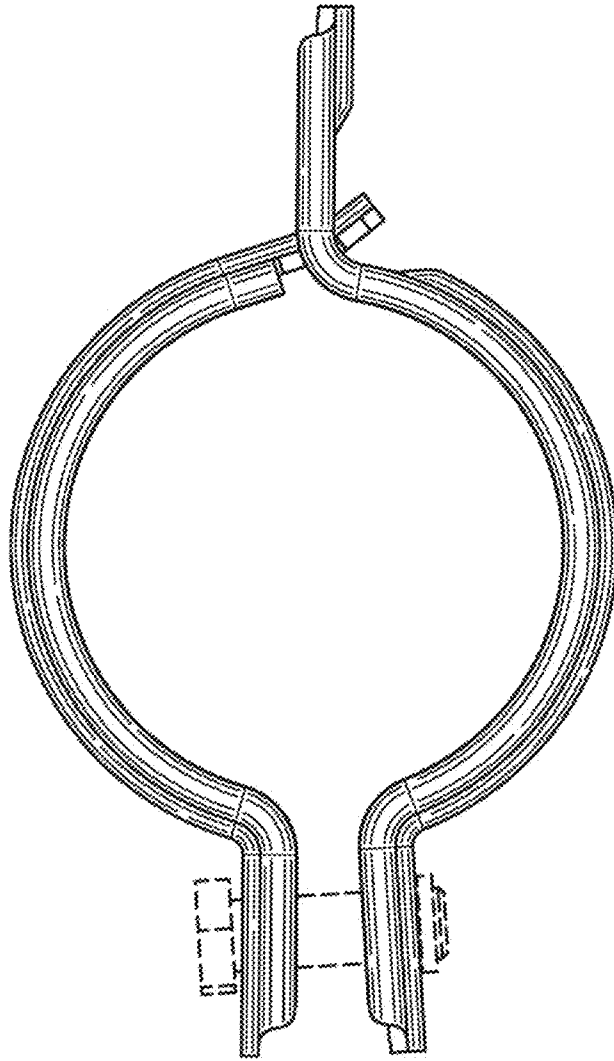

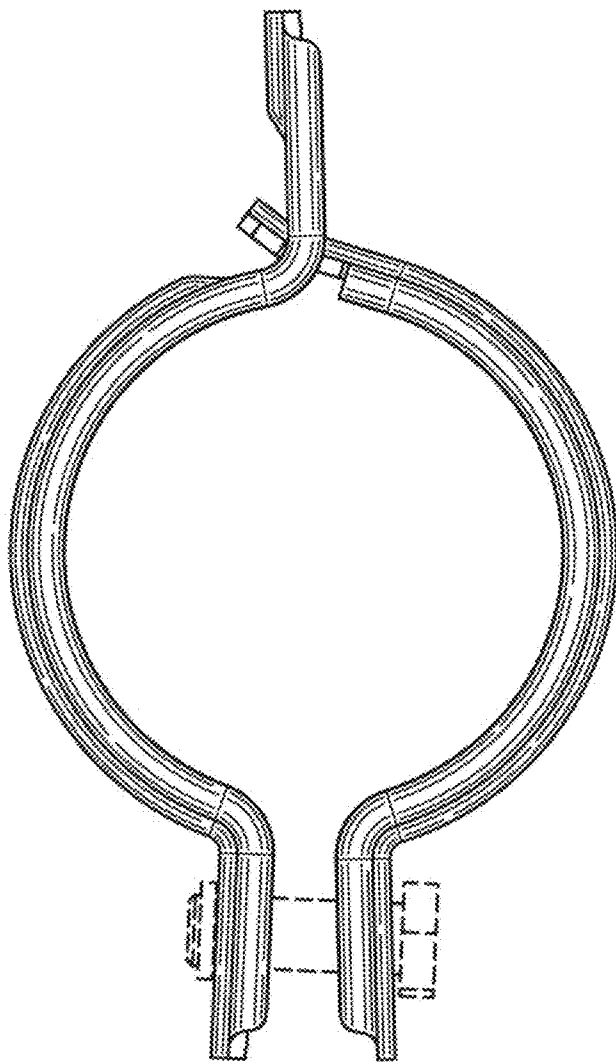

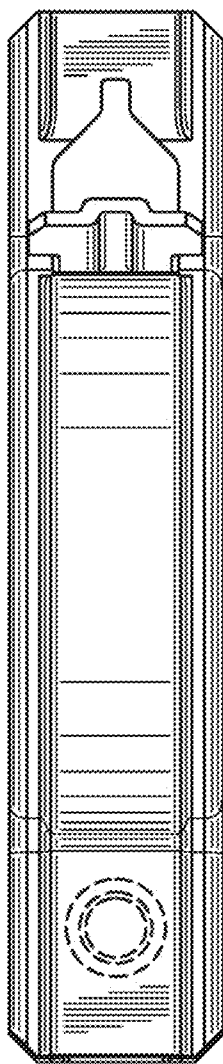

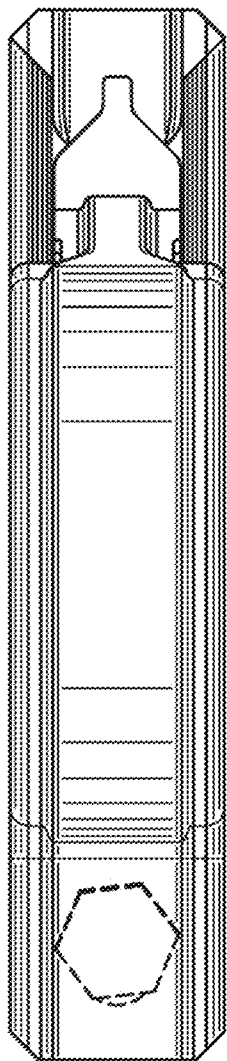

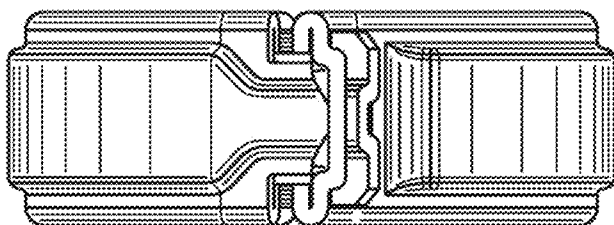

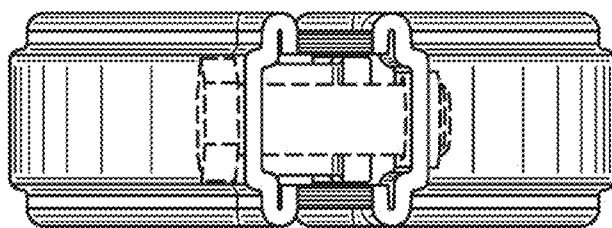

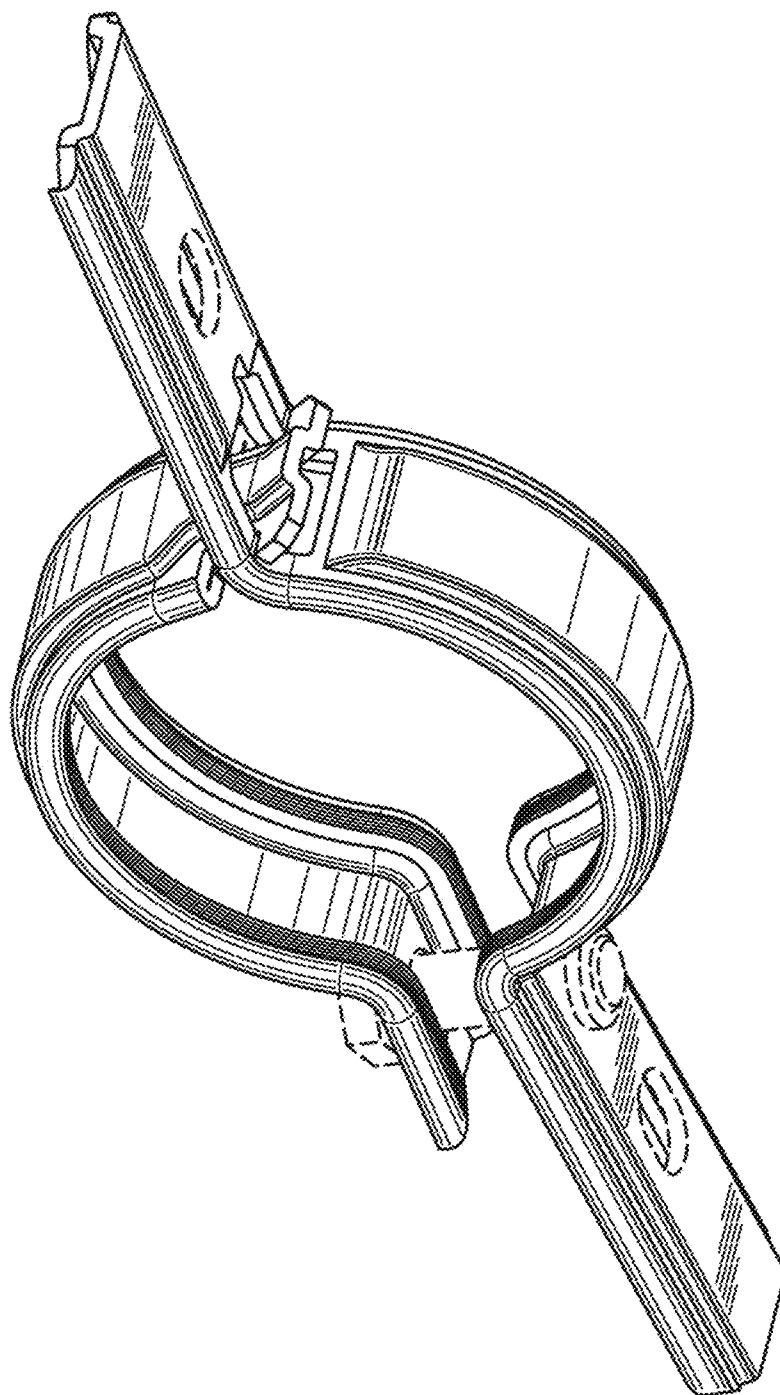

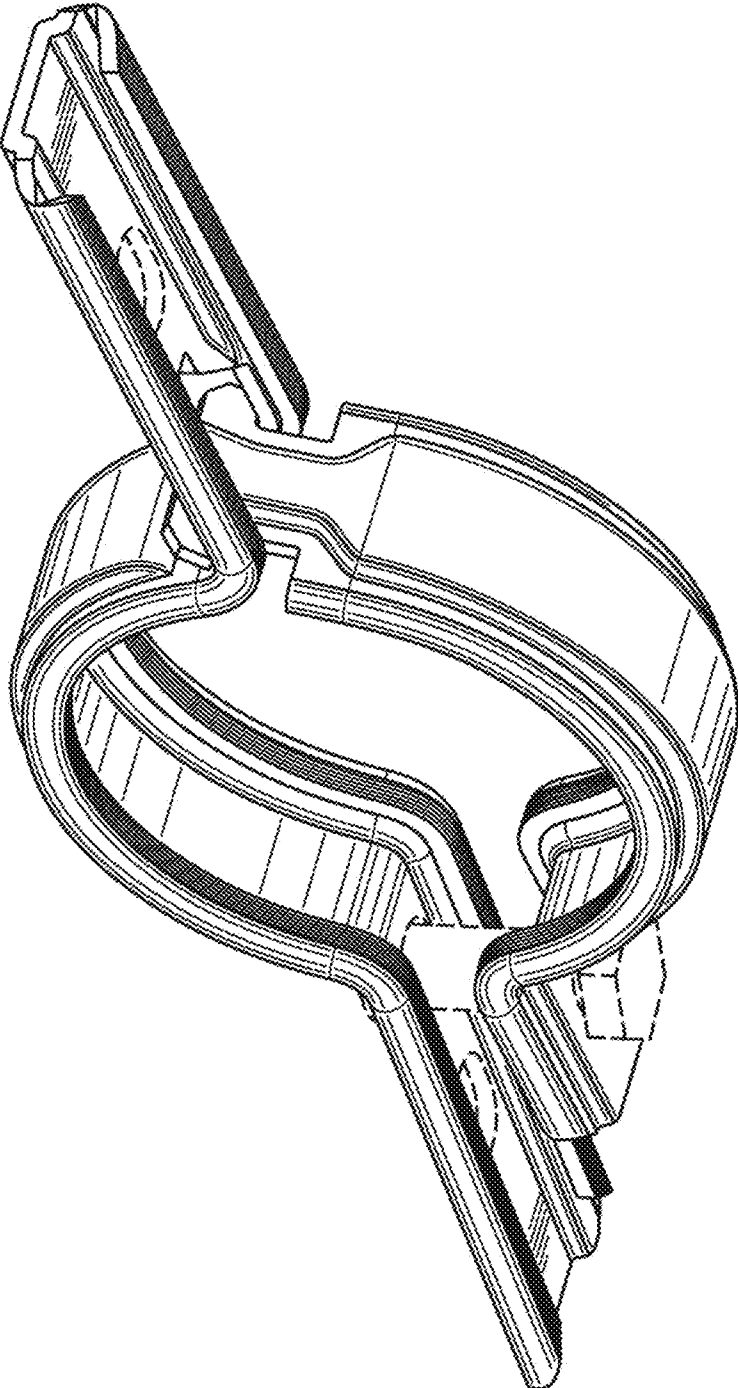

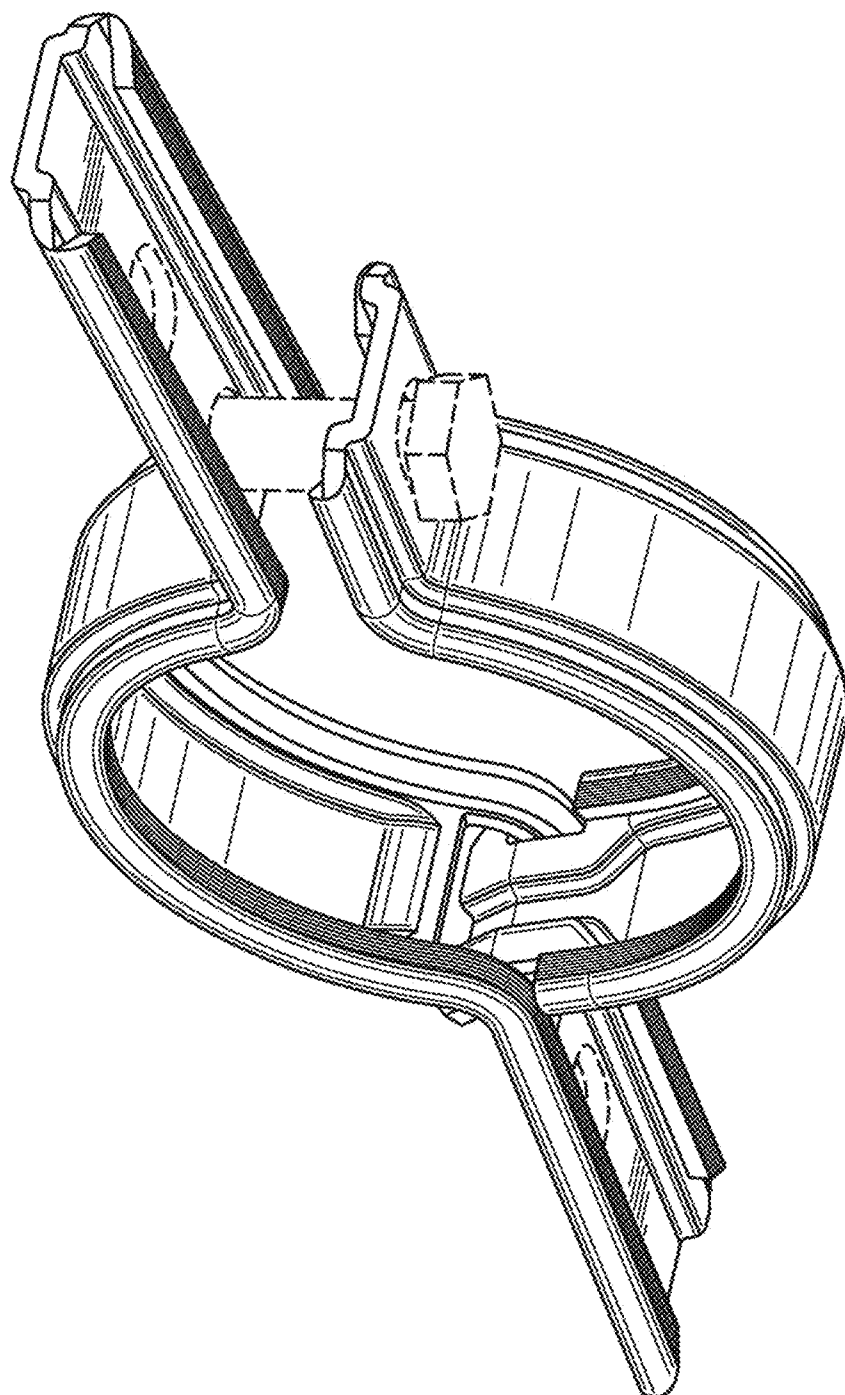

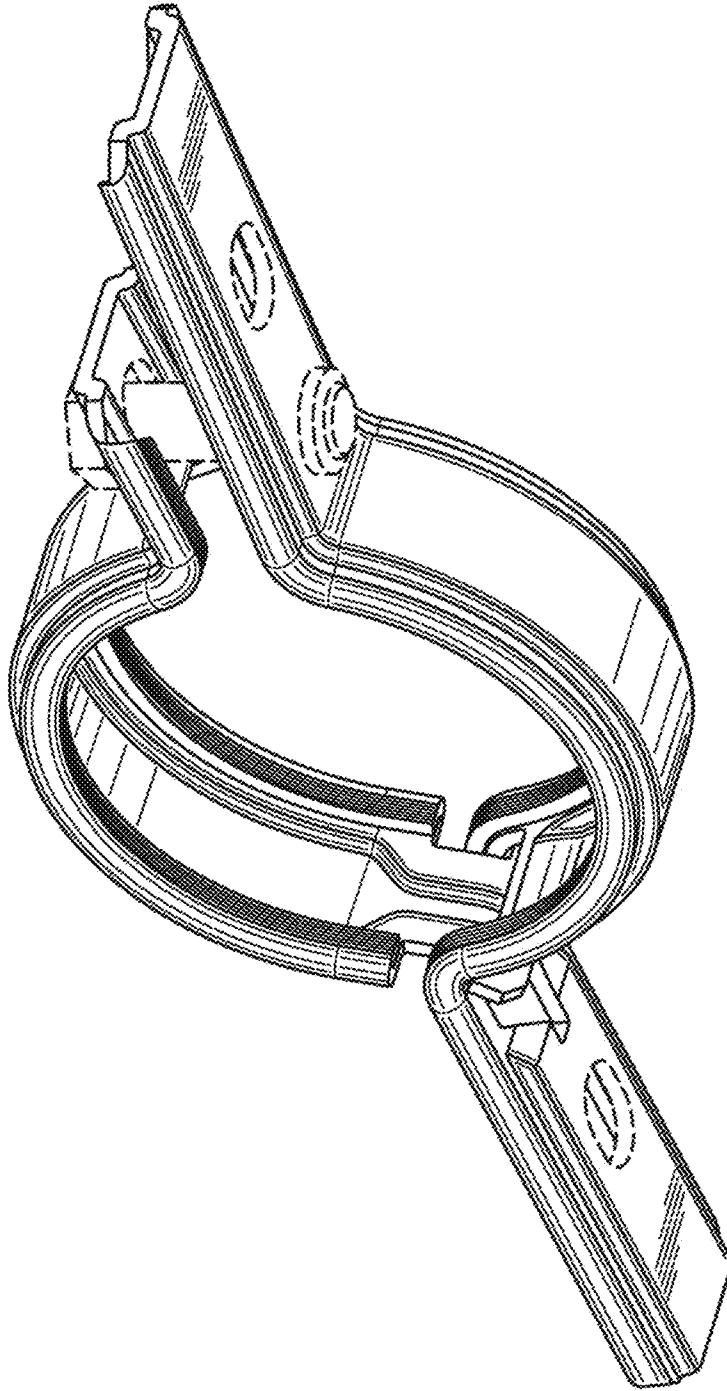

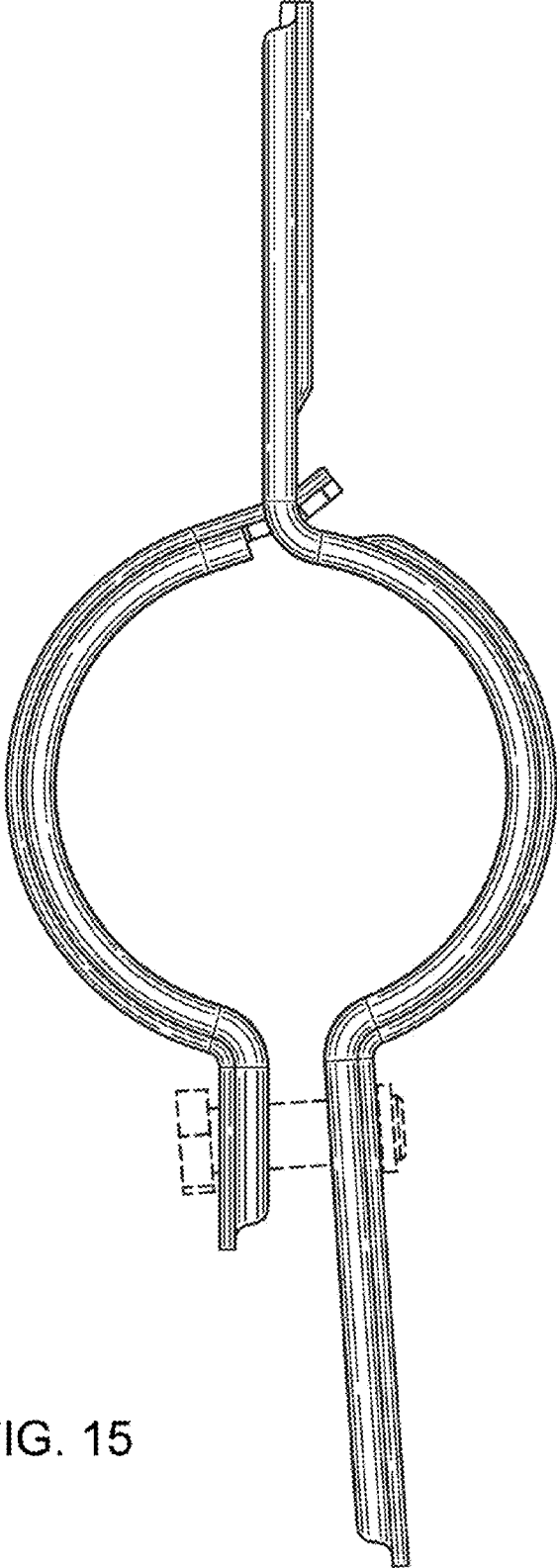

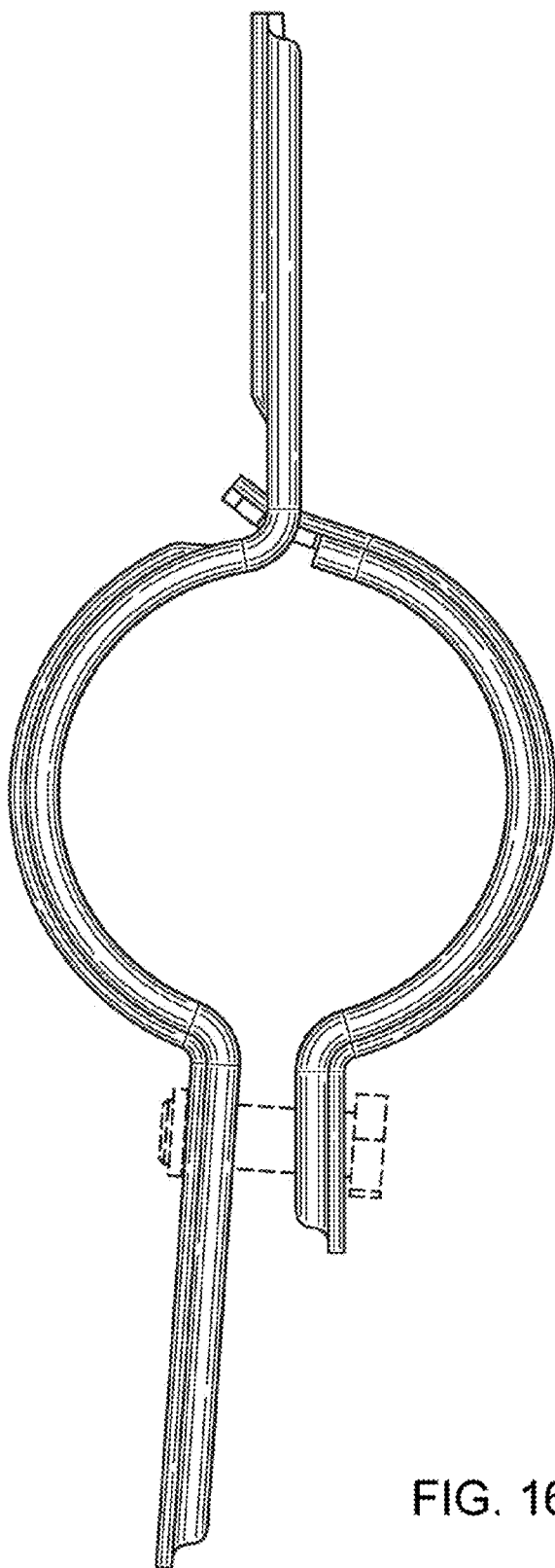

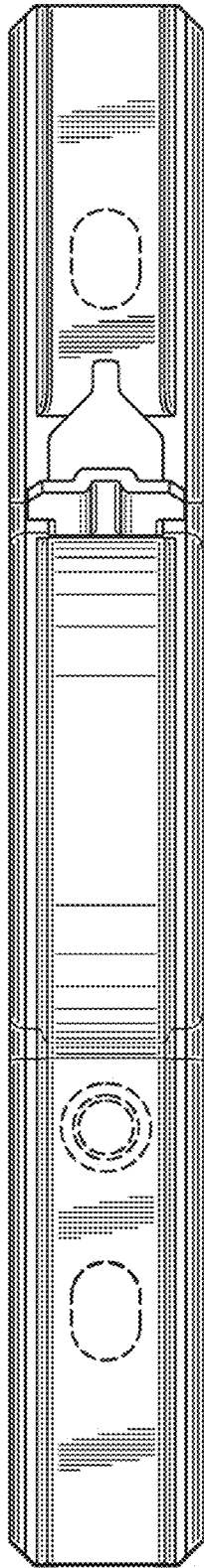

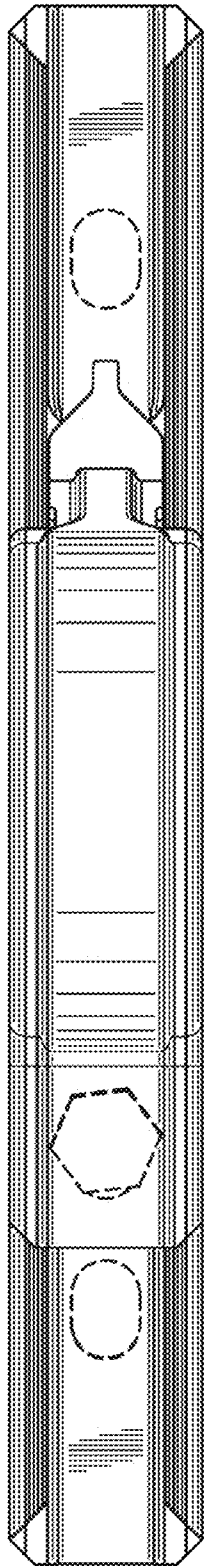

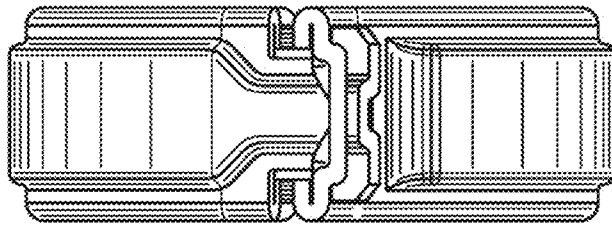

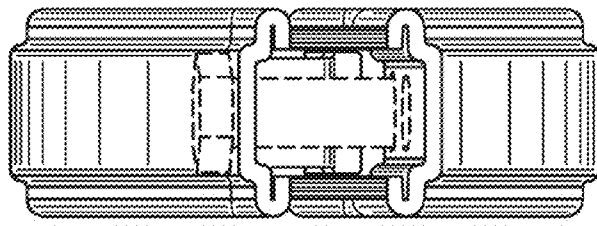
