The ornamental design for pliers, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from above and the rear of the pliers, typically used for stripping electrical cable, of this invention

FIG. 2 is a perspective view from above and the front of the pliers;

FIG. 3 is a top view of the pliers;

FIG. 4 is a bottom view of the pliers;

FIG. 5 is a left-side elevational view of the pliers;

FIG. 6 is a right-side elevational view of the pliers;

FIG. 7 is a large-scale front end view of the pliers; and,

FIG. 8 is a large-scale rear end view of the pliers.

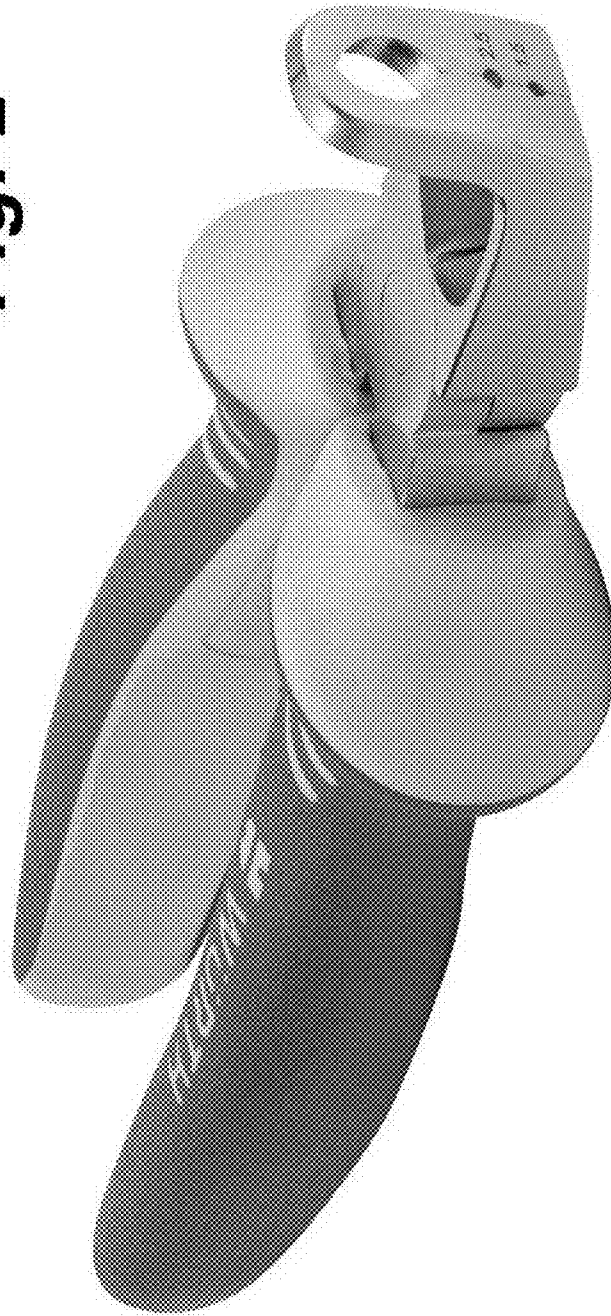

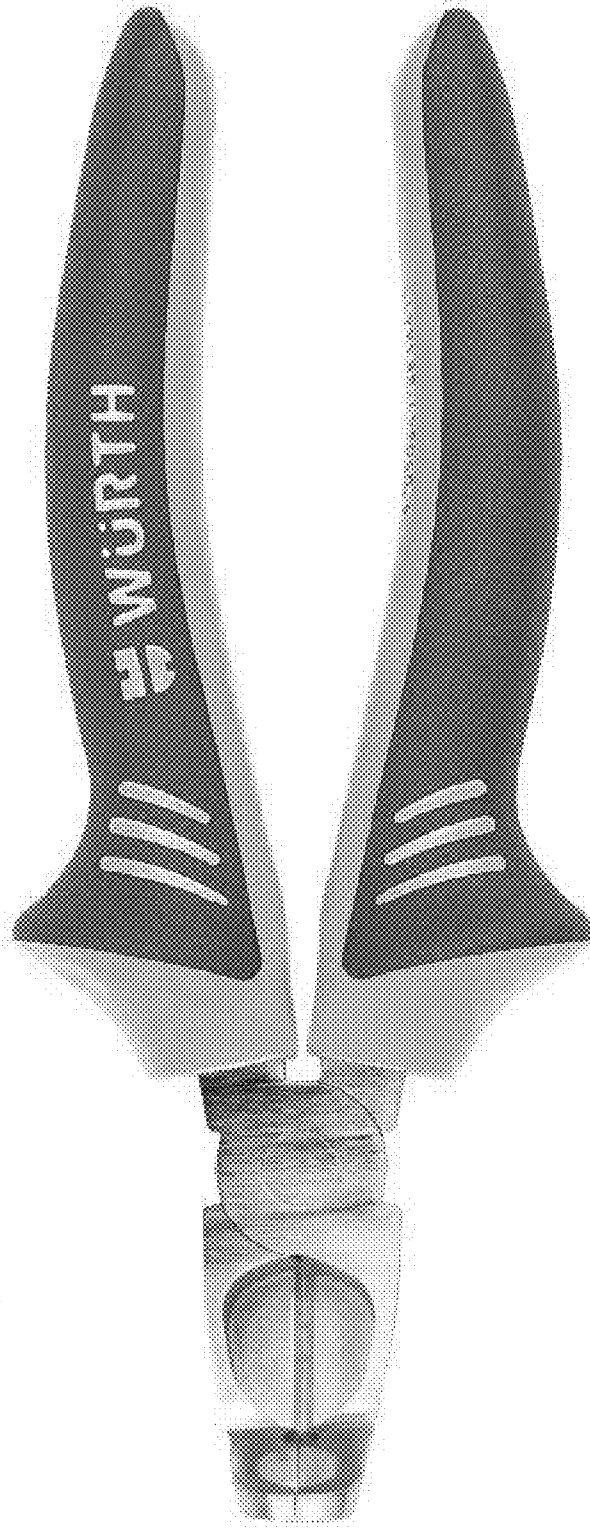

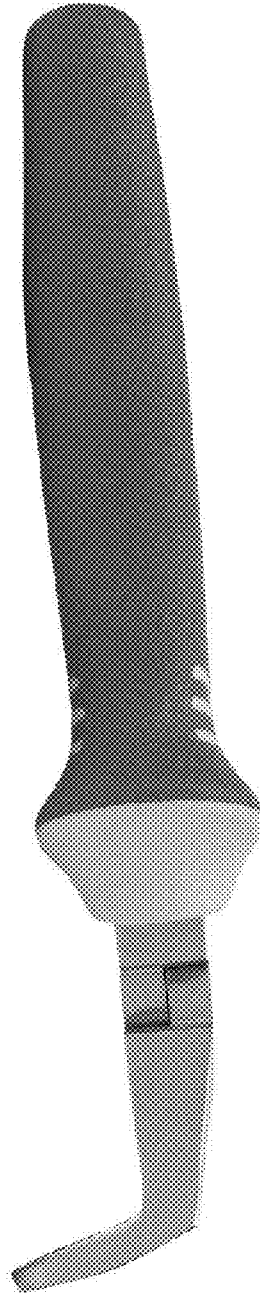




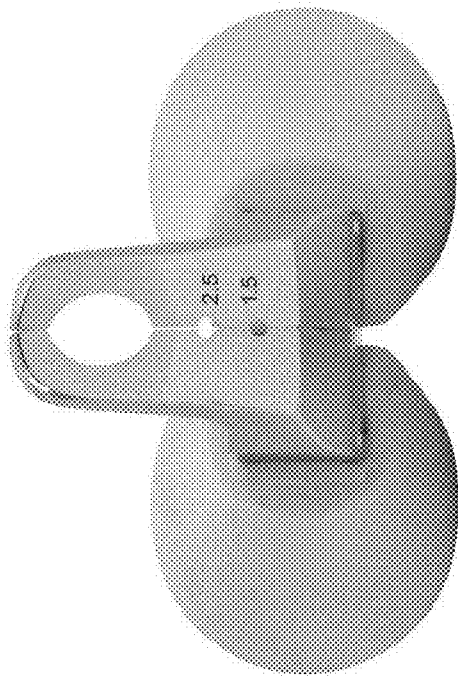
