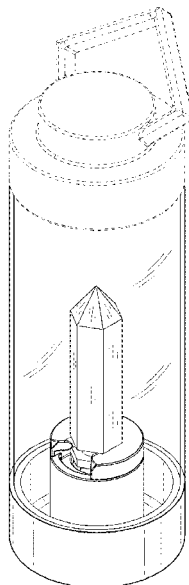
(57) **CLAIM**

The ornamental design for a bottle holding a crystal, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a bottle holding a crystal showing my new design;  
FIG. 2 is a front elevational view thereof;

FIG. 4 is a right elevational view thereof;

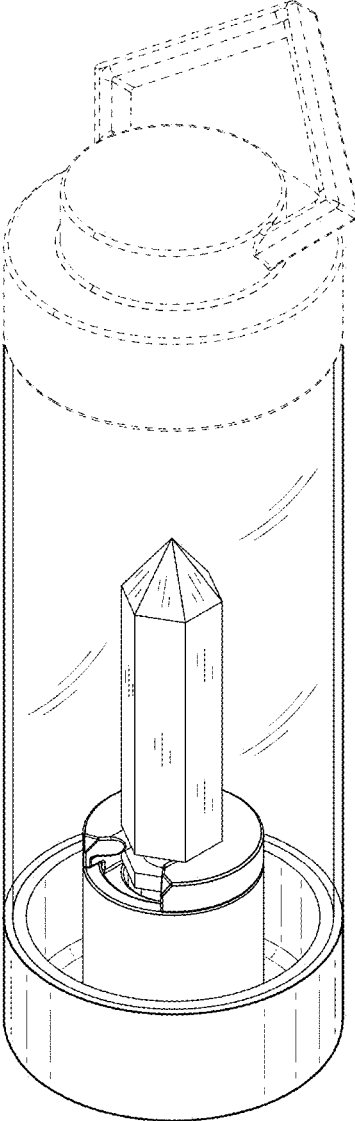

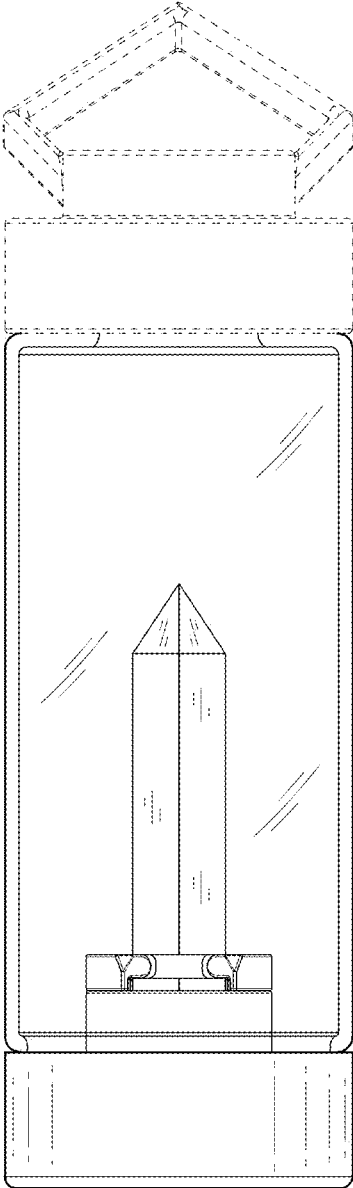

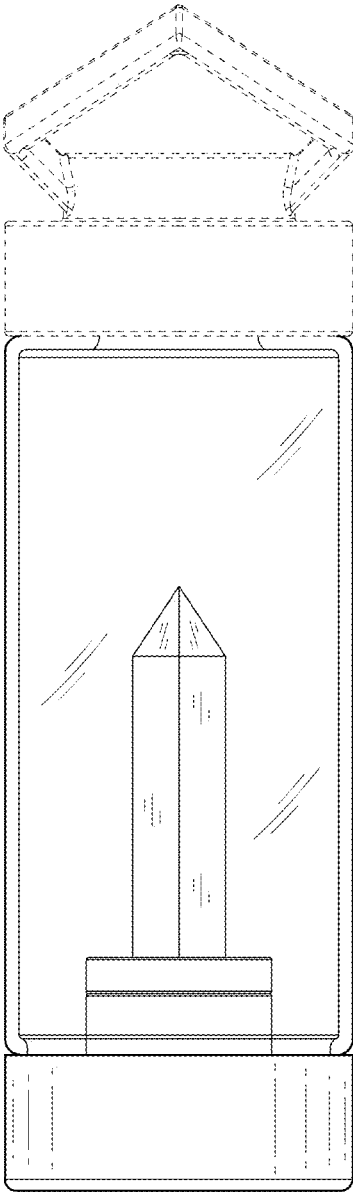

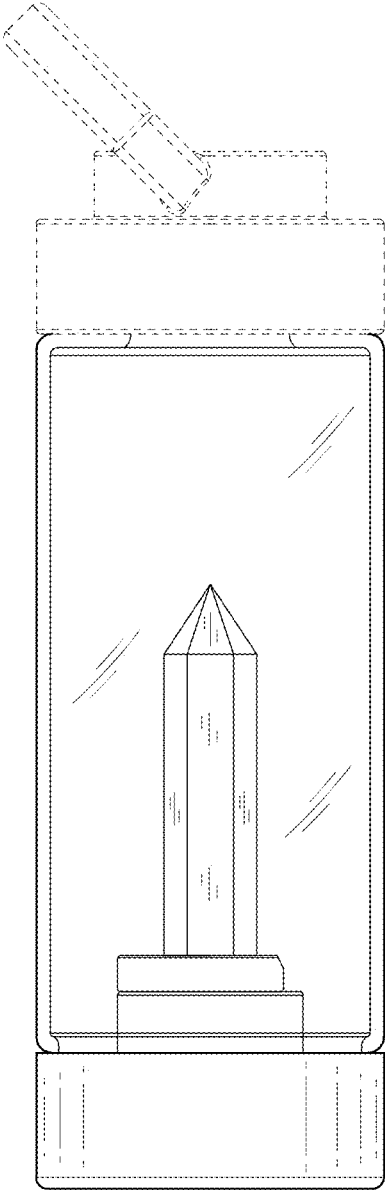

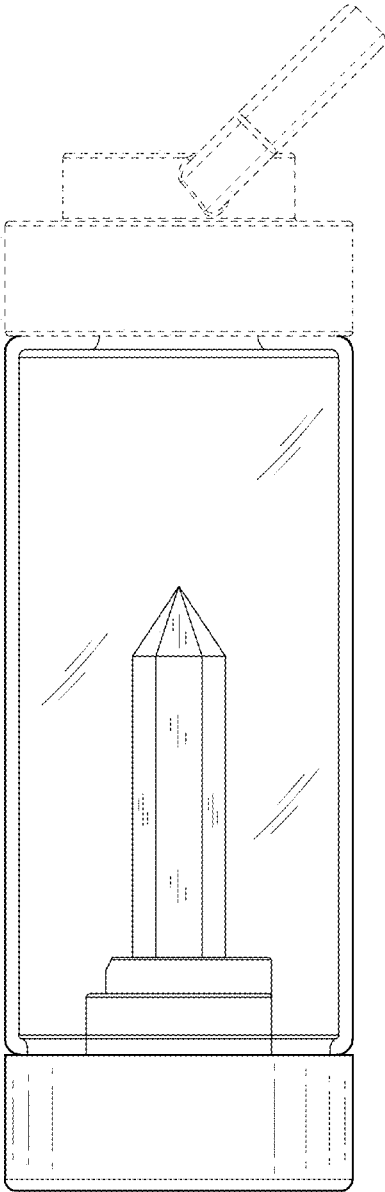

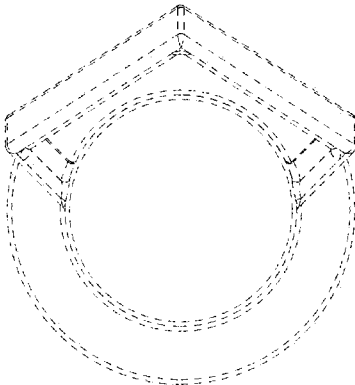

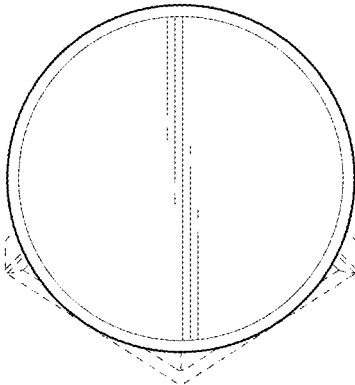
