WHEREAS, the Federal Government is making provision for the use of a certain portion of Highway Funds on Secondary and Feeder Roads; and

WHEREAS, the State Highway Commission of Texas has from time to time conditionally designated State highways, and which said designations have not been taken over for maintenance, thereby constituting only State high ways for the purpose of future connections; and

WHEREAS, in many cases these designations are principally county roads and farm-to-market roads; now,

THEREFORE, it is, on this day, expressed as the intention of the Commission that any and all such highways, that are not either under construction or maintenance or for which the State Highway Commission has not specifically ordered plans to be prepared for such highway or any portion thereof, be camceled and that the State Highway Engineer be directed to prepare specific orders for the future carrying out of this intention.

No highway on the Federal Aid System is to be so canceled.

The purpose of this order is to make possible the eligibility of certain county and inter-county roads that have been designated and State highways in order to carry out the wishes of the U. S. Government for the apportionment and distribution of the Work Relief Fund.

In Gregg County, Minutes 9398 dated May 14, 1934, and 10672, dated April 3, 1985, having authorised State participation to the extent of the entire cost of the center twenty feet of pavement construction on certain sections of State Highways 15, 31 and 65 in the City of Gladewater and advertisement for bids in accordance with plans approved by the State Highway Department, and the City having received bids and having tentatively awarded contract to the low bidder, the Austin Road Company of Dallas, subject to the State Highway Commission's concurrence in the award, and the low bid having been examined and found to be acceptable, the City is hereby authorized to proceed with the final award of contract to the low bidder, and, based on estimated quantities and low bid unit costs, and appropriation of \$44,453.95 State funds is hereby made to finance only the actual cost of construction on the State participating sections and of such state engineering costs as may be incurred on the project, it being understood that payment is to be made on actual costs incurred, that the total cost to the State shall not exceed the amount of this appropria tion, and further that the City of Gladewater will pass and enforce such laws and ordinances as may be required for the proper regulation and control of traffic, parking, and right-of-way encroachments on the routes of these highways with in the corporate limits of the city.
