IT IS FURTHER ORDERED that when the respective counties have placed into the State Highway Fund the above mentioned sum of \$3300.00, that the State Highway Engineer shall take steps to determine where the crossing of the Brazos River should be made and to investigate the possibilities of a crossing of Highway No. 22, with a view to using the same structure if possible and that upon completion the various counties concerned will be furnished with right-of-way maps to secure the right-of-way if they desire, it being understood that this action was taken primarily for the purpose of developing the crossing of the Brazos River with incidental crossings, and does not commit the Commission to confirm the designation or to any time or procedure of construction. Any costs not covered by the above fund that are considered necessary shall be appropriated by the Commission and the State Highway Engineer is authorized to proceed in accordance with the usual plan of making surveys under the general authority given him.

In Fort Bend County, it is ordered by the Commission that an appropriation of \$3,025.64 be made to cover the cost of constructing a sidewalk along the south side of San Bernardo River Bridge on Highway No. 3, a length of 1040 feet, in order to provide safe passage for pedestrians and school children across this bridge. WHEREAS, the State Highway Commission of Texas is deeply interested in the welfare of rural school children and their safety on the highways and has taken many precautionary measures to protect school children who must use the highways by being transported either in school buses or by other means; and

WHEREAS, although existing law provides that each school bus be adequately identified by having the words, "School Bus" in letters not less than 6 inches high printed on both front and rear and on both sides of the school bus; and provides a penalty for passing a school bus while stopped discharging or taking on passengers, but does not provide a means to advise the motoring public of the penalty; and, it having been experienced that motorists almost without exception pass these school buses while stopped at such bus stops when they are taking on and discharging passengers; and

WHEREAS, it is believed that if such motorists had notice that a penalty was provided by law for passing such school buses while stopped taking on or discharging passengers, the existing law would be better obeyed; and

WHEREAS, numerous school authorities and other persons deeply interested in the safety of the school children have appealed to the Hign-way Department to provide added safety for school children being transported by school bus over highways, being picked up and discharged at various bus stops;

BE IT RESOLVED THAT, The State Board of Education be requested to make a ruling requiring the following words to be painted on the front and rear of each school bus in letters of readable size: "Unlawful to pass this bus when stopped to take on or discharge passengers."

IT IS ORDERED that a copy of this resolution be spread on the official minutes of the Highway Commission and a copy thereof furnished to Honorable L. A. Woods, State Superintendent of Public Instruction.
