

Minutes of Seventy-Third and Special Call Meeting of the State Highway Commission, held in the State Office Building with the following members present.

Motion by Mr. Lanham cancelling designation with Highway out of Dallas from the city limits out Maple Avenue road to Letote, designating same Highway to go out the Bonnie View road from city limits to the town of Lisbon. Motion seconded by Mr. Bickett. Motion carried.

Motion by Mr. Burkett, seconded by Mr. Bickett, allotting to Trinity County the sum of \$800,000.00 as a 50-50 proposition, to be allotted as follows:

\$800,000.00 the first year  
 \$300,000.00 the second year  
 \$300,000.00 the third year

also, designating a Highway from Crockett to Groveton, thence to Corrigan, also from Groveton to Lufkin, Highway No. 94 via Iron Bridge. Motion carried.

Motion by Mr. Lanham, seconded by Mr. Bickett, for the appointment of Mr. W. D. Shaddon as road foreman to Rusk County. Motion carried.

To advise Judge Moore of Crockett, Texas, and Dr. Collins, of Lovelady, Texas, that the Highway Commission will grant two-thirds aid on the Houston and Madison Bridge, and that they should advise with the Highway Commission at the next meeting as to the procedure they will take;
