



# WILD GAME & GAME BIRD BREEDER PERMIT APPLICATION



Before any person shall hold, possess or engage in the raising of game mammals, game birds or migratory game birds protected by the Illinois Wildlife Code, he/she shall procure a permit to do so, and the species can only be obtained from another licensed breeder. All permits expire on March 31 of each year. **GAME TAKEN IN THE WILD IS ILLEGAL AND IS NOT AUTHORIZED BY THESE PERMITS.** A federal permit, issued by the U.S. Fish & Wildlife Service, may be required before you can legally sell, trade or give away migratory game birds. For information on **federal** permits call 612 713-5436.

1 Check one box to indicate the type of permit you are applying for:

**Class A Noncommercial**  **\$10**

For any person desiring to possess, propagate or hold in captivity but not offer for sale any species from the list in number 2 (excluding ferrets).

**Class B Commercial**  **\$20**

For any person desiring to possess, propagate, to hold in captivity, to sell alive for propagation or hunting purposes, or sell dressed for food purposes any species from the list in number 2.
