



Council Welcomes Mayor Rossetto & Youth from Alba, Italy

At the September 1, 2005 City Council Meeting the Mayor and Council welcomed Mayor Giuseppe Rossetto, Vice Mayor Giulio Abbate and twenty eight high school exchange students.

The Sister Citv Program was introduced in 1960 and during the first Trans-Atlantic Telestar satellite phone between Medford Mavor John Snider and Alba Mayor Cagnasso, the formal sister city relationship was established.

Alba was in 1962. For the next twenty years, residents of both cities would visit and the program would continue to thrive. In 1984 the Sister City Committee was reformed as a non-profit organization whose goals were to continue to support this program and to further develop an academic and cultural exchange of youth. Over the years, the youth exchange program has provided opportunities for Medford and Alba students to spend time with host families and experience the different cultures.

Safe Sidewalks ~ Project Update

In November of 2004, the citizen's of Medford voted to approve a \$4.6 million bond measure to provide funding for safe school walk routes within one mile of all elementary schools. An additional \$2.8 million of federal funds will be available over the next six years to assist with this project.

This project is broken down into a number of phases for the design and development of individual segments.

<u>Phase 1</u> - Plum & Withington Streets currently under construction with expected completion in early fall of 2005.

<u>Phase 2</u> - Design of 7,800 lineal feet of sidewalks in various locations is 95% completed.

<u>Phase 3</u> - Howard Street preliminary design approved by the City Council on August 18, 2005. A consultant will be hired to complete final design.

<u>Phase 4</u> - Corona & Grand Streets transportation facility application to be considered by the City Council prior to the end of 2005.

These first four phases will cost approximately \$2.5 million. Information regarding additional phases will be made available as the phases are planned and designed. McAndrews Bridge at Bear Creek Replacement Project

The McAndrews Road bridge over Bear Creek, originally constructed in 1952 and widened in 1968, is being replaced due to deterioration and inadequate structural capacity. ODOT established a 6 ton maximum weight load limit for the bridge which prohibits most trucks and buses from crossing this structure.

McAndrews Road is designated as a major arterial street. The new bridge structure will

straighten the alignment of McAndrews Road by widening the roadway to the north and will a c c o m m o d a t e pedestrians, vehicles, and bicyclists. The existing bridge is 59.5 feet wide with a curb to curb width of approximately 50 feet. The new bridge structure will have an overall width of 90 feet

and curb to curb width of 72 feet.

The project will include modifications to the Rogue River Valley Irrigation District irrigation facility at the east end of the bridge and southern entrance to the Rogue Valley Mall at the west end of the bridge. Modifications will be made to the eastbound left turn lane onto Biddle Road by increasing the length of the turn lane. Improvements to the bike lane / pedestrian path include extending the existing bike path to the east, under the overcrossing, to meet with the Biddle Rd. bike path. This will be done on the north and south side of McAndrews Rd.

The completed bridge will consist of:

- 8 foot wide sidewalk on both sides of the bridge structure
- 2 travel lanes in each direction (11 and 12 foot wide lanes, respectively)
- 1 center turn lane (14 feet wide)
- 6 foot wide bike lanes on both sides
- Bridge rails on each side that are 1 ft wide

The City of Medford received a grant of \$7.9 million of OTIA funds to construct this project and to perform temporary repairs to the Barnett Rd Bridge over Bear Creek as well (completed June 2004). The City contracted with OTAK, Inc. (a Portland - based Engineering consultant) in August 2004 to design the new bridge and a temporary pedestrian bridge. In June 2005, a \$0.5 million construction contract was awarded to James W Fowler Co. to

construct a temporary pedestrian bridge and multi-use paths along McAndrews Rd. pedestrian bridge. located south of the existing bridge, designed to pedestrian traffic across Bear Creek while the north half of the bridge removed is and replaced. After the new

bridge is completed, the temporary bridge will be removed.

Final construction plans, specifications, and estimate were completed in June 2005 and bids were opened in late July. In August 2005, a \$5.6 million construction contract was awarded to Ross Bros. and Company, Inc.

Ross Bros. began construction the week of August 29th, 2005. The north half of the new bridge, irrigation facility relocation, and mall entrance improvements are scheduled to be reconstructed by Spring of 2006 (for more Stage 1 details go to the following website - http://www.ci.medford.or.us/Projects.asp).

After Stage 1 construction is complete, two lanes of traffic will be rerouted to the north side of the bridge to allow for removal and replacement of the south half of the bridge. The overall project is scheduled to be finished in the Fall of 2006.
