*Welcome to the Georgetown Leadership Seminar Alumni Reunion in Helsinki. We, the Finnish alumni, are looking forward to meeting old and new friends and to discussions both at our meetings and during free time.*

*At the same time we are delighted to have the opportunity to show you our country. The institutions that will be hosting and introducing themselves to you include the Parliament, the Ministry of Foreign Affairs, and Nokia.*

*Finland was part of Sweden until 1809, when it became an autonomous Grand Duchy in the Russian Empire. Today, you will still see the statue of Alexander II, Grand Duke of Finland, on the Senate Square. In 1917 Finland became independent. But already in 1906, we acquired universal suffrage - including the women's right to vote - and a unicameral Parliament which still exists. Despite having to fight on several fronts during World War II, Finland was never occupied, which made it possible for us to preserve our freedom and democracy all through the Cold War. In 1995 Finland joined the European Union. Our currency is the euro.*

*The period after WWII was a time of rapid social change and economic growth. A relatively poor, rural and agricultural country developed into an affluent, urban and industrial society. Today Finnish industries are known for their high quality and high technology, be it in telecommunications, paper machinery, or cruise ships.*

*You will have the opportunity to experience the life of the capital city and the tranquility of the countryside. The summer days in Finland will be long, interrupted not by darkness but a short period of twilight in the middle of the night.*

*I am sure all of this will create a propitious atmosphere for a fruitful meeting.*

# Participants



**Elias Aburdene '99** (USA) is President of Rock Creek Corporation, a privately owned investment and financial services company. He is an adviser for international private banking for Branch Banking & Trust. In 1986, he worked for Fairbanks Management Corporation, a private investment firm. Elias began his career with Citibank and Bank of America. He received a B.A. in economics from the University of Connecticut and an M.S. in international economics from the School of Foreign Service at Georgetown University. Mr. Aburdene sits on the advisory board of the Winston International Hedge Fund and the SFS Center for Contemporary Arab Studies.

**Martti Ahtisaari** (Finland) was President of Finland from 1994-2000, after which he founded Crisis Management Initiative, whose Board he currently chairs. President Ahtisaari joined his country's Ministry of Foreign Affairs in 1965 and became Ambassador to Tanzania in 1973. He became UN Commissioner for Namibia in 1977 and thereafter the Secretary General's Special Representative to Namibia until 1981. From 1984-1986, he was Under Secretary of State for International Development Cooperation in the Ministry of Foreign Affairs of Finland, serving as Finland's representative to the regional development banks. From 1987-1991, he was Under Secretary General for Administration at the United Nations, retaining his functions as the Secretary General's Special Representative for Namibia and leading the UN operation (UNTAG). Following a year as his country's Secretary of State for Foreign Affairs, he became involved in international efforts in Bosnia Herzegovina, becoming the UN Secretary General's Special Representative for the former Yugoslavia. President Ahtisaari graduated from the University of Oulu in 1959 and holds numerous honorary doctorate degrees from universities all over the world. He serves on many boards (Soros Foundation, Open Society Institute, International Youth Foundation, International Crisis Group) and has been awarded the FDR Four Freedoms Award, the Hessen

Peace Prize, the Euro-Atlantic Bridge Prize, among others.

**Tanya Alwi '01** (Indonesia) is Country Director for Indonesia at the Borneo Tropical Rainforest Foundation (BTRF). In 2004, Tanya was a communications specialist for Greencom, the World Bank-funded project to combat illegal logging in Indonesia. Currently she serves on several boards: as Secretary of the Parliament Watch Indonesia; as a committee member on women's roles at the Farmers Association; on the November 10th Veterans Foundation and the Indonesian Marine Tourism Association. She is also spearheading an effort to include the Banda Islands as part of the UNESCO World Heritage Site. She earned her B.A. from the San Francisco Art Institute.

**Francois Badoual '04** (France) has been with Total since 1988, holding positions in development and production, exploration, strategic planning and now as manager of new ventures and asset management. He was seconded for four years to SINCOR, a consortium of oil companies extracting oil in Venezuela, and for five years to CONOCO. Francois has been posted to the UAE and Venezuela and is a champion sailor. He earned his Ph.D. in civil engineering and urban design and holds an Executive M.B.A. from the IMD in Lausanne, Switzerland.

**Alberto Beeck '03** (USA/Peru) is the Chairman of Cementos Pacasmayo, S.A., a Peruvian cement and mining group, and a board member of the Hochschild Group. He served from 1992 to 1997 as managing director and head of Latin American investment banking for Barings, Inc, in New York and London. From 1988 to 1992, Alberto was the Vice President of Dillon, Reed Ltd., responsible for corporate financial activities in Spain and Portugal. As Vice President of Shearson Lehman Hutton, Inc. from 1982-1988, he advised a number of governments, primarily in Central America. He received a B.S. in mechanical engineering from Purdue University, and an MBA in fi-



nance and international business from Columbia University in 1982. He serves on a number of boards in Peru and in the United States and is a member of the Young Presidents Organization and the Group of 50.

**Wayne Brown '04** (New Zealand) is Chairman of Auckland District Health Board and Transmission Holdings Ltd which broadcasts the "Free to Air" TV channels in Australia and New Zealand. He has also headed other New Zealand health boards, was the director of TV New Zealand, Maori TV and Hoyts Cinemas and a founding partner of the Sundance Channel. Currently, he is part owner of the *Neva News*, a monthly English language analytical review in St. Petersburg. Wayne, who is a surfer, owns Coastlines Surf Clothing. For a number of years, he managed New Zealand's champion surfing team. He holds a degree in engineering.

**Oleg Buklemishev '03** (Russia) has recently left Morgan Stanley, where he was a senior advisor, to join the newly launched MK Analytica as a member of the board and chief analyst. From 2000-2004 he was with the Russian Government as special assistant to the Prime Minister, deputy head of the Prime Minister's Secretariat, and deputy head of Government Staff. From 1997-2000, he was with the Ministry of Finance where he headed the International Capital Markets Department and served as Special Assistant to the Minister of Finance. Oleg holds an undergraduate degree in economics and a PhD in the same field from the Central Economics and Mathematics Institute in Moscow.

**Mamadou Mansour Cama '04** (Senegal) is Chairman and CEO of the Senegal Invest Company, a holding company with interests in fishing, leather processing, and shoe manufacturing and interests in *Sargal Investment SA*, a mining company with shares in real estate and resorts along Senegal's coast. He is also a partner in the Bouygues Group, which holds shares in the Senegalese national water distribution company. Mansour is a founding member and chair of the Na-

tional Confederation of Employers and chair of the Coordination of Senegalese Employers. He is also a member of the African Business Roundtable and the ACP-EU Business Forum. He studied Spanish and English at Cheikh Anta Diop University in Dakar and business administration and economics in Canada and Japan.

**Enos Chiura '87** (Zimbabwe) is Chairman of Merchant Bank of Central Africa Limited, Chairman of the Public Private Partnership Fund and of Unilever SEA. Previously, he worked with National Breweries Ltd and became Executive Chairman of the Delta Corporation Limited. He has served as either chairman or a member of the board of the Zimbabwe Development Bank, Zimbabwe Sun Hotels, the Zimbabwe Electricity Supply Authority, the Zimbabwe Steel Company, the International Bank of Credit and Commerce, and is a member of the World Business Council for Sustainable Development. Enos' academic degrees include a B.Sc. in economics from the University of Zimbabwe, and a M.Sc. in management from the University of Salford.

**Roberto Teixeira Da Costa '89** (Brazil) has had a long career as an economist, mostly associated with capital markets. In 1958, he started at Deltec, a pioneer in this field, then joined the Brazilian Investment Bank and Unibanco, where he was Vice President for Capital Markets. He later founded the Brazilian counterpart of the Securities and Exchange Commission (the CVM) where he was President. In 1996, he was elected Vice Chair of the board of Banco Sul America and in 2001 joined the board of Banco Itau S.A. A graduate of the National Faculty of Economic Sciences, Roberto is a frequent speaker on Latin American integration, capital markets and corporate governance and has authored a number of books on the subject. In addition to the positions noted above, he also serves on the advisory boards of corporations and funds, as well as non profit organizations in the field of interna-



tional relations, economics, the media and cultural and art institutions. He has been honored by the Ministry of Foreign Relations with the Order of Rio Branco.

**Jan Dauman '82 (UK)** is Chief Executive Officer of the InterMatrix Group, an international consulting firm that he founded in 1973. The Group now comprises companies based in London, Geneva, Milan, and Westport, Connecticut and associates throughout the world. It provides research-based project and counseling services in the fields of international strategic management and public policy. Jan received an engineering degree from Imperial College, London, a master's degree in industrial administration from Yale University and a PhD in economics from Brunel University. Prior to establishing Matrix in 1973, he spent five years as a manager for external affairs, plans and programs with IBM United Kingdom, Ltd. Prior to joining IBM, he was a manager with M.W.Kellogg for five years. He founded the UK Corporate Responsibility Centre, the Centre for Accountability and Debt Relief, the Higher Education Strategic Planning Institute, and serves as an adviser to numerous funds and associations.

**Ibrahim "Bob" Debbas '99 (USA/Lebanon)** is the owner of both "Wearelogos," a promotional item and packaging firm, as well as owner and general manager of a Future Kids Computer Learning Center franchise in Beirut. He was an Instructor of Marketing, International Business and Management at Beirut's Notre Dame University during the 1990s. Bob received a masters degree in Arab Studies from the School of Foreign Service, Georgetown University, and both a BSBA and an MBA degree from American University in Washington, DC. He is now writing a book contrasting lifestyles in the Middle East and the United States and is involved in the Free Patriotic Movement (FPM) a secular movement in Lebanon.

**Karen Douglass (USA)** is Program Coordinator in the Office of the Dean, School of Foreign Service,

Georgetown University, where she works with the Georgetown Leadership Seminar, GLS Reunions and the Fellows in Foreign Service Program. Prior to coming to Georgetown in 1999, Karen worked in publishing and website research and development. She has a B.A. in journalism from Ohio State University.

**Joan Dudik-Gayoso '93 (USA)** is an advisor for the Department of State and the American Association for the Advancement of Science on development assistance. Ms. Dudik-Gayoso has represented the United States on the United Nations Commission on Science and Technology for Development, has directed African operations at Peace Corps headquarters, and has taught at the Department of State's Foreign Service Institute, the Thunderbird School of Management and at the School of Foreign Service, Georgetown University. Joan received a B.A. in international relations with a minor in economics and languages from the University of Maryland. She is a founding member of InfoChange, a foundation dedicated to assuring that information technology is available to populations in the developing world.

**Hisham El-Khazindar '04 (Egypt)** is a founding partner and Managing Director of Citadel Capital, a leading Cairo-based private equity firm, focused on the Middle East region. Prior to co-founding Citadel Capital, Hisham was Director of Investment Banking at EFG-Hermes, Egypt's leading investment bank (2000-2001). Previously, Hisham was an associate and founding team member of the Private Equity Group at EFG-Hermes (1996-1999), and an intern in the investment banking division of Goldman Sachs International in London (1999-2000). Hisham obtained his B.A. in economics from the American University of Cairo and an M.B.A. from the Harvard Business School.

**Loay El-Shawarby '03 (Egypt)** is a legal consultant specializing in international trade law and general corporate matters. Most recently, Loay received his LLM from Georgetown University, followed by a fellowship



at the Center for Strategic and International Studies (CSIS). He served as president of Foreign Lawyers at Georgetown (FLAG.) He was an adjunct lecturer of laws at Suez Canal University in Isma`iliya, Egypt (2001-2003) and practiced with the Sharaf law firm. He is founder and owner (1996 - present) of El-Shawarby Trading Company, an Egyptian import and distribution outfit in the beverage sector. He serves on numerous boards in Egypt, is a founding member of the Nahdet El-Mahrousa (Egypt Renaissance) NGO and the head of its project on stimulating the culture of R&D in Egypt. Loay holds a B.A. and a graduate diploma in Islamic studies from the American University in Cairo and an LL.B. from Cairo University.

**Oby Ezekwesili '02** (Nigeria) is a special assistant on budget matters in the Office of the President of Nigeria. From 1994-1999, Oby served as co-founding Director for Transparency International in Nigeria, where she designed and executed a national anti-corruption program. She was Managing Director (1994-1995) and General Manager (1990-1994) for Modern Finance Nigeria in Lagos. She holds a BS from the University of Nigeria (Nsukka) and a master of international law and diplomacy from the University of Lagos. In 2000, Oby received her MA in public policy and administration from the Kennedy School of Government at Harvard University. She is also the director of the Nigeria Project for the Center for International Development at Harvard University.

**J. 'Kayode Fayemi '00** (Nigeria) is the founding Director of the Centre for Democracy & Development, a research and training institution for the study and promotion of democratic development, peace-building and human security in Africa.. He is a graduate of the University of Lagos, earned a master's degree from the University of Ife, and his PhD in war studies from King's College, University of London. Kayode served as an adviser to Nigeria's Human Rights Violations Investigation Commission, to ECOWAS, the UK Foreign and

Commonwealth Office and to other regional and international organizations on human rights, governance and security issues. He has lectured at various universities and among his most recent publications are *Mercenaries: The Africa Security Dilemma* and *Deepening the Culture of Constitutionalism*. Kayode is on the governing board of the Open Society Justice Initiative and the management review board of the ECOWAS Secretariat.

**Florian Fenner '04** (Germany) has been managing partner at UFG Asset Management, Moscow, Russia's largest independent investment bank, since 2002. Prior to that, he was a portfolio manager at both Unifund S.A. and Brunswick Capital Management and did an apprenticeship with Schroder Munchmeyer Hengst and Co. from 1992-1996. He has lived in Russia since 1996. Florian is a chartered financial analyst and member of the New York Society of Security Analysts. He speaks German, English, Russian and French.

**Robert L. Gallucci** (USA) has served as Dean of the School of Foreign Service since May 1996. From March 1998 until January 2001, he concurrently served as dean and the Department of State's special envoy for non-proliferation and weapons of mass destruction. Bob began his foreign affairs career at the Arms Control and Disarmament Agency in 1974, followed by twenty one years of government service in the Department of State's Bureau of Intelligence and Research, Policy Planning Staff (1979 to 1981), Bureau of Near Eastern and South Asian Affairs (1982-83) and Bureau of Political-Military Affairs (1983-84). He has also served on the faculty of the National War College (1988-1991) and as deputy executive chairman of the UN Special Commission (UNSCOM) overseeing the disarmament of Iraq, as senior coordinator responsible for non-proliferation and nuclear safety initiatives in the former Soviet Union in the office of the Deputy Secretary (1992-1996) and as Assistant Secretary of State for Political Military Affairs, 1992. He published *Going*



*Critical: The First North Korean Crisis* in April, 2004. He received his M.A. and Ph.D. from Brandeis University.

**Francisco Gros '84** (Brazil), who began his career as an investment banker on Wall Street, has been President of Fosfertil-Ultrafertil and a member of their board of directors since 2003. He served previously on the board of directors and as President and CEO of Petrobras; as President and CEO of BNDES, Brazil's Development Bank; as a managing director of Morgan Stanley Dean Witter and as Chairman of Morgan Stanley (Brazil). Francisco served twice as President of the Central Bank of Brazil and as President and CEO of Aracruz Celulose S.A., the world's largest producer of eucalyptus, and as Executive Director of Unibanco, in charge of capital market transactions. Francisco received a B.A. from Princeton University's Woodrow Wilson School and did graduate studies in economics at Columbia University.
