Our legal status is a 'Company Limited by Guarantee and Not Having a Share Capital'. We have also applied for 'charitable status' with the Revenue Commissioners for tax purposes. **United Christian Broadcasters (Ireland) Ltd** is 100% owned by United Christian Broadcasters Ltd. and, subject to a successful licence application, will have a Board of between five and seven Directors who will be appointed by the members of the Charity. United Christian Broadcasters Ltd. (UCB) is a registered UK charity since 1986 with an exemplary record and has adhered to the stringent requirements of both Ofcom (previously the Radio Authority) and the Charity Commissioners in the UK.
