DIRECTOR'S COMMENTS

Theodore Robert Bundy has become, perhaps, society's most infamous and notorious serial killer. By committing his crimes in many different jurisdictions he wittingly or unwittingly complicated the investigative efforts to identify, locate, and prosecute him.

Unfortunately, such cases are becoming more commonplace in today's society. It is only through cooperation and communication that we in the law enforcement community can hope to stem the growing tide of violence. The following pages represent the product of just such a collaborative effort. This exhaustive documentation of Bundy's activities was prepared in the hopes that Bundy's suspected participation in crimes other than those he has confessed to can be clarified. We may never know the total extent of his devastation but through the efforts of the Bundy Task Force we now have one document with which to compare Bundy's whereabouts with crimes he may be suspected of committing.

I wish to express my gratitude to the individuals and agencies involved. Through the spirit of cooperation the law enforcement community now has definitive documentation of Bundy's activities.

On January 24, 1989, serial killer THEODORE ROBERT BUNDY was executed in Florida's electric chair. BUNDY had been convicted of killing two coeds on January 15, 1978, at Florida State University in Tallahassee. Also on that date he bludgeoned three other women who miraculously survived his attacks.

His final death warrant resulted from his slaying a 12-year-old girl who disappeared from school on February 9, 1978; her remains were discovered on April 7, 1978.

During the last years of his life, BUNDY confided to investigators directly and indirectly regarding the motivation, victim selection, modus operandi, etc., for his crimes. In his last days on death row, in an unsuccessful attempt to prolong his life, BUNDY requested certain investigators meet with him. Investigators from the Federal Bureau of Investigation and the states of Colorado, Idaho, Utah, and Washington traveled to the prison to talk to BUNDY about a number of unsolved murders in which he was a suspect. At BUNDY's request, all the interviews were conducted in the presence of a member of the FBI's National Center for the Analysis of Violent Crime (NCAVC) who had become BUNDY's confidant over the years. Based on BUNDY's communications with this FBI Agent over several years, and the information provided during the final days and hours of his life, BUNDY discussed thirty homicides.

BUNDY'S homicidal activities spanned at least five years and reportedly claimed the lives of thirty females in at least seven states. Although every effort has been made and

every available resource has been utilized throughout the years to arrive at a comprehensive count of his victims, the true toll may never be known.

In March, 1989, under the auspices of the FBI's NCAVC Violent Criminal Apprehension Program investigators involved in BUNDY's final revelations and other knowledgeable law enforcement officials attended the BUNDY Multi-Agency Investigative Team conference at the FBI Academy in Quantico, Virginia. The purpose of this meeting was to assess and share intelligence among the participants, inasmuch as the BUNDY interviews at the prison preceding his execution were specific as to individual crimes. Following the Quantico meeting, specialists from the FBI's Visual Investigative Analysis Unit consulted with investigators throughout the country in an attempt to formulate a singular data base reflecting BUNDY's documented whereabouts over the years. They hoped that such information, coupled with information derived by investigation and BUNDY's own revelations, might lead to the solution of additional unsolved murders.

The NCAVC and BUNDY conference members have responded to numerous inquiries from investigators who are attempting to determine BUNDY's culpability in unsolved matters. It is the purpose of this report to share, within the law enforcement community, information relative to BUNDY's crimes, furnish insight into his activities, and provide the most accurate time line possible for establishing his whereabouts during any known period.

HOMICIDE ADMISSIONS

BUNDY admitted to the murder of at least thirty women between 1973 and 1978 in the following states: California (1), Colorado (3), Florida (3), Idaho (2), Oregon (2), Utah (8), and Washington (11).

MODUS OPERANDI

BUNDY was involved in voyeuristic activities throughout his life and actually studied his victims without their knowledge through surveillance and occasional clandestine entry of their residences.

In discussions regarding the development of his method of operation, BUNDY differentiated between "dry runs" and "abductions." He defined a dry run as picking up a woman and releasing her unharmed to test his skills. An abduction was an incident in which an intended victim managed to escape.

Although BUNDY had sex with most of his victims, it is doubtful that he committed only rapes. He was more interested sexually in semiconscious or unconscious victims.

BUNDY termed one of his modes as a "predator mode." When operating in this mode, he was most organized. His planning included preselection of a body disposal site, discreet research regarding his victim, preparation of necessary paraphernalia, and complete planning of the assault to include flight, evidence

disposal, and alibi. Only then would he approach the victim and put his plan into action.

At times BUNDY would feel the urge to kill when he had not done this planning and was not in his "predator mode." His victims, then, were often hitchhikers. In those cases, BUNDY was unable to be of much help to law enforcement since he did not know the victims' names and was often not able to pinpoint the body disposal sites.

Generally, BUNDY's crimes followed a particular pattern. He would feign an injury and indicate he needed assistance or he would portray an authority figure such as a police officer. He thus persuaded the victim to voluntarily accompany him to his Volkswagen where he had secreted a crowbar near the rear of the vehicle. Upon reaching the vehicle, he would retrieve the crowbar and strike the victim over the head, rendering her unconscious. He would then handcuff her and place her in the passenger side of the vehicle, which he had modified by removing the seat.

BUNDY would often drive for hours with the victim in the car. If the victim regained consciousness while he was driving he would calm her down by talking to her. He commented that the victim was often so disoriented that he could convince her that she had been injured and he was transporting her to a hospital.

When BUNDY got to his preselected dump site, he would again hit the victim (if she had regained consciousness) and

strangle her with a ligature while raping her. Although his first murder was reportedly performed by beating and manual strangulation, he most often used a ligature he had prepared solely for that purpose. Victims were strangled from the rear.

Being voyeuristic, it was important that BUNDY be able to see what he was doing. He selected sites where the moon shone brightly, or he would "operate" in front of the headlights of his vehicle. He commented that there were times that he thought he should have been caught because the headlights of his vehicle would have been visible to people driving in the area.

BUNDY advised that he made return visits to nearly all of his crime scenes.

There is little evidence to indicate BUNDY recorded his murders or assaults in any particular fashion. He indicated he had, at one time, a box of Polaroid photographs of victims that he kept hidden but subsequently destroyed after becoming a suspect. It is known that he would sometimes keep ski brochures that were apparently marked to signify homicides. Also found was a brochure from the high school play where one of his victims was abducted. BUNDY advised he would discard everything belonging to his victims and would sometimes discard his possessions, such as his props or tools, connected with the incidents. He would later have to replace those items.

BUNDY gave the impression that he committed most of his assaults outdoors, except in Utah and Florida. In Utah, he was able to take his victims back to his apartment, where he could

reenact scenarios depicted on the covers of detective magazines.

Of the thirty victims BUNDY claimed to have killed, he reportedly buried about ten. He would always attempt to bury the bodies two or three feet deep and place rocks on top of the grave. He also claimed to have disposed of victims in bodies of water.

BUNDY reported he severed the heads of about a dozen of his victims. He would sometimes retain the heads for longer periods than the bodies and not necessarily dispose of the body and head in the same location. Actually, body parts, clothing, and other victim possessions were dispersed, perhaps, hundreds of miles from the discarded torso.

BUNDY clearly followed media reports of his crimes as well as the reports of others who killed. He was interested in other people's murders and the possibility that he was being copied. He followed his own cases to glean as much intelligence as possible regarding suspects, evidence, leads, etc. He felt he was helped quite a bit with the abundance of information from investigators' quotes available through the media and his perceived lack of cooperation among law enforcement agencies.

Although ligature strangulation was BUNDY's favorite method of killing, the manual strangulation of his first murder is consistent behavior in an evolving serial murderer. That is, a serial killer is disorganized when he starts but improves significantly as he progresses, choosing his victims, murder and

body disposal sites, and methodology more carefully. He becomes more sophisticated.

BUNDY exhibited this evolution toward sophistication. Finally, however, under the stress of being a fugitive, he regressed. He resorted to using his bare hands and a blunt weapon and selected sleeping victims or young girls as targets.

When asked about the bite marks he inflicted on his victims at one of his last crime scenes, and whether he had done anything like that before, BUNDY did not respond fully. However, he did say that when he was in an extremely aggravated state, biting took place.

Unfortunately, there remain, and perhaps forever will remain, many unanswered questions about BUNDY's activities.

CONCLUSION

Of the homicides examined at the BUNDY Multi-Agency Investigative Team conference, BUNDY claims responsibility for thirty. As a result of information provided by BUNDY and an independent verification of that information by investigators, it was possible to associate BUNDY with twenty cases.

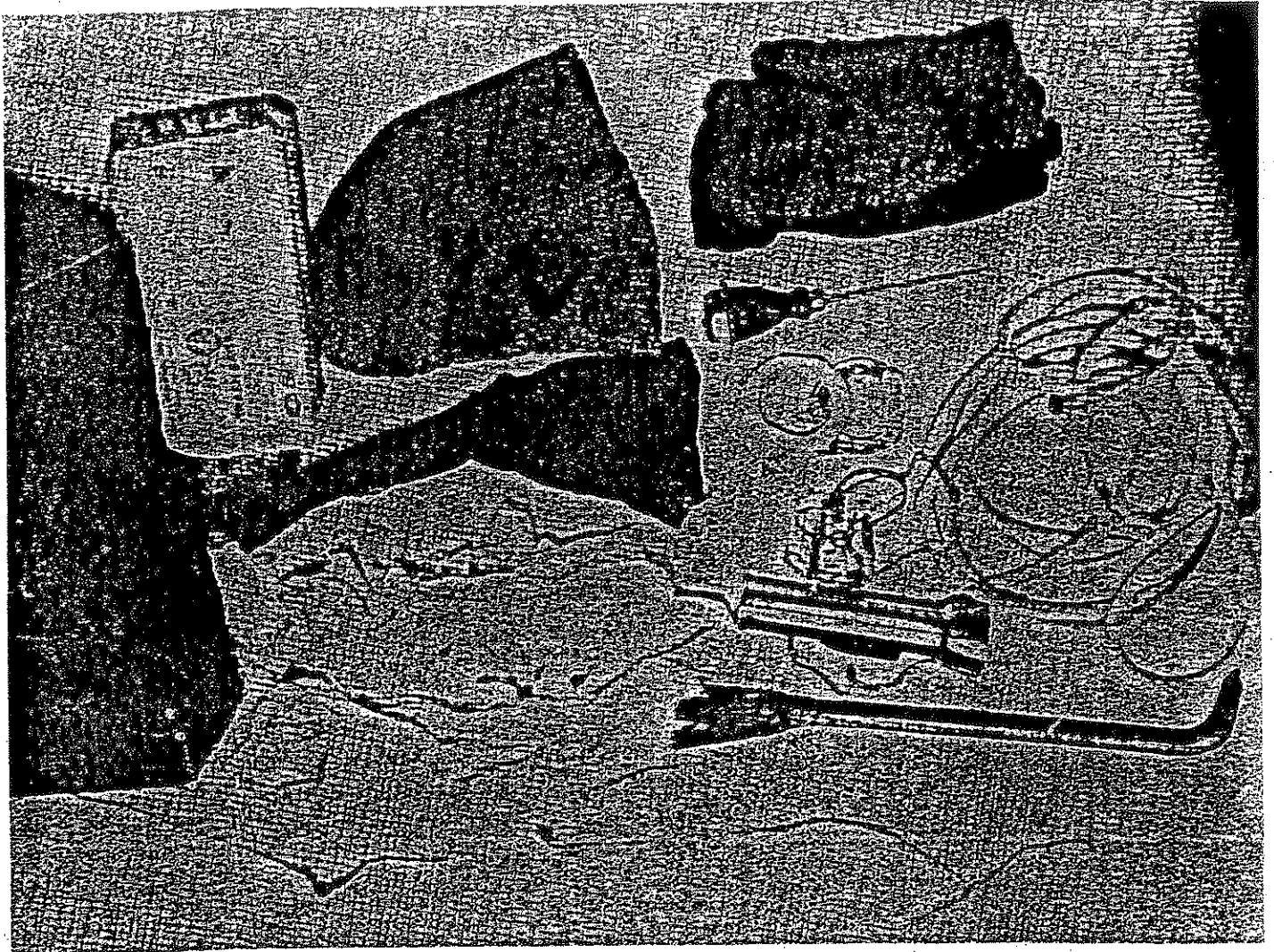

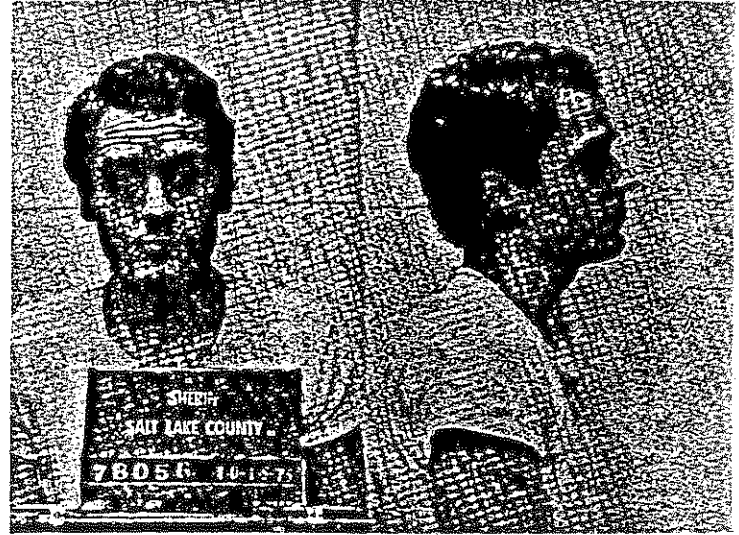
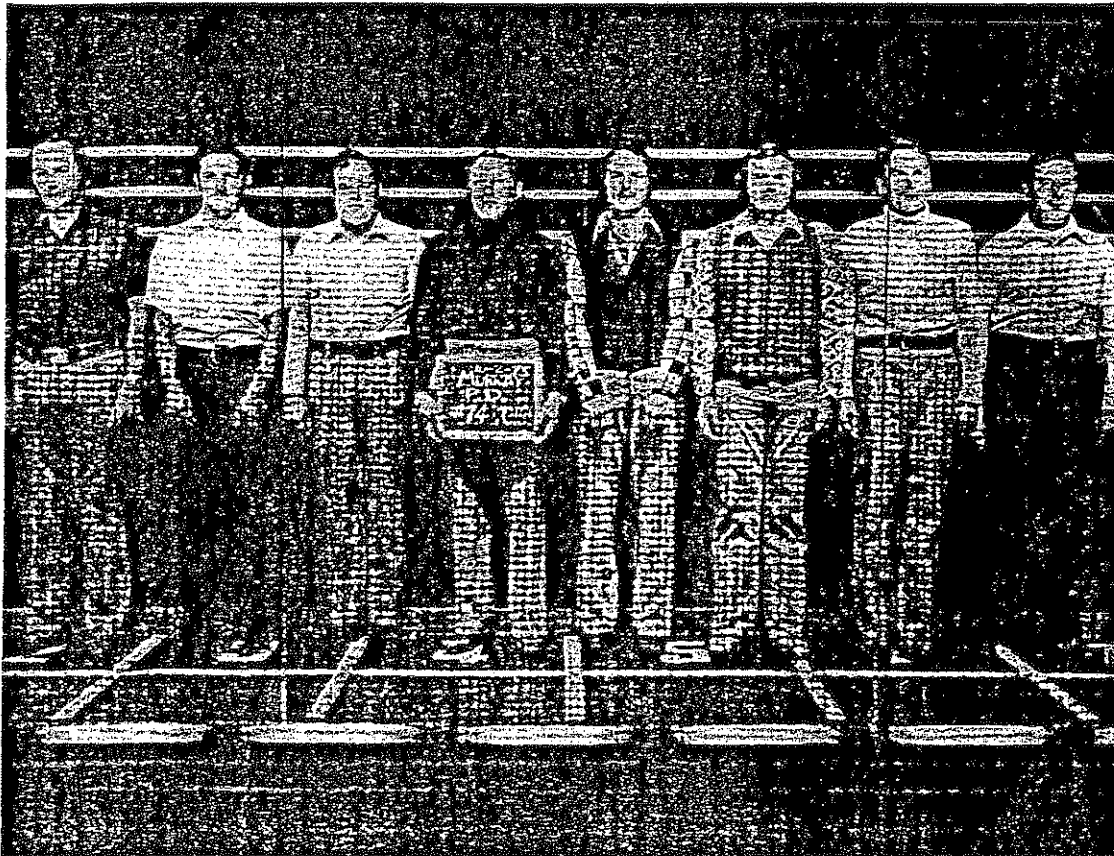


Photo taken of Bundy right after line up on 10/2/75.



One of Bundy's victims identified him from this line up even after he had cut his hair and parted it on the opposite side.

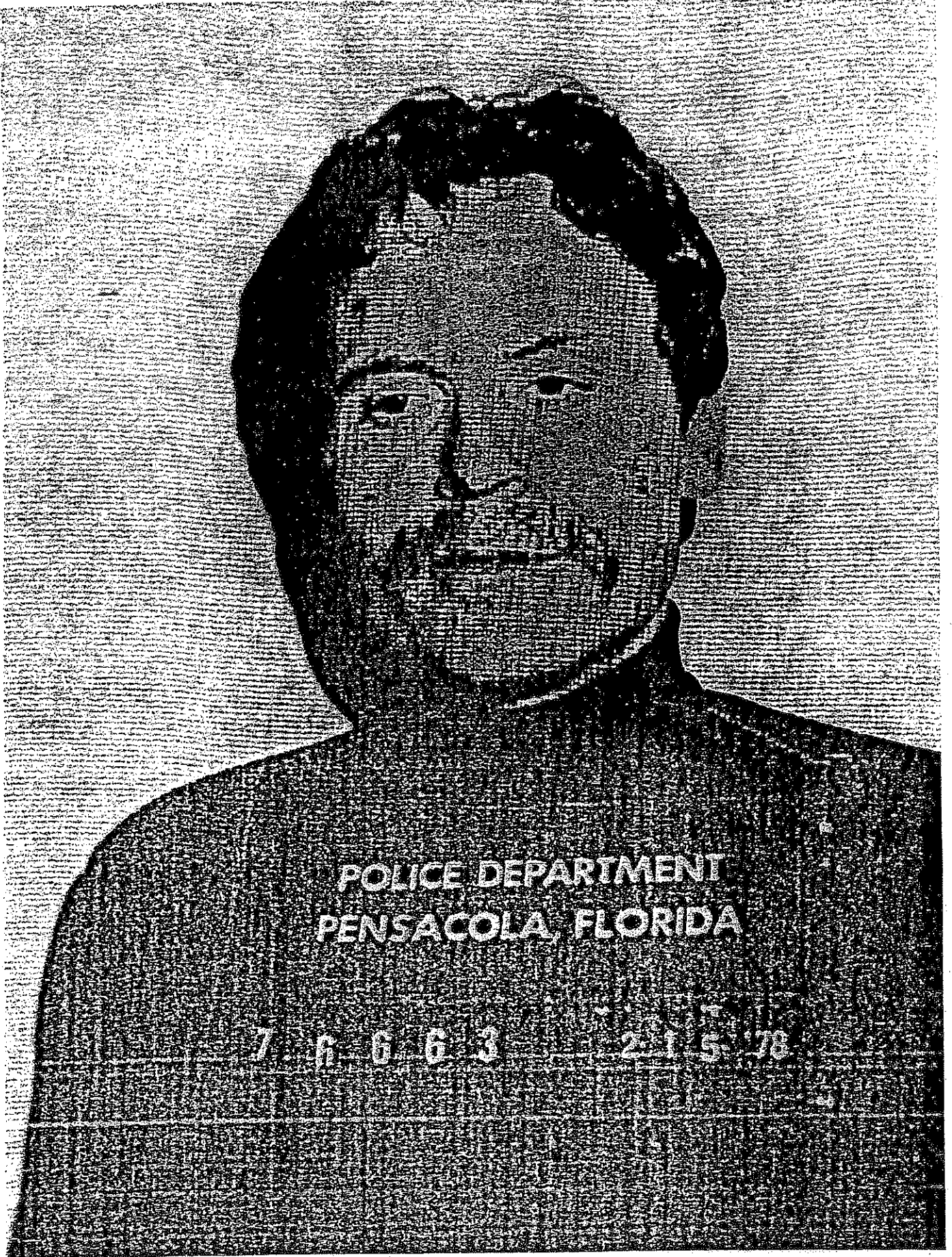
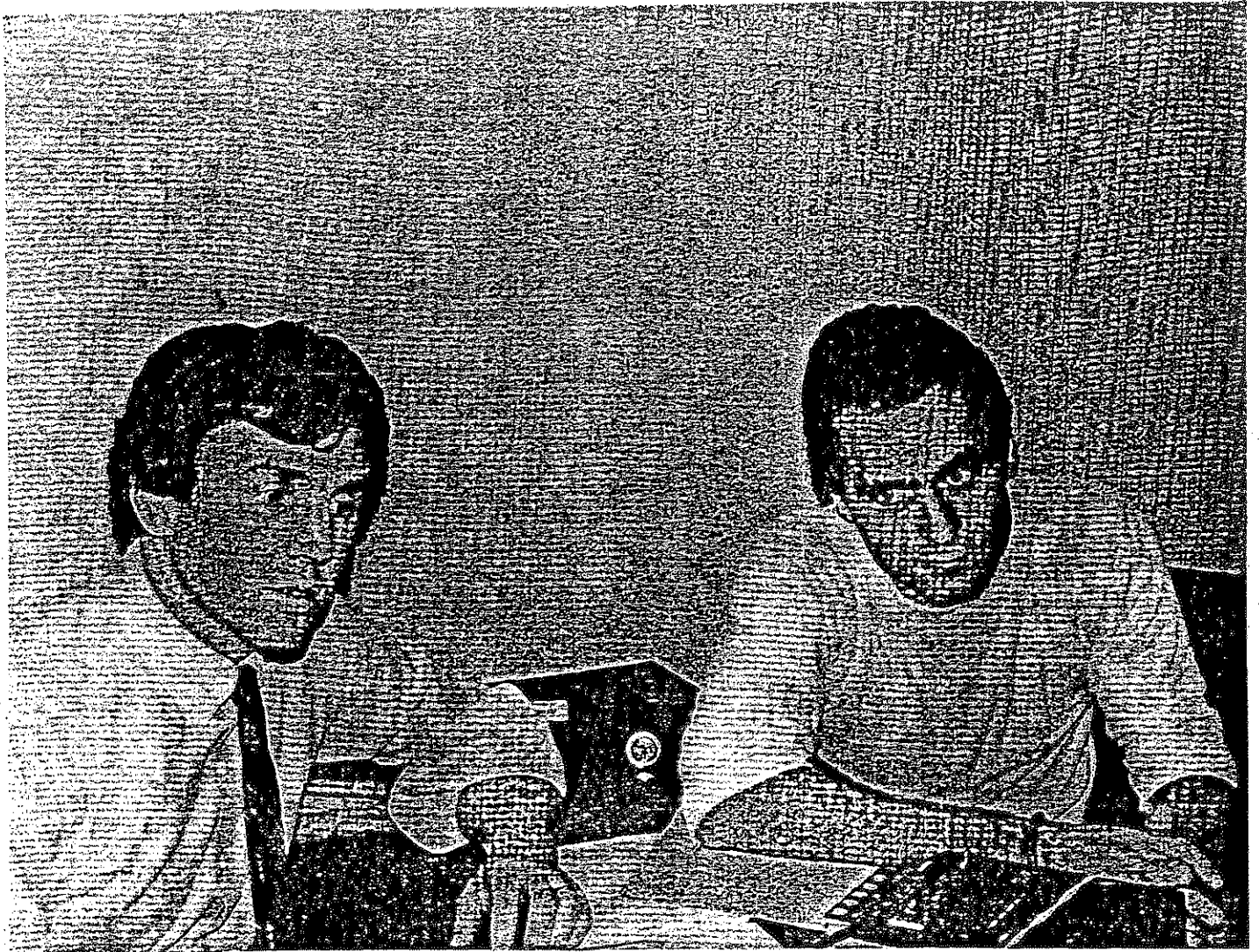

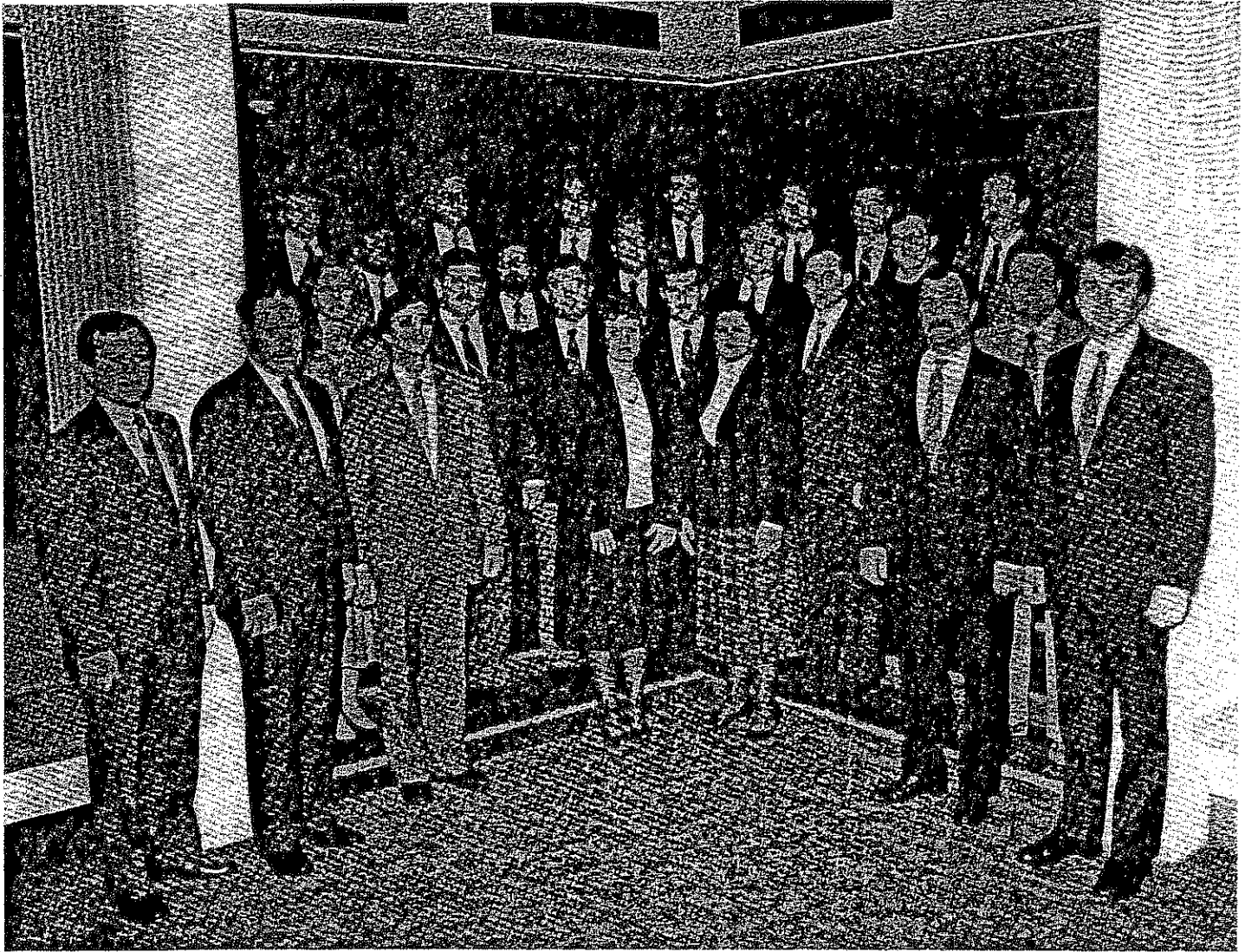
