# Introduction to the collection

The papers which make up the core of this collection were donated to The University of Auckland by Wilfred (Bill) McAra a prominent member of Communist Party of New Zealand (CPNZ) on behalf of the ESPAL Society. The papers document the activities of the CPNZ from the 1920s until the early 1970s at both the national and local level. The collection includes papers relating to National and District Conferences, general and local body election campaigns, Communist Party study courses, the production of the *People's voice* and other CPNZ publications, files of clippings and research materials and a set of original cartoons produced for the *People's voice* by Frank Dromgoole.

'ESPAL' is an acronym for the Economic Social Political and Literary Society. This society was registered in June 1964 by Bill McAra, his partner Diana Wilsie and other members of the CPNZ as an independent organisation, partly in response to the Communist Party losing out on a number of bequests from supporters. It was felt a donation to the ESPAL society would be less likely to be contested than a bequest to the Communist Party of New Zealand (MSS & Archives 89/25, item 2/25). It was to the ESPAL society that McAra transferred the ownership of his Hayden Street House in 1965 as part of the process of gifting the property to the CPNZ.

The donation of records to the University by McAra either personally on behalf of the ESPAL society was also one of the accusations of "big shotism" brought against McAra by other members of CPNZ in the early 1970's. McAra was accused of setting up a bureau consisting of himself and Wilsie, presumably this means the ESPAL society, "without the knowledge of the Party and dispersing Party documents to various institutions and individuals outside the Party" (MSS & Archives 89/25, item 2/15). McAra defending himself describes the disputed archives as follows:

"The so-called "Archives" are confined to a number (approximately a dozen) packages of papers. They were packed in black cellophane and put under seal in Auckland University for periods of 20 and 30 years. They include a very large part of my personal writings. Many had already been published. There are also some Party documents and some minutes. The University authorities are not aware of the contents of these packages. Sealed inside each is a list of contents. The only other copies of lists were in a file I handed to BH." (MSS & Archives 89/25, item 2/15) (BH is Beth Hollis).

In 1974 McAra writing to the University Librarian describes how the papers were given to the University with the full knowledge and approval of the Chairman of the National Control Commission of the Communist Party of New Zealand and how in 1970 McAra had been asked to go through files at the National Office and select material to be transferred to the University Library under seal "in the same way as had been done previously". Unable to visit the National Office at that time McAra implies that important material "went up in smoke" but that shortly after another

member of the National Control Commission brought a package of Party documents to be lodged at the University. (letter held in Bert Roth's papers at the Turnbull MS-papers-6164-056).

The original packages were unwrapped and listed by Frank Rogers in 1988 just prior to the end of the embargo period. This preliminary inventory simply listed the material in its original order. Rogers found the packages contained a set of distinctly labelled folders which with the exception of the first package were numbered MACK 2a to MACK 13d. Rogers assigned the unnumbered folders in package one numbers 1a to 1d to match the remainder of the material. However, a run of similarly labelled files numbered MACK 1a to 1n can be found in MSS 89/25: papers of Wilfred (Bill) McAra and Diana Wilsie, which were donated to the University in 1988. MACK appears to be an acronym but for what, is unclear.

The ESPAL material was later reorganised and some 92 folders of material from, MSS & Archives A-139, series 3: Communist Party of New Zealand 1921 -70, were then incorporated into the ESPAL material to form the collection as it exists today.

In 2009 when the collection was re-housed into acid-free folders, it was possible to identify much of the material that was added to the collection from MSS & Archives A-139, series 3, partly by the folders in which the material was housed, and by the fact that many items still had their original item numbers written on them. Where legible these previous control symbols have been recorded on the updated inventory. A note in the A-139 inventory suggested that MSS & Archives A-139, series 4: overseas communist parties 1935 – 69, had also been added to the original ESPAL material but it had in fact been retained in its own box at the end of the run and has been returned to MSS & Archives A-139.

As part of the work done on the collection in 2009, items in the collection were assigned consecutive item numbers, previously the items had been assigned consecutive numbers per each box. Bundles and very large folders of material were examined and divided into smaller more easily handled units. Existing item descriptions were checked against the contents of each folder and altered as necessary and the item date ranges updated as required. In addition, without altering the overall arrangement of the collection the contents were divided into ten series.
