



# The State of the School

Principal Dr. James L. Schlosser

One Saturday morning in October while priming the exterior of the PE Building and Athletic Locker Room to be painted on Make-A-Difference Day, two Kalaheo alumni unexpectedly appeared, visiting from Colorado. Without paintbrushes or rollers but with smiles and questions, they were curious to know where classmates are, what teachers remain on staff, and what's going on around the campus.

Jacque Ainlay ('83) and Lee Conley ('84), now married, were eager to hear about the changes and catch up on the campus news about their alma mater. Jacque is in education, by the way, and Lee is an engineer and a Naval Academy graduate. Catching up was great, but our volunteer paint foreman finally convinced me to stop talking and get back to painting. Visiting with alumni is indeed sweet.

Let me update you on some of this campus news.

## ON THE ACADEMIC FRONT

Three junior Mustangs, now seniors, qualified as **National Merit Scholar Semi-Finalists** and one recognized as a **2001 Merit Program Commended Student**. Kudos to Ashley Black, Caitlin Fackrell, Melelani Sax-Barnett and Chelsea Yamabe, respectively. Yes, Caitlin's mother is Mary Fackrell, the math department chairperson.

In the last three years, Kalaheo has placed seven **students at military academies**: two at West Point, one at the Air Force Academy and four at the Naval Academy. Additionally, we sent two students off to NAPS, the Naval Prep Academy. We take great pride in the achievements of all our graduates, in-

cluding Christie Raymond who stopped off in Hawaii last Spring after graduating from Embry-Riddle Aeronautical University. She was headed to her first post-college job with NASA in Texas. Christie spoke briefly to the faculty and left the meeting to standing applause.

Students' **SAT scores** continue to be above the national norm. For example, last year in reading (with national percentages in parentheses), our tenth graders scored 34% (23%) in the high stanine distribution range, 53% (54%) in the average and 13% (23%) in the low ranges. In math, our profile is 30%, 53% and 18%. This information might mean much more to our alumni readers now than when they were students as many have or are about to have children.

The faculty continues to focus on **writing improvement in all content areas**. For three years, all seniors have been required to write a senior paper as part of their English and social studies requirements. The entire faculty reads and scores the papers. A community group reads the top papers and awards the Outstanding Senior Paper with a \$500 savings bond from First Hawaiian Bank.

This year, students are writing a persuasive paper addressing this question: What amendment in the Bill of Rights would you broaden or maintain to reflect the issues and challenges to today's society? Yes, a tough question and one we want young minds to think clearly about.

Implemented with a Board of Education waiver, our **attendance policy** supports the academic program. Students automatically fail a course upon the fourth absence, with two tardies equaling

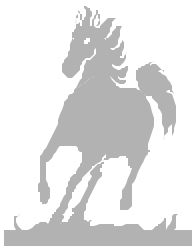

one absence, but an appeal procedure is in place for those who legitimately exceed three absences. This policy has increased our **daily average attendance rate** from 88% to 92% over the last three years and reduced the average daily absentees in days from over 20 to under 15. I expect these figures to improve over the next three years. The premise is clear: attendance is a prerequisite to learning.

High schools across the country have dealt with **textbook issues**, and Kalaheo is no exception. Although three years ago classroom sets were the norm at Kalaheo, today all students are issued textbooks in the core areas and in most elective classes, unless the curriculum does not require a textbook.

Recently, the community and faculty identified **school-wide learning outcomes**, educational jargon for what teachers and programs will focus on in all content areas. Critical thinking and responsibility will be added to writing as areas of major emphasis.

### THE PHYSICAL PLANT

Over the years, an administration-library-classroom building, a second shop building, the gymnasium and an athletic locker room have been constructed. However, the size and function of the physical plant remain fundamentally unchanged. On the other hand, **repair, maintenance and improvement needs** are ever-changing.

When alumni Lee Conley visited on that October Saturday, he commented that the campus looked much better than when he attended. Perhaps it should. During the last three years, hundreds of parent and student volunteers constructed dozens of concrete and wooden benches for students to use during morning and lunch recess; painted the exterior of three build-

ings, the interior of the cafeteria and one classroom and dozens of classroom doors; and planted dozens of plants and trees around campus.

The goal of this effort is, of course, to construct **an environment conducive to learning**. One would think that painting public school buildings is the State's responsibility, but with legislative funding cuts, our identified facilities' improvements are no longer State priorities. Our choices were to wait for restoration of funds or take action ourselves. Since the State is unwilling to make the learning environment a financial priority, the Kalaheo community—parents, students and faculty—decided to get it done by doing it themselves

**Computers** are in many classrooms, but except for H-Building, the campus is not wired. This school year, the backbone for a **campus-wide network** will be placed in the ground, and classrooms can then be wired for voice, video and data technology, including Internet.

Finally, we are working on a strategic plan to complete the **campus athletic facilities**, including a football field, baseball fields, and a swimming pool. Currently, the Department of Education has formally closed the books on Kalaheo's need for athletic facilities, projecting the cost to exceed \$25 million. In future issues, we will keep you updated on our progress.

I encourage all our alumni, friends, and supporters to keep in touch with the Kalaheo High School Foundation and Alumni Association. Let us know when you move, when your family grows, and when you get that promotion.

## FOCUS ON ALUMNI: Peggie Tester and Mike Akiu

Peggie earned an associate degree and CA in Cosmetology at Honolulu Community College; she also has her boat captain's license. She currently works for DHS Social Services and serves as a trainer for Special Olympics Coaches Clinics.

Peggie was named Coach of the Year for Swimming (1998-2000) in the OIA East and OIA.

Mike played Kalaheo JV and varsity football from 1976-1979 as defensive back, running back, and wide receiver. From 1977 to 1980, he played centerfield during baseball season.

Mike also ran 100, 200, 400, 4x100 track events. In his senior year, he was State Champion in all five

events, leading his team of five runners to a second place finish in the State Championships.

From 1980-1982, Mike attended Washington State University on a track scholarship, running 100, 200, and 4x100 events.

In 1983 and 1984 at the University of Hawaii, he played wide receiver under coach Dick Tomey, excelling on special teams and leading the team in block punts and kicks. His professional career was with the NFL Houston Oilers as wide receiver from 1985-1989.

About the Kalaheo Mustangs, Mike says, "This year our team is young, but very hardworking and competitive. We are looking forward to a strong finish and a great future. We appreciate all the support the students, parents, faculty, administration, community and alumni have provided us this year."

Mike and wife Sheraine have two children following in dad's athletic footsteps. Mike, Jr., a senior at Kamehameha, participates in football and track. Daughter Tiana, a Kalaheo freshman, plays JV volleyball. Mike's "day job" is with McCabe, Hamilton & Renny Stevedores.

## GRANT APPLICATIONS

Grant applications will be solicited twice this school year, in October 2000 and March 2001.

## TIME CAPSULE

Plans are underway to resurrect the time capsule buried on Kalaheo's campus in the late 1970s. Past and present students, administrators, faculty and staff will be involved in the opening of the capsule.

## ALUMNI WEB SITE

Students currently enrolled in the school's computer will manage the alumni Web site, keeping it up-to-date and loaded with helpful information.

## ALUMNI HONOR AWARDS

Board members Wade Nakashima and April Inouye will seek Alumni Honor Award nominees. The board recognizes that Kalaheo has many deserving alumni and desires to recognize their accomplishments.

## ACTIVE ALUMNI

We wish to include at least one representative from each graduating class on the board. The board recognizes the need to actively involve more alumni in the activities of the Foundation and Alumni Association.

## COURTYARD RENOVATIONS

We will support the efforts of board member Paul Ress and others in the school community as they clean up H-Building courtyard and create a welcoming, aesthetically pleasing entrance to the school.

## FINANCIAL MANAGEMENT

The board will seek opportunities for a higher return on Foundation funds. As advised by board member and attorney Bruce Voss, it is the board's duty to responsibly seek a higher return on funds. We plan to invest our \$25,000 endowment in a mutual fund, pending sound financial advice on specific funds. Treasurer Jim Hasselman and others will follow-up.

## EXPANSION OF ATHLETIC FACILITIES

Principal Jim Schlosser and board member Suzy Churchill will organize a school-community group to pursue the expansion of the school's athletic facilities through a public-private partnership. An innovative and exciting concept has been drafted by Kalaheo parent-architect Guy Jennings.

## PRINCIPAL'S RECEPTION

Board members Karen Kanda and Martha Robertson will help coordinate a Principal's Reception in May 2001 for graduates and their parents. With the support of students, faculty, staff and the community, we anticipate this event will become an annual tradition.
